1 AMEND House Committee Substitute for House Bill No. 334, Pages 5 to 6, Section 115.427, Lines
2 128 to 170, by deleting all of said lines and inserting in lieu thereof the following:

4 "5. The secretary of state shall provide advance notice of the personal identification
5 requirements of subsection 1 of this section in a manner calculated to inform the public generally of
6 the requirement for forms of personal identification as provided in this section. Such advance notice
7 shall include, at a minimum, the use of advertisements and public service announcements in print,
8 broadcast television, radio, and cable television media, as well as the posting of information on the
9 opening pages of the official state internet websites of the secretary of state and governor.

10 6. (1) Notwithstanding the provisions of section 136.055 and section 302.181 to the
11 contrary, the state and all fee offices shall provide one nondriver's license at no cost to any otherwise
12 qualified voter who does not already possess such identification and who desires the identification
13 ~~[in order to vote]~~ for voting.

14 (2) This state and its agencies shall provide one copy of each of the following, free of
15 charge, if needed by an individual seeking to obtain a form of personal identification described in
16 subsection 1 of this section ~~[in order to vote]~~ for voting:

17 (a) A birth certificate;

18 (b) A marriage license or certificate;

19 (c) A divorce decree;

20 (d) A certificate of decree of adoption;

21 (e) A court order changing the person's name;

22 (f) A Social Security card reflecting an updated name; and

23 (g) Naturalization papers or other documents from the United States Department of State
24 proving citizenship.

26 Any individual seeking one of the above documents in order to obtain a form of personal
27 identification described in subsection 1 of this section ~~[in order to vote]~~ for voting may request the
28 secretary of state to facilitate the acquisition of such documents. The secretary of state shall pay any
29 fee or fees charged by another state or its agencies, or any court of competent jurisdiction in this
30 state or any other state, or the federal government or its agencies, in order to obtain any of the above
31 documents from such state or the federal government.

32 (3) All costs associated with the implementation of this section shall be reimbursed from the
33 general revenue of this state by an appropriation for that purpose. If there is not a sufficient
34 appropriation of state funds, then the personal identification requirements of subsection 1 of this
35 section shall not be enforced.

36 (4) Any applicant who requests a nondriver's license for ~~[the purpose of]~~ voting shall not be

1 required to pay a fee [~~if the applicant executes a statement, under penalty of perjury, averring that~~
2 ~~the applicant does not have any other form of personal identification that meets the requirements of~~
3 ~~this section~~]. The state of Missouri shall pay the legally required fees for any such applicant. [~~The~~
4 ~~director of the department of revenue shall design a statement to be used for this purpose. The total~~
5 ~~cost associated with nondriver's license photo identification under this subsection shall be borne by~~
6 ~~the state of Missouri from funds appropriated to the department of revenue for that specific~~
7 ~~purpose.~~] The department of revenue and a local election authority may enter into a contract that
8 allows the local election authority to assist the department in issuing nondriver's license photo
9 identifications."; and

14 accordingly.
