FISCAL ANALYSIS

ASSUMPTION

§407.932 – Tobacco products

Officials from the **Department of Revenue (DOR)** state that currently, local political subdivisions cannot enact laws that are more stringent than the state regarding tobacco licenses. This proposal does allow them to limit the number of licenses issued but they cannot remove a license from an existing business. DOR assumes this will not have a fiscal impact on the Department.

Officials from the **Department of Public Safety - Division of Alcohol and Tobacco Control**, the **City of Kansas City**, and the **City of Springfield** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note.

Oversight only reflects the responses received from state agencies and political subdivisions; however, other cities and counties were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.

FISCAL DESCRIPTION


The proposed legislation appears to have no direct fiscal impact.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.


