ASSUMPTION

Officials from the **Missouri Department of Transportation**, **Missouri Highway Patrol**, **Office of the State Public Defender** and **Missouri Office of Prosecution Services** each assume the proposal will have no fiscal impact on their respective organizations.

In response to a similar proposal from 2024 (HB 2636), officials from the **Office of the State Courts Administrator** assumed the proposal would have no fiscal impact on their organization.
