**AN ACT**

To repeal sections 37.725, 43.400, 43.401, 43.539, 43.540, 57.280, 67.145, 70.631, 84.344, 160.660, 170.310, 190.091, 193.265, 210.305, 210.565, 211.071, 285.040, 307.175, 320.210, 321.246, 488.435, 491.075, 492.304, 556.021, 558.031, 565.003, 566.151, 567.030, 569.010, 569.100, 569.170, 570.010, 570.030, 571.020, 571.030, 575.205, 579.065, 579.068, 589.401, 589.403, 589.410, 589.414, 590.040, 590.080, 595.045, 610.021, 650.320, and 650.340, RSMo, and to enact in lieu thereof sixty-two new sections relating to public safety, with penalty provisions.

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Sections 37.725, 43.400, 43.401, 43.539, 43.540, 57.280, 67.145, 70.631, 2 84.344, 160.660, 170.310, 190.091, 193.265, 210.305, 210.565, 211.071, 285.040, 307.175, 3 320.210, 321.246, 488.435, 491.075, 492.304, 556.021, 558.031, 565.003, 566.151, 567.030, 4 569.010, 569.100, 569.170, 570.010, 570.030, 571.020, 571.030, 575.205, 579.065, 579.068, 5 589.401, 589.403, 589.410, 589.414, 590.040, 590.080, 595.045, 610.021, 650.320, and 6 650.340, RSMo, are repealed and sixty-two new sections enacted in lieu thereof, to be known 7 as sections 37.725, 43.400, 43.401, 43.539, 43.540, 57.280, 67.145, 70.631, 84.344, 160.660, 8 170.310, 190.091, 193.265, 195.817, 210.305, 210.565, 210.795, 211.071, 285.040, 307.018, 9 307.175, 320.210, 321.246, 488.435, 491.075, 492.304, 547.500, 550.125, 556.021, 557.520, 10 558.031, 565.003, 566.151, 567.030, 569.010, 569.100, 569.170, 569.175, 570.010, 570.030, 11 570.212, 571.020, 571.030, 571.031, 575.205, 579.021, 579.022, 579.041, 579.065, 579.068, 12 589.401, 589.403, 589.410, 589.414, 590.033, 590.040, 590.080, 595.045, 610.021, 650.320, 13 650.340, and 1, to read as follows:

EXPLANATION — Matter enclosed in bold-faced brackets **[thus]** in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

37.725. 1. Any files maintained by the advocate program shall be disclosed only at the discretion of the child advocate; except that the identity of any complainant or recipient shall not be disclosed by the office unless:

(1) The complainant or recipient, or the complainant's or recipient's legal representative, consents in writing to such disclosure; ~~[or]~~

(2) Such disclosure is required by court order; **or**

**(3) The disclosure is at the request of law enforcement as part of an investigation.**

2. Any statement or communication made by the office relevant to a complaint received by, proceedings before, or activities of the office and any complaint or information made or provided in good faith by any person shall be absolutely privileged and such person shall be immune from suit.

3. Any representative of the office conducting or participating in any examination of a complaint who knowingly and willfully discloses to any person other than the office, or those persons authorized by the office to receive it, the name of any witness examined or any information obtained or given during such examination is guilty of a class A misdemeanor. However, the office conducting or participating in any examination of a complaint shall disclose the final result of the examination with the consent of the recipient.

4. The office shall not be required to testify in any court with respect to matters held to be confidential in this section except as the court may deem necessary to enforce the provisions of sections 37.700 to 37.730, or where otherwise required by court order.

43.400. As used in sections 43.400 to 43.410, the following terms mean:

(1) "Missing child" or "missing juvenile", any person who is under the age of ~~seventeen~~ **eighteen years or who is in foster care regardless of the person's age or who is an emancipated minor as defined in section 302.178, a homeless youth as defined in section 167.020, or an unaccompanied minor as defined in section 210.121**, whose temporary or permanent residence is in the state of Missouri or who is believed to be within the state of Missouri, whose location has not been determined, and who has been reported as missing to a law enforcement agency;

(2) "Missing child report", a report prepared on a standard form supplied by the Missouri state highway patrol for the use by private citizens and law enforcement agencies to report missing children or missing juvenile information to the Missouri state highway patrol;

(3) "Missing person", a person who is missing and meets one of the following characteristics:

(a) Is physically or mentally disabled to the degree that the person is dependent upon an agency or another individual;

16 (b) Is missing under circumstances indicating that the missing person's safety may be  
17 in danger;

18 (c) Is missing under involuntary or unknown circumstances; subject to the provisions  
19 of (a), (b), (d), (e), and (f) of this subsection;

20 (d) Is a child or juvenile runaway from the residence of a parent, legal guardian, or  
21 custodian;

22 (e) Is a child and is missing under circumstances indicating that the person was or is  
23 in the presence of or under the control of a party whose presence or control was or is in  
24 violation of a permanent or temporary court order and fourteen or more days have elapsed,  
25 during which time the party has failed to file any pleading with the court seeking modification  
26 of the permanent or temporary court order;

27 (f) Is missing under circumstances indicating that the person was or is in the presence  
28 of or under the control of a party whose presence or control was or is in violation of a  
29 permanent or temporary court order and there are reasonable grounds to believe that the  
30 person may be taken outside of the United States;

31 (4) "Patrol", the Missouri state highway patrol;

32 (5) "Registrar", the state registrar of vital statistics.

43.401. 1. The reporting of missing persons by law enforcement agencies, private  
2 citizens, and the responsibilities of the patrol in maintaining accurate records of missing  
3 persons are as follows:

4 (1) A person may file a complaint of a missing person with a law enforcement agency  
5 having jurisdiction. The complaint shall include, but need not be limited to, the following  
6 information:

7 (a) The name of the complainant;

8 (b) The name, address, and phone number of the guardian, if any, of the missing  
9 person;

10 (c) The relationship of the complainant to the missing person;

11 (d) The name, age, address, and all identifying characteristics of the missing person;

12 (e) The length of time the person has been missing; and

13 (f) All other information deemed relevant by either the complainant or the law  
14 enforcement agency;

15 (2) A report of the complaint of a missing person shall be immediately entered into  
16 the Missouri uniform law enforcement system (MULES) and the National Crime Information  
17 Center (NCIC) system by the law enforcement agency receiving the complaint, and  
18 disseminated to other law enforcement agencies who may come in contact with or be  
19 involved in the investigation or location of a missing person;

20 (3) A law enforcement agency with which a complaint of a missing child has been  
21 filed shall prepare, as soon as practicable, a standard missing child report. The missing child  
22 report shall be maintained as a record by the reporting law enforcement agency during the  
23 course of an active investigation;

24 (4) Upon the location of a missing person, or the determination by the law  
25 enforcement agency of jurisdiction that the person is no longer missing, the law enforcement  
26 agency which reported the missing person shall immediately remove the record of the missing  
27 person from the MULES and NCIC files.

28 2. No law enforcement agency shall prevent an immediate active investigation on the  
29 basis of an agency rule which specifies an automatic time limitation for a missing person  
30 investigation.

31 **3. Any agency or placement provider with the care and custody of a child who is**  
32 **missing shall file a missing child complaint with the appropriate law enforcement**  
33 **agency within two hours of determining the child to be missing. The law enforcement**  
34 **agency shall immediately submit information as to the missing child to the National**  
35 **Center for Missing and Exploited Children (NCMEC) including, but not limited to, the**  
36 **name, date of birth, sex, race, height, weight, and eye and hair color of the child; a**  
37 **recent photograph of the child; and the date and location of the last known contact with**  
38 **the child. The law enforcement agency shall institute a proper investigation and search**  
39 **for the missing child and maintain contact with the agency or placement provider**  
40 **making the missing child complaint. The missing child's entry shall not be removed**  
41 **from any database or system until the child is found or the case is closed.**

43.539. 1. As used in this section, the following terms mean:

2 (1) "Applicant", a person who:

3 (a) Is actively employed by or seeks employment with a qualified entity;

4 (b) Is actively licensed or seeks licensure with a qualified entity;

5 (c) Actively volunteers or seeks to volunteer with a qualified entity;

6 (d) Is actively contracted with or seeks to contract with a qualified entity; or

7 (e) Owns or operates a qualified entity;

8 (2) "Care", the provision of care, treatment, education, training, instruction,  
9 supervision, or recreation to children, the elderly, or disabled persons;

10 (3) "Missouri criminal record review", a review of criminal history records and sex  
11 offender registration records under sections 589.400 to 589.425 maintained by the Missouri  
12 state highway patrol in the Missouri criminal records repository;

13 (4) "Missouri Rap Back program", any type of automatic notification made by the  
14 Missouri state highway patrol to a qualified entity indicating that an applicant who is

15 employed, licensed, or otherwise under the purview of that entity has been arrested for a  
16 reported criminal offense in Missouri as required under section 43.506;

17 (5) "National criminal record review", a review of the criminal history records  
18 maintained by the Federal Bureau of Investigation;

19 (6) "National Rap Back program", any type of automatic notification made by the  
20 Federal Bureau of Investigation through the Missouri state highway patrol to a qualified  
21 entity indicating that an applicant who is employed, licensed, or otherwise under the purview  
22 of that entity has been arrested for a reported criminal offense outside the state of Missouri  
23 and the fingerprints for that arrest were forwarded to the Federal Bureau of Investigation by  
24 the arresting agency;

25 (7) "Patient or resident", a person who by reason of age, illness, disease, or physical  
26 or mental infirmity receives or requires care or services furnished by an applicant, as defined  
27 in this section, or who resides or boards in, or is otherwise kept, cared for, treated, or  
28 accommodated in a facility as defined in section 198.006, for a period exceeding twenty-four  
29 consecutive hours;

30 (8) "Qualified entity", a person, business, or organization that provides care, care  
31 placement, or educational services for children, the elderly, or persons with disabilities as  
32 patients or residents, including a business or organization that licenses or certifies others to  
33 provide care or care placement services;

34 (9) "Youth services agency", any agency, school, or association that provides  
35 programs, care, or treatment for or exercises supervision over minors.

36 2. The central repository shall have the authority to submit applicant fingerprints to  
37 the National Rap Back program to be retained for the purpose of being searched against future  
38 submissions to the National Rap Back program, including latent fingerprint searches.  
39 Qualified entities may conduct Missouri and national criminal record reviews on applicants  
40 and participate in Missouri and National Rap Back programs for the purpose of determining  
41 suitability or fitness for a permit, license, or employment, and shall abide by the following  
42 requirements:

43 (1) The qualified entity shall register with the Missouri state highway patrol prior to  
44 submitting a request for screening under this section. As part of the registration, the qualified  
45 entity shall indicate if it chooses to enroll applicants in the Missouri and National Rap Back  
46 programs;

47 (2) Qualified entities shall notify applicants subject to a criminal record review under  
48 this section that the applicant's fingerprints shall be retained by the state central repository and  
49 the Federal Bureau of Investigation and shall be searched against other fingerprints on file,  
50 including latent fingerprints;

51 (3) Qualified entities shall notify applicants subject to enrollment in the National Rap  
52 Back program that the applicant's fingerprints, while retained, may continue to be compared  
53 against other fingerprints submitted or retained by the Federal Bureau of Investigation,  
54 including latent fingerprints;

55 (4) The criminal record review and Rap Back process described in this section shall  
56 be voluntary and conform to the requirements established in the National Child Protection  
57 Act of 1993, as amended, and other applicable state or federal law. As a part of the  
58 registration, the qualified entity shall agree to comply with state and federal law and shall  
59 indicate so by signing an agreement approved by the Missouri state highway patrol. The  
60 Missouri state highway patrol may periodically audit qualified entities to ensure compliance  
61 with federal law and this section;

62 (5) A qualified entity shall submit to the Missouri state highway patrol a request for  
63 screening on applicants covered under this section using a completed fingerprint card;

64 (6) Each request shall be accompanied by a reasonable fee, as provided in section  
65 43.530, plus the amount required, if any, by the Federal Bureau of Investigation for the  
66 national criminal record review and enrollment in the National Rap Back program in  
67 compliance with the National Child Protection Act of 1993, as amended, and other applicable  
68 state or federal laws;

69 (7) The Missouri state highway patrol shall provide, directly to the qualified entity,  
70 the applicant's state criminal history records that are not exempt from disclosure under  
71 chapter 610 or otherwise confidential under law;

72 (8) The national criminal history data shall be available to qualified entities to use  
73 only for the purpose of screening applicants as described under this section. The Missouri  
74 state highway patrol shall provide the applicant's national criminal history record information  
75 directly to the qualified entity;

76 (9) The determination whether the criminal history record shows that the applicant  
77 has been convicted of or has a pending charge for any crime that bears upon the fitness of the  
78 applicant to have responsibility for the safety and well-being of children, the elderly, or  
79 disabled persons shall be made solely by the qualified entity. This section shall not require  
80 the Missouri state highway patrol to make such a determination on behalf of any qualified  
81 entity;

82 (10) The qualified entity shall notify the applicant, in writing, of his or her right to  
83 obtain a copy of any criminal record review, including the criminal history records, if any,  
84 contained in the report and of the applicant's right to challenge the accuracy and completeness  
85 of any information contained in any such report and obtain a determination as to the validity  
86 of such challenge before a final determination regarding the applicant is made by the qualified  
87 entity reviewing the criminal history information. A qualified entity that is required by law to

88 apply screening criteria, including any right to contest or request an exemption from  
89 disqualification, shall apply such screening criteria to the state and national criminal history  
90 record information received from the Missouri state highway patrol for those applicants  
91 subject to the required screening; and

92 (11) Failure to obtain the information authorized under this section, with respect to an  
93 applicant, shall not be used as evidence in any negligence action against a qualified entity.  
94 The state, any political subdivision of the state, or any agency, officer, or employee of the  
95 state or a political subdivision shall not be liable for damages for providing the information  
96 requested under this section.

97 3. The criminal record review shall include the submission of fingerprints to the  
98 Missouri state highway patrol, who shall conduct a Missouri criminal record review,  
99 including closed record information under section 610.120. The Missouri state highway  
100 patrol shall also forward a copy of the applicant's fingerprints to the Federal Bureau of  
101 Investigation for a national criminal record review.

102 4. The applicant subject to a criminal record review shall provide the following  
103 information to the qualified entity:

104 (1) Consent to obtain the applicant's fingerprints, conduct the criminal record review,  
105 and participate in the Missouri and National Rap Back programs;

106 (2) Consent to obtain the identifying information required to conduct the criminal  
107 record review, which may include, but not be limited to:

108 (a) Name;

109 (b) Date of birth;

110 (c) Height;

111 (d) Weight;

112 (e) Eye color;

113 (f) Hair color;

114 (g) Gender;

115 (h) Race;

116 (i) Place of birth;

117 (j) Social Security number; and

118 (k) The applicant's photo.

119 5. Any information received by an authorized state agency or a qualified entity under  
120 the provisions of this section shall be used solely for internal purposes in determining the  
121 suitability of an applicant. The dissemination of criminal history information from the  
122 Federal Bureau of Investigation beyond the authorized state agency or related governmental  
123 entity is prohibited. All criminal record check information shall be confidential, and any

124 person who discloses the information beyond the scope allowed is guilty of a class A  
125 misdemeanor.

126         6. A qualified entity enrolled in either the Missouri or National Rap Back program  
127 shall be notified by the Missouri state highway patrol that a new arrest has been reported on  
128 an applicant who is employed, licensed, or otherwise under the purview of the qualified  
129 entity. Upon receiving the Rap Back notification, if the qualified entity deems that the  
130 applicant is still serving in an active capacity, the entity may request and receive the  
131 individual's updated criminal history record. This process shall only occur if:

132         (1) The entity has abided by all procedures and rules promulgated by the Missouri  
133 state highway patrol and Federal Bureau of Investigation regarding the Missouri and National  
134 Rap Back programs;

135         (2) The individual upon whom the Rap Back notification is being made has  
136 previously had a Missouri and national criminal record review completed for the qualified  
137 entity under this section [~~within the previous six years~~]; and

138         (3) The individual upon whom the Rap Back notification is being made is a current  
139 employee, licensee, or otherwise still actively under the purview of the qualified entity.

140         7. The Missouri state highway patrol shall make available or approve the necessary  
141 forms, procedures, and agreements necessary to implement the provisions of this section.

43.540. 1. As used in this section, the following terms mean:

2         (1) "Applicant", a person who:

3             (a) Is actively employed by or seeks employment with a qualified entity;

4             (b) Is actively licensed or seeks licensure with a qualified entity;

5             (c) Actively volunteers or seeks to volunteer with a qualified entity; or

6             (d) Is actively contracted with or seeks to contract with a qualified entity;

7         (2) "Missouri criminal record review", a review of criminal history records and sex  
8 offender registration records pursuant to sections 589.400 to 589.425 maintained by the  
9 Missouri state highway patrol in the Missouri criminal records repository;

10         (3) "Missouri Rap Back program", shall include any type of automatic notification  
11 made by the Missouri state highway patrol to a qualified entity indicating that an applicant  
12 who is employed, licensed, or otherwise under the purview of that entity has been arrested for  
13 a reported criminal offense in Missouri as required under section 43.506;

14         (4) "National criminal record review", a review of the criminal history records  
15 maintained by the Federal Bureau of Investigation;

16         (5) "National Rap Back program", shall include any type of automatic notification  
17 made by the Federal Bureau of Investigation through the Missouri state highway patrol to a  
18 qualified entity indicating that an applicant who is employed, licensed, or otherwise under the  
19 purview of that entity has been arrested for a reported criminal offense outside the state of



20 Missouri and the fingerprints for that arrest were forwarded to the Federal Bureau of  
21 Investigation by the arresting agency;

22 (6) "Qualified entity", an entity that is:

23 (a) An office or division of state, county, or municipal government, including a  
24 political subdivision or a board or commission designated by statute or approved local  
25 ordinance, to issue or renew a license, permit, certification, or registration of authority;

26 (b) An office or division of state, county, or municipal government, including a  
27 political subdivision or a board or commission designated by statute or approved local  
28 ordinance, to make fitness determinations on applications for state, county, or municipal  
29 government employment; or

30 (c) Any entity that is authorized to obtain criminal history record information under  
31 28 CFR 20.33.

32 2. The central repository shall have the authority to submit applicant fingerprints to  
33 the National Rap Back program to be retained for the purpose of being searched against future  
34 submissions to the National Rap Back program, including latent fingerprint searches.  
35 Qualified entities may conduct Missouri and national criminal record reviews on applicants  
36 and participate in Missouri and National Rap Back programs for the purpose of determining  
37 suitability or fitness for a permit, license, or employment, and shall abide by the following  
38 requirements:

39 (1) The qualified entity shall register with the Missouri state highway patrol prior to

53 applicable state or federal law. As a part of the registration, the qualified entity shall agree to

55 the Missouri state highway patrol. The Missouri state highway patrol may periodically audit  
56 qualified entities to ensure compliance with federal law and this section;

57 (5) A qualified entity shall submit to the Missouri state highway patrol a request for  
58 screening on applicants covered under this section using a completed fingerprint card;

59 (6) Each request shall be accompanied by a reasonable fee, as provided in section  
60 43.530, plus the amount required, if any, by the Federal Bureau of Investigation for the

97 record review, which may include, but not be limited to:

109 5. Any information received by an authorized state agency or a qualified entity

111 determining the suitability of an applicant. The dissemination of criminal history information  
112 from the Federal Bureau of Investigation beyond the authorized state agency or related  
113 governmental entity is prohibited. All criminal record check information shall be confidential  
114 and any person who discloses the information beyond the scope allowed is guilty of a class A  
115 misdemeanor.

116 6. A qualified entity enrolled in either the Missouri or National Rap Back programs

130           7. The highway patrol shall make available or approve the necessary forms,  
131 procedures, and agreements necessary to implement the provisions of this section.

          57.280. 1. Sheriffs shall receive a charge for service of any summons, writ or other  
2 order of court, in connection with any civil case, and making on the same either a return  
3 indicating service, a non est return or a nulla bona return, the sum of twenty dollars for each

58 4. A certified copy of a death record by the local registrar can only be issued within  
59 twenty-four hours of receipt of the record by the local registrar. Computer-generated  
60 certifications of death records may be issued by the local registrar after twenty-four hours of  
61 receipt of the records. The fees paid to the official county health agency shall be retained by  
62 the local agency for local public health purposes.

63 5. No fee under this section shall be required or collected from a parent or guardian of  
64 a homeless child or homeless youth, as defined in subsection 1 of section 167.020, or an  
65 unaccompanied youth, as defined in 42 U.S.C. Section 11434a(6), for the issuance of a  
66 certification, or copy of such certification, of birth of such child or youth. An unaccompanied  
67 youth shall be eligible to receive a certification or copy of his or her own birth record without  
68 the consent or signature of his or her parent or guardian; provided, that only one certificate  
69 under this provision shall be provided without cost to the unaccompanied or homeless youth.  
70 For the issuance of any additional certificates, the statutory fee shall be paid.

(b) The child or vulnerable person is unavailable as a witness; or

(c) The child or vulnerable person is otherwise physically available as a witness but the court finds that the significant emotional or psychological trauma which would result from testifying in the personal presence of the defendant makes the child or vulnerable person unavailable as a witness at the time of the criminal proceeding.

2. Notwithstanding subsection 1 of this section or any provision of law or rule of evidence requiring corroboration of statements, admissions or confessions of the defendant, and notwithstanding any prohibition of hearsay evidence, a statement by a child when under the age of ~~fourteen~~ **eighteen**, or a vulnerable person, who is alleged to be victim of an offense under chapter 565, 566, 568 or 573 is sufficient corroboration of a statement, admission or confession regardless of whether or not the child or vulnerable person is available to testify regarding the offense.

**557.520. 1. For purposes of this section, the following terms shall mean:**

21 intoxicated-related traffic offense in violation of section 577.010, 577.012, 577.013,

23 (2) The defendant is not currently enrolled in, and has not in the previous ten  
24 years completed, a diversion program pursuant to this section;

27 (5) The offense did not result in the injury or death of another person.

28 3. Upon a motion filed by a prosecuting or circuit attorney, the court may

A person commits the offense of delivery of a controlled substance causing serious physical injury, as defined in section 556.061, if a person delivers or distributes a controlled substance under section 579.020 and serious physical injury results from the use of such controlled substance.

2. It shall not be a defense that the user contributed to the user's own serious physical injury by using the controlled substance or consenting to the administration of the controlled substance by another.

3. The offense of delivery of a controlled substance causing serious physical injury is a class C felony.

4. For purposes of this section, "controlled substance" means a Schedule I or Schedule II controlled substance, as defined in section 195.017.

579.022. 1. A person commits the offense of delivery of a controlled substance causing death if a person delivers or distributes a controlled substance under section 579.020 and a death results from the use of such controlled substance.

2. It shall not be a defense that the user contributed to the user's own death by using the controlled substance or consenting to the administration of the controlled substance by another.

3. The offense of delivery of a controlled substance causing death is a class A felony.

4. For purposes of this section, "controlled substance" means a Schedule I or Schedule II controlled substance, as defined in section 195.017.

579.041. 1. For purposes of this section, the following terms mean:

48 satisfy the amount of compensation payable pursuant to sections 595.010 to 595.075,  
49 excluding sections 595.050 and 595.055;

50 (2) Beginning on September 1, 2004, and on the first of each month the director of  
51 revenue or the director's designee shall deposit fifty percent of the balance of funds available  
52 to the credit of the crime victims' compensation fund and fifty percent to the services to  
53 victims' fund established in section 595.100.

54           7. These funds shall be subject to a biennial audit by the Missouri state auditor. Such  
55 audit shall include all records associated with crime victims' compensation funds collected,  
56 held or disbursed by any state agency.

57           8. In addition to the moneys collected pursuant to subsection 1 of this section, the  
58 court shall enter a judgment in favor of the state of Missouri, payable to the crime victims'  
59 compensation fund, of sixty-eight dollars upon a plea of guilty or a finding of guilt for a class  
60 A or B felony; forty-six dollars upon a plea of guilty or finding of guilt for a class C ~~[or]~~, D,  
61 or E felony; and ten dollars upon a plea of guilty or a finding of guilt for any misdemeanor  
62 under Missouri law except for those in chapter 252 relating to fish and game, chapter 302  
63 relating to drivers' and commercial drivers' license, chapter 303 relating to motor vehicle  
64 financial responsibility, chapter 304 relating to traffic regulations, chapter 306 relating to  
65 watercraft regulation and licensing, and chapter 307 relating to vehicle equipment regulations.  
66 Any clerk of the court receiving moneys pursuant to such judgments shall collect and disburse  
67 such crime victims' compensation judgments in the manner provided by sections 488.010 to  
68 488.020. Such funds shall be payable to the state treasury and deposited to the credit of the  
69 crime victims' compensation fund.

70           9. The clerk of the court processing such funds shall maintain records of all  
71 dispositions described in subsection 1 of this section and all dispositions where a judgment  
72 has been entered against a defendant in favor of the state of Missouri in accordance with this  
73 section; all payments made on judgments for alcohol-related traffic offenses; and any  
74 judgment or portion of a judgment entered but not collected. These records shall be subject to  
75 audit by the state auditor. The clerk of each court transmitting such funds shall report  
76 separately the amount of dollars collected on judgments entered for alcohol-related traffic  
77 offenses from other crime victims' compensation collections or services to victims  
78 collections.

79           10. The department of revenue shall maintain records of funds transmitted to the  
80 crime victims' compensation fund by each reporting court and collections pursuant to  
81 subsection 16 of this section and shall maintain separate records of collection for alcohol-  
82 related offenses.

83           11. The state courts administrator shall include in the annual report required by  
84 section 476.350 the circuit court caseloads and the number of crime victims' compensation  
85 judgments entered.

86           12. All awards made to injured victims under sections 595.010 to 595.105 and all  
87 appropriations for administration of sections 595.010 to 595.105, except sections 595.050 and  
88 595.055, shall be made from the crime victims' compensation fund. Any unexpended balance  
89 remaining in the crime victims' compensation fund at the end of each biennium shall not be  
90 subject to the provision of section 33.080 requiring the transfer of such unexpended balance

91 to the ordinary revenue fund of the state, but shall remain in the crime victims' compensation  
92 fund. In the event that there are insufficient funds in the crime victims' compensation fund to  
93 pay all claims in full, all claims shall be paid on a pro rata basis. If there are no funds in the  
94 crime victims' compensation fund, then no claim shall be paid until funds have again  
95 accumulated in the crime victims' compensation fund. When sufficient funds become  
96 available from the fund, awards which have not been paid shall be paid in chronological order  
97 with the oldest paid first. In the event an award was to be paid in installments and some  
98 remaining installments have not been paid due to a lack of funds, then when funds do become  
99 available that award shall be paid in full. All such awards on which installments remain due  
100 shall be paid in full in chronological order before any other postdated award shall be paid.  
101 Any award pursuant to this subsection is specifically not a claim against the state, if it cannot  
102 be paid due to a lack of funds in the crime victims' compensation fund.

103 13. When judgment is entered against a defendant as provided in this section and such  
104 sum, or any part thereof, remains unpaid, there shall be withheld from any disbursement,  
105 payment, benefit, compensation, salary, or other transfer of money from the state of Missouri  
106 to such defendant an amount equal to the unpaid amount of such judgment. Such amount  
107 shall be paid forthwith to the crime victims' compensation fund and satisfaction of such  
108 judgment shall be entered on the court record. Under no circumstances shall the general  
109 revenue fund be used to reimburse court costs or pay for such judgment. The director of the  
110 department of corrections shall have the authority to pay into the crime victims' compensation  
111 fund from an offender's compensation or account the amount owed by the offender to the  
112 crime victims' compensation fund, provided that the offender has failed to pay the amount  
113 owed to the fund prior to entering a correctional facility of the department of corrections.

114 14. All interest earned as a result of investing funds in the crime victims'  
115 compensation fund shall be paid into the crime victims' compensation fund and not into the  
116 general revenue of this state.

117 15. Any person who knowingly makes a fraudulent claim or false statement in  
118 connection with any claim hereunder is guilty of a class A misdemeanor.

119 16. The department may receive gifts and contributions for the benefit of crime  
120 victims. Such gifts and contributions shall be credited to the crime victims' compensation  
121 fund as used solely for compensating victims under the provisions of sections 595.010 to  
122 595.075.

610.021. Except to the extent disclosure is otherwise required by law, a public  
2 governmental body is authorized to close meetings, records and votes, to the extent they relate  
3 to the following:

4 (1) Legal actions, causes of action or litigation involving a public governmental body  
5 and any confidential or privileged communications between a public governmental body or

6 its representatives and its attorneys. However, any minutes, vote or settlement agreement  
7 relating to legal actions, causes of action or litigation involving a public governmental body  
8 or any agent or entity representing its interests or acting on its behalf or with its authority,  
9 including any insurance company acting on behalf of a public government body as its insured,  
10 shall be made public upon final disposition of the matter voted upon or upon the signing by  
11 the parties of the settlement agreement, unless, prior to final disposition, the settlement  
12 agreement is ordered closed by a court after a written finding that the adverse impact to a  
13 plaintiff or plaintiffs to the action clearly outweighs the public policy considerations of  
14 section 610.011, however, the amount of any moneys paid by, or on behalf of, the public  
15 governmental body shall be disclosed; provided, however, in matters involving the exercise of  
16 the power of eminent domain, the vote shall be announced or become public immediately  
17 following the action on the motion to authorize institution of such a legal action. Legal work  
18 product shall be considered a closed record;

19 (2) Leasing, purchase or sale of real estate by a public governmental body where  
20 public knowledge of the transaction might adversely affect the legal consideration therefor.  
21 However, any minutes, vote or public record approving a contract relating to the leasing,  
22 purchase or sale of real estate by a public governmental body shall be made public upon  
23 execution of the lease, purchase or sale of the real estate;

24 (3) Hiring, firing, disciplining or promoting of particular employees by a public  
25 governmental body when personal information about the employee is discussed or recorded.

61 universities in the state of Missouri and the amount of money contributed by the source;

62 (14) Records which are protected from disclosure by law;

63 (15) Meetings and public records relating to scientific and technological innovations  
64 in which the owner has a proprietary interest;

65 (16) Records relating to municipal hotlines established for the reporting of abuse and  
66 wrongdoing;

67 (17) Confidential or privileged communications between a public governmental body  
68 and its auditor, including all auditor work product; however, all final audit reports issued by  
69 the auditor are to be considered open records pursuant to this chapter;

70 (18) **(a) Security measures, global positioning system (GPS) data, investigative**  
71 **information, or investigative or surveillance techniques of any public agency responsible**  
72 **for law enforcement or public safety that, if disclosed, has the potential to endanger the**  
73 **health or safety of an individual or the public.**

74 **(b) Any information or data provided to a tip line for the purpose of safety or**  
75 **security at an educational institution that, if disclosed, has the potential to endanger the**  
76 **health or safety of an individual or the public.**

77           **(c) Any information contained in any suspicious activity report provided to law**  
78 **enforcement that, if disclosed, has the potential to endanger the health or safety of an**  
79 **individual or the public.**

80           **(d)** Operational guidelines, policies and specific response plans developed, adopted,  
81 or maintained by any public agency responsible for law enforcement, public safety, first  
82 response, or public health for use in responding to or preventing any critical incident which is  
83 or appears to be terrorist in nature and which has the potential to endanger individual or  
84 public safety or health. Financial records related to the procurement of or expenditures  
85 relating to operational guidelines, policies or plans purchased with public funds shall be open.  
86 When seeking to close information pursuant to this exception, the public governmental body  
87 shall affirmatively state in writing that disclosure would impair the public governmental  
88 body's ability to protect the security or safety of persons or real property, and shall in the same  
89 writing state that the public interest in nondisclosure outweighs the public interest in  
90 disclosure of the records;

91           (19) Existing or proposed security systems and structural plans of real property  
92 owned or leased by a public governmental body, and information that is voluntarily submitted  
93 by a nonpublic entity owning or operating an infrastructure to any public governmental body  
94 for use by that body to devise plans for protection of that infrastructure, the public disclosure  
95 of which would threaten public safety:

96           (a) Records related to the procurement of or expenditures relating to security systems  
97 purchased with public funds shall be open;

98           (b) When seeking to close information pursuant to this exception, the public

107           (20) The portion of a record that identifies security systems or access codes or

109           (21) Records that identify the configuration of components or the operation of a  
110 computer, computer system, computer network, or telecommunications network, and would  
111 allow unauthorized access to or unlawful disruption of a computer, computer system,  
112 computer network, or telecommunications network of a public governmental body. This  
113 exception shall not be used to limit or deny access to otherwise public records in a file,



114 document, data file or database containing public records. Records related to the procurement  
115 of or expenditures relating to such computer, computer system, computer network, or  
116 telecommunications network, including the amount of moneys paid by, or on behalf of, a  
117 public governmental body for such computer, computer system, computer network, or

119 (22) Credit card numbers, personal identification numbers, digital certificates,  
120 physical and virtual keys, access codes or authorization codes that are used to protect the

123 close the record of a person or entity using a credit card held in the name of a public

127 public institution of higher education in connection with a proposal to license intellectual  
128 property or perform sponsored research and which contains sales projections or other  
129 business plan information the disclosure of which may endanger the competitiveness of a

131 (24) Records relating to foster home or kinship placements of children in foster care  
132 under section 210.498; and

133 (25) Individually identifiable customer usage and billing records for customers of a  
134 municipally owned utility, unless the records are requested by the customer or authorized for  
135 release by the customer, except that a municipally owned utility shall make available to the  
136 public the customer's name, billing address, location of service, and dates of service provided  
137 for any commercial service account.

650.320. For the purposes of sections 650.320 to 650.340, the following terms mean:

2 (1) "Board", the Missouri 911 service board established in section 650.325;

3 (2) "Public safety answering point", the location at which 911 calls are answered;

4 (3) "Telecommunicator **first responder**", any person employed as an emergency  
5 telephone worker, call taker or public safety dispatcher whose duties include receiving,  
6 processing or transmitting public safety information received through a 911 public safety  
7 answering point.

650.340. 1. The provisions of this section may be cited and shall be known as the  
2 "911 Training and Standards Act".

3 2. Initial training requirements for [~~telecommunicators~~] **telecommunicator first**  
4 **responders** who answer 911 calls that come to public safety answering points shall be as  
5 follows:

6 (1) Police telecommunicator **first responder**, 16 hours;

- 7 (2) Fire telecommunicator **first responder**, 16 hours;  
8 (3) Emergency medical services telecommunicator **first responder**, 16 hours;  
9 (4) Joint communication center telecommunicator **first responder**, 40 hours.

10 3. All persons employed as a telecommunicator **first responder** in this state shall be  
11 required to complete ongoing training so long as such person engages in the occupation as a

13 ongoing training every three years by such persons or organizations as provided in subsection  
14 6 of this section.

15 4. Any person employed as a telecommunicator on August 28, 1999, shall not be  
16 required to complete the training requirement as provided in subsection 2 of this section. Any  
17 person hired as a telecommunicator **or a telecommunicator first responder** after August 28,  
18 1999, shall complete the training requirements as provided in subsection 2 of this section  
19 within twelve months of the date such person is employed as a telecommunicator **or a**  
20 **telecommunicator first responder**.

21 5. The training requirements as provided in subsection 2 of this section shall be  
22 waived for any person who furnishes proof to the committee that such person has completed  
23 training in another state which is at least as stringent as the training requirements of  
24 subsection 2 of this section.

25 6. The board shall determine by administrative rule the persons or organizations  
26 authorized to conduct the training as required by subsection 2 of this section.

27 7. This section shall not apply to an emergency medical dispatcher or **dispatch**  
28 agency as defined in section 190.100, or a person trained by an entity accredited or certified  
29 under section 190.131, or a person who provides prearrival medical instructions who works  
30 for an agency which meets the requirements set forth in section 190.134.

**Section 1. 1. For purposes of this section, the term "exoneree" means a person**  
2 **who was convicted of an offense and the conviction was later overturned, vacated, or set**  
3 **aside, or the person was relieved of all legal consequences of the conviction because**  
4 **evidence of innocence that was not presented at trial required reconsideration of the**  
5 **case.**

6 2. (1) **The department of corrections shall develop a policy and procedures to**  
7 **assist exonerees in obtaining a birth certificate, Social Security card, and state**  
8 **identification prior to release from a correctional center. The policy shall be made**  
9 **available to all exonerees, regardless of the method by which an exoneree was**  
10 **exonerated. If an exoneree does not have access to his or her birth certificate, Social**  
11 **Security card, or state identification upon release, the department shall assist such**  
12 **exoneree in obtaining the documents prior to release.**

13           **(2) A delay in obtaining the documents in subdivision (1) of this subsection shall**  
14 **not be cause for a delay in the exoneree's release from a correctional center.**

15           **3. The department may provide an exoneree, upon his or her release from a**  
16 **correctional facility, with the same services the department may provide an offender**  
17 **upon release from a correctional facility or an offender who is on probation or parole.**
