AN ACT

To amend chapter 301, RSMo, by adding thereto one new section relating to motor vehicle miles driven fees.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 301, RSMo, is amended by adding thereto one new section, to be
2 known as section 301.045, to read as follows:

**301.045. 1. Beginning January 1, 2016, in addition to all other registration fees
2 required under state law, the department of revenue may charge and collect a “miles
3 driven” fee in the amount of up to two hundred dollars for a one-year registration and up
4 to four hundred dollars for a two-year registration to each owner registering or renewing
5 the registration of a motor vehicle as required under this chapter.**

**6 2. At the time of the issuance of registration, an odometer reading shall be recorded
7 by the department which shall be either taken from the bill of sale or certificate of title of
8 vehicle if newly acquired, or from the official odometer reading at the motor vehicle’s most
9 recent safety inspection, or other method approved by the department to verify the vehicle
10 mileage.**

**11 3. Upon registration renewal, the owner registering the motor vehicle shall be
12 entitled to a prorated credit against the miles driven fee for that registration period. The
13 department shall set such a credit; however, no credit nor an additional charge shall be
14 allowed for any motor vehicles that travel greater than twenty thousand miles during the
15 preceding one-year registration period or forty thousand miles during the preceding two-
16 year registration period. The odometer reading used to determine credit eligibility shall
17 be the official odometer reading recorded at the time of the motor vehicle’s most recent**

18 safety inspection; provided, however, that no global positioning system or other technology
19 that identifies and records the motor vehicle's location at all times shall be required to be
20 used to monitor mileage traveled by any motor vehicle on any road, highway, or street in
21 this state for the purpose of imposing this fee or any state tax on the mileage traveled by
22 such motor vehicle.

23 **4. Revenue from the fee collected under this section shall be deposited into the state**
24 **road fund to be used and expended as provided by article IV, section 30(b) of the**
25 **Constitution of Missouri.**

26 **5. The director of the department of revenue may promulgate all necessary rules**
27 **for the administration of this section. Any rule or portion of a rule, as that term is defined**
28 **in section 536.010, that is created under the authority delegated in this section shall become**
29 **effective only if it complies with and is subject to all of the provisions of chapter 536 and,**
30 **if applicable, section 536.028. This section and chapter 536 are nonseverable, and if any**
31 **of the powers vested with the general assembly pursuant to chapter 536 to review, to delay**
32 **the effective date, or to disapprove and annul a rule are subsequently held**
33 **unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted**
34 **after August 28, 2015, shall be invalid and void.**
