AN ACT

To amend chapter 354, RSMo, by adding thereto one new section relating to health maintenance organizations.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 354, RSMo, is amended by adding thereto one new section, to be
2 known as section 354.402, to read as follows:

**354.402. 1. The department of commerce and insurance shall publish a report on
2 the effect of the COVID-19 pandemic on those health maintenance organizations that are
3 also Medicaid managed care organizations defined in 42 U.S.C. Section 1396b(m) that
4 provide or arrange health care services for MO HealthNet enrollees in Missouri in
5 accordance with chapter 208. The report shall:**

6 **(1) Compile, by category of health care service, the projected and actual monthly
7 and aggregate quantities of and payments for health care services by such health
8 maintenance organizations during the 2020 calendar year;**

9 **(2) Compile monthly changes in Medicaid managed care enrollment during the
10 2020 calendar year;**

11 **(3) Assess the expenditures of such health maintenance organizations for
12 nonmedical services in the 2020 calendar year;**

13 **(4) List monthly and total premium payments made by the department of social
14 services during the 2020 calendar year for coverage of MO HealthNet enrollees by such
15 health maintenance organizations;**

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

16 **(5) Assess the medical loss ratios of such health maintenance organizations in the**
17 **2020 calendar year and the effect of changes in utilization resulting from the COVID-19**
18 **pandemic on such medical loss ratios;**

19 **(6) Analyze changes made retrospectively, if any, to increase or decrease the**
20 **premium payments made by the department of social services in response to changes in**
21 **utilization of medical services; and**

22 **(7) Include recommendations on policies or practices to ensure that future premium**
23 **payments to health maintenance organizations for coverage of MO HealthNet enrollees**
24 **during a public health emergency are synchronized with utilization of services in order to**
25 **prevent overpayments and underpayments.**

26 **2. The report required under this section shall be prepared by the actuary**
27 **appointed and employed by the director of the department of commerce and insurance**
28 **under section 374.090. The department of social services shall provide the department of**
29 **commerce and insurance all data and information deemed necessary by the actuary to**
30 **fulfill the requirements of this section.**

31 **3. The department of commerce and insurance shall submit the completed report**
32 **required under this section before December 2, 2021, to:**

33 **(1) The office of the governor;**

34 **(2) The state budget director of the office of administration;**

35 **(3) The speaker and minority leader of the house of representatives;**

36 **(4) The president pro tempore and minority leader of the senate;**

37 **(5) The director of the department of social services; and**

38 **(6) The chairs of the committees of the senate and house of representatives having**
39 **jurisdiction over insurance, appropriations, and health care services.**
