AN ACT

To repeal section 160.514, RSMo, and to enact in lieu thereof one new section relating to academic performance standards.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 160.514, RSMo, is repealed and one new section enacted in lieu 2 thereof, to be known as section 160.514, to read as follows:

160.514. 1. By rule and regulation, and consistent with the provisions contained in section 160.526, the state board of education shall adopt no more than seventy-five academic performance standards which establish the knowledge, skills, and competencies necessary for students to successfully advance through the public elementary and secondary education system of this state; lead to or qualify a student for high school graduation; prepare students for postsecondary education or the workplace or both; and are necessary in this era to preserve the rights and liberties of the people.

8 2. Whenever the state board of education develops, evaluates, modifies, or revises academic performance standards or learning standards, it shall convene work groups composed 9 10 of education professionals to develop and recommend such academic performance standards or 11 Separate work groups composed of education professionals shall be learning standards. 12 convened for the following subject areas: English language arts; mathematics; science; and The subject area of history and governments shall incorporate 13 history and governments. 14 geography and the history and governments of the United States and the world. For each subject area in which the state board of education develops, evaluates, modifies, or revises academic 15 16 performance standards or learning standards, the state board shall convene two separate work 17 groups, one work group for standards for grades kindergarten through five consisting of sixteen

18 members and a second work group for standards for grades six through twelve consisting of 19 seventeen members. A person may be selected to serve on more than one work group if [he or 20 shel the person is qualified. No work group member shall be required to be a member of a 21 professional teacher association. An education professional serving on a work group shall be a 22 Missouri resident for at least three years and have taught in the work group's subject area for at 23 least ten years or have ten years of experience in that subject area, except for the parents 24 appointed by the president pro tempore of the senate and the speaker of the house of 25 representatives. Work group members shall be chosen in such a manner as to represent the 26 geographic diversity of the state.

3. (1) Work group members shall be selected in the following manner:

28 (4) (a) Two parents of children currently enrolled in grades kindergarten through 29 twelve shall be selected by the president pro tempore of the senate;

34 [(4)] (d) One education professional selected by a statewide association of Missouri 35 school boards;

38 [(6)] (f) Two education professionals selected by the president pro tempore of the senate 39 in addition to the members selected under [subdivision (1)] paragraph (a) of this [subsection] 40 subdivision:

41 Two education professionals selected by the speaker of the house of [(7)] (g) representatives in addition to the members selected under [subdivision (2)] paragraph (b) of this 42 43 [subsection] subdivision;

[(8)] (h) One education professional selected by the governor;

(9) (i) One education professional selected by the lieutenant governor; 46 [(10)] (i) One education professional selected by the commissioner of higher education;

50 [(12)] (2) One education professional selected by the state board of education from 51 names submitted to it by the heads of state-approved baccalaureate-level teacher preparation 52 programs located in Missouri.

(3) The state board of education shall also appoint to each work group for grades six through twelve from names submitted to it by a statewide organization for career and technical education one current or retired career and technical education professional who also serves or served as an advisor to any of the nationally recognized career and technical education student organizations identified in subdivision (4) of subsection 2 of section 178.550.

The state board of education shall hold at least three public hearings whenever it 59 develops, evaluates, modifies, or revises academic performance standards or learning standards. 60 The hearings shall provide an opportunity to receive public testimony, including but not limited 61 to testimony from educators at all levels in the state, local school boards, parents, representatives 62 from business and industry, labor and community leaders, members of the general assembly, and 63 the general public. The state board of education shall hold the first hearing within thirty days of 64 the work groups being convened. The state board of education shall hold the second hearing 65 approximately six months after it holds the first hearing. The state board of education shall hold 66 the third hearing when the work groups submit the academic performance standards they have developed to the state board. The state board of education shall also solicit comments and 67 68 feedback on the academic performance standards or learning standards from the joint committee 69 on education and from academic researchers. All comments shall be made publicly available.
- 5. The state board of education shall develop written curriculum frameworks that may be used by school districts. Such curriculum frameworks shall incorporate the academic performance standards adopted by the state board of education pursuant to subsection 1 of this section. The curriculum frameworks shall provide guidance to school districts but shall not be mandates for local school boards in the adoption or development of written curricula as required by subsection 6 of this section.
- 76 6. Not later than one year after the development of written curriculum frameworks 77 pursuant to subsection 5 of this section, the board of education of each school district in the state 78 shall adopt or develop a written curriculum designed to ensure that students attain the 79 knowledge, skills, and competencies established pursuant to subsection 1 of this section. Local 80 school boards are encouraged to adopt or develop curricula that are rigorous and ambitious and 81 may, but are not required to, use the curriculum frameworks developed pursuant to subsection 82 5 of this section. Nothing in this section or this act shall prohibit school districts, as determined 83 by local boards of education, to develop or adopt curricula that provide for academic standards 84 in addition to those identified by the state board of education pursuant to subsection 1 of this 85 section.
- 7. Local school districts and charter schools may adopt their own education standards,
 in addition to those already adopted by the state, provided the additional standards are in the
 public domain and do not conflict with the standards adopted by the state board of education.

The state board of education shall amend the existing health or physical 90 education academic performance standards, learning standards, and curriculum 91 frameworks to include instruction on the use and effects of vapor products, as such term 92 is defined in section 407.925, in any instruction or standard relating to the use and effects 93 of tobacco products. All future health or physical education academic performance 94 standards, learning standards, and curriculum frameworks developed, evaluated, 95 modified, or revised by the state board shall include instruction on the use and effects of 96 vapor products as described in this subsection.
