AN ACT

To amend chapter 650, RSMo, by adding thereto one new section relating to the establishment of a program on police officer presence in schools and communities.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 650, RSMo, is amended by adding thereto one new section, to be known as section 650.466, to read as follows:

650.466. 1. There is hereby established in the department of public safety a program on police officer presence in schools and communities to increase positive social interaction between youth and law enforcement officers and to develop a harmonious rapport between the two entities. The department of public safety shall focus its efforts on establishing programs, projects, activities, and events in communities located in a county with more than one million inhabitants that contain school districts with a total minority student population that exceeds fifty percent.

2. The department of public safety shall:

(1) Conduct studies on local, statewide, and national programs with demonstrated success at increasing positive social relationships between law enforcement agencies and youth;

(2) Make recommendations to law enforcement agencies, communities, and schools as to programs, projects, activities, and events that will aid in developing a harmonious rapport between law enforcement officers and youth;

(3) Advise the commissioner of education and the department of elementary and secondary education on issues relating to the establishment of community relations programs in communities located in a county with more than one million inhabitants

29 **3. For purposes of subsection 2 of this section, "community school" means a**
30 **school that makes its facilities available for citizen use, coordinates activities of local**
31 **citizens in identifying program needs and establishing priorities, identifies and utilizes**
32 **available program resources, and assists in the initiation of programs to improve the**
33 **cultural, social, recreational, and educational opportunities available in a community.**
