AN ACT

To repeal section 37.020, RSMo, and to enact in lieu thereof one new section relating to disadvantaged businesses.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 37.020, RSMo, is repealed and one new section enacted in lieu 2 thereof, to be known as section 37.020, to read as follows:

37.020. 1. As used in this section, the following words and phrases mean:

(1) "Certification", the determination, through whatever procedure is used by the office
of administration, that a legal entity is a socially and economically disadvantaged small business
concern for purposes of this section;

5 (2) "Department", the office of administration and any public institution of higher 6 learning in the state of Missouri;

(3) "Minority business enterprise", a business that is:

(a) A sole proprietorship owned and controlled by a minority;

9 (b) A partnership or joint venture owned and controlled by minorities in which at least 10 fifty-one percent of the ownership interest is held by minorities and the management and daily 11 business operations of which are controlled by one or more of the minorities who own it; or

12 (c) A corporation or other entity whose management and daily business operations are 13 controlled by one or more minorities who own it, and which is at least fifty-one percent owned 14 by one or more minorities, or if stock is issued, at least fifty-one percent of the stock is owned 15 by one or more minorities;

(4) "Socially and economically disadvantaged individuals", individuals, regardless ofgender, who have been subjected to racial, ethnic, or sexual prejudice or cultural bias because

18 of their identity as a member of a group without regard to their individual qualities and whose

ability to compete in the free enterprise system has been impaired due to diminished capital andcredit opportunities as compared to others in the same business area. In determining the degree

- 21 of diminished credit and capital opportunities the office of administration shall consider, but not
- 22 be limited to, the assets and net worth of such individual;
- (5) "Socially and economically disadvantaged small business concern", any smallbusiness concern:

(a) Which is at least fifty-one percentum owned by one or more socially and
economically disadvantaged individuals; or, in the case of any publicly owned business, at least
fifty-one percentum of the stock of which is owned by one or more socially and economically
disadvantaged individuals; and

(b) Whose management and daily business operations are controlled by one or more ofsuch individuals;

(6) "Women's business enterprise", a business that is:

(a) A sole proprietorship owned and controlled by a woman;

(b) A partnership or joint venture owned and controlled by women in which at least
fifty-one percent of the ownership interest is held by women and the management and daily
business operations of which are controlled by one or more of the women who own it; or

(c) A corporation or other entity whose management and daily business operations are
 controlled by one or more women who own it, and which is at least fifty-one percent owned by
 women, or if stock is issued, at least fifty-one percent of the stock is owned by one or more
 women.

The office of administration, in consultation with each department, shall establish and implement a plan to increase and maintain the participation of certified socially and economically 41 42 disadvantaged small business concerns or minority business enterprises, directly or indirectly, 43 in contracts for supplies, services, and construction contracts, consistent with goals determined 44 after an appropriate study conducted [to determine the availability of socially and economically disadvantaged small business concerns and minority business enterprises in the marketplace. 45 46 The commissioner of administration shall appoint an oversight review committee to oversee and 47 review the results of such study. The committee shall be composed of nine members, four of 48 whom shall be members of business, three of whom shall be from staff of selected departments, one of whom shall be a member of the house of representatives, and one of whom shall be a 49 50 member of the senate] under subsection 5 of this section.

3. The goals to be pursued by each department under the provisions of this section shallbe construed to overlap with those imposed by federal law or regulation, if any, shall run

53 concurrently therewith and shall be in addition to the amount required by federal law only to the

54 extent the percentage set by this section exceeds those required by federal law or regulations.

4. The commissioner of administration may designate a nonprofit organization as a minority business enterprise or women's business enterprise for the exclusive purpose of competing in other states, provided that the organization is headquartered in Missouri and the collective majority of the organization's board of directors and executive management in charge of daily business operations are minorities or women.

60 5. Every five years, the office of administration shall commission a study to determine the availability of socially and economically disadvantaged small business 61 62 concerns and minority business enterprises in the marketplace. The commissioner of 63 administration shall appoint an oversight review committee to oversee and review the 64 results of such study. The committee shall be composed of nine members: four of whom 65 shall be members of business, three of whom shall be from staff of selected departments, 66 one of whom shall be a member of the house of representatives, and one of whom shall be a member of the senate. After reviewing the results of the study, the house of 67 68 representatives and the senate shall discuss and propose legislation to address and improve 69 the social and economic disadvantages in this state that are described in the study.

1
