AN ACT

To repeal section 67.1018, RSMo, and to enact in lieu thereof one new section relating to transient guest taxes.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 67.1018, RSMo, is repealed and one new section enacted in lieu 2 thereof, to be known as section 67.1018, to read as follows:

67.1018. 1. The governing body of the following counties may impose a tax as 2 provided in this section:

3 (1) Any county of the third classification without a township form of government and 4 with more than five thousand nine hundred but fewer than six thousand inhabitants; or

5 (2) Any county with more than fifteen thousand seven hundred but fewer than 6 seventeen thousand six hundred inhabitants and with a county seat with more than two 7 thousand but fewer than three thousand inhabitants.

8 2. The governing body of any county listed in subsection 1 of this section may 9 impose a tax on the charges for all sleeping rooms paid by the transient guests of hotels or motels situated in the county or a portion thereof, which shall not be more than five percent 10 per occupied room per night, except that such tax shall not become effective unless the 11 governing body of the county submits to the voters of the county at a state general or primary 12 13 election a proposal to authorize the governing body of the county to impose a tax under this 14 section. The tax authorized in this section shall be in addition to the charge for the sleeping 15 room and all other taxes imposed by law, and fifty percent of the proceeds of such tax shall be used by the county to fund law enforcement with the remaining fifty percent of such proceeds 16

27 If a majority of the votes cast on the question by the qualified voters voting thereon are in 28 favor of the question, then the tax shall become effective on the first day of the second 29 calendar quarter following the calendar quarter in which the election was held. If a majority of the votes cast on the question by the qualified voters voting thereon are opposed to the 30 31 question, then the tax authorized by this section shall not become effective unless and until 32 the question is resubmitted under this section to the qualified voters of the county and such question is approved by a majority of the qualified voters of the county voting on the 33 34 question.
