AN ACT

To repeal section 170.315, RSMo, and to enact in lieu thereof two new sections relating to school safety.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 170.315, RSMo, is repealed and two new sections enacted in lieu 2 thereof, to be known as sections 170.314 and 170.315, to read as follows:

170.314. 1. The provisions of this section shall be known and may be cited as the 2 "Missouri S.A.F.E. (Strategic Action For Emergencies) Act".

2. There is hereby established the "School Safety Task Force". The joint committee
on education shall provide technical and administrative support as required by the task
force to fulfill its duties. Any such support involving monetary expenses shall first be
approved by the chair of the joint committee on education. All task force members shall
be appointed before November 1, 2018. The task force members shall be appointed as
follows:

(1) One member appointed by a statewide association supporting school counselors;

(2) One member appointed by a statewide organization supporting licensed clinical
 social workers;

(4) One member appointed by a statewide association for teachers;

14 (5) One member appointed by a statewide association supporting school 15 psychologists;

16 (6) One member appointed by a statewide association supporting school social

The task force shall meet as needed to fulfill its duties under this section. 34 35 4. The school safety task force shall: 36 (1) Examine the various funding streams for school-based mental health services and determine how these streams may best be used in order to provide more accessible and 37 efficient delivery of mental health programs; 38 39 (2) Examine school mental health staffing ratios and provide suggestions that allow 40 for the full delivery of services and effective school-community partnerships, including 41 collaboration between school districts: 42 (3) Develop standards for district-level policies to promote effective school 43 discipline and mental health intervention services; 44 (4) Examine current intra- and interagency collaboration and suggest ways to 45 improve cooperation; and 46 (5) Examine how to best support multitiered systems of support. 47 5. Before December 1, 2019, the school safety task force shall report its findings and 48 present its recommendations concerning any proposed changes to the general assembly. 49 Any recommendations made by the task force shall be revenue-neutral. Upon presenting 50 its findings and recommendations as described in this subsection, the school safety task

51 force shall dissolve.

170.315. 1. [There is hereby established the Active Shooter and Intruder Response Training for Schools Program (ASIRT)] (1) Each school district and each charter school shall establish:

(a) A schools safety and emergency response procedure; and

5

(b) An active shooter and intruder response training program.

6 (2) Both the procedure and the training required to be established under this 7 subsection shall include and address timely response to emergencies including, but not 8 limited to, invasions by armed outsiders, hostage situations, armed students, and any other 9 dangerous situations.

2. Each school district and charter school [may, by July 1, 2014,] shall include in its teacher and school employee training a component on how to properly respond to students who provide them with information about a threatening situation and how to address situations in which there is a potentially dangerous or armed intruder in the school. Training [may] shall also include information and techniques on how to address situations where an active shooter is present in the school or on school property.

[2.] 3. Each school district and charter school [may] shall conduct the active shooter
 and intruder response training on an annual basis. [If no formal training has previously
 occurred, the length of the training may be eight hours. The length of annual continuing training
 may be four hours.

20 participate in the annual active shooter and intruder response training, which shall include 21 22 a simulated active shooter and intruder response drill conducted and led by law enforcement 23 professionals. Each drill [may] shall include an explanation of its purpose and a safety briefing. 24 The training shall require each participant to know and understand how to respond in the event 25 of an actual emergency on school property or at a school event. The drill [may] shall include: 26 (1) Allowing school personnel to respond to the simulated emergency in whatever way 27 they have been trained or informed; and

(2) Allowing school personnel to attempt and implement new methods of responding tothe simulated emergency based upon previously used unsuccessful methods of response.

[4.] 5. All instructors for the active shooter and intruder response training program
 shall be certified by the department of public safety's peace officers standards training
 commission.

[5.] 6. School districts and charter schools [may] shall consult and collaborate with the
 department of public safety, law enforcement authorities, emergency response agencies, [and]
 or other organizations and entities trained to deal with active shooters or potentially dangerous

36 or armed intruders to develop and establish the active shooter and intruder response training

37 program and the schools safety and emergency response procedure.

- 38 [6.] 7. Public schools shall foster an environment in which students feel comfortable
- 39 sharing information they have regarding a potentially threatening or dangerous situation with a
- 40 responsible adult.
