AN ACT

To repeal sections 172.030, 172.035, 174.050, 174.055, 174.060, 174.300, 174.332, 174.450, 174.453, 174.610, 174.620, 175.020, and 175.021, RSMo, and to enact in lieu thereof thirteen new sections relating to student representatives to public institutions of higher education.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Sections 172.030, 172.035, 174.050, 174.055, 174.060, 174.300, 174.332, 174.450, 174.453, 174.610, 174.620, 175.020, and 175.021, RSMo, are repealed and thirteen new sections enacted in lieu thereof, to be known as sections 172.030, 172.035, 174.050, 174.055, 174.060, 174.300, 174.332, 174.450, 174.453, 174.610, 174.620, 175.020, and 175.021, to read as follows:

172.030. **1.** The board of curators of the University of the state of Missouri shall ~~hereafter~~ consist of nine members, who shall be appointed by the governor, by and with the advice and consent of the senate; provided, that at least one but no more than two shall be appointed upon ~~said~~ **the** board from each congressional district, and no person shall be appointed a curator who ~~shall~~ **is** not ~~be~~ a citizen of the United States, and who ~~shall~~ **has** not ~~have~~ been a resident of the state of Missouri two years next prior to ~~his~~ **the person's** appointment. ~~Not~~ **No** more than five curators shall belong to any one political party. ~~Notwithstanding any provision of law to the contrary, nothing in this section relating to a change in the composition and configuration of congressional districts in this state shall prohibit a member who is serving a term on August 28, 2011, from completing his or her term.]~~

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

11 **2. (1) In lieu of a student representative appointed to the board of curators under**
12 **section 172.035, one curator appointed under this section may be a full-time student of the**
13 **university appointed as provided in this subsection.**

14 **(2) Before January 1, 2022, the enrolled students from each of the four campuses**
15 **of the University of Missouri shall vote to determine whether to fill the next board vacancy**
16 **occurring on or after January 1, 2022, with a student curator appointed under this**
17 **subsection instead of a student representative appointed under section 172.035. If a**
18 **majority of the enrolled students on each campus approve the appointment of a student**
19 **curator, the governor shall fill the next vacancy caused by the expiration of a curator's**
20 **term as provided in this subsection. If a majority of the enrolled students on any of the**
21 **four campuses oppose the appointment of a student curator under this subsection, no**
22 **student shall be a curator and the governor shall appoint a student representative under**
23 **section 172.035.**

24 **(3) Each campus of the University of Missouri shall conduct a vote of the campus's**
25 **enrolled students every ten years after the initial vote held under this subsection to**
26 **determine whether to have a student curator under this subsection. If a majority of the**
27 **enrolled students on each campus fail to approve the appointment of a student curator**
28 **under this subsection in any subsequent vote, any existing student curator shall serve until**
29 **such student curator's term expires and the governor shall appoint a student**
30 **representative under section 172.035.**

31 **(4) Any student curator appointed under this subsection shall meet or exceed all**
32 **qualifications of the student representative under section 172.035.**

33 **(5) Any student curator appointed under this subsection shall exercise and be**
34 **responsible for all powers and duties vested in a curator under Article IX, Section 9(a) of**
35 **the Constitution of Missouri and this chapter.**

36 **(6) No more than one student shall serve as a curator at any one time under this**
37 **section.**

38 **(7) Appointments made under this subsection shall be made in rotation from each**
39 **of the four campuses of the University of Missouri, beginning with a student from the**
40 **Columbia campus, next from the Rolla campus, next from the Kansas City campus, and**
41 **then from the St. Louis campus.**

 172.035. 1. **Unless the university votes to have a student curator as provided in**
2 **subsection 2 of section 172.030, the governor shall, by and with the advice and consent of the**
3 **senate, appoint a student representative to the board of curators of the University of Missouri,**
4 **who shall attend all meetings and participate in all deliberations of the board. Such student**
5 **representative shall not have the right to vote on any matter before the board.**

6 2. Such student representative shall be a full-time student at the university as defined by
7 the board, selected from a panel of three names submitted to the governor by the student
8 government presidents of the campuses of the university, a citizen of the United States, and a
9 resident of the state of Missouri. No person ~~may~~ **shall** be appointed who is not actually
10 enrolled during the term of such person's appointment as a student at the University of Missouri.

11 3. The term of the student representative shall be two years, except that the person first
12 appointed shall serve until January 1, 1986.

13 4. If a vacancy occurs for any reason in the position of student representative, the
14 governor shall appoint a replacement who meets the qualifications set forth in subsection 2 of
15 this section and who shall serve until the student representative's successor is appointed and
16 qualified.

17 5. If the student representative ceases to be a student at the University of Missouri, or
18 a resident of the state of Missouri, or fails to follow the board's attendance policy, the student
19 representative's position shall at once become vacant, unless such absence is caused by sickness
20 or some accident preventing such representative's arrival at the time and place appointed for the
21 meeting.

22 6. The student representative shall receive the same reimbursement for expenses as other
23 members of the board of curators receive pursuant to section 172.040.

24 7. Appointments made under this section shall be made in rotation from each of the four
25 campuses of the University of Missouri, beginning with a student from the Columbia campus,
26 next from the Rolla campus, next from the Kansas City campus, and then from the St. Louis
27 campus.

28 8. Unless alternative arrangements for payment have been made and agreed to by the
29 student and the university, the student representative shall have paid all student and tuition fees
30 due prior to such appointment and shall pay all future student and tuition fees during the term
31 of office when such fees are due.

32 **9. No student representative shall be appointed under this section during the term**
33 **of any student curator appointed to the board under subsection 2 of section 172.030.**

174.050. 1. The board of regents for each college shall be composed of seven members,
2 six of whom shall reside in the district in which the college for which they are appointed regents
3 is situated, and at least one member of each board shall be a resident of the county in which the
4 college for such district is located. The state commissioner of education shall be an ex officio
5 member of each of ~~said~~ **such** boards.

6 **2. (1) In lieu of a student representative appointed under section 174.055 to each**
7 **board of each educational institution referred to in section 174.020, one regent of each**

8 educational institution appointed under this section may be a full-time student of the
9 educational institution appointed as provided in this subsection.

10 (2) Before January 1, 2022, the enrolled students from each of such educational
11 institutions shall vote to determine whether to fill the next vacancy on such educational
12 institution's board of regents occurring on or after January 1, 2022, with a student regent
13 appointed under this subsection instead of a student representative appointed under
14 section 174.055. If a majority of an educational institution's enrolled students approve the
15 appointment of a student regent under this subsection, the governor shall fill the next
16 vacancy on such educational institution's board caused by the expiration of a regent's term
17 as provided in this subsection. If a majority of an educational institution's enrolled
18 students oppose the appointment of a student regent under this subsection, no student shall
19 be a regent on such educational institution's board and the governor shall appoint a
20 student representative under section 174.055.

21 (3) Each educational institution shall conduct a vote of the educational institution's
22 enrolled students every ten years after the initial vote held under this subsection to
23 determine whether to have a student regent under this subsection. If a majority of the
24 educational institution's enrolled students fail to approve the appointment of a student
25 regent under this subsection in any subsequent vote, any existing student regent shall serve
26 until such student regent's term expires and the governor shall appoint a student
27 representative under section 174.055.

28 (4) Any student regent appointed under this subsection shall meet or exceed all
29 qualifications of the student representative under section 174.055.

30 (5) Any student regent appointed under this subsection shall exercise and be
31 responsible for all powers and duties vested in a regent under this chapter.

32 (6) No more than one student shall serve as a regent at any one time under this
33 section.

174.055. 1. Unless the educational institution votes to have a student regent as
2 provided in subsection 2 of section 174.050, the governor shall, by and with the advice and
3 consent of the senate, appoint a student representative to the board of regents or governors of
4 each educational institution referred to in section 174.020 who shall attend all meetings and
5 participate in all deliberations of the board. Such student representative shall not have the right
6 to vote on any matter before the board.

7 2. Such student representative shall be a full-time student at the institution as defined by
8 the board, selected from a panel of three names submitted to the governor by the student
9 government president, a citizen of the United States, and a resident of the state of Missouri. No

10 person may be appointed who is not actually enrolled during the term of such person's
11 appointment as a student at the institution.

12 3. The term of the student representative shall be two years~~[- except that the person first~~
13 ~~appointed shall serve until January 1, 1986].~~

14 4. If a vacancy occurs for any reason in the position of student representative, the
15 governor shall appoint a replacement who meets the qualifications set forth in subsection 2 of
16 this section and who shall serve until such representative's successor is appointed and qualified.

17 5. If the student representative ceases to be a student at the institution, or a resident of
18 the state of Missouri, or fails to follow the board's attendance policy, the student representative's
19 position shall at once become vacant, unless the student representative's absence is caused by
20 sickness or some accident preventing the student representative's arrival at the time and place
21 appointed for the meeting.

22 6. The student representative shall receive the same reimbursement for expenses as other
23 members of the board of regents receive pursuant to section 174.100.

24 7. Unless alternative arrangements for payment have been made and agreed to by the
25 student and the educational institution, the student representative shall have paid all student and
26 tuition fees due prior to such appointment and shall pay all future student and tuition fees during
27 the term of office when such fees are due.

28 **8. No student representative shall be appointed under this section during the term**
29 **of any student regent or governor appointed to the board under this chapter.**

174.060. Every two years during a regular session of the general assembly, the governor
2 shall, by and with the advice and consent of the senate, appoint two regents for each college, and
3 whenever a vacancy occurs in either of ~~[said]~~ **such** boards by death, resignation, removal from
4 the district or by operation of law or otherwise, the governor shall, in a like manner immediately
5 appoint some competent person to fill such vacancy, and communicate ~~[his]~~ **such** action thereon
6 to the senate at the next session of the general assembly thereafter. The person so appointed shall
7 hold ~~[his]~~ office subject to the confirmation of the senate, for the unexpired term; provided, that
8 not more than three of ~~[said]~~ **such** board, excluding the state commissioner of education, shall
9 belong to the same political party. Of each board of regents, at least one member shall be a
10 full-time student of the college over which the board has governance **and shall be appointed**
11 **as provided in section 174.050 or 174.055, as applicable.** ~~[The student regent, while attending~~
12 ~~the meetings of the board, shall receive his actual expenses, which shall be paid out of the~~
13 ~~university's ordinary revenue.]~~

174.300. 1. ~~[Prior to October 17, 1978,]~~ The governor shall, with the advice and consent
2 of the senate, appoint a six-member board of regents to assume the general control and
3 management of Harris-Stowe College. The members of the board shall serve for terms of six

4 years each, except for the members first appointed, two of whom shall serve two-year terms, two of whom shall serve four-year terms, and two of whom shall serve six-year terms. Not more than three of the regents shall be affiliated with any one political party. **One member of the board of regents may be a student regent appointed as provided in subsection 3 of this section.**

2. On and after August 28, 2005, Harris-Stowe State College shall be known as Harris-Stowe State University, and the provisions contained in subsection 1 of this section shall continue to apply to the institution.

3. (1) **In lieu of a student representative appointed under section 174.055 to each board of each educational institution referred to in section 174.020, one member of the board of regents appointed under subsection 1 of this section may be a full-time student of Harris-Stowe State University appointed as provided in this section.**

(2) **Before January 1, 2022, the enrolled students from Harris-Stowe State University shall vote to determine whether to fill the next vacancy on such university's board of regents occurring on or after January 1, 2022, with a student regent appointed under this subsection instead of a student representative appointed under section 174.055. If a majority of the university's enrolled students approve the appointment of a student regent under this subsection, the governor shall fill the next vacancy on such university's board caused by the expiration of a regent's term as provided in this subsection. If a majority of the university's enrolled students oppose the appointment of a student regent under this subsection, no student shall be a regent on such university's board and the governor shall appoint a student representative under section 174.055.**

(3) **Harris-Stowe State University shall conduct a vote of the university's enrolled students every ten years after the initial vote held under this subsection to determine whether to have a student regent under this subsection. If a majority of the university's enrolled students fail to approve the appointment of a student regent under this subsection in any subsequent vote, any existing student regent shall serve until such student regent's term expires and the governor shall appoint a student representative under section 174.055.**

(4) **Any student regent appointed under this subsection shall meet or exceed all qualifications of the student representative under section 174.055.**

(5) **Any student regent appointed under this subsection shall exercise and be responsible for all powers and duties vested in a regent under this chapter.**

(6) **No more than one student shall serve as a regent at any one time under this section.**

174.332. 1. Notwithstanding the provisions of section 174.050 to the contrary, the board of regents of Northwest Missouri State University shall be composed of nine members, eight of

3 whom shall be voting members and one who shall be a nonvoting member, **or nine voting**
4 **members if the university votes to have a student regent as provided in subsection 5 of this**
5 **section.** Not more than four voting members shall belong to any one political party. Not more
6 than two voting members shall be residents of the same county. [~~The appointed members of the~~
7 ~~board serving on August 28, 2008, shall continue to serve until the expiration of the terms for~~
8 ~~which the appointed members were appointed and until such time a successor is duly appointed.]~~

9 2. The board of regents shall be appointed as follows:

10 (1) Six voting members shall be residents of the university's historic statutory service
11 region, provided at least one member shall be a resident of Nodaway County. For the sole
12 purpose of determining the composition of the board of regents, the university's historic statutory
13 service region shall consist of the counties of Atchison, Andrew, Caldwell, Carroll, Clay,
14 Clinton, Daviess, DeKalb, Gentry, Grundy, Harrison, Holt, Livingston, Mercer, Nodaway, Ray,
15 and Worth;

16 (2) Two voting members shall be residents of a county in the state that is outside the
17 university's historic statutory service region, as described in subdivision (1) of this subsection,
18 provided these two members shall not be appointed from the same congressional district; and

19 (3) **Unless the university votes to have a student regent as provided in subsection**
20 **5 of this section,** one nonvoting member shall be a full-time student of the university, a United
21 States citizen, and a resident of Missouri.

22 3. A majority of the voting members of the board shall constitute a quorum for the
23 transaction of business; however, no appropriation of money nor any contract that shall require
24 any appropriation or disbursement of money shall be made, nor teacher employed or dismissed,
25 unless a majority of the voting members of the board vote for the same.

26 4. Except as specifically provided in this section, the appointments and terms of office
27 for the voting and nonvoting members of the board, and all other duties and responsibilities of
28 the board, shall comply with the provisions of state law regarding boards of regents.

29 **5. (1) In lieu of a nonvoting student member appointed under subsections 1 and**
30 **2 of this section, one regent of the university appointed under this section may be a full-**
31 **time student of the university appointed as provided in this subsection.**

32 **(2) Before January 1, 2022, the enrolled students from such university shall vote**
33 **to determine whether to fill the next vacancy on such university's board of regents**
34 **occurring on or after January 1, 2022, with a student regent appointed under this**
35 **subsection instead of a nonvoting student member appointed under subsections 1 and 2 of**
36 **this section. If a majority of the university's enrolled students approve the appointment**
37 **of a student regent under this subsection, the governor shall fill the next vacancy on such**
38 **university's board caused by the expiration of a regent's term as provided in this**

39 subsection. If a majority of the university's enrolled students oppose the appointment of
40 a student regent under this subsection, no student shall be a regent on such university's
41 board and the governor shall appoint a nonvoting student member under subsections 1 and
42 2 of this section.

43 (3) The university shall conduct a vote of the university's enrolled students every
44 ten years after the initial vote held under this subsection to determine whether to have a
45 student regent under this subsection. If a majority of the university's enrolled students fail
46 to approve the appointment of a student regent under this subsection in any subsequent
47 vote, any existing student regent shall serve until such student regent's term expires and
48 the governor shall appoint a nonvoting student member under subsections 1 and 2 of this
49 section.

50 (4) Any student regent appointed under this subsection shall meet or exceed all
51 qualifications of the student representative under section 174.055.

52 (5) Any student regent appointed under this subsection shall exercise and be
53 responsible for all powers and duties vested in a regent under this chapter.

54 (6) No more than one student shall serve as a regent at any one time under this
55 section.

174.450. 1. Except as provided in subsection 2 and subsection 6 of this section, the
2 governing [~~board~~] boards of the University of Central Missouri, Missouri State University,
3 Missouri Southern State University, Missouri Western State University, and of each other public
4 institution of higher education [~~which~~] that, through the procedures established in subdivision
5 (8) or (9) of section 173.030, is charged with a statewide mission shall be a board of governors
6 consisting of eight members, composed of seven voting members and one nonvoting member
7 as provided in sections 174.453 and 174.455, **or eight voting members if an educational**
8 **institution votes to have a student member of its board of governors as provided in**
9 **subsection 7 of this section**, who shall be appointed by the governor of Missouri, by and with
10 the advice and consent of the senate. No person shall be appointed a voting member who is not
11 a citizen of the United States and who has not been a resident of the state of Missouri for at least
12 two years immediately prior to such appointment. Not more than four voting members shall
13 belong to any one political party. The appointed members of the board of regents serving on the
14 date of the statutory mission change shall become members of the board of governors on the
15 effective date of the statutory mission change and serve until the expiration of the terms for
16 which they were appointed. The board of regents of any such institution shall be abolished on
17 the effective date of the statutory mission change, as prescribed in subdivision (8) or (9) of
18 section 173.030.

19 2. The governing board of Missouri State University, a public institution of higher
20 education charged with a statewide mission in public affairs, shall be a board of governors of ten
21 members, composed of nine voting members and one nonvoting member, **or ten voting**
22 **members if the university votes to have a student member of the board of governors as**
23 **provided in subsection 7 of this section**, who shall be appointed by the governor, by and with
24 the advice and consent of the senate. The nonvoting member shall be a student selected in the
25 same manner as prescribed in section 174.055. At least one but no more than two voting
26 members shall be appointed to the board from each congressional district, and every member of
27 the board shall be a citizen of the United States, and a resident of this state for at least two years
28 prior to ~~his or her~~ **the member's** appointment. No more than five voting members shall belong
29 to any one political party. The term of office of the governors shall be six years, except as
30 provided in this subsection. The term of office for those appointed hereafter shall end January
31 first in years ending in an odd number. ~~[For the six voting members' terms that expired in 2011,~~
32 ~~the successors shall be appointed in the following manner:~~

33 ~~—— (1) Of the five voting members' terms that expired on August 28, 2011, one successor~~
34 ~~member shall be appointed, or the existing member shall be reappointed, to a term that shall~~
35 ~~expire on January 1, 2013;~~

49 3. If a voting member of the board of governors of Missouri State University is found
50 by unanimous vote of the other governors to have moved such governor's residence from the
51 district from which such governor was appointed, then the office of such governor shall be
52 forfeited and considered vacant.

53 4. Should the total number of Missouri congressional districts be altered, all members
54 of the board of governors of Missouri State University shall be allowed to serve the remainder
55 of the term for which they were appointed.

56 5. Should the boundaries of any congressional districts be altered in a manner that
57 displaces a member of the board of governors of Missouri State University from the
58 congressional district from which the member was appointed, the member shall be allowed to
59 serve the remainder of the term for which the member was appointed.

60 6. The governing board of Missouri Southern State University shall be a board of
61 governors consisting of nine members, composed of eight voting members and one nonvoting
62 member as provided in sections 174.453 and 174.455, **or nine voting members if the university**
63 **votes to have a student member of the board of governors as provided in subsection 7 of**
64 **this section**, who shall be appointed by the governor of Missouri, by and with the advice and
65 consent of the senate. No person shall be appointed a voting member who is not a citizen of the
66 United States and who has not been a resident of the state of Missouri for at least two years
67 immediately prior to such appointment. Not more than four voting members shall belong to any
68 one political party.

69 7. **(1) In lieu of a nonvoting student member appointed under subsection 1, 2, or**
70 **6 of this section, one member of the board of governors of an educational institution**
71 **appointed under this section may be a full-time student of the educational institution**
72 **appointed as provided in this subsection.**

73 **(2) Before January 1, 2022, the enrolled students from such educational institution**
74 **shall vote to determine whether to fill the next vacancy on such educational institution's**
75 **board of governors occurring on or after January 1, 2022, with a student governor on the**
76 **board of governors appointed under this subsection instead of a nonvoting student member**
77 **appointed under subsection 1, 2, or 6 of this section. If a majority of the educational**
78 **institution's enrolled students approve the appointment of a student governor on the board**
79 **of governors under this subsection, the governor of Missouri shall fill the next vacancy on**
80 **such educational institution's board caused by the expiration of a member's term as**
81 **provided in this subsection. If a majority of the educational institution's enrolled students**
82 **oppose the appointment of a student member of the board of governors under this**

174.453. 1. Except as provided in section 174.450, the board of governors shall be
2 appointed as follows:

3 (1) Five voting members shall be selected from the counties comprising the institution's
4 historic statutory service region as described in section 174.010, except that no more than two
5 members shall be appointed from any one county with a population of less than two hundred
6 thousand inhabitants;

7 (2) Two voting members shall be selected from any of the counties in the state which are
8 outside of the institution's historic service region; and

9 (3) One nonvoting member who is a student shall be selected in the same manner as
10 prescribed in section 174.055, **unless the educational institution votes to have a student**
11 **member of the board of governors as provided in subsection 7 of section 174.450.**

12 2. The term of service of the governors shall be as follows:

13 (1) The voting members shall be appointed for terms of six years; and

174.610. 1. The governing board of ~~the~~ Truman State University shall be a board of
 2 governors consisting of ten members, composed of seven voting members and three nonvoting
 3 members as provided in section 174.620, **or eight voting members and two nonvoting**
 4 **members as provided in section 174.620 if the university votes to have a student member**
 5 **of the board of governors as provided in subsection 2 of this section**, who shall be appointed
 6 by the governor of Missouri, by and with the advice and consent of the senate. No person shall
 7 be appointed a voting governor who is not a citizen of the United States and who has not been
 8 a resident of the state of Missouri for at least two years immediately prior to such person's

 17 **to determine whether to fill the next vacancy on such university's board of governors**

174.620. 1. The board of governors shall be appointed as follows:

2 (1) Four voting members from the counties of Adair, Audrain, Boone, Callaway,
3 Chariton, Clark, Howard, Knox, Lewis, Lincoln, Linn, Marion, Macon, Monroe, Montgomery,
4 Pike, Putnam, Ralls, Randolph, St. Charles, Schuyler, Scotland, Shelby, Sullivan, and Warren,
5 provided that not more than one member shall be appointed from the same county;

6 (2) Three voting members from any of the seven college districts as contained in section
7 174.010, provided that no more than one member shall be appointed from the same
8 congressional district;

15 board, but shall have all other powers and duties of section 174.055, and shall also meet the

17 2. The term of service of the governors shall be as follows:

18 (1) The voting members shall be appointed for terms of six years; except, that of the
19 voting members first appointed, two shall serve for terms of two years, two for terms of four
20 years, and three for terms of six years;

21 (2) The nonvoting members who are not students shall be appointed for terms of six
22 years; except, that of the nonvoting members first appointed, one shall serve for a term of three
23 years, and one shall serve a term of six years; and

27 **(4) Any student curator appointed under this subsection shall meet or exceed all**

32 **(6) No more than one student shall serve as a member of the board of curators at**

175.021. 1. **Unless Lincoln University votes to have a student curator as provided**

3 the senate, appoint a student representative to the board of curators of Lincoln University, who

5 representative shall not have the right to vote on any matter before the board.

13 4. If a vacancy occurs for any reason in the position of student representative, the
14 governor shall appoint a replacement who meets the qualifications set forth in subsection 2 of
15 this section and who shall serve until ~~his or her~~ **a** successor is appointed and qualified.

16 5. If the student representative ceases to be a student at the university, or a resident of
17 the state of Missouri, or fails to attend any regularly called meeting of the board of which the
18 representative has due notice, the position shall at once become vacant, unless the absence is
19 caused by sickness or some accident preventing the representative's arrival at the time and place
20 appointed for the meeting.

21 6. The student representative shall receive the same reimbursement for expenses as other
22 members of the board of curators receive pursuant to section 175.030.

23 7. Unless alternative arrangements for payment have been made and agreed to by the
24 student and the university, the student representative shall have paid all student and tuition fees
25 due prior to such appointment and shall pay all future student and tuition fees during the term
26 of office when such fees are due.

27 **8. No student representative shall be appointed under this section during the term**
28 **of any student curator appointed to the board under subsection 2 of section 175.020.**
