AN ACT

To repeal sections 60.301, 60.315, 60.345, 135.305, 135.686, 137.1018, 144.030, 266.355, 301.010, 301.062, 304.180, 304.240, 348.436, 348.500, 643.050, 643.079, and 643.245, RSMo, and to enact in lieu thereof twenty-three new sections relating to agricultural economic opportunities, with a penalty provision and an emergency clause.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Sections 60.301, 60.315, 60.345, 135.305, 135.686, 137.1018, 144.030, 266.355, 301.010, 301.062, 304.180, 304.240, 348.436, 348.500, 643.050, 643.079, and 643.245, RSMo, are repealed and twenty-three new sections enacted in lieu thereof, to be known as sections 60.301, 60.315, 60.345, 135.305, 135.686, 135.755, 135.775, 135.778, 135.1610, 137.1018, 144.030, 275.357, 301.010, 301.062, 304.180, 304.240, 348.436, 348.491, 348.493, 348.500, 643.050, 643.079, and 643.245, to read as follows:

60.301. Whenever the following words and terms are used in this chapter they shall have the following meaning unless the context clearly indicates that a different meaning is intended:

(1) "Corners of the United States public land survey", those points that determine the boundaries of the various subdivisions represented on the official plat such as the township corner, the section corner, the quarter-section corner, grant corner ~~and~~, meander corner, **and center of section**;

(2) "Existent corner", a corner whose position can be identified by verifying the evidence of the original monument or its accessories, or by some physical evidence described in the field notes, or located by an acceptable supplemental survey record or some physical

11 evidence thereof, or by testimony. The physical evidence of a corner may have been entirely
12 obliterated but the corner will be considered existent if its position can be recovered through
13 the testimony of one or more witnesses who have a dependable knowledge of the original
14 location. A legally reestablished corner shall have the same status as an existent corner;

15 (3) "Lost corner", a corner whose position cannot be determined, beyond reasonable
16 doubt, either from traces of the original marks or from acceptable evidence or testimony that
17 bears upon the original position;

18 (4) "Monument", the physical object which marks the corner point determined by the
19 surveying process. The accessories, such as bearing trees, bearing objects, reference
20 monuments, mounds of stone and other similar objects that aid in identifying the corner
21 position, are also considered a part of a corner monument;

22 (5) "Obliterated, decayed or destroyed corner", ~~[an-existent corner]~~ **a position** at
23 whose point there are no remaining traces of the original monument or its accessories, but
24 whose location has been perpetuated by subsequent surveys, or the point may be recovered
25 beyond reasonable doubt by the acts and testimony of local residents, competent surveyors,
26 other qualified local authorities or witnesses, or by some acceptable record evidence. A
27 position that depends upon the use of collateral evidence can be accepted only if duly
28 supported, generally through proper relation to known corners, and agreement with the field
29 notes regarding distances to natural objects, stream crossings, line trees, etc., or
30 unquestionable testimony;

31 (6) "Original government survey", that survey executed under the authority of the
32 United States government as recorded on the official plats and field notes of the United States
33 public land survey maintained by the Missouri department of agriculture;

34 (7) "Proportionate measurement", a measurement of a line that gives equal relative
35 weight to all parts of the line. The excess or deficiency between two existent corners is so
36 distributed that the amount of excess or deficiency given to each interval bears the same
37 proportion to the whole difference as the record length of the interval bears to the whole
38 record distance:

39 (a) "Single proportionate measurement", a measurement of a line applied to a new
40 measurement made between known points on a line to determine one or more positions on
41 that line;

42 (b) "Double proportionate measurement", a measurement applied to a new
43 measurement made between four known corners, two each on intersecting meridional and
44 latitudinal lines, for the purpose of relating the intersection to both. ~~[The procedure is
45 described as follows: first, measurements will be made between the nearest existent corners
46 north and south of the lost corner. A temporary point will be determined to locate the latitude
47 of the lost corner on the straight line connecting the existent corners and at the proper~~

48 ~~proportionate distance. Second, measurements will be made between the nearest existent~~
49 ~~corners east and west of the lost corner. A temporary point will be determined to locate the~~
50 ~~longitude of the lost corner on the straight line connecting the existent corners and at the~~
51 ~~proportionate distance. Third, determine the location of the lost corner at the intersection of~~
52 ~~an east-west line through the point determining the latitude of the lost corner with a north-~~
53 ~~south line through the point determining the longitude of the lost corner.]~~ When the total
54 length of the line between the nearest existing corners was not measured in the original
55 government survey, the record distance from one existing corner to the lost corner will be
56 used instead of the proportionate distance. This exception will apply to either or both of the
57 east-west or north-south lines;

58 (8) "Record distance", the distance or length as shown on the original government
59 survey. In determining record distances, consideration shall be given as to whether the
60 distance was measured on a random or true line.

60.315. The following rules for the reestablishment of lost corners shall be applied
2 only when it is determined that the corner is lost: (The rules utilize proportional measurement
3 which harmonizes surveying practice with legal and equitable considerations. This plan of
4 relocating a lost corner is always employed unless it can be shown that the corner so located
5 is in substantial disagreement with the general scheme of the original government survey as
6 monumented. In such cases the surveyor shall use procedures that produce results consistent
7 with the original survey of that township.)

8 (1) Existent original corners shall not be disturbed. Consequently, discrepancies
9 between the new and record measurements shall not in any manner affect the measurements
10 beyond the existent corners; but the differences shall be distributed proportionately within the
11 several intervals along the line between the corners;

12 (2) Standard parallels shall be given precedence over other township exteriors, and,
13 ordinarily, the latter shall be given precedence over subdivisional lines; section corners shall
14 be located or reestablished before the position of lost quarter-section corners can be
15 determined;

16 (3) Lost township corners common to four townships shall be reestablished by double
17 proportionate measurement between the nearest existent corners on opposite sides of the lost
18 township corner;

19 (4) Lost township corners located on standard parallels and common only to two
20 townships shall be reestablished by single proportionate measurement between the nearest
21 existent corners on opposite sides of the lost township corner on the standard parallel;

22 (5) ~~[Lost standard corners shall be reestablished on a standard or correction line by~~
23 ~~single proportionate measurement on the line connecting the nearest identified standard or~~
24 ~~closing corners on opposite sides of the lost corner or corners, as the case may be;~~

25 ~~(6) All lost section and quarter-section corners on the township boundary lines shall~~
26 ~~be reestablished by single proportionate measurement between the nearest existent corners on~~
27 ~~opposite sides of the lost corner according to the conditions represented upon the original~~
28 ~~government plat;~~

29 ~~(7)~~ **Lost corners on township exteriors, excluding corners referenced in**
30 **subdivision (3) of this section, whether they are standard or closing corners, shall be**
31 **reestablished by single proportionate measurement on the line connecting the next**
32 **nearest existent standard or closing corner on opposite sides of the lost corner;**

33 **(6)** A lost interior corner of four sections shall be reestablished by double
34 proportionate measurement;

35 ~~[(8) A lost closing corner shall be reestablished on the true line that was closed upon,~~
36 ~~and at the proper proportional interval between the nearest existent corners on opposite sides~~
37 ~~of the lost corner;~~

38 ~~(9)~~ **(7)** All lost quarter-section corners on the section boundaries within the township
39 shall be reestablished by single proportionate measurement between the adjoining section
40 corners, after the section corners have been identified or reestablished; and

41 ~~[(10)]~~ **(8)** Where a line has been terminated with a measurement in one direction only,
42 a lost corner shall be reestablished by record bearing and distance, counting from the nearest
43 regular corner, the latter having been duly identified or reestablished.

60.345. The quarter-section corners of sections south of the township line and east of
2 the range line, and not established by the original government survey will be established
3 according to the conditions represented upon the official government plat using **single**
4 proportionate measurement between the ~~adjoining~~ section corners belonging to the same
5 section as the quarter-section corner being established, the section corners having first been
6 identified or reestablished. **The proportional position shall be offset, if necessary, in a**
7 **cardinal direction to the true line defined by the nearest adjacent corners on opposite**
8 **sides of the quarter-section corner to be established.**

135.305. A Missouri wood energy producer shall be eligible for a tax credit on taxes
2 otherwise due under chapter 143, except sections 143.191 to 143.261, as a production
3 incentive to produce processed wood products in a qualified wood-producing facility using
4 Missouri forest product residue. The tax credit to the wood energy producer shall be five
5 dollars per ton of processed material. The credit may be claimed for a period of five years
6 and is to be a tax credit against the tax otherwise due. No new tax credits, provided for under
7 sections 135.300 to 135.311, shall be authorized after June 30, ~~[2020]~~ **2028**. In no event shall
8 the aggregate amount of all tax credits allowed under sections 135.300 to 135.311 exceed six
9 million dollars in any given fiscal year. There shall be no tax credits authorized under
10 sections 135.300 to 135.311 unless an appropriation is made for such tax credits.

135.686. 1. This section shall be known and may be cited as the "Meat Processing Facility Investment Tax Credit Act".

2. As used in this section, the following terms mean:

(1) "Authority", the agricultural and small business development authority established in chapter 348;

(2) "Meat processing facility", any commercial plant, as defined under section 265.300, at which livestock are slaughtered or at which meat or meat products are processed for sale commercially and for human consumption;

(3) "Meat processing modernization or expansion", constructing, improving, or acquiring buildings or facilities, or acquiring equipment for meat processing including the following, if used exclusively for meat processing and if acquired and placed in service in this state during tax years beginning on or after January 1, 2017, but ending on or before December 31, ~~2024~~ **2028**:

(a) Building construction including livestock handling, product intake, storage, and warehouse facilities;

(b) Building additions;

(c) Upgrades to utilities including water, electric, heat, refrigeration, freezing, and waste facilities;

(d) Livestock intake and storage equipment;

(e) Processing and manufacturing equipment including cutting equipment, mixers, grinders, sausage stuffers, meat smokers, curing equipment, cooking equipment, pipes, motors, pumps, and valves;

(f) Packaging and handling equipment including sealing, bagging, boxing, labeling, conveying, and product movement equipment;

(g) Warehouse equipment including storage and curing racks;

(h) Waste treatment and waste management equipment including tanks, blowers, separators, dryers, digesters, and equipment that uses waste to produce energy, fuel, or industrial products;

(i) Computer software and hardware used for managing the claimant's meat processing operation including software and hardware related to logistics, inventory management, production plant controls, and temperature monitoring controls; and

(j) Construction or expansion of retail facilities or the purchase or upgrade of retail equipment for the commercial sale of meat products if the retail facility is located at the same location as the meat processing facility;

(4) "Tax credit", a credit against the tax otherwise due under chapter 143, excluding withholding tax imposed under sections 143.191 to 143.265, or otherwise due under chapter 147;

38 (5) "Taxpayer", any individual or entity who:

39 (a) Is subject to the tax imposed under chapter 143, excluding withholding tax
40 imposed under sections 143.191 to 143.265, or the tax imposed under chapter 147;

41 (b) In the case of an individual, is a resident of this state as verified by a 911 address
42 or, in the absence of a 911 system, a physical address; and

43 (c) Owns a meat processing facility located in this state **and employs a combined**
44 **total of fewer than five hundred individuals in all meat processing facilities owned by**
45 **the individual or entity in this country;**

46 (6) "Used exclusively", used to the exclusion of all other uses except for use not
47 exceeding five percent of total use.

48 3. For all tax years beginning on or after January 1, 2017, but ending on or before
49 December 31, ~~[2021]~~ **2028**, a taxpayer shall be allowed a tax credit for meat processing
50 modernization or expansion related to the taxpayer's meat processing facility. The tax credit
51 amount shall be equal to twenty-five percent of the amount the taxpayer paid in the tax year
52 for meat processing modernization or expansion.

53 4. The amount of the tax credit claimed shall not exceed the amount of the taxpayer's
54 state tax liability for the tax year for which the credit is claimed. No tax credit claimed under
55 this section shall be refundable. The tax credit shall be claimed in the tax year in which the
56 meat processing modernization or expansion expenses were paid, but any amount of credit
57 that the taxpayer is prohibited by this section from claiming in a tax year may be carried
58 forward to any of the taxpayer's four subsequent tax years. The total amount of tax credits
59 that any taxpayer may claim shall not exceed seventy-five thousand dollars per year. If two or
60 more persons own and operate the meat processing facility, each person may claim a credit
61 under this section in proportion to ~~[his or her]~~ **such person's** ownership interest; except that,
62 the aggregate amount of the credits claimed by all persons who own and operate the meat
63 processing facility shall not exceed seventy-five thousand dollars per year. The amount of tax
64 credits authorized in this section ~~[and section 135.679]~~ in a calendar year shall not exceed two
65 million dollars. Tax credits shall be issued on an as-received application basis until the
66 calendar year limit is reached. Any credits not issued in any calendar year shall expire and
67 shall not be issued in any subsequent year.

68 5. To claim the tax credit allowed under this section, the taxpayer shall submit to the
69 authority an application for the tax credit on a form provided by the authority and any
70 application fee imposed by the authority. The application shall be filed with the authority at
71 the end of each calendar year in which a meat processing modernization or expansion project
72 was completed and for which a tax credit is claimed under this section. The application shall
73 include any certified documentation, proof of meat processing modernization or expansion,
74 and any other information required by the authority. All required information obtained by the

75 authority shall be confidential and not disclosed except by court order, subpoena, or as
76 otherwise provided by law. If the taxpayer and the meat processing modernization or
77 expansion meet all criteria required by this section and approval is granted by the authority,
78 the authority shall issue a tax credit certificate in the appropriate amount. Tax credit
79 certificates issued under this section may be assigned, transferred, sold, or otherwise
80 conveyed, and the new owner of the tax credit certificate shall have the same rights in the tax
81 credit as the original taxpayer. If a tax credit certificate is assigned, transferred, sold, or
82 otherwise conveyed, a notarized endorsement shall be filed with the authority specifying the
83 name and address of the new owner of the tax credit certificate and the value of the tax credit.

84 6. Any information provided under this section shall be confidential information, to
85 be shared with no one except state and federal animal health officials, except as provided in
86 subsection 5 of this section.

87 7. The authority shall promulgate rules establishing a process for verifying that a
88 facility's modernization or expansion for which tax credits were allowed under this section
89 has in fact expanded the facility's production within three years of the issuance of the tax
90 credit and if not, the authority shall promulgate through rulemaking a process by which the
91 taxpayer shall repay the authority an amount equal to that of the tax credit allowed.

92 8. The authority shall, at least annually, submit a report to the Missouri general
93 assembly reviewing the costs and benefits of the program established under this section.

94 9. The authority may promulgate rules to implement the provisions of this section.
95 Any rule or portion of a rule, as that term is defined in section 536.010, that is created under
96 the authority delegated in this section shall become effective only if it complies with and is
97 subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section
98 and chapter 536 are nonseverable and if any of the powers vested with the general assembly
99 pursuant to chapter 536 to review, to delay the effective date, or to disapprove and annul a
100 rule are subsequently held unconstitutional, then the grant of rulemaking authority and any
101 rule proposed or adopted after August 28, 2016, shall be invalid and void.

102 10. This section shall not be subject to the Missouri sunset act, sections 23.250 to
103 23.298.

135.755. 1. For the purposes of this section, the following terms shall mean:

- 2 **(1) "Department", the Missouri department of revenue;**
3 **(2) "Distributor", a person, firm, or corporation doing business in this state**
4 **that:**
5 **(a) Produces, refines, blends, compounds, or manufactures motor fuel;**
6 **(b) Imports motor fuel into the state; or**
7 **(c) Is engaged in distribution of motor fuel;**

8 **(3) "Higher ethanol blend", a fuel capable of being dispensed directly into motor**
9 **vehicle fuel tanks for consumption that is comprised of at least fifteen percent but not**
10 **more than eighty-five percent ethanol;**

11 **(4) "Retail dealer", a person, firm, or corporation doing business in this state**
12 **that owns or operates a retail service station in this state;**

13 **(5) "Retail service station", a location in this state from which higher ethanol**
14 **blend is sold to the general public and is dispensed directly into motor vehicle fuel tanks**
15 **for consumption.**

16 **2. For all tax years beginning on or after January 1, 2023, a retail dealer that**
17 **sells higher ethanol blend at such retail dealer's retail service station or a distributor**
18 **that sells higher ethanol blend directly to the final user located in this state shall be**
19 **allowed a tax credit to be taken against the retail dealer's or distributor's state income**
20 **tax liability. The amount of the credit shall equal five cents per gallon of higher ethanol**
21 **blend sold by the retail dealer and dispensed through metered pumps at the retail**
22 **dealer's retail service station or by a distributor directly to the final user located in this**
23 **state during the tax year for which the tax credit is claimed. Tax credits authorized**
24 **pursuant to this section shall not be transferred, sold, or assigned. If the amount of the**
25 **tax credit exceeds the taxpayer's state tax liability, the difference shall not be refundable**
26 **but may be carried forward to any of the five subsequent tax years. The total amount of**
27 **tax credits issued pursuant to this section for any given fiscal year shall not exceed five**
28 **million dollars.**

29 **3. In the event the total amount of tax credits claimed under this section exceeds**
30 **the amount of available tax credits, the tax credits shall be apportioned among all**
31 **eligible retail dealers and distributors claiming a tax credit by April fifteenth, or as**
32 **directed by section 143.851, of the fiscal year in which the tax credit is claimed.**

33 **4. The tax credit allowed by this section shall be claimed by such taxpayer at the**
34 **time such taxpayer files a return and shall be applied against the income tax liability**
35 **imposed by chapter 143, excluding the withholding tax imposed by sections 143.191 to**
36 **143.265, after reduction for all other credits allowed thereon. The department may**
37 **require any documentation it deems necessary to implement the provisions of this**
38 **section.**

39 **5. The department shall promulgate rules to implement the provisions of this**
40 **section. Any rule or portion of a rule, as that term is defined in section 536.010, that is**
41 **created under the authority delegated in this section shall become effective only if it**

52 shall automatically sunset twelve years after the effective date of the reauthorization of
53 this section; and

54 (3) This section shall terminate on September first of the calendar year
55 immediately following the calendar year in which the program authorized under this
56 section is sunset.

135.775. 1. As used in this section, the following terms mean:

2 (1) "Biodiesel blend", a blend of diesel fuel and biodiesel fuel of at least five
3 percent and not more than twenty percent for on-road and off-road diesel-fueled vehicle
4 use;

5 (2) "Biodiesel fuel", a renewable, biodegradable, mono alkyl ester combustible
6 liquid fuel that is derived from agricultural and other plant oils or animal fats and that
7 meets the most recent version of the ASTM International D6751 Standard Specification
8 for Biodiesel Fuel Blend Stock. A fuel shall be deemed to be biodiesel fuel if the fuel
9 consists of a pure B100 or B99 ratio. Biodiesel produced from palm oil is not biodiesel
10 fuel for the purposes of this section unless the palm oil is contained within waste oil and
11 grease collected within the United States;

12 (3) "B99", a blend of ninety-nine percent biodiesel fuel that meets the most
13 recent version of the ASTM International D6751 Standard Specification for Biodiesel
14 Fuel Blend Stock with a minimum of one-tenth of one percent and maximum of one
15 percent diesel fuel that meets the most recent version of the ASTM International D975
16 Standard Specification for Diesel Fuel;

17 (4) "Department", the Missouri department of revenue;

18 (5) "Distributor", a person, firm, or corporation doing business in this state
19 that:

20 (a) Produces, refines, blends, compounds, or manufactures motor fuel;

21 (b) Imports motor fuel into the state; or

22 (c) Is engaged in distribution of motor fuel;

23 (6) "Retail dealer", a person, firm, or corporation doing business in this state
24 that owns or operates a retail service station in this state;

25 **(7) "Retail service station", a location in this state from which biodiesel blend is**
26 **sold to the general public and is dispensed directly into motor vehicle fuel tanks for**
27 **consumption at retail.**

28 **2. For all tax years beginning on or after January 1, 2023, a retail dealer that**
29 **sells a biodiesel blend at a retail service station or a distributor that sells a biodiesel**
30 **blend directly to the final user located in this state shall be allowed a tax credit to be**
31 **taken against the retail dealer or distributor's state income tax liability. The amount of**
32 **the credit shall be equal to:**

33 **(1) Two cents per gallon of biodiesel blend of at least five percent but not more**
34 **than ten percent sold by the retail dealer at a retail service station or by a distributor**
35 **directly to the final user located in this state during the tax year for which the tax credit**
36 **is claimed; and**

37 **(2) Five cents per gallon of biodiesel blend in excess of ten percent but not more**
38 **than twenty percent sold by the retail dealer at a retail service station or by a distributor**
39 **directly to the final user located in this state during the tax year for which the tax credit**
40 **is claimed.**

41 **3. Tax credits authorized under this section shall not be transferred, sold, or**
42 **assigned. If the amount of the tax credit exceeds the taxpayer's state tax liability, the**
43 **difference shall be refundable. The total amount of tax credits issued under this section**
44 **for any given fiscal year shall not exceed sixteen million dollars.**

45 **4. In the event the total amount of tax credits claimed under this section exceeds**
46 **the amount of available tax credits, the tax credits shall be apportioned among all**
47 **eligible retail dealers and distributors claiming a tax credit by April fifteenth, or as**
48 **directed by section 143.851, of the fiscal year in which the tax credit is claimed.**

49 **5. The tax credit allowed by this section shall be claimed by such taxpayer at the**
50 **time such taxpayer files a return and shall be applied against the income tax liability**
51 **imposed by chapter 143, excluding the withholding tax imposed by sections 143.191 to**
52 **143.265, after reduction for all other credits allowed thereon. The department may**
53 **require any documentation it deems necessary to administer the provisions of this**
54 **section.**

55 **6. Notwithstanding any other provision of law to the contrary, if the maximum**
56 **amount of tax credits authorized by this section are not claimed, the remaining amount**
57 **of tax credits available to claim shall be applied to the tax credit in section 135.778 if the**
58 **maximum amount of tax credits authorized by section 135.778 have been claimed.**

59 **7. Notwithstanding the provisions of section 32.057 to the contrary, the**
60 **department may work with the division of weights and measures within the department**
61 **of agriculture to validate that the biodiesel blend a retail dealer or distributor claims for**

62 the tax credit authorized under this section contains a sufficient percentage of biodiesel
63 fuel.

64 8. The department shall promulgate rules to implement and administer the
65 provisions of this section. Any rule or portion of a rule, as that term is defined in section
66 536.010, that is created pursuant to the authority delegated in this section shall become
67 effective only if it complies with and is subject to all of the provisions of chapter 536 and,
68 if applicable, section 536.028. This section and chapter 536 are nonseverable and if any
69 of the powers vested with the general assembly pursuant to chapter 536 to review, to
70 delay the effective date, or to disapprove and annul a rule are subsequently held
71 unconstitutional, then the grant of rulemaking authority and any rule proposed or
72 adopted after the effective date of this section shall be invalid and void.

73 9. Under section 23.253 of the Missouri sunset act:

74 (1) The provisions of the new program authorized under this section shall
75 automatically sunset on December 31, 2028, unless reauthorized by an act of the general
76 assembly;

77 (2) If such program is reauthorized, the program authorized under this section
78 shall automatically sunset twelve years after the effective date of the reauthorization of
79 this section; and

80 (3) This section shall terminate on September first of the calendar year
81 immediately following the calendar year in which the program authorized under this
82 section is sunset. The termination of the program as described in this subsection shall
83 not be construed to preclude any qualified taxpayer who claims any benefit under any
84 program that is sunset under this subsection from claiming such benefit for all allowable
85 activities related to such claim that were completed before the program was sunset or to

143 within such municipal corporation and such municipal corporation and adjacent commercial
144 zone;

145 (32) "Log truck", a vehicle which is not a local log truck or local log truck tractor and
146 is used exclusively to transport harvested forest products to and from forested sites which is
147 registered pursuant to this chapter to operate as a motor vehicle on the public highways of this
148 state for the transportation of harvested forest products;

149 (33) "Major component parts", the rear clip, cowl, frame, body, cab, front-end
150 assembly, and front clip, as those terms are defined by the director of revenue pursuant to
151 rules and regulations or by illustrations;

152 (34) "Manufacturer", any person, firm, corporation or association engaged in the
153 business of manufacturing or assembling motor vehicles, trailers or vessels for sale;

154 (35) "Motor change vehicle", a vehicle manufactured prior to August, 1957, which
155 receives a new, rebuilt or used engine, and which used the number stamped on the original
156 engine as the vehicle identification number;

157 (36) "Motor vehicle", any self-propelled vehicle not operated exclusively upon tracks,
158 except farm tractors and electric bicycles;

159 (37) "Motor vehicle primarily for business use", any vehicle other than a recreational
160 motor vehicle, motorcycle, motortricycle, or any commercial motor vehicle licensed for over
161 twelve thousand pounds:

162 (a) Offered for hire or lease; or

163 (b) The owner of which also owns ten or more such motor vehicles;

164 (38) "Motorcycle", a motor vehicle operated on two wheels;

165 (39) "Motorized bicycle", any two-wheeled or three-wheeled device having an
166 automatic transmission and a motor with a cylinder capacity of not more than fifty cubic
167 centimeters, which produces less than three gross brake horsepower, and is capable of
168 propelling the device at a maximum speed of not more than thirty miles per hour on level
169 ground, but excluding an electric bicycle;

170 (40) "Motortricycle", a motor vehicle upon which the operator straddles or sits astride
171 that is designed to be controlled by handle bars and is operated on three wheels, including a

173 a third wheel, but excluding an electric bicycle. A motortricycle shall not be included in the

175 (41) "Municipality", any city, town or village, whether incorporated or not;

176 (42) "Nonresident", a resident of a state or country other than the state of Missouri;

177 (43) "Non-USA-std motor vehicle", a motor vehicle not originally manufactured in
178 compliance with United States emissions or safety standards;

179 (44) "Operator", any person who operates or drives a motor vehicle;

180 (45) "Owner", any person, firm, corporation or association, who holds the legal title
181 to a vehicle or who has executed a buyer's order or retail installment sales contract with a
182 motor vehicle dealer licensed under sections 301.550 to 301.580 for the purchase of a vehicle
183 with an immediate right of possession vested in the transferee, or in the event a vehicle is the
184 subject of an agreement for the conditional sale or lease thereof with the right of purchase
185 upon performance of the conditions stated in the agreement and with an immediate right of
186 possession vested in the conditional vendee or lessee, or in the event a mortgagor of a vehicle

189 (46) "Public garage", a place of business where motor vehicles are housed, stored,
190 repaired, reconstructed or repainted for persons other than the owners or operators of such

192 (47) "Rebuilder", a business that repairs or rebuilds motor vehicles owned by the
193 rebuilder, but does not include certificated common or contract carriers of persons or
194 property;

195 (48) "Reconstructed motor vehicle", a vehicle that is altered from its original
196 construction by the addition or substitution of two or more new or used major component
197 parts, excluding motor vehicles made from all new parts, and new multistage manufactured
198 vehicles;

199 (49) "Recreational motor vehicle", any motor vehicle designed, constructed or
200 substantially modified so that it may be used and is used for the purposes of temporary
201 housing quarters, including therein sleeping and eating facilities which are either permanently
202 attached to the motor vehicle or attached to a unit which is securely attached to the motor
203 vehicle. Nothing herein shall prevent any motor vehicle from being registered as a
204 commercial motor vehicle if the motor vehicle could otherwise be so registered;

205 (50) "Recreational off-highway vehicle", any motorized vehicle manufactured and
206 used exclusively for off-highway use which is more than fifty inches but no more than eighty
207 inches in width, measured from outside of tire rim to outside of tire rim, with an unladen dry
208 weight of three thousand five hundred pounds or less, traveling on four or more nonhighway
209 tires and which may have access to ATV trails;

210 (51) "Recreational trailer", any trailer designed, constructed, or substantially modified
211 so that it may be used and is used for the purpose of temporary housing quarters, including
212 therein sleeping or eating facilities, which can be temporarily attached to a motor vehicle or
213 attached to a unit which is securely attached to a motor vehicle;

214 (52) "Rollback or car carrier", any vehicle specifically designed to transport wrecked,
215 disabled or otherwise inoperable vehicles, when the transportation is directly connected to a
216 wrecker or towing service;

217 (53) "Saddlemount combination", a combination of vehicles in which a truck or truck
218 tractor tows one or more trucks or truck tractors, each connected by a saddle to the frame or
219 fifth wheel of the vehicle in front of it. The "saddle" is a mechanism that connects the front
220 axle of the towed vehicle to the frame or fifth wheel of the vehicle in front and functions like
221 a fifth wheel kingpin connection. When two vehicles are towed in this manner the
222 combination is called a "double saddlemount combination". When three vehicles are towed
223 in this manner, the combination is called a "triple saddlemount combination";

224 (54) "Salvage dealer and dismantler", a business that dismantles used motor vehicles
225 for the sale of the parts thereof, and buys and sells used motor vehicle parts and accessories;

226 (55) "Salvage vehicle", a motor vehicle, semitrailer, or house trailer which:

227 (a) Was damaged during a year that is no more than six years after the manufacturer's
228 model year designation for such vehicle to the extent that the total cost of repairs to rebuild or
229 reconstruct the vehicle to its condition immediately before it was damaged for legal operation
230 on the roads or highways exceeds eighty percent of the fair market value of the vehicle
231 immediately preceding the time it was damaged;

232 (b) By reason of condition or circumstance, has been declared salvage, either by its
233 owner, or by a person, firm, corporation, or other legal entity exercising the right of security
234 interest in it;

235 (c) Has been declared salvage by an insurance company as a result of settlement of a
236 claim;

237 (d) Ownership of which is evidenced by a salvage title; or

238 (e) Is abandoned property which is titled pursuant to section 304.155 or section
239 304.157 and designated with the words "salvage/abandoned property". The total cost of
240 repairs to rebuild or reconstruct the vehicle shall not include the cost of repairing, replacing,
241 or reinstalling inflatable safety restraints, tires, sound systems, or damage as a result of hail,
242 or any sales tax on parts or materials to rebuild or reconstruct the vehicle. For purposes of
243 this definition, "fair market value" means the retail value of a motor vehicle as:

244 a. Set forth in a current edition of any nationally recognized compilation of retail
245 values, including automated databases, or from publications commonly used by the
246 automotive and insurance industries to establish the values of motor vehicles;

247 b. Determined pursuant to a market survey of comparable vehicles with regard to
248 condition and equipment; and

249 c. Determined by an insurance company using any other procedure recognized by the
250 insurance industry, including market surveys, that is applied by the company in a uniform
251 manner;

252 (56) "School bus", any motor vehicle used solely to transport students to or from
253 school or to transport students to or from any place for educational purposes;

254 (57) "Scrap processor", a business that, through the use of fixed or mobile equipment,
255 flattens, crushes, or otherwise accepts motor vehicles and vehicle parts for processing or
256 transportation to a shredder or scrap metal operator for recycling;

257 (58) "Shuttle bus", a motor vehicle used or maintained by any person, firm, or
258 corporation as an incidental service to transport patrons or customers of the regular business
259 of such person, firm, or corporation to and from the place of business of the person, firm, or
260 corporation providing the service at no fee or charge. Shuttle buses shall not be registered as
261 buses or as commercial motor vehicles;

262 (59) "Special mobile equipment", every self-propelled vehicle not designed or used
263 primarily for the transportation of persons or property and incidentally operated or moved
264 over the highways, including farm equipment, implements of husbandry, road construction or
265 maintenance machinery, ditch-digging apparatus, stone crushers, air compressors, power
266 shovels, cranes, graders, rollers, well-drillers and wood-sawing equipment used for hire,
267 asphalt spreaders, bituminous mixers, bucket loaders, ditchers, leveling graders, finished
268 machines, motor graders, road rollers, scarifiers, earth-moving carryalls, scrapers, drag lines,

269 concrete pump trucks, rock-drilling and earth-moving equipment. This enumeration shall be
270 deemed partial and shall not operate to exclude other such vehicles which are within the
271 general terms of this section;

272 (60) "Specially constructed motor vehicle", a motor vehicle which shall not have been
273 originally constructed under a distinctive name, make, model or type by a manufacturer of
274 motor vehicles. The term specially constructed motor vehicle includes kit vehicles;

275 (61) "Stinger-steered combination", a truck tractor-semitrailer wherein the fifth wheel
276 is located on a drop frame located behind and below the rearmost axle of the power unit;

277 (62) "Tandem axle", a group of two or more axles, arranged one behind another, the
278 distance between the extremes of which is more than forty inches and not more than ninety-
279 six inches apart;

280 (63) "Towaway trailer transporter combination", a combination of vehicles consisting
281 of a trailer transporter towing unit and two trailers or semitrailers, with a total weight that
282 does not exceed twenty-six thousand pounds; and in which the trailers or semitrailers carry no
283 property and constitute inventory property of a manufacturer, distributor, or dealer of such
284 trailers or semitrailers;

285 (64) "Tractor", "truck tractor" or "truck-tractor", a self-propelled motor vehicle
286 designed for drawing other vehicles, but not for the carriage of any load when operating
287 independently. When attached to a semitrailer, it supports a part of the weight thereof;

288 (65) "Trailer", any vehicle without motive power designed for carrying property or
289 passengers on its own structure and for being drawn by a self-propelled vehicle, except those
290 running exclusively on tracks, including a semitrailer or vehicle of the trailer type so designed
291 and used in conjunction with a self-propelled vehicle that a considerable part of its own
292 weight rests upon and is carried by the towing vehicle. The term trailer shall not include
293 cotton trailers as defined in this section and shall not include manufactured homes as defined
294 in section 700.010;

295 (66) "Trailer transporter towing unit", a power unit that is not used to carry property
296 when operating in a towaway trailer transporter combination;

297 (67) "Truck", a motor vehicle designed, used, or maintained for the transportation of
298 property;

299 (68) "Truck-tractor semitrailer-semitrailer", a combination vehicle in which the two
300 trailing units are connected with a B-train assembly which is a rigid frame extension attached
301 to the rear frame of a first semitrailer which allows for a fifth-wheel connection point for the
302 second semitrailer and has one less articulation point than the conventional A-dolly connected
303 truck-tractor semitrailer-trailer combination;

304 (69) "Truck-trailer boat transporter combination", a boat transporter combination
305 consisting of a straight truck towing a trailer using typically a ball and socket connection with

306 the trailer axle located substantially at the trailer center of gravity rather than the rear of the
307 trailer but so as to maintain a downward force on the trailer tongue;

308 (70) "Used parts dealer", a business that buys and sells used motor vehicle parts or
309 accessories, but not including a business that sells only new, remanufactured or rebuilt parts.
310 Business does not include isolated sales at a swap meet of less than three days;

311 (71) "Utility vehicle", any motorized vehicle manufactured and used exclusively for
312 off-highway use which is more than fifty inches but no more than eighty inches in width,
313 measured from outside of tire rim to outside of tire rim, with an unladen dry weight of three
314 thousand five hundred pounds or less, traveling on four or six wheels, to be used primarily for
315 landscaping, lawn care, or maintenance purposes;

316 (72) "Vanpool", any van or other motor vehicle used or maintained by any person,
317 group, firm, corporation, association, city, county or state agency, or any member thereof, for
318 the transportation of not less than eight nor more than forty-eight employees, per motor
319 vehicle, to and from their place of employment; however, a vanpool shall not be included in
320 the definition of the term bus or commercial motor vehicle as defined in this section, nor shall
321 a vanpool driver be deemed a chauffeur as that term is defined by section 303.020; nor shall
322 use of a vanpool vehicle for ride-sharing arrangements, recreational, personal, or maintenance
323 uses constitute an unlicensed use of the motor vehicle, unless used for monetary profit other
324 than for use in a ride-sharing arrangement;

325 (73) "Vehicle", any mechanical device on wheels, designed primarily for use, or used,
326 on highways, except motorized bicycles, electric bicycles, vehicles propelled or drawn by
327 horses or human power, or vehicles used exclusively on fixed rails or tracks, or cotton trailers
328 or motorized wheelchairs operated by handicapped persons;

329 (74) "Wrecker" or "tow truck", any emergency commercial vehicle equipped,
330 designed and used to assist or render aid and transport or tow disabled or wrecked vehicles
331 from a highway, road, street or highway rights-of-way to a point of storage or repair,
332 including towing a replacement vehicle to replace a disabled or wrecked vehicle;

333 (75) "Wrecker or towing service", the act of transporting, towing or recovering with a
334 wrecker, tow truck, rollback or car carrier any vehicle not owned by the operator of the
335 wrecker, tow truck, rollback or car carrier for which the operator directly or indirectly
336 receives compensation or other personal gain.

301.062. 1. The annual registration fee for a local log truck, registered pursuant to
2 this chapter, is three hundred dollars.

3 2. A local log truck may receive an extended distance local log truck permit for an
4 additional fee of three hundred dollars. A local log truck with an extended distance local log
5 truck permit shall be allowed to transport harvested or processed forest products outside of
6 the ~~[one hundred mile]~~ radius from the forested site **specified in section 301.010** at the

7 weight limits for commercial vehicles specified in section 304.180. For the purposes of this
 8 section, "processed forest products" shall mean wood products that are produced from the
 9 initial processing of a round log and have received no additional manufacturing or packaging

304.180. 1. No vehicle or combination of vehicles shall be moved or operated on any
 2 highway in this state having a greater weight than twenty thousand pounds on one axle, no
 3 combination of vehicles operated by transporters of general freight over regular routes as
 4 defined in section 390.020 shall be moved or operated on any highway of this state having a
 5 greater weight than the vehicle manufacturer's rating on a steering axle with the maximum
 6 weight not to exceed twelve thousand pounds on a steering axle, and no vehicle shall be
 7 moved or operated on any state highway of this state having a greater weight than thirty-four
 8 thousand pounds on any tandem axle; the term "tandem axle" shall mean a group of two or
 9 more axles, arranged one behind another, the distance between the extremes of which is more
 10 than forty inches and not more than ninety-six inches apart.

11 2. An "axle load" is defined as the total load transmitted to the road by all wheels
 12 whose centers are included between two parallel transverse vertical planes forty inches apart,
 13 extending across the full width of the vehicle.

14 3. Subject to the limit upon the weight imposed upon a highway of this state through
 15 any one axle or on any tandem axle, the total gross weight with load imposed by any group of
 16 two or more consecutive axles of any vehicle or combination of vehicles shall not exceed the
 17 maximum load in pounds as set forth in the following table:

80 Notwithstanding the above table, two consecutive sets of tandem axles may carry a gross load
 81 of thirty-four thousand pounds each if the overall distance between the first and last axles of
 82 such consecutive sets of tandem axles is thirty-six feet or more.

83 4. Whenever the state highways and transportation commission finds that any state
 84 highway bridge in the state is in such a condition that use of such bridge by vehicles of the
 85 weights specified in subsection 3 of this section will endanger the bridge, or the users of the
 86 bridge, the commission may establish maximum weight limits and speed limits for vehicles
 87 using such bridge. The governing body of any city or county may grant authority by act or
 88 ordinance to the commission to enact the limitations established in this section on those
 89 roadways within the purview of such city or county. Notice of the weight limits and speed
 90 limits established by the commission shall be given by posting signs at a conspicuous place at
 91 each end of any such bridge.

92 5. Nothing in this section shall be construed as permitting lawful axle loads, tandem
 93 axle loads or gross loads in excess of those permitted under the provisions of P.L. 97-424
 94 codified in Title 23 of the United States Code (23 U.S.C. Section 101, et al.), as amended.

95 6. Notwithstanding the weight limitations contained in this section, any vehicle or
 96 combination of vehicles operating on highways other than the interstate highway system may
 97 exceed single axle, tandem axle and gross weight limitations in an amount not to exceed two
 98 thousand pounds. However, total gross weight shall not exceed eighty thousand pounds,
 99 except as provided in subsections 9, 10, 12, ~~and~~ 13, **and 14** of this section.

100 7. Notwithstanding any provision of this section to the contrary, the commission shall
 101 issue a single-use special permit, or upon request of the owner of the truck or equipment shall

102 issue an annual permit, for the transporting of any crane or concrete pump truck or well-
103 drillers' equipment. The commission shall set fees for the issuance of permits and parameters
104 for the transport of cranes pursuant to this subsection. Notwithstanding the provisions of
105 section 301.133, cranes, concrete pump trucks, or well-drillers' equipment may be operated
106 on state-maintained roads and highways at any time on any day.

107 8. Notwithstanding the provision of this section to the contrary, the maximum gross
108 vehicle limit and axle weight limit for any vehicle or combination of vehicles equipped with
109 an idle reduction technology may be increased by a quantity necessary to compensate for the
110 additional weight of the idle reduction system as provided for in 23 U.S.C. Section 127, as
111 amended. In no case shall the additional weight increase allowed by this subsection be
112 greater than five hundred fifty pounds. Upon request by an appropriate law enforcement
113 officer, the vehicle operator shall provide proof that the idle reduction technology is fully
114 functional at all times and that the gross weight increase is not used for any purpose other
115 than for the use of idle reduction technology.

116 9. Notwithstanding any provision of this section or any other law to the contrary, the
117 total gross weight of any vehicle or combination of vehicles hauling milk from a farm to a
118 processing facility or livestock may be as much as, but shall not exceed, eighty-five thousand
119 five hundred pounds while operating on highways other than the interstate highway system.
120 The provisions of this subsection shall not apply to vehicles operated and operating on the
121 Dwight D. Eisenhower System of Interstate and Defense Highways.

122 10. Notwithstanding any provision of this section or any other law to the contrary, any
123 vehicle or combination of vehicles hauling grain or grain coproducts during times of harvest
124 may be as much as, but not exceeding, ten percent over the maximum weight limitation
125 allowable under subsection 3 of this section while operating on highways other than the
126 interstate highway system. The provisions of this subsection shall not apply to vehicles
127 operated and operating on the Dwight D. Eisenhower System of Interstate and Defense
128 Highways.

129 11. Notwithstanding any provision of this section or any other law to the contrary, the
130 commission shall issue emergency utility response permits for the transporting of utility wires
131 or cables, poles, and equipment needed for repair work immediately following a disaster
132 where utility service has been disrupted. Under exigent circumstances, verbal approval of
133 such operation may be made either by the department of transportation motor carrier
134 compliance supervisor or other designated motor carrier services representative. Utility
135 vehicles and equipment used to assist utility companies granted special permits under this
136 subsection may be operated and transported on state-maintained roads and highways at any
137 time on any day. The commission shall promulgate all necessary rules and regulations for the
138 administration of this section. Any rule or portion of a rule, as that term is defined in section

53 U.S.C. Section 7661[~~7~~] et seq., and used, upon appropriation, to fund activities by the
54 department to implement the operating permits program authorized by Title V of the federal
55 Clean Air Act, as amended. Another subaccount shall be maintained for fees paid by air
56 contaminant sources which are not required to be permitted under Title V of the federal Clean
57 Air Act as amended, and used, upon appropriation, to fund other air pollution control program
58 activities. Another subaccount shall be maintained for service fees paid under subsection 8 of
59 this section by Phase I affected units which are subject to the requirements of Title IV, Section
60 404, of the federal Clean Air Act Amendments of 1990 (**42 U.S.C. Section 7651c**), as
61 amended, [~~42 U.S.C. Section 7651,~~] and used, upon appropriation, to fund air pollution
62 control program activities. The provisions of section 33.080 to the contrary notwithstanding,
63 moneys in the fund shall not revert to general revenue at the end of each biennium. Interest
64 earned by moneys in the subaccounts shall be retained in the subaccounts. The per-ton fees
65 established under subsection 1 of this section may be adjusted annually, consistent with the
66 need to fund the reasonable costs of the program, but shall not be less than twenty-five dollars
67 per ton of regulated air contaminant nor more than forty dollars per ton of regulated air
68 contaminant. The first adjustment shall apply to moneys payable on April 1, 1994, and shall
69 be based upon the general price level for the twelve-month period ending on August thirty-
70 first of the previous calendar year.

71 6. The department may initiate a civil action in circuit court against any air
72 contaminant source which has not remitted the appropriate fees within thirty days. In any
73 judgment against the source, the department shall be awarded interest at a rate determined

75 department, the source shall be awarded reasonable attorney's fees.

83 I affected generating unit to help fund the administration of sections 643.010 to 643.355.
84 Thereafter, the service fee shall be annually set by the commission by rule, following public
85 hearing, based on an annual allocation prepared by the department showing the details of all
86 costs and expenses upon which such fees are based consistent with the department's

95 9. The department of natural resources shall determine the fees due pursuant to this
96 section by the state of Missouri and its departments, agencies and institutions, including two-
97 and four-year institutions of higher education. The director of the department of natural
98 resources shall forward the various totals due to the joint committee on capital improvements
99 and the directors of the individual departments, agencies and institutions. The departments,
100 as part of the budget process, shall annually request by specific line item appropriation funds
101 to pay said fees and capital funding for projects determined to significantly improve air
102 quality. If the general assembly fails to appropriate funds for emissions fees as specifically

107 10. **Each retail agricultural facility that uses, stores, or sells anhydrous ammonia**

110 **dollars. In addition, each retail agricultural facility that uses, stores, or sells anhydrous**

120 **amended, for such agricultural facilities. Fees paid by agricultural air contaminant**
121 **sources that use, store, or sell anhydrous ammonia for the purposes of implementing the**

123 **anhydrous ammonia risk management plan subaccount within the natural resources**

129 **11.** Notwithstanding any statutory fee amounts or maximums to the contrary, the
130 department of natural resources may conduct a comprehensive review and propose changes to
131 the fee structure authorized by sections 643.073, 643.075, 643.079, 643.225, 643.228,
132 643.232, 643.237, and 643.242 after holding stakeholder meetings in order to solicit
133 stakeholder input from each of the following groups: the asbestos industry, electric utilities,
134 mineral and metallic mining and processing facilities, cement kiln representatives, and any
135 other interested industrial or business entities or interested parties. The department shall
136 submit a proposed fee structure with stakeholder agreement to the air conservation
137 commission. The commission shall review such recommendations at the forthcoming regular
138 or special meeting, but shall not vote on the fee structure until a subsequent meeting. If the
139 commission approves, by vote of two-thirds majority or five of seven commissioners, the fee
140 structure recommendations, the commission shall authorize the department to file a notice of
141 proposed rulemaking containing the recommended fee structure, and after considering public
142 comments, may authorize the department to file the order of rulemaking for such rule with the
143 joint committee on administrative rules pursuant to sections 536.021 and 536.024 no later
144 than December first of the same year. If such rules are not disapproved by the general
145 assembly in the manner set out below, they shall take effect on January first of the following
146 calendar year and the previous fee structure shall expire upon the effective date of the
147 commission-adopted fee structure. Any regulation promulgated under this subsection shall be
148 deemed to be beyond the scope and authority provided in this subsection, or detrimental to

643.245. 1. All moneys received pursuant to sections 643.225 to 643.245 and any
2 other moneys so designated shall be placed in the state treasury and credited to the "Natural
3 Resources Protection Fund — Air Pollution Asbestos Fee Subaccount", which is hereby
4 created. Such moneys received pursuant to sections 643.225 to 643.245 shall, subject to
5 appropriation, be used solely for the purpose of administering this chapter. Any unexpended
6 balance in such fund at the end of any appropriation period shall not be transferred to the

Section B. Because immediate action is necessary to promote agricultural economic
