AN ACT

To repeal section 558.041, RSMo, and to enact in lieu thereof one new section relating to good time credit.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 558.041, RSMo, is repealed and one new section enacted in lieu thereof, to be known as section 558.041, to read as follows:

558.041. 1. Any offender committed to the department of corrections, except those persons committed pursuant to subsection 7 of section 558.016, or subsection 3 of section 566.125, ~~may~~ **shall** receive additional credit in terms of days spent in confinement upon recommendation for such credit by the offender's institutional superintendent when the offender meets the requirements for such credit as provided in subsections 3 and 4 of this section. Good time credit may be rescinded by the director or his or her designee pursuant to the divisional policy issued pursuant to subsection 3 of this section.

2. Any credit extended to an offender shall only apply to the sentence which the offender is currently serving.

3. **(1)** The director of the department of corrections shall issue a policy for awarding credit.

(2) The policy ~~may~~ **shall** reward an ~~inmate~~ **offender** who has served his or her sentence in an orderly and peaceable manner and has taken advantage of the rehabilitation programs available to him or her.

(3) Any **major conduct** violation of institutional rules ~~or~~, the laws of this state ~~may~~, **or the accumulation of minor conduct violations exceeding six within a calendar**

26 ~~536.024.]~~ **No offender committed to the department who is sentenced to death or**
27 **sentenced to life without probation or parole shall be eligible for good time credit.**

28 **5. The department shall award credit of sixty days for programs and activities to**
29 **any qualifying offender who successfully:**

30 **(1) Receives a high school diploma or equivalent, college diploma, or a**
31 **vocational training certificate as provided under the department's policy;**

32 **(2) Completes an alcohol or drug abuse treatment program as provided under**
33 **the department's policy, except that alcohol and drug abuse treatment programs**
34 **ordered by the court or parole board shall not qualify;**

35 **(3) Completes one thousand hours of restorative justice; or**

36 **(4) Completes other programs as provided under the department's policy.**

37 **6. Offenders sentenced under subsections 2 and 3 of section 558.019 shall be**
38 **eligible for good time credit. Any good time credit earned shall be subtracted from the**
39 **offender's minimum eligibility-for-release date.**

40 **7. Nothing in this section shall be construed to require that the offender be**
41 **released as a result of good time credit. The parole board in its discretion shall**
42 **determine the date of release.**
