AN ACT

To amend chapter 161, RSMo, by adding thereto one new section relating to the 21st-century Missouri education task force.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 161, RSMo, is amended by adding thereto one new section, to be
2 known as section 161.245, to read as follows:

**161.245. 1. There is hereby established the "21st-Century Missouri Education Task
2 Force".**

3 2. The task force shall consist of the following members:

**4 (1) Three members of the house of representatives, with two members to be
5 appointed by the speaker of the house of representatives, at least one of whom is a member
6 of the joint committee on education, and one member to be appointed by the minority
7 leader of the house of representatives;**

**8 (2) Three members of the senate, with two members to be appointed by the
9 president pro tempore of the senate, at least one of whom is a member of the joint
10 committee on education, and one member to be appointed by the minority leader of the
11 senate;**

12 (3) The governor or the governor's designee;

13 (4) The commissioner of education or the commissioner's designee;

14 (5) The commissioner of higher education or the commissioner's designee; and

**15 (6) Eleven members who represent the interests of each of the following groups, to
16 be appointed by the governor:**

17 (a) The Missouri workforce development board;

18 (b) Charter schools;

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

- 19 **(c) Community colleges;**
20 **(d) Private colleges or universities;**
21 **(e) Children with disabilities, including children with autism spectrum disorders;**
22 **(f) After-school programs;**
23 **(g) Public school board members;**
24 **(h) Public school teachers;**
25 **(i) The business community in this state;**
26 **(j) The parents as teachers program established under sections 178.691 to 178.699;**
27 **and**
28 **(k) Home-schooled students.**
- 29 **3. The speaker of the house of representatives shall designate the chair of the task**
30 **force, and the president pro tempore of the senate shall designate the vice chair of the task**
31 **force.**
- 32 **4. Staff members of house research, house drafting, senate research, and the joint**
33 **committee on legislative research shall provide such legal, research, clerical, technical, and**
34 **bill drafting services as the task force may require in the performance of its duties.**
- 35 **5. Members of the task force shall serve without compensation, but the members**
36 **and any staff assigned to the task force shall receive reimbursement for actual and**
37 **necessary expenses incurred in attending meetings of the task force or any subcommittee**
38 **thereof. All task force members shall be subject to the same conflict of interest provisions**
39 **in chapter 105 that are enforced by the Missouri ethics commission in the same manner**
40 **that elected or appointed officials and employees are subject to such provisions.**
- 41 **6. The task force shall hold its first meeting within two months from the effective**
42 **date of this section.**
- 43 **7. The mission of the task force shall be to:**
- 44 **(1) Evaluate the condition of the state's public education system, including the**
45 **standardized testing system;**
46 **(2) Study successful educational models in order to identify highly effective**
47 **teaching strategies;**
48 **(3) Evaluate the state's certificate programs and workforce development efforts,**
49 **including any efforts to use knowledge models to help guide students into certain**
50 **employment areas from young ages so that they are able to advance in rewarding careers;**
51 **(4) Evaluate current funding for elementary and secondary education and higher**
52 **education in Missouri;**

53 **(5) Evaluate whether current education funding in Missouri is sufficient to not only**
54 **maintain the public education system in its current state but also to ensure that it serves**
55 **the educational needs of Missouri's citizens moving forward into the twenty-first century;**

56 **(6) Make recommendations regarding the condition of the state's public education**
57 **system;**

58 **(7) Make recommendations regarding funding of education and workforce**
59 **development efforts; and**

60 **(8) Make recommendations regarding the use of technology and artificial**
61 **intelligence to improve student outcomes and to inform future educational needs in relation**
62 **to workforce development in order to maximize the impact of the Missouri public**
63 **education system in regards to future employment opportunities including, but not limited**
64 **to, manufacturing, trades, STEM fields, and agriculture.**

65 **8. The task force shall report a summary of its activities and any recommendations**
66 **for legislation to the general assembly before August 28, 2022.**

67 **9. (1) The task force shall suspend its operations on January 1, 2023. At such time,**
68 **all members of the task force shall be relieved of their positions on the task force.**

69 **(2) The task force shall resume its operations on January 1, 2024, with a new set**
70 **of members to be selected according to the provisions of subsection 2 of this section. The**
71 **new chair and the new vice chair of the task force shall be designated according to the**
72 **provisions of subsection 3 of this section.**

73 **(3) Upon resumption of its operations, the task force shall continue to receive**
74 **services according to the provisions of subsection 4 of this section and shall continue to be**
75 **subject to all provisions of subsection 5 of this section.**

76 **(4) Upon resumption of its operations, the task force shall review all summaries and**
77 **recommendations previously made under subsection 8 of this section and shall continue to**
78 **carry out the mission described in subsection 7 of this section.**

79 **(5) Upon resumption of its operations, the task force shall report an updated**
80 **summary of its activities and any recommendations for legislation to the general assembly**
81 **before August 28, 2024.**

82 **(6) After providing a report to the general assembly as required under subdivision**
83 **(5) of this subsection, the task force shall continue to meet every two years periodically**
84 **until this section expires. The task force shall provide additional updated summaries of**
85 **its activities and additional recommendations for legislation to the general assembly, at**
86 **such times as the task force deems necessary, until the task force is terminated.**

87 **10. Under section 23.253 of the Missouri sunset act:**

88 **(1) The provisions of the new program authorized under this section shall**
89 **automatically sunset twelve years after the effective date of this section unless reauthorized**
90 **by an act of the general assembly;**

91 **(2) If such program is reauthorized, the program authorized under this section**
92 **shall automatically sunset twelve years after the effective date of the reauthorization of this**
93 **section; and**

94 **(3) This section shall terminate on September first of the calendar year immediately**
95 **following the calendar year in which the program authorized under this section is sunset.**
