## AN ACT

To repeal section 57.317, RSMo, and to enact in lieu thereof one new section relating to sheriffs.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 57.317, RSMo, is repealed and one new section enacted in lieu 2 thereof, to be known as section 57.317, to read as follows:

57.317. 1. (1) The county sheriff in any county of the first classification shall, at

### 2 a minimum, receive an annual salary no less than ninety percent of the salary of the

## **3** prosecuting attorney for the county.

(2) The county sheriff in any county [, other than in a first] of the second, third, or 4 fourth classification [chartered county,] shall receive an annual salary computed as set forth in 5 the following schedule. The assessed valuation factor shall be the amount thereof as shown for 6 7 the year next preceding the computation. The provisions of this section shall not permit or require a reduction in the amount of compensation being paid for the office of sheriff on January 8 9 1, 1997. 10 Assessed Valuation Salary 11 \$18,000,000 to 40,999,999 \$36,000

Two thousand dollars of the salary authorized in this section shall be payable to the 30 sheriff only if the sheriff has completed at least twenty hours of classroom instruction each calendar year relating to the operations of the sheriff's office when approved by a professional 31 32 association of the county sheriffs of Missouri unless exempted from the training by the 33 professional association. The professional association approving the program shall provide a certificate of completion to each sheriff who completes the training program and shall send a list 34 35 of certified sheriffs to the treasurer of each county. Expenses incurred for attending the training 36 session may be reimbursed to the county sheriff in the same manner as other expenses as may 37 be appropriated for that purpose. 38 3. The county sheriff in any county, other than a first classification charter county, shall

not, except upon two-thirds vote of all the members of the salary commission, receive an annual
compensation less than the total compensation being received for the office of county sheriff in

41 the particular county for services rendered or performed on the date the salary commission votes.
