JOINT RESOLUTION

Submitting to the qualified voters of Missouri an amendment repealing Section 40(a) of Article IV of the Constitution of Missouri, and adopting one new section in lieu thereof relating to the conservation commission.

Be it resolved by the House of Representatives, the Senate concurring therein:

That at the next general election to be held in the state of Missouri, on Tuesday next following the first Monday in November, 2020, or at a special election to be called by the governor for that purpose, there is hereby submitted to the qualified voters of this state, for adoption or rejection, the following amendment to Article IV of the Constitution of the state of Missouri:

Section A. Section 40(a), Article IV, Constitution of Missouri, is repealed and one new 2 section adopted in lieu thereof, to be known as Section 40(a), to read as follows:

Section 40(a). The control, management, restoration, conservation and regulation of the bird, fish, game, forestry and all wildlife resources of the state, including hatcheries, sanctuaries, 2 3 refuges, reservations and all other property owned, acquired or used for such purposes and the 4 acquisition and establishment thereof, but excluding any animal born and held in captivity by any private entity, and the administration of all laws pertaining thereto, shall be vested in 5 6 a conservation commission consisting of four members appointed by the governor, by and with the advice and consent of the senate, not more than two of whom shall be of the same political 7 8 party. The members shall have knowledge of and interest in wildlife conservation. The members shall hold office for terms of six years beginning on the first day of July of consecutive 9 odd years. Two of the terms shall be concurrent; one shall begin two years before and one two 10 11 years after the concurrent terms. If the governor fails to fill a vacancy within thirty days, the

12 remaining members shall fill the vacancy for the unexpired term. The members shall receive no 13 salary or other compensation for their services as members, but shall receive their necessary 14 traveling and other expenses incurred while actually engaged in the discharge of their official 15 duties.

Section B. Under chapter 116, RSMo, and other applicable constitutional provisions and 2 laws of this state allowing the general assembly to adopt ballot language for the submission of 3 a joint resolution to the voters of this state, the official ballot title of the amendment proposed 4 in section A shall be as follows:

5 "Shall the Constitution of Missouri be amended to state that the conservation commission 6 shall have exclusive control over all wild animals that are not born and held in captivity by 7 private entities?".
