## **AN ACT**

To repeal section 334.285, RSMo, and to enact in lieu thereof one new section relating to physician maintenance of certification or licensure.

Be it enacted by the General Assembly of the State of Missouri, as follows:

- Section A. Section 334.285, RSMo, is repealed and one new
- 2 section enacted in lieu thereof, to be known as section 334.285,
- 3 to read as follows:
  - 334.285. 1. For purposes of this section, the
- 2 following terms shall mean:
- 3 (1) "Continuing medical education", continued
- 4 postgraduate medical education intended to provide [medical
- 5 professionals] physicians with knowledge of new developments
- 6 in their field;
- 7 (2) "Maintenance of certification", any process
- 8 requiring periodic recertification examinations, or
- 9 completion of proprietary activities, modules, or regular
- 10 payment of fees, to maintain specialty medical board
- 11 certification;
- 12 (3) "Maintenance of licensure", the Federation of
- 13 State Medical Boards' proprietary framework for physician
- 14 license renewal including additional periodic testing other
- 15 than continuing medical education;
- 16 (4) "Specialty medical board certification",
- 17 certification by a board that specializes in one particular
- 18 area of medicine and typically requires additional and more

strenuous exams than state board of registration for the healing arts requirements to practice medicine.

- 21 2. The state shall not require any form of maintenance
- 22 of licensure as a condition of physician licensure including
- 23 requiring any form of maintenance of licensure tied to
- 24 maintenance of certification. Current requirements
- 25 including continuing medical education shall suffice to
- 26 demonstrate professional competency.
- 27 3. The state shall not require any form of specialty
- 28 medical board certification or any maintenance of
- 29 certification to practice medicine within the state. There
- 30 shall be no discrimination by the state board of
- 31 registration for the healing arts or any other state agency
- 32 against physicians who do not maintain specialty medical
- 33 board certification including recertification.
- 4. No hospital, health care facility, or institution
- or program owned, operated, or licensed by the state shall
- 36 condition employment or the granting of medical staff
- 37 privileges on a physician's maintenance of certification or
- 38 maintenance of licensure.
- 39 5. No health carrier, as defined in section 376.1350,
- 40 shall condition physician reimbursement or participation in
- 41 the carrier's health plans on a physician's maintenance of
- 42 certification or maintenance of licensure.
