AN ACT

To repeal section 301.451, RSMo, and to enact in lieu thereof one new section relating to Purple Heart license plates.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 301.451, RSMo, is repealed and one new section
2 enacted in lieu thereof, to be known as section 301.451, to read as follows:

301.451. Any person who has been awarded the purple heart medal may
2 apply for special motor vehicle license plates for any vehicle he or she owns,
3 either solely or jointly, other than commercial vehicles weighing over twelve
4 thousand pounds. Any such person shall make application for the special license
5 plates on a form provided by the director of revenue and furnish such proof as a
6 recipient of the purple heart medal as the director may require. The director
7 shall then issue license plates bearing letters or numbers or a combination
8 thereof, with the words "PURPLE HEART" in place of the words "SHOW-ME
9 STATE" in a form prescribed by the advisory committee established in section
10 301.129. Such license plates shall be made with fully reflective material with a
11 common color scheme and design, shall be clearly visible at night, and shall be
12 aesthetically attractive, as prescribed by section 301.130. There shall be no fee
13 in addition to regular registration fees for the [initial set of] **purple heart**
14 **license** plates issued to the applicant[, however, there shall be an additional fee
15 charged for each subsequent set of special purple heart license plates issued
16 equal to the fee charged for personalized license plates, but the additional fee

17 shall only have to be paid once by the qualified applicant at the time of initial
18 application for the additional set of plates]. There shall be no limit on the
19 number of license plates any person qualified under this section may obtain so
20 long as each set of license plates issued under this section is issued for vehicles
21 owned solely or jointly by such person. License plates issued under the
22 provisions of this section shall not be transferable to any other person except that
23 any registered co-owner of the motor vehicle shall be entitled to operate the motor
24 vehicle for the duration of the year licensed in the event of the death of the
25 qualified person.
