## **AN ACT**

To repeal section 227.803, RSMo, and to enact in lieu thereof thirteen new sections relating to the designation of memorial infrastructure.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 227.803, RSMo, is repealed and thirteen

- 2 new sections enacted in lieu thereof, to be known as sections
- 3 227.479, 227.485, 227.499, 227.778, 227.779, 227.787, 227.788,
- 4 227.789, 227.803, 227.806, 1, 2, and 3, to read as follows:

227.479. The portion of State Highway D from the

- 2 intersection with State Highway 84 continuing north to
- 3 County Road 321 in Pemiscot County shall be designated the
- 4 "Duane S Michie Memorial Highway". The department of
- 5 transportation shall erect and maintain appropriate signs
- 6 designating such highway, with the costs to be paid by
- 7 private donations.

227.485. The portion of State Highway H from

- 2 Interstate 44 West continuing north to County Road 88 in
- 3 Greene County shall be designated as "Deputy Sheriff Aaron P
- 4 Roberts Memorial Highway". The department of transportation

- 3 shall be designated as the "MSgt. Carl Cosper Jr Memorial
- 4 Highway". The department of transportation shall erect and
- 5 maintain appropriate signs designating such highway, with
- 6 the costs to be paid by private donations.
  - 227.778. The portion of State Highway 25 from U.S.
- 2 Highway 60 continuing north to Mary Street in Stoddard
- 3 County shall be designated as "Stars and Stripes Highway".
- 4 The department of transportation shall erect and maintain
- 5 appropriate signs designating such highway, with the costs
- 6 to be paid by private donations.
  - 227.779. The bridge on Interstate 55 crossing over
- 2 Butler Hill Road in St. Louis County shall be designated as
- 3 "Police Officer Michael V Langsdorf Memorial Bridge". The
- 4 department of transportation shall erect and maintain
- 5 appropriate signs designating such bridge, with the costs to
- 6 be paid by private donations.
  - 227.787. The portion of Interstate 70 from Shreve Road
- 2 continuing to Kingshighway Boulevard shall be designated as
- 3 "David Dorn Memorial Highway". The department of
- 4 transportation shall erect and maintain appropriate signs
- 5 designating such highway, with the costs to be paid by
- 6 private donations.
- 227.788. The bridge on Interstate 64 crossing over
- 2 Sarah Street in St. Louis City shall be designated as the
- 3 "Police Surgeon James F Cooper MD Memorial Bridge". The
- 4 department of transportation shall erect and maintain
- 5 appropriate signs designating such bridge, with the costs to
- 6 be paid by private donations.

227.789. The portion of State Highway 91 from U.S.

- 2 State 61 to State Highway C and continuing east on State
- 3 Highway C through the city of Morley to State Highway H in
- 4 Scott County shall be designated as "Billy Ray Cousin
- 5 Carl Anderson Memorial Highway". The department of
- 6 transportation shall erect and maintain appropriate signs
- 7 designating such highway, with the costs to be paid by
- 8 private donations.
  - 227.803. The portion of State Highway 7 from County
- 2 Road 221 West continuing to [Calvird Drive] State Highway 52
- 3 in the city of Clinton in Henry County shall be designated
- 4 as "Police Officer Christopher Ryan Morton Memorial
- 5 Highway". The department shall erect and maintain
- 6 appropriate signs designating such highway with the costs to
- 7 be paid for by private donations.
  - 227.806. The portion of State Highway 180 from
- 2 Interstate 170 continuing to Kienlen Avenue shall be
- 3 designated as "Captain David Dorn Memorial Highway". The
- 4 department of transportation shall erect and maintain
- 5 appropriate signs designating such highway, with the costs
- 6 to be paid by private donations.
  - Section 1. The bridge on State Highway 34, also known
- 2 as South Main Street, crossing over the Makenzie Creek in
- 3 Wayne County shall be designated as "WW II POW Alex Cortez
- 4 Memorial Bridge". The department of transportation shall
- 5 erect and maintain appropriate signs designating such
- 6 bridge, with the costs to be paid by private donations.
  - Section 2. The portion of State Highway 43 from State
- 2 Highway U continuing to State Highway C in Newton County
- 3 shall be designated as "Firefighter Tyler H Casey Memorial
- 4 Highway". The department of transportation shall erect and

- 5 maintain appropriate signs designating such highway, with
- 6 the costs to be paid by private donations.

Section 3. That portion of Interstate 64 between

- 2 Jefferson Avenue and Tucker Boulevard located in the City of
- 3 Saint Louis shall be designated as "Bobby Plager Memorial
- 4 Highway". The department of transportation shall erect and
- 5 maintain appropriate signs designating such highway, with
- 6 the costs to be paid by private donations.
