Description of fiscal impact: HB 662 establishes the Mary Fields memorial highway on Old US Highway 91 from mile marker 0 at 4th Avenue North in Cascade, Montana to mile marker 14.3 at Railroad Avenue in Ulm, Montana. The Montana Department of Transportation's (MDT) Maintenance sign shop employees will make the signs and Maintenance employees will install the signs. The MDT Rail, Transit and Planning Division is responsible for adding this designation to the appropriate maps. There is appropriated \$1 from the general fund to the MDT and this bill is effective upon passage and approval.

FISCAL ANALYSIS

Assumptions:

- 1. It is assumed that two signs are needed on Old US Highway 91 from mile marker 0 at 4th Avenue North in Cascade, Montana and the other at mile marker 14.3 at Railroad Avenue in Ulm, Montana.
- 2. The cost per sign for labor, materials and installation would be \$1,998.72.
- 3. Any costs associated with adding the designation to the appropriate maps will be absorbed within existing resources and added during regular update cycles.
