Description of fiscal impact

SB541 requires the department of Agriculture to create and administer a Pollinator Health Task Force.

FISCAL ANALYSIS

Assumptions

Department of Agriculture

- 1. The Department of Agriculture is appropriated \$50,000 from the general fund to cover costs associated with the task force duties prescribed in Section 2.
- 2. Assumed a 3-day travel with 2-night stay per panel member, per meeting annually. Assumed a daily per diem rate of \$100.00 per 10 panel member is \$3,000.00 annually. Daily in-state meal per diem \$33.50 for 3 days, for 10 panel members is \$1,005.00 annually. In-state lodging rate is \$110.00 per night, for 2-night stay per 10 panel members is \$2,200.00 annually. High mileage rate of \$.70 per mile for 350 roundtrip miles, per 10 panel members is \$2,450.00 annually. Assumed panel would meet at the Department of Agriculture, thus no meeting room costs. Assumed a 3% increase on travel costs for each year thereafter.

Department of Fish, Wildlife, and Parks

3. SB 541 requires the task force must include one representative of the department of Fish, Wildlife, and Parks.

Secretary of State's Office

4. SB 541 requires the Office of the Secretary of State to notify each federally recognized tribal government in Montana. While there may be a minimal fiscal impact, the Office of the Secretary of State will absorb the costs associated with implementing this bill within its existing operating budget.

4. The proposed legislation would not have a fiscal impact on the MUS. Any expenses for the appointment of an expert in managed and wild pollinator health from Montana State University would be handled within current appropriations.

Department of Natural Resources and Conservation
