16 A BILL FOR AN ACT ENTITLED: "AN ACT DIRECTING THAT MEDICAID APPROPRIATIONS BE USED ONLY  
17 FOR MEDICAID EXPENDITURES; AND PROVIDING AN EFFECTIVE DATE."

19 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

21 NEW SECTION. **Section 1. Appropriations for medicaid expenditures.** Appropriations in a general  
22 appropriations act for medicaid may be used only to pay for or administer medicaid services.

24 NEW SECTION. **Section 2. Codification instruction.** [Section 1] is intended to be codified as an  
25 integral part of Title 53, chapter 6, part 1, and the provisions of Title 53, chapter 6, part 1, apply to [section 1].

27 NEW SECTION. **Section 3. Effective date.** [This act] is effective July 1, 2017.
