13	a rental agreement terms and conditions not prohibited by this chapter or other rule or law, including rent, term
14	of the agreement, and other provisions governing the rights and obligations of the parties.
15	(2) Unless the rental agreement provides otherwise:
16	(a) the tenant shall pay as rent the fair rental value for the use and occupancy of the dwelling unit as
17	determined by the landlord;
18	(b) rent is payable at the landlord's address or using electronic funds transfer to an account designated
19	for the payment of rent by the landlord;
20	(c) periodic rent is payable at the beginning of a term of a month or less and otherwise in equal monthly
21	installments at the beginning of each month;
22	(d) rent is uniformly apportionable from day to day; and
23	(e) the tenancy is week to week in the case of a roomer who pays weekly rent and in all other cases
24	month to month.
25	(3) Rent is payable without demand or notice at the time and place agreed upon by the parties or
26	provided for by subsection (2) of this section."

28	Section 2. Section 70-24-205, MCA, is amended to read:
29	"70-24-205. Extension of written rental agreements. (1) Prior to signing a written rental agreement,
30	the landlord and tenant shall agree to accept a default extension period for the lease chosen by the tenant

1 pursuant to subsection (2) that is to be given effect if a revised lease is not agreed to or if neither party gives a 2 30-day written notice of termination to the other prior to the rental agreement's original termination date. 3 (2) The tenant shall choose from a list of default options, including but not limited to renewal for an 4 additional term of equal length as the original term, renewal for a set term that is not of equal length as the original 5 term, renewal on a month-to-month basis, or termination of the tenancy. 6 (3) If neither party gives a 30-day written notice to the other as to the extension or termination of the 7 tenancy, the mutually agreed upon default option takes effect immediately following the termination of the original 8 rental agreement. 9 (4) If the landlord and tenant fail to establish a default option at the beginning of the tenancy as required 10 in subsection (1) a default extension period for the lease in the rental agreement and neither party gives a 30-day 11 written notice to the other to terminate the tenancy before the rental agreement's original termination date, the 12 tenancy continues on a month-to-month basis." 13 14 **Section 3.** Section 70-33-201, MCA, is amended to read: 15 "70-33-201. Rental agreements. (1) A landlord and a tenant may include in a rental agreement terms and conditions not prohibited by this chapter or other rule or law. 16 17 (2) Unless the rental agreement provides otherwise: 18 (a) the tenant shall pay as rent the fair rental value for the use and occupancy of the lot as determined 19 by the landlord; 20 (b) rent is payable at the landlord's address or using electronic funds transfer to an account designated 21 for the payment of rent by the landlord; 22 (c) periodic rent is payable at the beginning of a term that is a month or less and otherwise in equal 23 monthly installments at the beginning of each month; 24 (d) rent is uniformly apportionable from day to day; and 25 (e) the tenancy is from month to month. 26 (3) Rent is payable without demand or notice at the time and place agreed upon by the parties or as 27 provided by subsection (2)." 28 29 NEW SECTION.
