5	A BILL FOR AN ACT ENTITLED: "AN ACT REQUIRING DISCLOSURE OF DATES OF CERTAIN CAMPAIGN
6	CONTRIBUTIONS; AND AMENDING SECTION 13-37-229, MCA."

8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

10	Section 1. Section 13-37-229, MCA, is amended to read:
11	"13-37-229. Disclosure requirements for candidates, ballot issue committees, political party
12	committees, and independent committees. (1) The reports required under 13-37-225 through 13-37-227 from
13	candidates, ballot issue committees, political party committees, and independent committees must disclose the
14	following information concerning contributions received:
15	(a) the amount of cash on hand at the beginning of the reporting period;
16	(b) the full name, mailing address, occupation, and employer, if any, of each person who has made
17	aggregate contributions, other than loans, of \$35 or more to a candidate or political committee, including the
18	purchase of tickets and other items for events, such as dinners, luncheons, rallies, and similar fundraising events;
19	(c) for each person identified under subsection (1)(b), the aggregate amount of contributions made by
20	that person within the reporting period and the total amount of contributions made by that person for all reporting
21	periods;
22	(d) the total sum of individual contributions made to or for a political committee or candidate and not
23	reported under subsections (1)(b) and (1)(c);
24	(e) the name and address of each political committee or candidate from which the reporting committee
25	or candidate received any transfer of funds, together with the amount and dates of all transfers;
26	(f) each loan from any person during the reporting period, together with the full names, mailing
27	addresses, occupations, and employers, if any, of the lender and endorsers, if any, and the date and amount of
28	each loan;
29	(g) the amount and nature of debts and obligations owed to a political committee or candidate, in the
30	form prescribed by the commissioner;

(h) an itemized account of proceeds that total less than \$35 from a person from mass collections made
 at fundraising events;

3 (i) each contribution, rebate, refund, or other receipt not otherwise listed under subsections (1)(b) through
4 (1)(h) during the reporting period;

5 (j) the total sum of all receipts received by or for the committee or candidate during the reporting period;

6 (k) the date associated with each contribution reported under this subsection (1) WAS RECEIVED; and

7 (k)(l) other information that may be required by the commissioner to fully disclose the sources of funds
8 used to support or oppose candidates or issues.

9 (2) (a) Except as provided in subsection (2)(c), the reports required under 13-37-225 through 13-37-227
10 from candidates, ballot issue committees, political party committees, and independent committees must disclose
11 the following information concerning expenditures made:

(i) the full name, mailing address, occupation, and principal place of business, if any, of each person to
 whom expenditures have been made by the committee or candidate during the reporting period, including the
 amount, date, and purpose of each expenditure and the total amount of expenditures made to each person;

(ii) the full name, mailing address, occupation, and principal place of business, if any, of each person to
whom an expenditure for personal services, salaries, and reimbursed expenses has been made, including the
amount, date, and purpose of that expenditure and the total amount of expenditures made to each person;

(iii) the total sum of expenditures made by a political committee or candidate during the reporting period;
 (iv) the name and address of each political committee or candidate to which the reporting committee or

20 candidate made any transfer of funds, together with the amount and dates of all transfers;

(v) the name of any person to whom a loan was made during the reporting period, including the full
name, mailing address, occupation, and principal place of business, if any, of that person and the full names,
mailing addresses, occupations, and principal places of business, if any, of the endorsers, if any, and the date
and amount of each loan;

(vi) the amount and nature of debts and obligations owed by a political committee or candidate in the form
 prescribed by the commissioner; and

(vii) other information that may be required by the commissioner to fully disclose the disposition of fundsused to support or oppose candidates or issues.

(b) Reports of expenditures made to a consultant, advertising agency, polling firm, or other person that
 performs services for or on behalf of a candidate or political committee must be itemized and described in

1 sufficient detail to disclose the specific services performed by the entity to which payment or reimbursement was

2 made.

- 3 (c) A candidate is required to report the information specified in this subsection (2) only if the transactions
- 4 involved were undertaken for the purpose of supporting or opposing a candidate."
