4 A BILL FOR AN ACT ENTITLED: "AN ACT REQUIRING THE SUICIDE PREVENTION OFFICER TO PROVIDE
5 SUICIDE PREVENTION MATERIALS TO THE DEPARTMENT OF FISH, WILDLIFE, AND PARKS; REQUIRING
6 THE DEPARTMENT OF FISH, WILDLIFE, AND PARKS TO DISTRIBUTE SUICIDE PREVENTION MATERIALS
7 IN HUNTER SAFETY AND EDUCATION COURSES; AND AMENDING SECTION 53-21-1101, MCA."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11 **Section 1.** Section 53-21-1101, MCA, is amended to read:

12 **"53-21-1101. Suicide prevention officer -- duties.** (1) The department of public health and human
13 services shall implement a suicide prevention program administered by a suicide prevention officer attached to
14 the office of the director of the department.

15 (2) The suicide prevention officer shall:

16 (a) coordinate all suicide prevention activities being conducted by the department, including activities
17 in the addictive and mental disorders division, the health resources division, and the public health and safety
18 division, and coordinate with any suicide prevention activities that are conducted by other state agencies,
19 including the office of the superintendent of public instruction, the department of corrections, the department of
20 military affairs, and the university system;

21 (b) develop a biennial suicide reduction plan that addresses reducing suicides by Montanans of all ages,
22 ethnic groups, and occupations;

23 (c) direct a statewide suicide prevention program with evidence-based activities that include but are not
24 limited to:

25 (i) conducting statewide public awareness campaigns aimed at normalizing the need for all Montanans
26 to address mental health problems and utilizing both paid and free media, including digital and social media, and
27 including input from government agencies, school representatives from elementary schools through higher
28 education, mental health advocacy groups, veteran groups, and other relevant nonprofit organizations;

29 (ii) initiating, in partnership with Montana's tribes and tribal organizations, a public awareness program
30 that is culturally appropriate and that utilizes the modalities best suited for Indian country;

1 (iii) seeking opportunities for research that will improve understanding of suicide in Montana and provide
2 increased suicide-related services;

3 (iv) training for medical professionals, military personnel, school personnel, social service providers, and
4 the general public on recognizing the early warning signs of suicidality, depression, and other mental illnesses;
5 and

6 (v) providing grants to entities, including but not limited to tribes, tribal and urban health organizations,
7 local governments, schools, health care providers, professional associations, and other nonprofit and community
8 organizations, for development or expansion of evidence-based suicide prevention programs in accordance with
9 the requirements of 53-21-1111; and

10 (d) provide the director of the department of fish, wildlife, and parks provided for in 2-15-3401 with a
11 suicide prevention pamphlet or information sheet that the department of fish, wildlife, and parks shall distribute
12 to all individuals attending a hunter safety and education course pursuant to 87-2-105."
