12	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

14	NEW SECTION. Section 1. Transfer of funds. By August 1, 2013, the state treasurer shall transfer		
15	\$500,000 from the orphan share state special revenue account established in 75-10-743 to the fire suppression		
16	account established in 76-13-150.		
17			
18	NEW SECTION. Section 2. Appropriation. For the biennium beginning July 1, 2013, there is		
19	appropriated \$500,000 from the fire suppression account established in 76-13-150 to the department of natural		
20	resources and conservation for the purchase and design of fire engines and for development of fire engine		
21	technology.		
22			
23	NEW SECTION. Section 3. Transfer of funds. By August 1, 2013, the state treasurer shall transfer		
24	\$1,500,000 from the orphan share state special revenue account established in 75-10-743 to the Montana		
25	heritage preservation and development account established in 22-3-1004.		
26			
27	NEW SECTION. Section 4. Appropriation. For the biennium beginning July 1, 2013, there is		
28	appropriated \$1,500,000 from the Montana heritage preservation and development account established in		
29	22-3-1004 to the Montana heritage preservation and development commission for capital improvement projects		
30	in Virginia City and Nevada City.

<u>NEW SECTION.</u> **Section 4. Transfer of funds.** By August 1, 2013, the state treasurer shall transfer \$460,000 from the orphan share state special revenue account established in 75-10-743 to the state special revenue fund in the account established for miscellaneous funds received for state parks.

<u>NEW SECTION.</u> **Section 5. Appropriation.** For the biennium beginning July 1, 2013, there is appropriated \$160,000 from the state special revenue fund in the account established for miscellaneous funds received for state parks to the parks division of the department of fish, wildlife, and parks to stabilize and reconstruct the dam at McCarty pond and to reroof the visitor center in Makoshika state park.

<u>NEW SECTION.</u> **Section 6. Appropriation.** For the biennium beginning July 1, 2013, there is appropriated \$50,000 from the state special revenue fund in the account established for miscellaneous funds received for state parks to the parks division of the department of fish, wildlife, and parks for construction of the Pow Wow Arbor at the First People's Buffalo Jump.

<u>NEW SECTION.</u> **Section 7. Appropriation.** For the biennium beginning July 1, 2013, there is appropriated \$250,000 from the state special revenue fund in the account established for miscellaneous funds received for state parks to the parks division of the department of fish, wildlife, and parks for parking lot construction at Flathead Lake.

NEW SECTION. Section 8. Effective date. [This act] is effective July 1, 2013.
