A BILL FOR AN ACT ENTITLED: "~~AN ACT REVISING THE VALUATION AND TAXATION OF CERTAIN AGRICULTURAL LAND AND RELATED LAWS; REQUIRING THE DEPARTMENT OF REVENUE TO CORRECT THE 2002 BASE YEAR PRODUCTIVE CAPACITY VALUES OF CERTAIN AGRICULTURAL LAND AS THE BASIS FOR PHASING IN 2008 BASE YEAR PRODUCTIVE CAPACITY VALUES; REQUIRING THE DEPARTMENT OF REVENUE TO PROVIDE A REFUND TO CERTAIN OWNERS OF AGRICULTURAL LAND FOR TAXES ERRONEOUSLY COLLECTED; CREATING AN AGRICULTURAL LAND ADVISORY COMMITTEE TO ADVISE THE DEPARTMENT OF REVENUE ON IMPROVING THE VALUATION OF AGRICULTURAL LAND; DIRECTING THE AGRICULTURAL LAND ADVISORY COMMITTEE TO REPORT TO THE REVENUE AND TRANSPORTATION INTERIM COMMITTEE; REQUIRING THAT THE AGRICULTURAL LAND ADVISORY COMMITTEE ASSIST THE DEPARTMENT OF REVENUE IN THE VALUATION OF AGRICULTURAL LAND; PROVIDING A STATUTORY APPROPRIATION FOR THE PAYMENT OF PROPERTY TAX REFUNDS; AMENDING SECTIONS 15-7-102, 15-7-111, SECTION 15-7-201, 15-7-202, AND 17-7-502, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE AND RETROACTIVE APPLICABILITY DATES.~~"

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

NEW SECTION. Section 1. Agricultural land advisory committee -- appointment -- duties. (1) (a)

There is an agricultural land advisory committee of persons knowledgeable in agriculture and agricultural economics. The advisory committee must include one staff member of the Montana state university-Bozeman, college of agriculture. The committee consists of seven members:

(i) three persons appointed by the president of the senate, one of whom must be the staff member of Montana state university-Bozeman. The president shall appoint one of the other two appointees as presiding officer of the committee.

(ii) two persons appointed by the speaker of the house of representatives; and

(iii) two persons appointed by the governor.

(b) The appointments must be made by July 1 of each odd-numbered year and expire on June 30 of the

1 subsequent odd-numbered year. Any vacancy must be filled by the appointing authority of the member causing
2 the vacancy. Members are entitled to meals, lodging, and transportation reimbursement as provided in 2-18-501
3 through 2-18-503.

4 (2) In addition to advising the department as provided in 15-7-201, the committee shall:

5 (a) investigate problems that have arisen concerning the use of soil surveys in the valuation of class
6 three property described in 15-6-133; and

7 (b) assist the department in providing transparency, efficiency, and taxpayer understanding of the
8 valuation of agricultural land.

9 (3) The committee may meet as frequently as it considers necessary, but not less than once each
10 calendar quarter beginning July 1, 2011.

11 (4) The department shall provide support for the committee, including staff support by departmental
12 rangeland and geographic information system specialists.

13 (5) By May 31, 2012, the committee shall report to the revenue and transportation interim committee its
14 recommendations in identifying, evaluating, and providing possible solutions to problems that arose in valuing
15 agricultural property during the last reappraisal cycle through the use of soil surveys.

16 (6) On an ongoing basis, the committee shall advise the department on:

17 (a) establishing transparency and understanding of the agricultural land valuation process;

18 (b) providing taxpayer information on the valuation of agricultural land online that is up-to-date and
19 understandable and includes maps and geographical information system information;

20 (c) reviewing and reevaluating the agricultural land classification system, including but not limited to
21 productivity, soils, and moisture;

22 (d) defining and establishing a method to value or exempt agricultural land significantly affected by:

23 (i) soil type and the chemical content of the soil;

24 (ii) slope, aspect, and elevation of the land;

25 (iii) water levels;

26 (iv) wildlife and nonproductive vegetation;

27 (v) rock outcroppings or other natural or constructed physical impediments that limit or prohibit use of
28 the land; and

29 (vi) any other factors that the committee considers appropriate;

30 (e) what constitutes credible documentation necessary for adjusting an individual's or region's productive

1 capacity values;

2 (f) developing a procedure for an agricultural producer to gather and present appropriate evidence during
3 an assessment review or formal protest of valuation; and

4 (g) any other relevant issues and recommended legislation.

6 ~~NEW SECTION. Section 2. Agricultural land taxation -- legislative findings -- declaration of
7 purpose -- phase-in criteria.~~ (1) The legislature finds that:

8 ~~(a) the department incorrectly revalued a substantial portion of agricultural land described in
9 15-6-133(1)(A) during the revaluation period completed December 31, 2008;~~

10 ~~(b) the department did not phase in the revaluation of agricultural land for the revaluation completed on
11 December 31, 2008, as the legislature intended under the provisions of Chapter 483, Laws of 2009; and~~

12 ~~(c) the department's method of revaluing agricultural land and the method for phasing in the revaluation
13 of agricultural land resulted in the erroneous and unfair taxation of agricultural land.~~

14 ~~(2) The legislature declares that it is the purpose of [sections 2 and 3] to restore equity in the taxation
15 of agricultural land and to provide refunds to owners of agricultural land who were erroneously and unfairly taxed
16 on the phase-in value of their land.~~

17 ~~(3) In order to remedy the erroneous and unfair taxation of agricultural land DESCRIBED IN 15-6-133(1)(A),
18 the department shall, by December 31, 2011, recompute the phase-in of the 2008 base value of agricultural land
19 as provided in this section.~~

20 ~~(4) For an agricultural parcel that had a change in acreage from the 2002 base year because the parcel
21 was subdivided or was combined with another parcel of agricultural land or there was a change in a parcel
22 description that was attributable to a change in mapping of the parcel, an error in an earlier description of the
23 parcel, or another change that was not the result of the taxpayer's agricultural decision, the department shall
24 determine the productive capacity value of the land for the 2002 base year. The department shall phase in the
25 difference between 2008 base year productive capacity value and the 2002 base year productive capacity value
26 determined under this subsection for tax years 2009 through 2014 at 16.66% a year. IF THE 2008 BASE YEAR
27 PRODUCTIVE CAPACITY VALUE IS LESS THAN THE 2002 BASE YEAR PRODUCTIVE CAPACITY VALUE, THE 2008 PRODUCTIVE
28 CAPACITY VALUE IS NOT PHASED IN FOR TAX YEARS 2009 THROUGH 2014.~~

29 ~~(5) For an agricultural parcel that was reclassified or a parcel that was reclassified in a different
30 subclassification after the 2002 revaluation, the department shall calculate a productive capacity value of the~~

1 parcel as if the land had been reclassified in the 2002 base year by determining an average productive capacity
 2 value per acre for similarly classified parcels in the county in 2002 and multiplying the average productive
 3 capacity value by the acres in the parcel to determine the 2002 base value of the parcel. The department shall
 4 phase in the difference between the 2008 base year productive capacity value and the 2002 base year productive
 5 capacity value determined under this subsection for tax years 2009 through 2014 at 16.66% a year. ~~IF THE 2008~~
 6 ~~BASE YEAR PRODUCTIVE CAPACITY VALUE IS LESS THAN THE 2002 BASE YEAR PRODUCTIVE CAPACITY VALUE, THE 2008~~

8 ~~—— (6) (a) The department shall provide notice under 15-7-102 to the owner of agricultural land of the~~
 9 ~~change in value. The taxpayer may request an assessment review as provided in 15-7-102.~~

10 ~~—— (b) The department shall mail to each county assessment notices containing the phase-in values~~
 11 ~~determined under this section. The revised phase-in values must be used to certify taxable value to the county.~~
 12 ~~The adjustments to taxable value apply only to tax years 2012, 2013, and 2014.~~

13 ~~—— (7) This section does not apply to:~~

14 ~~—— (a) agricultural parcels for which a final appeal has been granted to the taxpayer by the department, a~~

 20 ~~—— NEW SECTION. **Section 3. Refund of erroneously collected taxes -- appropriation.** (1) (a) To~~
 21 ~~further remedy the erroneous and unfair taxation of agricultural land for tax years 2009, 2010, and 2011, the~~
 22 ~~department shall, by June 15, 2012, compute a refund for each taxpayer caused by a reduction in the taxable~~
 23 ~~value based on the recomputation of the phase-in of the productive capacity value of agricultural parcels under~~
 24 ~~[section 2]. The refund for each of the tax years 2009, 2010, and 2011 is equal to the difference between the~~
 25 ~~original taxable value of the agricultural parcel in the relevant tax year times the mill levies imposed in that tax~~
 26 ~~year and the taxable value of the parcel based on the recomputation of phase-in value of the parcel in the relevant~~
 27 ~~tax year times the mill levy imposed in that tax year.~~

28 ~~—— (b) (i) The department shall, by June 15, 2011, compute the refund for each taxpayer whose phased-in~~

 30 ~~42-20-607. The refund for tax year 2009 is equal to the difference between the original taxable value of the~~

1 agricultural parcel in the 2009 tax year times the mill levies imposed in that tax year and the taxable value of the
 2 parcel based on the recomputation of the phase in of changes in productivity only in tax year 2009 times the mill
 3 levy imposed in that tax year.

4 ~~———(ii) A taxpayer who timely filed an appeal of valuation based on changes in productivity only for the~~
 5 ~~agricultural parcel to the department, a county tax appeal board, or the state tax appeal board in tax year 2009~~
 6 ~~and received a refund of property taxes is not entitled to a refund under this subsection (1)(b). A taxpayer who~~
 7 ~~timely filed an appeal but did not receive a refund may be eligible for a refund under subsection (1)(b)(i).~~

8 ~~———(2) The department shall, by June 30, 2012, distribute refunds calculated under this section to each~~
 9 ~~taxpayer less any refund of protested taxes amounts that the taxpayer is entitled to under 15-1-402 because of~~
 10 ~~the recomputation of the phase-in value required by [section 1]. Interest on the refund must be determined as~~
 11 ~~provided in 15-1-402. A taxpayer is not entitled to a refund under this section unless all taxes on the parcel have~~

 18 ~~in 15-7-138, the department shall mail to each owner or purchaser under contract for deed a notice of the~~
 19 ~~classification of the land owned or being purchased and the appraisal of the improvements on the land only if one~~
 20 ~~or more of the following changes pertaining to the land or improvements have been made since the last notice:~~

21 ~~———(i) change in ownership;~~

19 ~~(2)(a) are mailed. The department shall notify the county tax appeal board of the date of the mailing.~~
20 ~~———(3) If the owner of any land and improvements is dissatisfied with the appraisal as it reflects the market~~
21 ~~value of the property as determined by the department or with the classification of the land or improvements, the~~
22 ~~owner may request an assessment review by submitting an objection in writing to the department, on forms~~
23 ~~provided by the department for that purpose, within 30 days after receiving the notice of classification and~~

 23 ~~15-6-134, and class ten under 15-6-143. All other property must be revalued annually.~~
 24 ~~——— (2) The department shall value and phase in the value of newly constructed, remodeled, or reclassified~~
 25 ~~property in a manner consistent with the valuation within the same class and the values established pursuant to~~
 26 ~~subsection (1). The department shall adopt rules for determining the assessed valuation and phased-in value of~~

11 **Section 2.** Section 15-7-201, MCA, is amended to read:

12 **"15-7-201. Legislative intent -- value of agricultural property.** (1) Because the market value of many
 13 agricultural properties is based upon speculative purchases that do not reflect the productive capability of
 14 agricultural land, it is the legislative intent that bona fide agricultural properties be classified and assessed at a
 15 value that is exclusive of values attributed to urban influences or speculative purposes.

16 (2) Agricultural land must be classified according to its use, which classifications include but are not
 17 limited to irrigated use, nonirrigated use, and grazing use.

18 (3) Within each class, land must be subclassified by production categories. Production categories are
 19 determined from the productive capacity of the land based on yield.

20 (4) ~~In Subject to [section 2], in IN~~ computing the agricultural land valuation schedules to take effect on
 21 the date when each revaluation cycle takes effect pursuant to 15-7-111, the department of revenue shall
 22 determine the productive capacity value of all agricultural lands using the formula $V = I/R$ where:

23 (a) V is the per-acre productive capacity value of agricultural land in each land use and production
 24 category;

25 (b) I is the per-acre net income of agricultural land in each land use and production category and is to
 26 be determined as provided in subsection (5); and

27 (c) R is the capitalization rate and, unless the agricultural land advisory committee created under [section
 28 1] recommends a different rate and the department adopts the recommended capitalization rate by rule, is equal
 29 to 6.4%. This capitalization rate must remain in effect until the next revaluation cycle.

30 (5) (a) Net income must be determined separately in each land use based on production categories.

1 (b) Net income must be based on commodity price data, which may include grazing fees, crop and
2 livestock share arrangements, cost of production data, and water cost data for the base period using the best
3 available data.

4 (i) Commodity price data and cost of production data for the base period must be obtained from the
5 Montana Agricultural Statistics, the Montana crop and livestock reporting service, and other sources of publicly
6 available information if considered appropriate by the agricultural land advisory committee.

7 (ii) Crop share and livestock share arrangements are based on typical agricultural business practices and
8 average landowner costs.

9 (iii) Allowable water costs consist only of the per-acre labor costs, energy costs of irrigation, and, unless
10 the agricultural land advisory committee recommends otherwise and the department adopts the recommended
11 cost by rule, a base water cost of \$15 for each acre of irrigated land. Total allowable water costs may not exceed
12 \$50 for each acre of irrigated land. Labor and energy costs must be determined as follows:

13 (A) Labor costs are \$5 an acre for pivot sprinkler irrigation systems; \$10 an acre for tow lines, side roll,
14 and lateral sprinkler irrigation systems; and \$15 an acre for hand-moved and flood irrigation systems.

15 (B) Energy costs must be based on per-acre energy costs incurred in the energy cost base year, which
16 is the calendar year immediately preceding the year specified by the department in 15-7-103(5). By July 1 of the
17 year following the energy cost base year, an owner of irrigated land shall provide the department, on a form
18 prescribed by the department, with energy costs incurred in that energy cost base year. In the event that no
19 energy costs were incurred in the energy cost base year, the owner of irrigated land shall provide the department
20 with energy costs from the most recent year available. The department shall adjust the most recent year's energy
21 costs to reflect costs in the energy cost base year.

22 (c) The base crop for valuation of irrigated land is alfalfa hay adjusted to 80% of the sales price, and the
23 base crop for valuation of nonirrigated land is spring wheat. The base unit for valuation of grazing lands is animal
24 unit months (AUM), defined as the average monthly requirement of pasture forage to support a 1,000-pound cow
25 with a calf or its equivalent.

26 (d) Unless the agricultural land advisory committee recommends a different base period and the
27 department adopts the recommended base period by rule, the base period used to determine net income must
28 be the most recent 7 years for which data is available prior to the date the revaluation cycle ends. Unless the
29 agricultural land advisory committee recommends a different averaging method and the department adopts the
30 recommended averaging method by rule, data referred to in subsection (5)(b) must be averaged, but the average

1 must exclude the lowest and highest yearly data in the period.

2 (6) The department shall compile data and develop valuation manuals adopted by rule to implement the
3 valuation method established by subsections (4) and (5).

4 (7) ~~The governor shall appoint an advisory committee of persons knowledgeable in agriculture and
5 agricultural economics. The advisory committee shall include one member of the Montana state
6 university-Bozeman, college of agriculture, staff. The~~ In addition to the duties specified in [section 1], the
7 agricultural land advisory committee shall:

8 (a) compile and review data required by subsections (4) and (5);

9 (b) evaluate the information, data, and procedures that should be used by the department for determining
10 the productive capacity value of agricultural land;

11 ~~(b)(c)~~ recommend to the department any adjustments to data or to landowners' share percentages if
12 required by changes in government agricultural programs, market conditions, or prevailing agricultural practices;

23 160 acres or more under one ownership are eligible for valuation, assessment, and taxation as agricultural land
24 each year that none of the parcels is devoted to a residential, commercial, or industrial use:~~

25 ~~(b) (i) Contiguous parcels of land of 20 acres or more but less than 160 acres under one ownership that
26 are actively devoted to agricultural use are eligible for valuation, assessment, and taxation as agricultural land
27 if:~~

28 ~~(A) the land is used primarily for raising and marketing, as defined in subsection (1)(c), products that
29 meet the definition of agricultural in 15-1-101 and if, except as provided in subsection (3), the owner or the
