BY REQUEST OF THE DEPARTMENT OF PUBLIC HEALTH AND HUMAN SERVICES

A BILL FOR AN ACT ENTITLED: "AN ACT REVISING LAWS RELATED TO ASSISTANCE FOR LOW-INCOME FAMILIES WITH DEPENDENT CHILDREN; REMOVING OUTDATED TERMINOLOGY; PROVIDING DEFINITIONS; CLARIFYING APPLICATION AND ELIGIBILITY PROCESSES; AMENDING SECTIONS 39-7-303, 39-71-118, 40-4-215, 52-2-710, 53-2-201, 53-2-211, 53-2-215, 53-2-606, 53-2-613, 53-2-901, 53-2-902, 53-2-903, 53-3-115, 53-4-201, 53-4-202, 53-4-212, 53-4-221, 53-4-231, 53-4-232, 53-4-233, 53-4-241, 53-4-244, 53-4-602, 53-4-611, 53-4-613, 53-4-702, 53-4-704, 53-4-705, 53-4-706, 53-4-717, AND 53-6-101, MCA; REPEALING SECTIONS 53-4-216, 53-4-250, 53-4-255, 53-4-256, 53-4-257, 53-4-601, 53-4-606, 53-4-609, 53-4-612, AND 53-4-721, MCA; AND PROVIDING AN EFFECTIVE DATE."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Section 39-7-303, MCA, is amended to read:

"39-7-303. Definitions. As used in this part, the following definitions apply:

(1) "Adult" means a person who is 18 years of age or older.

(2) "Commissioner" means the commissioner of labor and industry as provided in 2-15-1701.

(3) "Displaced homemaker" means an adult who:

(a) has worked as an adult primarily without remuneration to care for the home and family and for that reason has diminished marketable skills and who has been dependent on public assistance or on the income of a relative but is no longer supported by that income; or

(b) (i) is a parent whose youngest dependent child will become ineligible to receive financial cash assistance, as defined in 53-4-201, pursuant to Title 53, chapter 4, part 2, within 2 years of the parent's application for displaced homemaker assistance;

(ii) is unemployed or underemployed and is experiencing difficulty in obtaining any employment or suitable employment, as appropriate; or

(iii) meets the qualifications described in subsection (3)(a) or (3)(b) and is a criminal offender."

1 **Section 2.** Section 39-71-118, MCA, is amended to read:

2 **"39-71-118. Employee, worker, volunteer, volunteer firefighter, and volunteer emergency medical**
3 **technician defined -- election of coverage.** (1) As used in this chapter, the term "employee" or "worker" means:

4 (a) each person in this state, including a contractor other than an independent contractor, who is in the
5 service of an employer, as defined by 39-71-117, under any appointment or contract of hire, expressed or implied,
6 oral or written. The terms include aliens and minors, whether lawfully or unlawfully employed, and all of the
7 elected and appointed paid public officers and officers and members of boards of directors of quasi-public or
8 private corporations, except those officers identified in 39-71-401(2), while rendering actual service for the
9 corporations for pay. Casual employees, as defined by 39-71-116, are included as employees if they are not
10 otherwise covered by workers' compensation and if an employer has elected to be bound by the provisions of
11 the compensation law for these casual employments, as provided in 39-71-401(2). Household or domestic
12 employment is excluded.

13 (b) any juvenile who is performing work under authorization of a district court judge in a delinquency
14 prevention or rehabilitation program;

15 (c) a person who is receiving on-the-job vocational rehabilitation training or other on-the-job training
16 under a state or federal vocational training program, whether or not under an appointment or contract of hire with
17 an employer, as defined in 39-71-117, and, except as provided in subsection (9), whether or not receiving
18 payment from a third party. However, this subsection (1)(c) does not apply to students enrolled in vocational
19 training programs, as outlined in this subsection, while they are on the premises of a public school or community
20 college.

21 (d) an aircrew member or other person who is employed as a volunteer under 67-2-105;

22 (e) a person, other than a juvenile as described in subsection (1)(b), who is performing community
23 service for a nonprofit organization or association or for a federal, state, or local government entity under a court
24 order, or an order from a hearings officer as a result of a probation or parole violation, whether or not under
25 appointment or contract of hire with an employer, as defined in 39-71-117, and whether or not receiving payment
26 from a third party. For a person covered by the definition in this subsection (1)(e):

27 (i) compensation benefits must be limited to medical expenses pursuant to 39-71-704 and an impairment
28 award pursuant to 39-71-703 that is based upon the minimum wage established under Title 39, chapter 3, part
29 4, for a full-time employee at the time of the injury; and

30 (ii) premiums must be paid by the employer, as defined in 39-71-117(3), and must be based upon the

1 minimum wage established under Title 39, chapter 3, part 4, for the number of hours of community service
2 required under the order from the court or hearings officer.

3 (f) an inmate working in a federally certified prison industries program authorized under 53-30-132;

4 (g) a volunteer firefighter as described in 7-33-4109 or a person who provides ambulance services under
5 Title 7, chapter 34, part 1;

6 (h) a person placed at a public or private entity's worksite pursuant to 53-4-704. The person is
7 considered an employee for workers' compensation purposes only. The department of public health and human
8 services shall provide workers' compensation coverage for recipients of ~~financial~~ cash assistance, as defined in
9 53-4-201, or for participants in the food stamp program, as defined in 53-2-902, who are placed at public or
10 private worksites through an endorsement to the department of public health and human services' workers'
11 compensation policy naming the public or private worksite entities as named insureds under the policy. The
12 endorsement may cover only the entity's public assistance participants and may be only for the duration of each
13 participant's training while receiving ~~financial~~ cash assistance or while participating in the food stamp program
14 under a written agreement between the department of public health and human services and each public or
15 private entity. The department of public health and human services may not provide workers' compensation
16 coverage for individuals who are covered for workers' compensation purposes by another state or federal
17 employment training program. Premiums and benefits must be based upon the wage that a probationary
18 employee is paid for work of a similar nature at the assigned worksite.

19 (i) subject to subsection (11), a member of a religious corporation, religious organization, or religious
20 trust while performing services for the religious corporation, religious organization, or religious trust, as described
21 in 39-71-117(1)(d).

22 (2) The terms defined in subsection (1) do not include a person who is:

23 (a) performing voluntary service at a recreational facility and who receives no compensation for those
24 services other than meals, lodging, or the use of the recreational facilities;

25 (b) performing services as a volunteer, except for a person who is otherwise entitled to coverage under
26 the laws of this state. As used in this subsection (2)(b), "volunteer" means a person who performs services on
27 behalf of an employer, as defined in 39-71-117, but who does not receive wages as defined in 39-71-123.

28 (c) serving as a foster parent, licensed as a foster care provider in accordance with 52-2-621, and
29 providing care without wage compensation to no more than six foster children in the provider's own residence.
30 The person may receive reimbursement for providing room and board, obtaining training, respite care, leisure

1 and recreational activities, and providing for other needs and activities arising in the provision of in-home foster
2 care.

3 (d) performing temporary agricultural work for an employer if the person performing the work is otherwise
4 exempt from the requirement to obtain workers' compensation coverage under 39-71-401(2)(r) with respect to
5 a company that primarily performs agricultural work at a fixed business location or under 39-71-401(2)(d) and is
6 not required to obtain an independent contractor's exemption certificate under 39-71-417 because the person
7 does not regularly perform agricultural work away from the person's own fixed business location. For the
8 purposes of this subsection, the term "agricultural" has the meaning provided in 15-1-101(1)(a).

9 (3) With the approval of the insurer, an employer may elect to include as an employee under the
10 provisions of this chapter a volunteer as defined in subsection (2)(b) or a volunteer firefighter as defined in
11 7-33-4510.

12 (4) (a) If the employer is a partnership, limited liability partnership, sole proprietor, or a member-managed
13 limited liability company, the employer may elect to include as an employee within the provisions of this chapter
14 any member of the partnership or limited liability partnership, the owner of the sole proprietorship, or any member
15 of the limited liability company devoting full time to the partnership, limited liability partnership, proprietorship, or
16 limited liability company business.

17 (b) In the event of an election, the employer shall serve upon the employer's insurer written notice
18 naming the partners, sole proprietor, or members to be covered and stating the level of compensation coverage
19 desired by electing the amount of wages to be reported, subject to the limitations in subsection (4)(d). A partner,
20 sole proprietor, or member is not considered an employee within this chapter until notice has been given.

21 (c) A change in elected wages must be in writing and is effective at the start of the next quarter following
22 notification.

23 (d) All weekly compensation benefits must be based on the amount of elected wages, subject to the
24 minimum and maximum limitations of this subsection (4)(d). For premium ratemaking and for the determination
25 of the weekly wage for weekly compensation benefits, the electing employer may elect an amount of not less than
26 \$900 a month and not more than 1 1/2 times the state's average weekly wage.

27 (5) (a) If the employer is a quasi-public or a private corporation or a manager-managed limited liability
28 company, the employer may elect to include as an employee within the provisions of this chapter any corporate
29 officer or manager exempted under 39-71-401(2).

30 (b) In the event of an election, the employer shall serve upon the employer's insurer written notice

1 naming the corporate officer or manager to be covered and stating the level of compensation coverage desired
2 by electing the amount of wages to be reported, subject to the limitations in subsection (5)(d). A corporate officer
3 or manager is not considered an employee within this chapter until notice has been given.

4 (c) A change in elected wages must be in writing and is effective at the start of the next quarter following
5 notification.

6 (d) For the purposes of an election under this subsection (5), all weekly compensation benefits must be
7 based on the amount of elected wages, subject to the minimum and maximum limitations of this subsection (5)(d).
8 For premium ratemaking and for the determination of the weekly wage for weekly compensation benefits, the
9 electing employer may elect an amount of not less than \$200 a week and not more than 1 1/2 times the state's
10 average weekly wage.

11 (6) Except as provided in Title 39, chapter 8, an employee or worker in this state whose services are
12 furnished by a person, association, contractor, firm, limited liability company, limited liability partnership, or
13 corporation, other than a temporary service contractor, to an employer, as defined in 39-71-117, is presumed to
14 be under the control and employment of the employer. This presumption may be rebutted as provided in
15 39-71-117(3).

16 (7) A student currently enrolled in an elementary, secondary, or postsecondary educational institution
17 who is participating in work-based learning activities and who is paid wages by the educational institution or
18 business partner is the employee of the entity that pays the student's wages for all purposes under this chapter.
19 A student who is not paid wages by the business partner or the educational institution is a volunteer and is subject
20 to the provisions of this chapter.

21 (8) For purposes of this section, an "employee or worker in this state" means:

22 (a) a resident of Montana who is employed by an employer and whose employment duties are primarily
23 carried out or controlled within this state;

24 (b) a nonresident of Montana whose principal employment duties are conducted within this state on a
25 regular basis for an employer;

26 (c) a nonresident employee of an employer from another state engaged in the construction industry, as
27 defined in 39-71-116, within this state; or

28 (d) a nonresident of Montana who does not meet the requirements of subsection (8)(b) and whose
29 employer elects coverage with an insurer that allows an election for an employer whose:

30 (i) nonresident employees are hired in Montana;

- 1 (ii) nonresident employees' wages are paid in Montana;
2 (iii) nonresident employees are supervised in Montana; and
3 (iv) business records are maintained in Montana.

4 (9) An insurer may require coverage for all nonresident employees of a Montana employer who do not
5 meet the requirements of subsection (8)(b) or (8)(d) as a condition of approving the election under subsection
6 (8)(d).

7 (10) (a) An ambulance service not otherwise covered by subsection (1)(g) or a paid or volunteer
8 nontransporting medical unit, as defined in 50-6-302, in service to a town, city, or county may elect to include as
9 an employee within the provisions of this chapter a volunteer emergency medical technician who serves public
10 safety through the ambulance service not otherwise covered by subsection (1)(g) or the paid or volunteer
11 nontransporting medical unit. The ambulance service or nontransporting medical unit may purchase workers'
12 compensation coverage from any entity authorized to provide workers' compensation coverage under plan No.
13 1, 2, or 3 as provided in this chapter.

14 (b) If there is an election under subsection (10)(a), the employer shall report payroll for all volunteer
15 emergency medical technicians for premium and weekly benefit purposes based on the number of volunteer
16 hours of each emergency medical technician, but no more than 60 hours, times the state's average weekly wage
17 divided by 40 hours.

18 (c) An ambulance service not otherwise covered by subsection (1)(g) or a paid or volunteer
19 nontransporting medical unit, as defined in 50-6-302, may make a separate election to provide benefits as
20 described in this subsection (10) to a member who is either a self-employed sole proprietor or partner who has
21 elected not to be covered under this chapter, but who is covered as a volunteer emergency medical technician
22 pursuant to subsection (10)(a). When injured in the course and scope of employment as a volunteer emergency
23 medical technician, a member may instead of the benefits described in subsection (10)(b) be eligible for benefits
24 at an assumed wage of the minimum wage established under Title 39, chapter 3, part 4, for 2,080 hours a year.
25 If the separate election is made as provided in this subsection (10), payroll information for those self-employed
26 sole proprietors or partners must be reported and premiums must be assessed on the assumed weekly wage.

27 (d) A volunteer emergency medical technician who receives workers' compensation coverage under this
28 section may not receive disability benefits under Title 19, chapter 17, if the individual is also eligible as a volunteer
29 firefighter.

30 (e) An ambulance service not otherwise covered by subsection (1)(g) or a nontransporting medical unit,

1 as defined in 50-6-302, that does not elect to purchase workers' compensation coverage for its volunteer
2 emergency medical technicians under the provisions of this section shall annually notify its volunteer emergency
3 medical technicians that coverage is not provided.

4 (f) (i) The term "volunteer emergency medical technician" means a person who has received a certificate
5 issued by the board of medical examiners as provided in Title 50, chapter 6, part 2, and who serves the public
6 through an ambulance service not otherwise covered by subsection (1)(g) or a paid or volunteer nontransporting
7 medical unit, as defined in 50-6-302, in service to a town, city, or county.

8 (ii) The term does not include a volunteer emergency medical technician who serves an employer as
9 defined in 7-33-4510.

10 (g) The term "volunteer hours" means the time spent by a volunteer emergency medical technician in
11 the service of an employer or as a volunteer for a town, city, or county, including but not limited to training time,
12 response time, and time spent at the employer's premises.

13 (11) The definition of "employee" or "worker" in subsection (1)(i) is limited to implementing the
14 administrative purposes of this chapter and may not be interpreted or construed to create an employment
15 relationship in any other context."

16

17 **Section 3.** Section 40-4-215, MCA, is amended to read:

18 **"40-4-215. Investigations and reports.** (1) If a parent or a court-appointed third party requests, or if
19 the court finds that a parenting proceeding is contested, the court may order an investigation and report
20 concerning parenting arrangements for the child. The investigator may be the child's guardian ad litem or other
21 professional considered appropriate by the court. The department of public health and human services may not
22 be ordered to conduct the investigation or draft a report unless the person requesting the investigation is a
23 recipient of ~~financial~~ cash assistance, as defined in 53-4-201, or a participant in the food stamp program, as
24 defined in 53-2-902, and all reasonable options for payment of the investigation, if conducted by a person not
25 employed by the department, are exhausted. The department may consult with any investigator and share
26 information relevant to the child's best interests. The cost of the investigation and report must be paid according
27 to the final order. The cost of the educational evaluation under subsection (2)(a) must be paid by the state as
28 provided in 3-5-901.

29 (2) The court shall determine, if appropriate, the level of evaluation necessary for adequate investigation
30 and preparation of the report, which may include one or more of the following:

- 1 (a) parenting education;
- 2 (b) mediation pursuant to 40-4-301;
- 3 (c) factfinding by the investigator; and
- 4 (d) psychological evaluation of the parties.
- 5 (3) In preparing a report concerning a child, the investigator may consult any person who has information
- 6 about the child and the child's potential parenting arrangements. Upon order of the court, the investigator may
- 7 refer the child to professional personnel for diagnosis. Except as required for children 16 years of age or older,
- 8 the investigator may consult with and obtain information from medical, psychiatric, or other expert persons who
- 9 have served the child in the past without obtaining the consent of the persons or entities authorized by law to
- 10 grant or withhold access to the records. The child's consent must be obtained if the child is 16 years of age or
- 11 older unless the court finds that the child lacks mental capacity to consent. If the requirements of subsection (4)
- 12 are fulfilled, the investigator's report may be received in evidence at the hearing.
- 13 (4) The investigator shall mail the investigator's report to counsel and to any party not represented by
- 14 counsel at least 10 days prior to the hearing. When consistent with state and federal law, the investigator shall
- 15 make available to counsel and to any party not represented by counsel the investigator's file of underlying data
- 16 and reports, complete texts of diagnostic reports made to the investigator pursuant to the provisions of subsection
- 17 (3), and the names and addresses of all persons whom the investigator has consulted. Any party to the
- 18 proceeding may call the investigator and any person the investigator has consulted for cross-examination. A party
- 19 may not waive the right of cross-examination prior to the hearing. The results of the investigation must be included
- 20 in the court record and may, without objection, be sealed."

21

22 **Section 4.** Section 52-2-710, MCA, is amended to read:

23 **"52-2-710. At-home infant care program -- definition.** (1) There is an at-home infant care program

24 for low-income families in which a parent provides full-time child care for the family's infant under 2 years of age

25 that will be funded if a specific appropriation is added to the general appropriations act or by budget amendment

26 if funds become available from federal or private sources. Subject to subsection (2), the family may receive a

27 payment in lieu of child-care assistance if the family meets the following eligibility requirements:

- 28 (a) The family is not receiving ~~financial~~ cash assistance under Title 53, chapter 4, parts 2 and 6.
- 29 (b) The family has not previously received a total of 24 months of at-home infant care assistance under
- 30 this section.

- 1 (c) The family is at or below 150% of the federal poverty level.
- 2 (d) The family has fulfilled the following work requirements for 1 out of the 3 months prior to entering the
3 program:
- 4 (i) 120 hours a month for two-parent families, which may be the contribution of one or both parents;
5 (ii) 60 hours a month for single-parent families;
6 (iii) 40 hours a month for single-parent families who are attending postsecondary education or training.
- 7 (e) A parent must be 18 years of age or older or, if under 18 years of age, have attained an equivalency
8 of completion of secondary education, as provided in 20-7-131, or a high school diploma.
- 9 (f) A parent must meet any additional requirements as provided in administrative rules.
- 10 (2) A parent who is under 18 years of age and attending high school or a program for equivalency of
11 completion of secondary education, as provided in 20-7-131, may receive benefits for months outside of the
12 regular school year.
- 13 (3) For the purposes of this section, "parent" means a birth parent, a stepparent, a foster parent, or a
14 guardian who is acting in loco parentis.
- 15 (4) The maximum rate of assistance allowed is equal to the amount of child-care assistance for infant
16 family care for the appropriate district, as adopted by the department by rule. The family may not receive
17 subsidies for child care for other children in the family.
- 18 (5) A participating family shall report income and other family changes as specified by rule. State
19 agencies shall treat income received under this program as earned income.
- 20 (6) Family members may participate in education and work activities as long as one or both parents
21 provide care full time for the infant."

22

23 **Section 5.** Section 53-2-201, MCA, is amended to read:

24 **"53-2-201. Powers and duties of department.** (1) The department shall:

- 25 (a) administer and supervise public assistance, including the provision of food stamps, food commodities,
26 ~~financial~~ cash assistance and nonfinancial assistance, as defined in 53-2-902, energy assistance, weatherization,
27 vocational rehabilitation, services for persons with severe disabilities, developmental disability services, medical
28 care payments in behalf of recipients of public assistance, employment and training services for recipients of
29 public assistance, and other programs as necessary to strengthen and preserve families;
- 30 (b) give consultant service to private institutions providing care for adults who are needy, indigent, or

1 dependent or who have disabilities;

2 (c) cooperate with other state agencies and develop provisions for services to the blind, including the
3 prevention of blindness, the location of blind persons, medical services for eye conditions, and vocational
4 guidance and training of the blind;

5 (d) organize and supervise the local offices of public assistance in an efficient and economical manner;

6 (e) assist and cooperate with other state and federal departments, bureaus, agencies, and institutions,
7 when requested, by performing services in conformity with public assistance purposes;

8 (f) administer all state and federal funds allocated to the department for public assistance and do all
9 things necessary, in conformity with federal and state law, for the proper fulfillment of public assistance purposes;

10 (g) make rules governing payment for services and supplies provided to recipients of public assistance;

11 and

12 (h) adopt rules regarding assignment of monetary and medical support upon application for ~~financial~~
13 cash assistance, as defined in 53-2-902, and related medical assistance.

14 (2) The department may:

15 (a) purchase, exchange, condemn, as provided in Title 70, chapter 30, or receive by gift either real or
16 personal property that is necessary to carry out its public assistance functions. Title to property obtained under
17 this subsection must be taken in the name of the state of Montana for the use and benefit of the department.

18 (b) contract with the federal government to carry out its public assistance functions. ~~The department may~~
19 ~~do all things necessary in order to avail itself of~~ and comply with requirements for receiving federal aid and
20 assistance; and

21 (c) make rules, consistent with state and federal law, establishing the amount, scope, and duration of
22 services to be provided to recipients of public assistance."
23

24 **Section 6.** Section 53-2-211, MCA, is amended to read:

25 **"53-2-211. Department to share eligibility data.** (1) The department shall make available to the
26 unemployment compensation program of the department of labor and industry all information contained in its files
27 and records pertaining to eligibility of persons for medicaid, ~~financial~~ cash assistance and nonfinancial assistance,
28 as defined in 53-2-902, and food stamps. The information made available must include information on the amount
29 and source of an applicant's income. ~~The department of labor and industry may use the~~ information received from
30 the department ~~must be used by the department of labor and industry only~~ MUST BE USED BY THE DEPARTMENT OF

1 LABOR AND INDUSTRY for the purpose of determining fraud, abuse, or eligibility for benefits under the
 2 unemployment compensation program ~~of the state and for no other purpose~~ OF THE STATE AND FOR NO OTHER
 3 PURPOSE.

4 (2) The department shall make available to the unemployment compensation and workers' compensation
 5 programs of the department of labor and industry all information contained in its files and records pertaining to
 6 eligibility of persons for low-income energy assistance and weatherization. The information made available must
 7 include information on the amount and source of an applicant's income. The ~~department of labor and industry may~~
 8 use the information received from the department ~~must be used by the department of labor and industry only~~
 9 MUST BE USED BY THE DEPARTMENT OF LABOR AND INDUSTRY for the purpose of determining fraud, abuse, or eligibility
 10 for benefits under the unemployment compensation and workers' compensation programs ~~of the state and for~~
 11 ~~no other purpose~~ OF THE STATE AND FOR NO OTHER PURPOSE.

12 (3) (a) Subject to federal restrictions, the department may request information from the department of
 13 labor and industry pertaining to unemployment, workers' compensation, and occupational disease benefits. If the
 14 department of labor and industry discovers evidence relating to fraud or abuse for unemployment, workers'
 15 compensation, or occupational benefits, the department of labor and industry may request information from the
 16 department of revenue pertaining to income as provided in 15-30-2618(9)(c).

17 (b) The information ~~must~~ may only MUST be used by the department for the purpose of determining fraud,
 18 abuse, or eligibility for benefits.

19 (4) The department may, to the extent permitted by federal law, make available to an agency of the state
 20 or to any other organization information contained in its files and records pertaining to the eligibility of persons
 21 for medicaid, ~~financial~~ cash assistance and nonfinancial assistance, as defined in 53-2-902, food stamps,
 22 low-income energy assistance, weatherization, or other public assistance."

23

24 **Section 7.** Section 53-2-215, MCA, is amended to read:

25 **"53-2-215. Social Security Act section 1115 waiver.** (1) The department may pursue approval from
 26 the U.S. department of health and human services for implementation in Montana of a health insurance flexibility
 27 and accountability demonstration initiative and other demonstration projects through section 1115 waivers.

28 (2) The department may implement a demonstration project upon approval of a section 1115 waiver by
 29 the U.S. department of health and human services. The department may:

30 (a) coordinate a demonstration project with a program approved through a section 1915 waiver; or

1 (b) terminate and subsume in a new section 1115 waiver an existing managed care or access program
 2 approved through a section 1915(b) waiver, an optional state plan medicaid service authorized under 53-6-101,
 3 an optional state plan eligibility group authorized under 53-6-131, or an existing program approved by a section
 4 1115 waiver, ~~inclusive of the demonstration program authorized by 53-4-202 and Title 53, chapter 4, part 6~~; that
 5 is administered by the department.

6 ~~(3) The department may amend the existing section 1115 demonstration project authorized in 53-4-604~~
