12	"(20) Sports wager or sports wagering. – Placing of wagers via a sports wagering		
13	platform on any portion of a sporting event, or on the individual performance		
14	statistics of athletes in a sporting event or combination of sporting events. The		
15	term also includes single-game wagers, teaser wagers, parlays, over-unde		
16	moneyline, pools, exchange wagering, in-game wagering, in-play wager		
17	proposition wagers, and straight wagers.";

19	and on page 9, line 35, through page 10, line 42, by deleting those lines.

21	and on page 14, lines 27-45, by rewriting those lines to read:		
22	"(a) The owner or operator of a sports facility may establish places of public		

23 accommodation for the purpose of accessing a sports vagering platform. Each owner or operator 24 of a sports facility shall be limited to one place of public accommodation described under 25 subsection (b) of this section.

26 (b) Places of public accommodation allowed under this section shall be located on the
27 property containing the sports facility.

(c) Nothing in this section shall be construed to exempt a place of public accommodation
from the provisions of any other law that may be enforceable. A place of public accommodation
may be either a permanent establishment or a temporary establishment associated with a specific

31 sporting event of a series of sporting events.

5	<u>(1)</u>	Any person under the age of 21.
6	<u>(2)</u>	Any person who has requested and not revoked a voluntary exclusion
7		designation from sports wagering pursuant to G.S. 18C-922.
8	<u>(3)</u>	Any person who has been adjudicated by law as prohibited from engaging in
9		sports wagering.
10	<u>(4)</u>	Any member, officer, or employee of the Commission if placing a sports
11		wager in this State.
12	<u>(5)</u>	Any employee or key person of an interactive sports wagering operator or
13		service provider license when placing sports wagers with that interactive
14		sports wagering operator.
15	<u>(6)</u>	With respect to a sporting event, any participant in that sporting event,
16		including an athlete, coach, trainer, official, or any employee or staff of a
17		participant, when placing a sports wager on that sporting event in which that
18		participant is participating.
19	<u>(7)</u>	Any employees or staff of a sports governing body or authorizing league or
20		similar sponsoring organization, but only from the sporting events with which
21		that individual or sports governing body, authorizing league or similar
22		sponsoring organization is affiliated.".
