3	The General Assembly of North Carolina enacts:
4	SECTION 1. G.S. 20-4.01 reads as rewritten:
5	"§ 20-4.01. Definitions.
6	Unless the context requires otherwise, the following definitions apply throughout this
7	Chapter to the defined words and phrases and their cognates:

9	(7c) <u>Electric vehicle charging station. – A public or private parking space that is</u>
10	served by charging equipment that has as its primary purpose the transfer of
11	electric energy to a battery or other energy storage device in an electric
12	<u>vehicle.</u>
13 14	(7c)(7d) Employer. – Any person who owns or leases a commercial motor vehicle or assigns a person to drive a commercial motor vehicle and would be subject
14	to the alcohol and controlled substance testing provisions of 49 C.F.R. § 382
15	and also includes any consortium or third-party administrator administering
17	the alcohol and controlled substance testing program on behalf of
18	owner-operators subject to the provisions of 49 C.F.R. § 382.

20	SECTION 2. Article 3 of Chapter 20 of the General Statutes is amended by adding
21	a new section to read:
22	"§ 20-162.4. Parking in a space designated as an electric vehicle charging station.
23	(a) <u>Prohibited Conduct. – No person may park a vehicle in an electric vehicle charging</u>
24	station located on public or private property if the vehicle is not connected to the charging
25	equipment.
26	(b) Signage. – A space designated as an electric vehicle charging station must be (i)
27	indicated by vertical signage identifying the station as an electric vehicle charging station and
28	indicating that it is only for electric vehicle charging and (ii) the signage must be consistent with
29	the Manual on Uniform Traffic Control Devices for Streets and Highways, published by the
30	United States Department of Transportation, and any supplement to that Manual adopted by the
31	North Carolina Department of Transportation.
32	(c) <u>Penalty. – Any person who commits a violation of subsection (a) of this section shall</u>
33 34	<u>be guilty of an infraction and a fine of one hundred dollars (\$100.00).</u> (d) Local Jurisdictions. – Municipalities may authorize by ordinance additional
34 35	(d) <u>Local Jurisdictions. – Municipalities may authorize by ordinance additional</u> prohibited conduct for parking in a space designated as an electric vehicle charging station and
35 36	higher penalties than those set out in this section.
