**SECTION 2.** There is appropriated from the General Fund to the Administrative Office of the Courts the sum of three hundred thirty-eight thousand fifteen dollars (\$338,015) for the 2019-2020 fiscal year and three hundred twenty-two thousand eight hundred seventy-five dollars (\$322,875) for the 2020-2021 fiscal year.
