4	The General Assembly of North Carolina enacts:						
5	<b>SECTION 1.</b> G.S. 20-79.4(b)(147) is reenacted as it existed immediately before its						
6	expiration and reads as rewritten:						
7	"(147) NCAMC/NCACC Clerk. – Issuable to a clerk of a municipal governing board						
8	or a clerk of a county board of commissioners of a municipality or county in						
9	this State. State upon furnishing to the Division proof that the applicant						
10	currently holds the position. For a municipal clerk, the plate shall bear the						
11	words "NCAMC Clerk" followed by a number representing the municipal						
12	clerk's city or town. The number of a city shall be the order of the city in an						
13	alphabetical list of cities that assigns number one to the first city in the list.						
14	<u>Clerk.</u> For a county clerk, the plate shall bear the words "NCACC Clerk"						
15	followed by a number representing the county clerk's county. The number of						
16	a county shall be the order of the county in an alphabetical list of counties that						
17	assigns number one to the first county in the list. <u>Clerk.</u> The Division may						
18	not issue the <u>a</u> plate authorized by this subdivision unless it receives at least						
19 20	$\frac{300-50}{2}$ applications for the plate."

32	<u>subsection (a1)</u> of this section among the Special Registration Plate Account (SRPA), the						
33	Collegiate and Cultural Attraction Plate Account (CCAPA), the Clean Water Management Trust						
34	Fund (CWMTF), which is established under G.S. 113A-253, and the Parks and Recreation Trust						
35	Fund, which is established under G.S. 113-44.15, as follows:
