8 **PART I. TITLE AND INTRODUCTION**

9
10 **TITLE OF ACT**

11 **SECTION 1.1.** This act shall be known as the "Current Operations Appropriations
12 Act of 2021."

13
14 **INTRODUCTION**

15 **SECTION 1.2.** The appropriations made in this act are for maximum amounts
16 necessary to provide the services and accomplish the purposes described in the budget in
17 accordance with the State Budget Act. Savings shall be effected where the total amounts
18 appropriated are not required to perform these services and accomplish these purposes, and the
19 savings shall revert to the appropriate fund at the end of each fiscal year, except as otherwise
20 provided by law.

24 **GENERAL FUND APPROPRIATIONS**

25 **SECTION 2.1.(a)** Appropriations from the General Fund for the budgets of the State

7 **SECTION 2.2.(b)** Notwithstanding G.S. 143C-4-2, the State Controller shall
8 transfer a total of five hundred twenty-four million eight hundred thousand dollars
9 (\$524,800,000) from the unreserved fund balance to the Savings Reserve on June 30, 2021. This
10 transfer is not an "appropriation made by law," as that phrase is used in Section 7(1) of Article V
11 of the North Carolina Constitution. This subsection becomes effective June 30, 2021.

12 **SECTION 2.2.(c)** The State Controller shall reserve to the Medicaid Transformation
13 Reserve from funds available in the General Fund the sum of sixty-four million dollars
14 (\$64,000,000) in nonrecurring funds for the 2021-2022 fiscal year and the sum of one hundred
15 sixty million dollars (\$160,000,000) in nonrecurring funds for the 2022-2023 fiscal year. Funds
16 reserved in the Medicaid Transformation Reserve do not constitute an "appropriation made by
17 law," as that phrase is used in Section 7(1) of Article V of the North Carolina Constitution.

18 **SECTION 2.2.(d)** The State Controller shall transfer from the Medicaid
19 Transformation Reserve in the General Fund to the Medicaid Transformation Fund, established
20 under Section 12H.29 of S.L. 2015-241, the sum of two hundred seventy-five million two
21 hundred fifty-one thousand three hundred two dollars (\$275,251,302) for the 2021-2022 fiscal
22 year and the sum of one hundred sixty-three million two hundred thirty-two thousand three
23 hundred twenty-three dollars (\$163,232,323) for the 2022-2023 fiscal year.

24 **SECTION 2.2.(e)** The State Controller shall reserve to the Medicaid Contingency
25 Reserve from funds available in the General Fund the sum of one hundred fifty million dollars
26 (\$150,000,000) in nonrecurring funds for the 2021-2022 fiscal year. Funds reserved in the
27 Medicaid Contingency Reserve do not constitute an "appropriation made by law," as that phrase
28 is used in Section 7(1) of Article V of the North Carolina Constitution.

29 **SECTION 2.2.(f)** The State Controller shall transfer the sum of one hundred fifty
30 million dollars (\$150,000,000) from the unreserved fund balance in the General Fund to the
31 Retiree Healthcare Reserve (OPEB Liability). This section becomes effective June 30, 2021.

32 **SECTION 2.2.(g)** Notwithstanding the provisions of G.S. 143C-4-3(a), the State
33 Controller shall transfer one hundred twenty-five million dollars (\$125,000,000) from the
34 unreserved fund balance to the Repairs and Renovations Reserve on June 30, 2021 and one
35 hundred twenty-five million dollars (\$125,000,000) from the unreserved fund balance to the
36 Repairs and Renovations Reserve on June 30, 2022. This subsection becomes effective June 30,
37 2021. Funds transferred under this section to the Repairs and Renovations Reserve are
38 appropriated for the 2021-2022 fiscal year and the 2022-2023 fiscal year.

39 **SECTION 2.2.(h)** The State Controller shall transfer the sum of four hundred
40 twenty-three million five hundred fifty-nine thousand seven hundred thirty-four dollars
41 (\$423,559,734) from the unreserved fund balance in the General Fund to the Project Reserve
42 Account on June 30, 2021 and the sum of four hundred sixty-two million one hundred seventy
43 thousand dollars (\$462,170,000) from the unreserved fund balance in the General Fund to the
44 Project Reserve Account on June 30, 2022. This section becomes effective June 30, 2021. Funds
45 transferred under this section to Project Reserve are appropriated for the 2021-2022 fiscal year
46 and the 2022-2023 fiscal year and shall be used in accordance with Section 39.2 of this act.

47 **SECTION 2.2.(i)** There is established an Energy and Environment Reserve which
48 shall make funds available for expenditure only upon an act of appropriation by the General
49 Assembly. The State Controller shall transfer the sum of two hundred twenty-five million dollars
50 (\$225,000,000) from the unreserved fund balance in the General Fund to the Energy and
51 Environment Reserve on June 30, 2021 and the sum of five million dollars (\$225,000,000) from

1 the unreserved fund balance in the General Fund to the Energy and Environment Reserve on June
2 30, 2022. This section becomes effective June 30, 2021. Funds transferred under this section to
3 Energy and Environment Reserve are appropriated for the 2021-2022 fiscal year and the
4 2022-2023 fiscal year and shall be used in accordance with this act.

5 **SECTION 2.2.(j)** There is established an Information Technology Reserve which
6 shall make funds available for information technology project expenditure only upon an act of
7 appropriation by the General Assembly. The State Controller shall transfer the sum of one
8 hundred sixty-nine million nine hundred twenty-five thousand nine hundred fifty dollars
9 (\$169,925,950) from the unreserved fund balance in the General Fund to the Information
10 Technology Reserve on June 30, 2021 and the sum of one hundred fifty-seven million nine
11 hundred eleven thousand five hundred fifty-six dollars (\$157,911,556) from the unreserved fund
12 balance in the General Fund to the Information Technology Reserve on June 30, 2022. This
13 section becomes effective June 30, 2021. Funds transferred under this section to Information
14 Technology Reserve are appropriated for the 2021-2022 fiscal year and the 2022-2023 fiscal year
15 and shall be used in accordance with this act.

16 **SECTION 2.2.(k)** Notwithstanding G.S. 143C-4-2, the State Controller shall
17 transfer a total of one hundred million dollars (\$100,000,000) from the unreserved fund balance
18 to the State Emergency Response and Disaster Relief Fund in the General Fund on June 30, 2021.
19 This subsection becomes effective June 30, 2021.

PART IV. OTHER AVAILABILITY AND APPROPRIATIONS

CASH BALANCES AND OTHER APPROPRIATIONS

SECTION 4.1.(a) Cash balances, federal funds, departmental receipts, grants, and gifts from the General Fund, revenue funds, enterprise funds, and internal service funds are appropriated for the 2021-2023 fiscal biennium as follows:

- (1) For all budget codes listed in the Governor's Recommended Budget for the 2021-2023 fiscal biennium, dated March 2021, and in the Budget Support Document, fund balances and receipts are appropriated up to the amounts specified, as adjusted by the General Assembly, for the 2021-2022 fiscal year and the 2022-2023 fiscal year. Funds may be expended only for the programs, purposes, objects, and line items or as otherwise authorized by the General Assembly. Expansion budget funds listed in those documents are appropriated only as otherwise provided in this act.
- (2) Notwithstanding the provisions of subdivision (1) of this subsection:
 - a. Any receipts that are required to be used to pay debt service requirements for various outstanding bond issues and certificates of participation are appropriated up to the actual amounts received for the 2021-2022 fiscal year and the 2022-2023 fiscal year and shall be used only to pay debt service requirements.
 - b. Other funds, cash balances, and receipts of funds that meet the definition issued by the Governmental Accounting Standards Board of a trust or agency fund are appropriated for and in the amounts required to meet the legal requirements of the trust agreement for the 2021-2022 fiscal year and the 2022-2023 fiscal year.

SECTION 4.1.(b) Receipts collected in a fiscal year in excess of the amounts appropriated by this section shall remain unexpended and unencumbered until appropriated by the General Assembly, unless the expenditure of over-realized receipts in the fiscal year in which the receipts were collected is authorized by the State Budget Act. Over-realized receipts are appropriated in the amounts necessary to implement this subsection.

SECTION 4.1.(c) Notwithstanding subsections (a) and (b) of this section, there is appropriated from the Reserve for Reimbursements to Local Governments and Shared Tax Revenues for each fiscal year an amount equal to the amount of the distributions required by law to be made from that reserve for that fiscal year.

OTHER RECEIPTS FROM PENDING GRANT AWARDS

SECTION 4.2.(a) Notwithstanding G.S. 143C64, State agencies may, with approval of the Director of the Budget, spend funds received from grants awarded subsequent to the enactment of this act for grant awards that are for less than two million five hundred thousand dollars (\$2,500,000), do not require State matching funds, and will not be used for a capital project. State agencies shall report to the Joint Legislative Commission on Governmental Operations within 30 days of receipt of such funds.

State agencies may spend all other funds from grants awarded after the enactment of this act only with approval of the Director of the Budget and after consultation with the Joint Legislative Commission on Governmental Operations.

SECTION 4.2.(b) The Office of State Budget and Management shall work with the recipient State agencies to budget grant awards according to the annual program needs and within the parameters of the respective granting entities. Depending on the nature of the award, additional State personnel may be employed on a time-limited basis. Funds received from such grants are hereby appropriated and shall be incorporated into the authorized budget of the recipient State agency.

1 **SECTION 4.2.(c)** Notwithstanding the provisions of this section, no State agency
 2 may accept a grant not anticipated in this act if acceptance of the grant would obligate the State
 3 to make future expenditures relating to the program receiving the grant or would otherwise result

43 Emergency Response and Disaster Relief Fund and those funds are allocated as follows:

- 44 (1) \$50,000,000 to the Department of Public Safety, Division of Emergency
45 Management to provide State match for federal disaster assistance programs
46 related to Hurricane Florence, Hurricane Dorian, Hurricane Isaias, and other
47 recent natural disasters.
- 48 (2) \$10,000,000 to the Department of Public Safety, Office of Recovery and
49 Resiliency to provide flexible local government grants to assist distressed
50 communities impacted by Hurricane Dorian. Grants may be used for repairs,

- 1 staff support and technical assistance, cash flow assistance, and other related
2 activities.
- 3 (3) \$40,000,000 to the Office of State Budget and Management, for the following
4 housing-related matters:
- 5 a. To be used for housing elevation, acquisition, and mitigation
6 reconstruction for homes not covered by Hazard Mitigation Grant
7 Program.
- 8 b. For the repair, reconstruction, replacement, or acquisition of
9 owner-occupied homes not covered by Community Development
10 Block Grant Disaster Recovery Program funding.
- 11 c. To provide State Acquisition Relocation funds, which enable low-
12 moderate-income homeowners to purchase homes.
- 13 d. To provide flood insurance subsidies.
- 14 e. To construct infrastructure to support (i) hazard mitigation and (ii) the
15 development of new residential structures in areas outside the 100-year
16 floodplain.

17 **SECTION 5.7.(b)** Applicability. – Subdivision (3) of Section 5.7.(a) applies in the
18 North Carolina counties that were declared a major disaster by the President of the United States
19 under the Stafford Act (P.L. 93-288) as a result of Hurricane Florence, Matthew, Michael, or
20 Dorian.

21 **SECTION 5.7.(c)** Implementation. – The following actions and policies shall be
22 taken to implement subsection 5.7.(a)(3) of this section:

- 23 (1) If a person's home is relocated or purchased with funds from the Hazard
24 Mitigation Grant Program or the State Acquisition and Relocation Fund, the
25 State Emergency Response and Disaster Relief Fund is subrogated to the
26 person's rights under any insurance coverage for the damage to the home and
27 any monies received from the insurance coverage shall be paid to the State
28 Emergency Response and Disaster Relief Fund. The Office of State Budget
29 and Management shall ensure that those potentially affected by this section
30 are notified of, and adhere to, its requirements.
- 31 (2) No State funds appropriated in this section may be expended for the
32 construction of any new residence within the 100-year floodplain unless the
33 construction is in an area regulated by a unit of local government pursuant to
34 a floodplain management ordinance and the construction complies with the
35 ordinance. As used in this section, "100-year floodplain" means any area
36 subject to inundation by a 100-year flood, as indicated on the most recent
37 Flood Insurance Rate Map prepared by the Federal Emergency Management
38 Agency under the National Flood Insurance Program.
- 39 (3) Homeowners in the 100-year floodplain who receive homeowner's housing
40 assistance pursuant to this section shall have in effect federal flood insurance,
41 if available, as a precondition to receipt of State homeowner's housing
42 assistance for losses resulting from future flooding.

43 **SECTION 5.7.(d)** Limitation. – The Governor shall ensure that funds allocated in
44 this act are expended in a manner that does not adversely affect any person's or entity's eligibility
45 for federal funds that are made available, or that are anticipated to be made available, as a result
46 of Hurricanes Florence, Matthew, Michael, or Dorian. The Governor shall also, to the extent
47 practicable, avoid using State funds to cover costs that will be, or likely will be, covered by
48 federal funds.

49 **SECTION 5.7.(e)** No Reversion of Funds. – Funds described in subsection
50 5.87.(a)(3) shall remain available to implement the provisions of this section until the General

1 Assembly directs the reversion of any unexpended and unencumbered funds and
2 G.S. 143C-6-23(f1)(1) shall not apply to those funds.

3 **SECTION 5.7.(f)** Reporting Requirements. – The Office of State Budget and
4 Management shall provide periodic reports on the use of the funds allocated and appropriated in
5 this Act in a manner which is consistent with Section 5.8 of Session Law 2019-250.
6

7 **DIRECTED GRANTS EXTENSION**

8 **SECTION 5.8.** Extension of Term for Administration of Directed Grants. –
9 Subdivision (4) of Section 3.1(b) of S.L. 2019-224, reads as rewritten:

10 "(4) Notwithstanding any provision of G.S. 143C 1 2(b) to the contrary,
11 nonrecurring funds appropriated in this act as directed grants shall not revert
12 until June 30, ~~2021~~2024.
13

14 **PART VI. COMMUNITY COLLEGES**

15 16 **NC GETTING READY FOR OPPORTUNITIES IN THE WORKFORCE (NC GROW)** 17 **COMPLETION INCENTIVE**

18 **SECTION 6.1.(a)** There is established the North Carolina Getting Ready for
19 Opportunities in the Workforce (NC GROW) Completion Incentive Program to be administered
20 by the North Carolina State Education Assistance Authority (SEAA) in collaboration with the
21 State Board of Community Colleges. Of funds appropriated in this act for the NC GROW
22 Completion Incentive Program, one thousand (\$1,000) dollars shall be awarded to students that
23 successfully graduate from eligible programs of study.

24 **SECTION 6.1.(b)** The State Board of Community Colleges, in collaboration with
25 the Department of Commerce, shall determine the eligible programs of study for the NC GROW
26 Completion Incentives. The eligible programs of study shall include programs in Architecture
27 and Construction, Health Sciences, Information Technology, Electrical Line Worker, and
28 Manufacturing programs, and may include other programs to meet local workforce needs.

29 **SECTION 6.1.(c)** The North Carolina Community College System shall contract
30 with SEAA to administer awards under the NC GROW Completion Incentive Program. SEAA
31 is authorized to administer this program consistent with the manner in which it administers grants
32 to community college students qualifying for the Scholarships for Needy Students under Article
33 35A of Chapter 115C of the General Statutes and the Need-Based Assistance Program under
34 G.S. 115D-40.1, so that no qualifying North Carolina student incurs costs of tuition and selected
35 fees to attend a community college. Of the funds appropriated in fiscal year 2021-2022, up to
36 five hundred thousand dollars (\$500,000) may be used for program administration and outreach
37 to encourage students to pursue coursework in the selected programs of study.

38 **SECTION 6.1.(d)** The State Board of Community Colleges shall establish criteria
39 for initial and continuing eligibility to participate in the NC GROW Scholarship Program. At a
40 minimum, the criteria shall require an eligible student to:

- 41 (1) Be a legal resident of North Carolina for tuition purposes.
- 42 (2) Be enrolled in and graduate from an eligible program of study in areas of high,
43 in-demand training.

44 **SECTION 6.1.(e)** The North Carolina Community College System and SEAA shall
45 report annually on:

- 46 (1) The number of students receiving awards.
- 47 (2) The enrollment (by headcount and FTE) in each selected program of study.
- 48 (3) The number of graduates produced in each selected program of study.
49

50 **NC JOB READY (WORKFORCE) – NC GROW FINANCIAL AID FOR STUDENTS** 51 **SEEKING INDUSTRY CREDENTIALS**

1 **SECTION 6.2.(a)** There is established the North Carolina Getting Ready for
2 Opportunities in the Workforce (NC GROW) Financial Aid for Students Seeking Industry
3 Credentials Program to be administered by the State Board of Community Colleges.

4 **SECTION 6.2.(b)** The State Board of Community Colleges, in collaboration with
5 the Department of Commerce, shall determine the eligible programs of study for the NC GROW
6 Financial Aid for Students Seeking Industry Credentials Program. The eligible programs of study
7 shall include programs in Architecture and Construction, Health Sciences, Information
8 Technology, Electrical Line Worker, and Manufacturing programs, and may include other
9 programs to meet local workforce needs.

10 **SECTION 6.2.(c)** Of funds appropriated in this act for the NC GROW Financial Aid
11 for Students Seeking Industry Credentials Program, the State Board of Community Colleges shall
12 determine the allocation of awards to students pursuing short-term, noncredit State and industry
13 workforce credentials. The State Board of Community Colleges, in collaboration with the
14 Department of Commerce, shall determine the eligible programs of study for this financial
15 assistance. The eligible programs of study shall include programs in Architecture and
16 Construction, Health Sciences, Information Technology, Electrical Line Worker, and
17 Manufacturing programs, and may include other programs to meet local workforce needs. These
18 funds shall be used to assist students with any education related costs incurred while in pursuit
19 of these credentials.

20 **SECTION 6.2.(d)** For fiscal year 2021-22, from funds appropriated for the NC
21 GROW Financial Aid for Students Seeking Industry Credentials Program, up to five hundred
22 thousand (\$500,000) dollars may be used may be used to administer this program and the NC
23 GROW Scholarships program administered by SEAA, as well as for outreach to encourage
24 students to pursue coursework in the selected programs of study. For the 2022-23 fiscal year on,
25 from funds appropriated for the NC GROW Financial Aid for Students Seeking Industry
26 Credentials Program, up to five hundred thousand (\$500,000) dollars may be used to administer
27 this program and to market the financial assistance to prospective recipients.

28 **ENROLLMENT GROWTH AND BUDGET STABILIZATION**

29 **SECTION 6.3.(a)** When calculating the enrollment growth budget request for the
30 2022-2023 fiscal year, for any colleges whose 2020-2021 FTE is a decline from 2019-2020 FTE,
31 the North Carolina Community College System Office shall use the 2019-2020 FTE instead of
32 the 2020-2021 FTE in the calculation of the 2-year average used for determining budget FTE.

33 **SECTION 6.3.(b)** The appropriation in this act of Budget Stabilization funds for the
34 North Carolina Community College System shall remain available for expenditure through June
35 30, 2023.
36
37

38 **PART VII. PUBLIC INSTRUCTION**

39 **FUNDS FOR CHILDREN WITH DISABILITIES**

40 **SECTION 7.1.** The State Board of Education shall allocate additional funds for
41 children with disabilities on the basis of four thousand five hundred forty-nine dollars and
42 eighty-eight cents (\$4,549.88) per child for fiscal year 2021-2022 and four thousand seven
43 hundred four dollars and twenty-eight cents (\$4,704.28) per child for fiscal year 2022-2023. Each
44 local school administrative unit shall receive funds for the total number of children who are
45 identified as children with disabilities in the local school administrative unit. The dollar amounts
46 allocated under this section for children with disabilities shall also be adjusted in accordance with
47 legislative salary increments, retirement rate adjustments, and health benefit adjustments for
48 personnel who serve children with disabilities.
49
50

51 **FUNDS FOR ACADEMICALLY GIFTED CHILDREN**

1 **SECTION 7.2.** The State Board of Education shall allocate additional funds for
2 academically or intellectually gifted children on the basis of one thousand three hundred
3 sixty-four dollars and seventy-eight cents (\$1,3464.78) per child for fiscal years 2021-2022 and
4 2022-2023. A local school administrative unit shall receive funds for a maximum of four percent
5 (4%) of its 2021-2022 allocated average daily membership, regardless of the number of children
6 identified as academically or intellectually gifted in the unit. The dollar amounts allocated under
7 this section for academically or intellectually gifted children shall also be adjusted in accordance
8 with legislative salary increments, retirement rate adjustments, and health benefit adjustments
9 for personnel who serve academically or intellectually gifted children.

10 11 **SUPPLEMENTAL FUNDING IN LOW-WEALTH COUNTIES**

12 **SECTION 7.3.(a)** Use of Funds for Supplemental Funding. – All funds received
13 pursuant to this section shall be used only (i) to provide instructional positions, instructional
14 support positions, teacher assistant positions, clerical positions, school computer technicians,
15 instructional supplies and equipment, staff development, and textbooks and digital resources and
16 (ii) for salary supplements for instructional personnel and instructional support personnel. Local
17 boards of education are encouraged to use at least twenty-five percent (25%) of the funds
18 received pursuant to this section to improve the academic performance of children who are
19 performing at Level I or II on either reading or mathematics end-of-grade tests in grades three
20 through eight.

21 **SECTION 7.3.(b)** Definitions. – As used in this section, the following definitions
22 apply:

- 23 (1) Anticipated county property tax revenue availability. – The county-adjusted
24 property tax base multiplied by the effective State average tax rate.
- 25 (2) Anticipated total county revenue availability. – The sum of the following:
26 a. Anticipated county property tax revenue availability.
27 b. Local sales and use taxes received by the county that are levied under
28 Chapter 1096 of the 1967 Session Laws or under Subchapter VIII of
29 Chapter 105 of the General Statutes.
30 c. Fines and forfeitures deposited in the county school fund for the most
31 recent year for which data are available.
- 32 (3) Anticipated total county revenue availability per student. – The anticipated
33 total county revenue availability for the county divided by the average daily
34 membership of the county.
- 35 (4) Anticipated State average revenue availability per student. – The sum of all
36 anticipated total county revenue availability divided by the average daily
37 membership for the State.
- 38 (5) Average daily membership. – Average daily membership as defined in the
39 North Carolina Public Schools Allotment Policy Manual adopted by the State
40 Board of Education. If a county contains only part of a local school
41 administrative unit, the average daily membership of that county includes all
42 students who reside within the county and attend that local school
43 administrative unit.
- 44 (6) County-adjusted property tax base. – Computed as follows:
45 a. Subtract the present-use value of agricultural land, horticultural land,
46 and forestland in the county, as defined in G.S. 105-277.2, from the
47 total assessed real property valuation of the county.
48 b. Adjust the resulting amount by multiplying by a weighted average of
49 the three most recent annual sales assessment ratio studies.
50 c. Add to the resulting amount the following:

- 1 1. Present-use value of agricultural land, horticultural land, and
2 forestland, as defined in G.S. 105-277.2.
- 3 2. Value of property of public service companies, determined in
4 accordance with Article 23 of Chapter 105 of the General
5 Statutes.
- 6 3. Personal property value for the county.
- 7 (7) County-adjusted property tax base per square mile. – The county-adjusted
8 property tax base divided by the number of square miles of land area in the
9 county.
- 10 (8) County wealth as a percentage of State average wealth. – Computed as
11 follows:
 - 12 a. Compute the percentage that the county per capita income is of the
13 State per capita income and weight the resulting percentage by a factor
14 of five-tenths.
 - 15 b. Compute the percentage that the anticipated total county revenue
16 availability per student is of the anticipated State average revenue
17 availability per student and weight the resulting percentage by a factor
18 of four-tenths.
 - 19 c. Compute the percentage that the county-adjusted property tax base per
20 square mile is of the State-adjusted property tax base per square mile
21 and weight the resulting percentage by a factor of one-tenth.
 - 22 d. Add the three weighted percentages to derive the county wealth as a
23 percentage of the State average wealth.
- 24 (9) Effective county tax rate. – The actual county tax rate multiplied by a weighted
25 average of the three most recent annual sales assessment ratio studies.
- 26 (10) Effective State average tax rate. – The average of effective county tax rates
27 for all counties.
- 28 (11) Local current expense funds. – The most recent county current expense
29 appropriations to public schools, as reported by local boards of education in
30 the audit report filed with the Secretary of the Local Government Commission
31 pursuant to G.S. 115C-447.
- 32 (12) Per capita income. – The average for the most recent three years for which
33 data are available of the per capita income according to the most recent report
34 of the United States Department of Commerce, Bureau of Economic Analysis,
35 including any reported modifications for prior years as outlined in the most
36 recent report.
- 37 (13) Sales assessment ratio studies. – Sales assessment ratio studies performed by
38 the Department of Revenue under G.S. 105-289(h).
- 39 (14) State average adjusted property tax base per square mile. – The sum of the
40 county-adjusted property tax bases for all counties divided by the number of
41 square miles of land area in the State.
- 42 (15) State average current expense appropriations per student. – The most recent
43 State total of county current expense appropriations to public schools, as
44 reported by local boards of education in the audit report filed with the
45 Secretary of the Local Government Commission pursuant to G.S. 115C-447.
- 46 (16) Supplant. – To decrease local per student current expense appropriations from
47 one fiscal year to the next fiscal year.
- 48 (17) Weighted average of the three most recent annual sales assessment ratio
49 studies. – The weighted average of the three most recent annual sales
50 assessment ratio studies in the most recent years for which county current
51 expense appropriations and adjusted property tax valuations are available. If

1 real property in a county has been revalued one year prior to the most recent
2 sales assessment ratio study, a weighted average of the two most recent sales
3 assessment ratios shall be used. If property has been revalued the year of the
4 most recent sales assessment ratio study, the sales assessment ratio for the year
5 of revaluation shall be used.

6 **SECTION 7.3.(c) Eligibility for Funds.** – Except as provided in subsection (g) of
7 this section, the State Board of Education shall allocate these funds to local school administrative
8 units located in whole or in part in counties in which the county wealth as a percentage of the
9 State average wealth is less than one hundred percent (100%).

10 **SECTION 7.3.(d) Allocation of Funds.** – Except as provided in subsection (f) of this
11 section, the amount received per average daily membership for a county shall be the difference
12 between the State average current expense appropriations per student and the current expense
13 appropriations per student that the county could provide given the county's wealth and an average
14 effort to fund public schools. To derive the current expense appropriations per student that the
15 county could be able to provide given the county's wealth and an average effort to fund public
16 schools, multiply the county's wealth as a percentage of State average wealth by the State average
17 current expense appropriations per student. The funds for the local school administrative units
18 located in whole or in part in the county shall be allocated to each local school administrative
19 unit located in whole or in part in the county based on the average daily membership of the
20 county's students in the school units. If the funds appropriated for supplemental funding are not
21 adequate to fund the formula fully, each local school administrative unit shall receive a pro rata
22 share of the funds appropriated for supplemental funding.

23 **SECTION 7.3.(e) Formula for Distribution of Supplemental Funding Pursuant to**
24 **this Section Only.** – The formula in this section is solely a basis for distribution of supplemental
25 funding for low-wealth counties. It is the intent of the General Assembly to incrementally
26 increase appropriations for low-wealth allotment to provide eligible counties supplemental
27 funding equal to 110 percent of the statewide local revenue per student by fiscal year 2027-2028.
28 The State Board of Education shall adjust the formula to ensure each local school administrative
29 unit receives a pro rata share of the additional funds appropriated for the low-wealth allotment
30 in this act for supplemental funding.

31 **SECTION 7.3.(f) Minimum Effort Required.** – A county shall receive full funding
32 under this section if the county (i) maintains an effective county tax rate that is at least one
33 hundred percent (100%) of the effective State average tax rate in the most recent year for which
34 data are available or (ii) maintains a county appropriation per student to the school local current
35 expense fund of at least one hundred percent (100%) of the current expense appropriations per
36 student to the school local current expense fund that the county could provide given the county's
37 wealth and an average effort to fund public schools. A county that maintains a county
38 appropriation per student to the school local current expense fund of less than one hundred
39 percent (100%) of the current expense appropriations per student to the school local current
40 expense fund that the county could provide given the county's wealth and an average effort to
41 fund public schools shall receive funding under this section at the same percentage that the
42 county's appropriation per student to the school local current expense fund is of the current
43 expense appropriations per student to the school local current expense fund that the county could
44 provide given the county's wealth and an average effort to fund public schools.

45 **SECTION 7.3.(g) Nonsupplant Requirement.** – A county in which a local school
46 administrative unit receives funds under this section shall use the funds to supplement local
47 current expense funds and shall not supplant local current expense funds. For the 2021-2023
48 fiscal biennium, the State Board of Education shall not allocate funds under this section to a
49 county found to have used these funds to supplant local per student current expense funds. The
50 State Board of Education shall make a finding that a county has used these funds to supplant

1 local current expense funds in the prior year, or the year for which the most recent data are
 2 available, if all of the following criteria apply:

- 3 (1) The current expense appropriations per student of the county for the current
 4 year is less than ninety-five percent (95%) of the average of local current
 5 expense appropriations per student for the three prior fiscal years.
- 6 (2) The county cannot show (i) that it has remedied the deficiency in funding or
 7 (ii) that extraordinary circumstances caused the county to supplant local
 8 current expense funds with funds allocated under this section.

9 The State Board of Education shall adopt rules to implement the requirements of this
 10 subsection.

11 **SECTION 7.3.(h)** Counties Containing a Base of the Armed Forces. –
 12 Notwithstanding any other provision of this section, for the 2021-2023 fiscal biennium, counties
 13 containing a base of the Armed Forces of the United States that have an average daily
 14 membership of more than 17,000 students shall receive whichever is the higher amount in each
 15 fiscal year as follows: either the amount of supplemental funding the county received as a
 16 low-wealth county in the 2012-2013 fiscal year or the amount of supplemental funding the county
 17 is eligible to receive as a low-wealth county pursuant to the formula for distribution of
 18 supplemental funding under the other provisions of this section.

19 **SECTION 7.3.(i)** Funds for EVAAS Data. – Notwithstanding the requirements of
 20 subsection (a) of this section, local school administrative units may utilize funds allocated under
 21 this section to purchase services that allow for extraction of data from the Education
 22 Value-Added Assessment System (EVAAS).

23 **SECTION 7.3.(j)** Reports. – For the 2021-2023 fiscal biennium, the State Board of
 24 Education shall report to the Fiscal Research Division prior to May 15 of each year if it
 25 determines that counties have supplanted funds.

26 **SECTION 7.3.(k)** Department of Revenue Reports. – The Department of Revenue
 27 shall provide to the Department of Public Instruction a preliminary report for the current fiscal
 28 year of the assessed value of the property tax base for each county prior to March 1 of each year
 29 and a final report prior to May 1 of each year. The reports shall include for each county the annual
 30 sales assessment ratio and the taxable values of (i) total real property, (ii) the portion of total real
 31 property represented by the present-use value of agricultural land, horticultural land, and
 32 forestland, as defined in G.S. 105-277.2, (iii) property of public service companies determined
 33 in accordance with Article 23 of Chapter 105 of the General Statutes, and (iv) personal property.

34
 35 **SMALL COUNTY SCHOOL SYSTEM SUPPLEMENTAL FUNDING**

36 **SECTION 7.4.(a)** Allotment Schedule for the 2021-2023 Fiscal Biennium. – Except
 37 as otherwise provided in subsection (d) of this section, each eligible county school administrative
 38 unit shall receive a dollar allotment according to the following schedule:

47 **SECTION 7.4.(b)** Phase-Out Provision for the 2021-2022 Fiscal Year. – If a local
 48 school administrative unit becomes ineligible for funding under the schedule in subsection (a) of
 49 this section in the 2021-2022 fiscal year, funding for that unit shall be phased out over a five-year
 50 period. Funding for such local school administrative units shall be reduced in equal increments

1 in each of the five years after the unit becomes ineligible. Funding shall be eliminated in the fifth
2 fiscal year after the local school administrative unit becomes ineligible.

3 Allotments for eligible local school administrative units under this subsection shall
4 not be reduced by more than twenty percent (20%) of the amount received in fiscal year
5 2020-2021 in any fiscal year. A local school administrative unit shall not become ineligible for
6 funding if either the highest of the first two months' total projected average daily membership for
7 the current year or the higher of the first two months' total prior year average daily membership
8 would otherwise have made the unit eligible for funds under the schedule in subsection (a) of this
9 section.

10 **SECTION 7.4.(c)** Phase-Out Provision for the 2022-2023 Fiscal Year. – If a local
11 school administrative unit becomes ineligible for funding under the schedule in subsection (a) of
12 this section in the 2022-2023 fiscal year, funding for that unit shall be phased out over a five-year
13 period. Funding for such local school administrative units shall be reduced in equal increments
14 in each of the five years after the unit becomes ineligible. Funding shall be eliminated in the fifth
15 fiscal year after the local administrative unit becomes ineligible.

16 Allotments for eligible local school administrative units under this subsection shall
17 not be reduced by more than twenty percent (20%) of the amount received in fiscal year
18 2021-2022 in any fiscal year. A local school administrative unit shall not become ineligible for
19 funding if either the highest of the first two months' total projected average daily membership for
20 the current year or the higher of the first two months' total prior year average daily membership
21 would otherwise have made the unit eligible for funds under the schedule in subsection (a) of this
22 section.

23 **SECTION 7.4.(d)** Nonsupplant Requirement for the 2021-2023 Fiscal Biennium. –
24 A county in which a local school administrative unit receives funds under this section shall use
25 the funds to supplement local current expense funds and shall not supplant local current expense
26 funds. For the 2021-2023 fiscal biennium, the State Board of Education shall not allocate funds
27 under this section to a county found to have used these funds to supplant local per student current
28 expense funds. The State Board of Education shall make a finding that a county has used these
29 funds to supplant local current expense funds in the prior year or the year for which the most
30 recent data are available, if all of the following criteria apply:

- 31 (1) The current expense appropriation per student of the county for the current
32 year is less than ninety-five percent (95%) of the average of local current
33 expense appropriation per student for the three prior fiscal years.
34 (2) The county cannot show (i) that it has remedied the deficiency in funding or
35 (ii) that extraordinary circumstances caused the county to supplant local
36 current expense funds with funds allocated under this section.

37 The State Board of Education shall adopt rules to implement the requirements of this
38 subsection.

39 **SECTION 7.4.(e)** Reports. – For the 2021-2023 fiscal biennium, the State Board of
40 Education shall report to the Fiscal Research Division prior to May 15 of each fiscal year if it
41 determines that counties have supplanted funds.

42 **SECTION 7.4.(f)** Use of Funds. – Local boards of education are encouraged to use
43 at least twenty percent (20%) of the funds they receive pursuant to this section to improve the
44 academic performance of children who are performing at Level I or II on either reading or
45 mathematics end-of-grade tests in grades three through eight.

46 Local school administrative units may also utilize funds allocated under this section
47 to purchase services that allow for extraction of data from the Education Value-Added
48 Assessment System (EVAAS).

50 **DISADVANTAGED STUDENT SUPPLEMENTAL FUNDING (DSSF)/AT-RISK**
51 **STUDENT SERVICES/ALTERNATIVE SCHOOLS**

1 **SECTION 7.5.(a)** Funds appropriated in this act for disadvantaged student
2 supplemental funding shall be used, consistent with the policies and procedures adopted by the
3 State Board of Education, only to do the following:

- 4 (1) Provide instructional positions or instructional support positions.
- 5 (2) Provide professional development.
- 6 (3) Provide intensive in-school or after-school remediation, or both.
- 7 (4) Purchase diagnostic software and progress-monitoring tools.
- 8 (5) Provide funds for teacher bonuses and supplements.

9 The State Board of Education may require local school administrative units receiving
10 funding under the Disadvantaged Student Supplemental Fund to purchase the Education
11 Value-Added Assessment System (EVAAS) in order to provide in-depth analysis of student
12 performance and help identify strategies for improving student achievement. This data shall be
13 used exclusively for instructional and curriculum decisions made in the best interest of children
14 and for professional development for their teachers and administrators.

15 **SECTION 7.5.(b)** Disadvantaged student supplemental funding (DSSF) shall be
16 allotted to a local school administrative unit based on (i) the unit's eligible DSSF population and
17 (ii) the difference between a teacher-to-student ratio of 1:21 and the following teacher-to-student
18 ratios:

- 19 (1) For counties with wealth greater than ninety percent (90%) of the statewide
20 average, a ratio of 1:19.9.
- 21 (2) For counties with wealth not less than eighty percent (80%) and not greater
22 than ninety percent (90%) of the statewide average, a ratio of 1:19.4.
- 23 (3) For counties with wealth less than eighty percent (80%) of the statewide
24 average, a ratio of 1:19.1.
- 25 (4) For local school administrative units that received DSSF funds in fiscal year
26 2005-2006, a ratio of 1:16. These local school administrative units shall
27 receive no less than the DSSF amount allotted in fiscal year 2006-2007.

28 For the purpose of this subsection, wealth shall be calculated under the low-wealth
29 supplemental formula as provided for in this act.

30 **SECTION 7.5.(c)** If a local school administrative unit's wealth increases to a level
31 that adversely affects the unit's disadvantaged student supplemental funding (DSSF) allotment
32 ratio, the DSSF allotment for that unit shall be maintained at the prior year level for one additional
33 fiscal year.

34 **SECTION 7.5.(d)** For the 2022-2023 fiscal year the State Board of Education shall
35 transfer the At-Risk Student Services/Alternative Schools allotment into the DSSF allotment and
36 allocate these funds to local school administrative units under a formula that:

- 37 (1) Expands the allowable uses of the DSSF allotment to incorporate activities
38 allowed under the current At-Risk allotment; and
- 39 (2) Provides that no local administrative unit receives a decrease in combined
40 funding.

41 Reallocated At-Risk funding must be counted as an independent supplement to
42 existing DSSF funds.

43 44 **FUNDS FOR LIMITED ENGLISH PROFICIENCY**

45 **SECTION 7.6.** The State Board of Education shall allocate funds for services to
46 students with limited proficiency in the English language to local school administrative units and
47 to charter schools based on the three-year weighted headcount of students in the units or charter
48 school with limited English proficiency.

49 50 **UNIFORM EDUCATION REPORTING SYSTEM (UERS) FUNDS**

1 **SECTION 7.7.(a)** Funds appropriated for the Uniform Education Reporting System
2 (UERS) for fiscal year 2020-2021 shall not revert at the end of the fiscal year but shall remain
3 available until expended.

4 **SECTION 7.7.(b)** Funds appropriated in this act for the Uniform Education
5 Reporting System (UERS) for the 2021-2023 fiscal biennium shall not revert at the end of each
6 fiscal year but shall remain available until expended.

8 **EDUCATION AND WORKFORCE INNOVATION PROGRAM GRANTS**
9 **COMBINATION**

10 **SECTION 7.8.(a)** G.S. 115C-64.15 reads as rewritten:

11 **"§ 115C-64.15. North Carolina Education and Workforce Innovation Commission.**

12 ...

13 (d1) The Commission shall develop and administer, in coordination with the State
14 Board of Education and the Superintendent of Public Instruction, and in collaboration
15 with the North Carolina Career and Technical Education Foundation, Inc., the Career and
16 Technical Education Grade Expansion Program, as established under G.S. 115C-64.17,
17 and shall make awards of grants under the Program.

18 The Education and Workforce Innovation Program shall administer the Education Workforce

30 needs at the time of grant approval.

5 period from the initial award. Grants may be awarded for new or existing projects. Grant funds

9 STUDENT MEAL DEBT REPORT AND REDUCED LUNCH CO-PAYS

10 SECTION 7.9.(a) Section 2.3(a) of S.L. 2020-80 reads as rewritten:

6 **DEVELOPING A REPRESENTATIVE AND INCLUSIVE VISION FOR EDUCATION**
7 **(DRIVE) GRANT PROGRAM**

8 **SECTION 7.12.(a)** Purpose. – The State Board of Education, in consultation with
9 the Office of the Governor, the University of North Carolina System, and the North Carolina
10 Community College System, shall establish a grant program to support strategic partnerships
11 committed to increasing the pipeline of educators of color across the state. As an extension of the
12 recommendations and strategies presented by Governor Cooper's DRIVE Task Force on January
13 1, 2021, this grant program provides funds for local school administrative units, institutions of
14 higher education, and community organizations to implement innovative initiatives that support
15 the recruitment, preparation, support, and retention of racially, ethnically, and linguistically
16 diverse educators.

17 The purpose of this program shall be to the following:

- 18 (1) Increase the diversity of the educator workforce across the state through novel
19 recruitment efforts.
- 20 (2) Strengthen the pipeline of aspiring teachers of color across the state through
21 traditional and alternative certification pathways.
- 22 (3) Provide mechanisms to support and retain educators of color currently serving
23 in K-12 public schools.
- 24 (4) Promote collaboration between districts, institutions of higher education, and
25 community/non-profit organizations to diversify the educator workforce.

26 For grant award consideration, applicants must:

- 27 (1) Include a partnership between at least two of the following entities: K-12
28 districts, Historically Black Colleges and Universities, Minority-serving
29 Institutions, educator preparation programs, alternative certification
30 programs, public and private colleges and universities, community colleges,
31 and community or nonprofit organizations.
- 32 (2) Propose strategies that address one or more of the following components of
33 the educator development continuum as highlighted by the DRIVE Task
34 Force's 2021 Report to the Governor: recruitment, placement and induction,
35 and support and retention of educators of color.

36 Grants activities may include, but are not limited to:

- 37 (1) Strengthen existing high school dual enrollment programs to offer
38 education-based college credit or honors courses as streamlined pathways for
39 future careers in education.
- 40 (2) Implement targeted district-level and community-based recruitment programs
41 for aspiring educators of color interested in traditional and alternative educator
42 preparation programs.
- 43 (3) Utilize and leverage existing financial aid programs that include scholarships,
44 loan forgiveness, and tuition reimbursement that reduce the disproportionate
45 financial burden incurred by aspiring candidates of color.
- 46 (4) Increase preparation and support for pre-service educators of color through
47 paid clinical learning experiences, with a commitment to teaching in North
48 Carolina public schools.
- 49 (5) Offer support for job placement and licensure for candidates of color after
50 completing their educator preparation program.

1 (6) Provide induction and mentoring programs that address the needs of educators
2 of color that include sustaining networking and professional learning
3 communities or affinity groups.

4 (7) Encourage and financially support educators of color interested in joining
5 national professional organizations or attending national conferences.

6 **SECTION 7.12.(b)** Request for Proposal. – By October 1, 2021, the State Board of
7 Education shall issue a Request for Proposal (RFP) for the grant program. Applicants shall submit
8 their proposals by December 1, 2021. The RFP shall require that proposals include the following
9 information at a minimum:

10 (1) Description of the proposal;

11 (2) Evidence-based research that supports the proposal;

12 (3) Implementation Plan; and

13 (4) Plans for financial sustainability once grant money is no longer available.

14 **SECTION 7.12.(c)** Selection. – By February 1, 2022, a selection committee will
15 select up to five grantees, making the effort to ensure that there is representation across the State

22 qualitative and quantitative data to demonstrate program effectiveness.

23 **SECTION 7.12.(e)** Evaluation and Reporting. – Of the funds appropriated by this
24 act, the State Board of Education may use up to \$300,000 to contract with an independent
25 research organization to evaluate the impact of this grant program. The independent research
26 organization shall report the results of this evaluation to the Joint Legislative Education Oversight
27 Committee, the Fiscal Research Division of the General Assembly, and the Office of State
28 Budget and Management by September 1, 2023. The State Board of Education shall report

32 **TEACHER PREPARATION RESIDENCY PILOT GRANT PROGRAM**

33 **SECTION 7.13.(a)** Purpose. – The State Board of Education shall establish a grant
34 program to assist local school administrative units in the development of teacher preparation
35 residency pilot programs. Teacher preparation residency programs provide the necessary
36 preparation and induction supports to teacher preparation candidates pursuing a continuing
37 professional license. Teacher preparation residency programs eligible to receive grant funding
38 through this program shall include, at a minimum, the following components:

39 (1) Coursework in the candidate's area of licensure;

40 (2) Tuition and stipends;

41 (3) Faculty advising;

42 (4) Clinical training experiences; and

43 (5) Ongoing induction support.

44 Residency programs eligible for this grant program may include partnerships between
45 local school administrative units, educator preparation programs, local community college or
46 universities, and other community organizations. Grant funds awarded to local school
47 administrative units under this program shall be matched by the local school administrative unit
48 on the basis of one dollar (\$1.00) in non-grant funds for every one dollar (\$1.00) in grant funds.

49 **SECTION 7.13.(b)** Request for Proposal. – By October 1, 2021, the State Board of
50 Education shall issue a Request for Proposal (RFP) for the grant program. Local boards of
51

1 education shall submit their proposals by January 15, 2022. The RFP shall require that proposals
2 include the following information at a minimum:

- 3 (1) Description of the proposal, including the number of teacher preparation
4 candidates to be served;
- 5 (2) Evidence-based research that supports the proposal;
- 6 (3) Implementation plan; and
- 7 (4) Plans for financial sustainability once grant money is no longer available.

8 **SECTION 7.13.(c) Grant Awards.** – By April 15, 2022, the State Board of Education
9 shall review the proposals submitted by local boards of education and shall select up to 10 local
10 school administrative units for grant awards. The State Board of Education may make grant
11 awards for up to three years. A local school administrative unit may not receive more than five
12 hundred thousand dollars (\$500,000) in a single fiscal year from this grant program.

13 **SECTION 7.13.(d) Evaluation and Reporting.** – Of the funds appropriated by this
14 act, the State Board of Education may use up to three hundred thousand dollars (\$300,000) to
15 contract with an independent research organization to evaluate the impact of this grant program.
16 The independent research organization shall report the results of this evaluation to the Joint
17 Legislative Education Oversight Committee, the Fiscal Research Division of the General
18 Assembly, and the Office of State Budget and Management by September 1, 2025. The
19 Department of Public Instruction shall report annually on the implementation of this grant
20 program beginning on March 1, 2023.

21 **SECTION 7.13.(e) Carryforward.** – Funds unspent in the 2022-2023 fiscal year shall
22 not revert and shall be carried forward to implement this section.

23 24 **RECRUITMENT BONUS PILOT PROGRAM FOR TEACHERS IN LOW WEALTH, 25 LOW PERFORMING OR HIGH NEEDS SCHOOLS**

26 **SECTION 7.14.(a) Purpose.** – The State Board of Education shall establish a grant
27 program to assist local school administrative units in providing multi-year recruitment bonuses
28 to certified teachers who commit to teach multiple years in a low-performing or high-needs
29 school. Bonuses awarded as part of this grant program shall include, but are not limited to, the
30 following components:

- 31 (1) Awarded over multiple years with a requirement that teachers remain in the
32 school over multiple years to receive the bonus;
- 33 (2) Awarded to certified teachers who commit to teach in a school identified as
34 low-performing, as defined in G.S. 115C-105.37, a school identified as
35 continually low-performing as defined in G.S. 115C-105.37A, or a school
36 where 75 percent or greater of students qualify for free or reduced-price lunch
37 under the National School Lunch Program.

38 **SECTION 7.14.(b) Request for Proposal.** – By September 1, 2021, and on that date
39 in subsequent years, the State Board of Education shall issue a Request for Proposal (RFP) for
40 the grant program. Local boards of education shall submit their proposals by December 1, 2021.
41 The RFP shall require that proposals include the following information at a minimum:

- 42 (1) Description of the proposal, including details on targeted schools for the bonuses
43 and how the bonus program will be structured;
- 44 (2) Evidence-based research that supports the proposal;
- 45 (3) Implementation plan; and
- 46 (4) Plans for financial sustainability once grant money is no longer available.

47 **SECTION 7.14.(c) Grant Awards.** – By February 15, 2022, the State Board of
48 Education shall review the proposals submitted by local boards of education and shall select up
49 to 10 local school administrative units for grant awards. The State Board of Education may make
50 grant awards for up to three years. A local school administrative unit may not receive more than
51 five hundred thousand dollars (\$500,000) in a single fiscal year from this grant program.

1 **SECTION 7.14.(d)** Evaluation and Reporting. – Of the funds appropriated by this
2 act, the State Board of Education may use up to three hundred thousand dollars (\$300,000) to
3 contract with an independent research organization to evaluate the impact of this grant program.
4 The independent research organization shall report the results of this evaluation to the Joint
5 Legislative Education Oversight Committee, the Fiscal Research Division of the General
6 Assembly, and the Office of State Budget and Management by September 1, 2024. The
7 Department of Public Instruction shall report annually on the implementation of this grant
8 program beginning on March 1, 2022.

9 **SECTION 7.14.(e)** Carryforward. – Funds unspent in the 2021-2022 and 2022-2023
10 fiscal years shall not revert and shall be carried forward to implement this section.

11 12 **EDUCATOR WAGE COMPARABILITY STUDY**

13 **SECTION 7.15.** The State Board of Education shall conduct a wage comparability
14 study to determine competitive pay for North Carolina teachers in comparison to salaries in
15 similar professions in North Carolina. The study shall focus on, but not be limited to, the
16 following areas:

- 17 (1) Compare North Carolina teacher salaries to salaries for professions in North
18 Carolina that require similar education and credentials as teachers;
- 19 (2) Identify the level of compensation needed to provide a competitive salary to
20 similar professions in North Carolina;

28 29 **EDUCATOR LICENSURE AND COMPENSATION REFORM PLAN**

30 **SECTION 7.16.** The State Board of Education shall develop a plan for implementing
31 a teacher licensure and compensation reform model designed to restore respect for the teaching
32 profession; build a more diverse, quality teaching force; increase instructional capabilities of
33 teachers; and entice more young professionals, mid-career professionals, and out-of-state
34 individuals into the teaching profession. The plan shall include, but not be limited to, the

31 Division, and the Office of State Budget and Management by March 1, 2022. Of the funds
32 appropriated in this act to the Department of Public Instruction, up to \$25,000 may be used
33 towards conducting this study.

35 **STUDY ON BARRIERS OF ACCESS TO HIGH SCHOOL COURSES LEADING TO** 36 **COLLEGE CREDIT**

37 **SECTION 7.20.** The State Board of Education, in collaboration with the Office of
38 State Budget and Management, shall conduct a study examining the barriers and supports
39 impacting all students' ability to complete high school courses leading to college credit, an
40 associate degree, or a career-ready credential, including an examination of access, equity,
41 resources, fees, and personnel. The State Board of Education shall report on the findings of this
42 study to the Joint Legislative Education Oversight Committee, the Fiscal Research Division, and
43 the Office of State Budget and Management by March 1, 2022. Of the funds appropriated in this
44 act to the Department of Public Instruction, up to \$25,000 may be used towards conducting this
45 study.

47 **NATIONAL BOARD CERTIFICATION FEE SUPPORT**

48 **SECTION 7.21.(a)** Of the funds appropriated to the Department of Public
49 Instruction by this act, the Department shall transfer the sum of one million nine hundred
50 thousand dollars (\$1,900,000) each year of the biennium to the State Education Assistance
51 Authority to pay the application fees for first time candidates applying for certification by the

1 National Board for Professional Teaching Standards. Funds shall be available beginning with the
2 2021-2022 school year.

26 funding for the Teacher Assistants allotment and to simplify the formula for allotting funding in
27 order to provide funding for one teacher assistant for every 27 kindergarten through third grade
28 students by fiscal year 2027-2028. Teacher Assistant funding shall be allotted to a local school
29 administrative unit based on a teacher assistant-to-kindergarten -through third grade student ratio
30 of 1:40 in fiscal year 2021-2022 and a teacher assistant-to-kindergarten through third grade
31 student ratio of 1:39 in fiscal year 2022-2023.

SECTION 7A.1.(c) Salary Supplements for Teachers Paid on This Salary Schedule.

- (1) Licensed teachers who have NBPTS certification shall receive a salary supplement each month of twelve percent (12%) of their monthly salary on the "A" salary schedule.
- (2) Licensed teachers who are classified as "M" teachers shall receive a salary supplement each month of ten percent (10%) of their monthly salary on the "A" salary schedule.
- (3) Licensed teachers with licensure based on academic preparation at the six-year degree level shall receive a salary supplement of one hundred twenty-six dollars (\$126.00) per month in addition to the supplement provided to them as "M" teachers.
- (4) Licensed teachers with licensure based on academic preparation at the doctoral degree level shall receive a salary supplement of two hundred fifty-three dollars (\$253.00) per month in addition to the supplement provided to them as "M" teachers.
- (5) Certified school nurses shall receive a salary supplement each month of ten percent (10%) of their monthly salary on the "A" salary schedule.
- (6) Certified school counselors shall receive a salary supplement of eighty dollars (\$80.00) per month.
- (7) School psychologists shall receive a salary supplement of five hundred (\$500.00) per month.

SECTION 7A.1.(d) The first step of the salary schedule for (i) school psychologists, (ii) school speech pathologists who are licensed as speech pathologists at the master's degree level or higher, and (iii) school audiologists who are licensed as audiologists at the master's degree level or higher shall be equivalent to the sixth step of the "A" salary schedule. These employees shall receive a salary supplement each month of ten percent (10%) of their monthly salary and are eligible to receive salary supplements equivalent to those of teachers for academic preparation at the six-year degree level or the doctoral degree level.

SECTION 7A.1.(e) The twenty-sixth step of the salary schedule for (i) school psychologists, (ii) school speech pathologists who are licensed as speech pathologists at the master's degree level or higher, and (iii) school audiologists who are licensed as audiologists at the master's degree level or higher shall be seven and one-half percent (7.5%) higher than the salary received by these same employees on the twenty-fifth step of the salary schedule.

SECTION 7A.1.(f) Beginning with the 2014-2015 fiscal year, in lieu of providing annual longevity payments to teachers paid on the teacher salary schedule, the amounts of those longevity payments are included in the monthly amounts under the teacher salary schedule.

SECTION 7A.1.(g) A teacher compensated in accordance with this salary schedule for the 2020-2021 and 2021-2022 year shall receive an amount equal to the greater of the following:

- (1) The applicable amount on the salary schedule for the applicable school year.

- 1 (2) For teachers who were eligible for longevity for the 2013-2014 school year,
 2 the sum of the following:
 3 a. The salary the teacher received in the 2013-2014 school year pursuant

4 determined according to the average daily membership of the school supervised by the principal,
5 as described in subsection (b) of this section, and the school growth scores, calculated pursuant

PRINCIPAL BONUSES

SECTION 7A.5.(a) No later than October 31, 2021, the Department of Public Instruction shall administer a one-time, lump sum bonus to any qualifying principal that is equal to the amount that qualifying principal received pursuant to Section 2.4 of S.L. 2019-247.

As used in this section, the term "qualifying principal" shall refer to a principal who meets all of the following criteria:

- (1) Received a bonus in the 2019-2020 fiscal year pursuant to Section 2.4 of S.L. 2019-247.
- (2) Is employed as a principal in a public school as of October 1, 2021.

SECTION 7A.5.(b) The Department of Public Instruction shall administer a bonus in the 2022-2023 fiscal year to any principal who supervised a school as a principal for a majority of the previous school year if that school was in the top fifty percent (50%) of school growth in the State during the previous school year, calculated by the State Board pursuant to G.S. 115C-83.15(c), as follows:

A principal shall receive no more than one bonus pursuant to this subsection. The bonus shall be paid at the highest amount for which the principal qualifies.

SECTION 7A.5.(c) Bonuses awarded pursuant to this section shall be in addition to any regular wage or other bonus the principal receives or is scheduled to receive.

SECTION 7A.5.(d) Notwithstanding G.S. 135-1(7a), bonuses awarded pursuant to this section is not compensation under Article 1 of Chapter 135 of the General Statutes, the Teachers' and State Employees' Retirement System.

SECTION 7A.5.(e) The bonus awarded pursuant subsection (a) to this section does not apply to principals no longer employed as a principal due to resignation, dismissal, reduction in force, death, or retirement or whose last workday is prior to October 1, 2021.

SECTION 7A.5.(f) The bonus awarded pursuant subsection (b) to this section does not apply to principals no longer employed as a principal due to resignation, dismissal, reduction in force, death, or retirement or whose last workday is prior to October 1, 2022.

SECTION 7A.5.(g) It is the intent of the General Assembly that funds provided pursuant to this section will supplement principal compensation and not supplant local funds.

SECTION 7A.5.(h) The bonus provided pursuant to subsection (a) of this section shall be paid no later than October 31, 2021, to qualifying principals employed as of October 1, 2021.

SECTION 7A.5.(i) The bonus provided pursuant to subsection (b) of this section shall be paid no later than October 31, 2022, to qualifying principals employed as of October 1, 2022.

ASSISTANT PRINCIPAL SALARIES

SECTION 7A.6.(a) For the 2021-2023 fiscal biennium, assistant principals shall receive a monthly salary based on the relevant salary schedule for teachers shown in Section 7A.1(a) and 7A.1(b) who are classified as "A" teachers plus nineteen percent (19%). An assistant principal shall be placed on the step on the salary schedule that reflects the total number of years of experience as a certified employee of the public schools. For purposes of this section, an administrator with a one-year provisional assistant principal's certificate shall be considered equivalent to an assistant principal.

SECTION 7A.6.(b) Assistant principals with certification based on academic preparation at the six-year degree level shall be paid a salary supplement of one hundred twenty-six dollars (\$126.00) per month and at the doctoral degree level shall be paid a salary supplement of two hundred fifty-three dollars (\$253.00) per month.

SECTION 7A.6.(c) Participants in an approved full-time master's in-school administration program shall receive up to a 10-month stipend at the beginning salary of an assistant principal during the internship period of the master's program. The stipend shall not exceed the difference between the beginning salary of an assistant principal plus the cost of tuition, fees, and books and any fellowship funds received by the intern as a full-time student, including awards of the Principal Fellows Program. The Principal Fellows Program or the school of education where the intern participates in a full-time master's in-school administration program shall supply the Department of Public Instruction with certification of eligible full-time interns.

SECTION 7A.6.(d) Beginning with the 2017-2018 fiscal year, in lieu of providing annual longevity payments to assistant principals on the assistant principal salary schedule, the amounts of those longevity payments are included in the monthly amounts provided to assistant principals pursuant to subsection (a) of this section.

SECTION 7A.6.(e) An assistant principal compensated in accordance with this section for the 2021-2023 fiscal biennium shall receive an amount equal to the greater of the following:

- (1) The applicable amount determined pursuant to subsections (a) through (d) of this section.
- (2) For assistant principals who were eligible for longevity in the 2016-2017 fiscal year, the sum of the following:
 - a. The salary the assistant principal received in the 2016-2017 fiscal year pursuant to Section 9.1 or Section 9.2 of S.L. 2016-94.
 - b. The longevity that the assistant principal would have received as provided for State employees under the North Carolina Human Resources Act for the 2016-2017 fiscal year based on the assistant principal's current years of service.
- (3) For assistant principals who were not eligible for longevity in the 2016-2017 fiscal year, the salary the assistant principal received in the 2016-2017 fiscal year pursuant to Section 9.1 or Section 9.2 of S.L. 2016-94.

CENTRAL OFFICE SALARIES

SECTION 7A.7.(a) For the 2021-2022 fiscal year, beginning July 1, 2021, the annual salary for superintendents, assistant superintendents, associate superintendents, directors/coordinators, supervisors, and finance officers, whose salaries are supported from State funds, shall be increased by five percent (5%).

SECTION 7A.7.(b) It is the intent of the General Assembly to increase the annual salary for superintendents, assistant superintendents, associate superintendents, directors/coordinators, supervisors, and finance officers, whose salaries are supported from State funds, in the 2022-2023 fiscal year, beginning July 1, 2022, by two and one-half percent (2.5%).

28 **SECTION 8.7.(a)** Purpose of the College Advising Corps Program. – From the funds
29 appropriated by this act for the 2021-2023 fiscal biennium to the Board of Governors of The
30 University of North Carolina for the College Advising Corps program, the Board of Governors
31 shall provide a directed grant to the National College Advising Corps, Inc. (CAC) to support an
32 expansion of the placement of college advisers in North Carolina public schools through their
33 program. CAC is a college access nonprofit organization with the mission to increase the number
34 of underrepresented, low-income, or first-generation postsecondary degree or certificate students
35 entering and completing their postsecondary education at community colleges and universities.
36 In furthering this mission, CAC operates an innovative model of partnering with schools,
37 communities, families, and postsecondary institutions, including providing for a two-year service
38 opportunity to recent college graduates as near-peer college advisers working full-time in the
39 public schools, with an emphasis on engaging college advisers who have similar backgrounds to
40 the students the program seeks to serve. Near-peer college advisers perform various services for
41 those students that are key components to the proven success of the program, including (i)
42 attending postsecondary campus visits, fairs, and workshops with students, (ii) assisting with
43 registering for college entrance exams, (iii) assisting with Free Application for Federal Student
44 Aid (FAFSA) registrations and completions, (iv) identifying available scholarships, (v) assisting
45 with postsecondary applications, and (vi) engaging with parents.

46 **SECTION 8.7.(b)** Matching Funds. – Funds made available to CAC pursuant to this
47 section shall be matched by CAC on the basis of two dollars (\$2.00) in non-State funds for every
48 one dollar (\$1.00) in State funds. Availability of these matching funds shall not revert, but shall
49 continue to be available for the purposes set forth in this section.

50 **SECTION 8.7.(c)** Use of Funds. – CAC shall focus the first two years of the
51 expansion of its program using the funds provided to it under this section by placing college

1 advisers in counties designated as Tier 1 and Tier 2. In subsequent years, CAC shall use the funds
 2 provided to it to place college advisers in the remaining counties designated as Tier 3 in order to
 3 achieve placement of college advisers in all 100 counties of the State. In addition, CAC shall
 4 select at least three additional postsecondary institutions to partner with in order to increase the
 5 number of recent graduates working as near-peer college advisers to meet the needs of the
 6 program expansion. Once CAC has reached the goal of placement of college advisers in 100
 7 counties, the funds provided to it for the program shall be used to continue the mission of the
 8 program to increase access for North Carolina public school students to postsecondary degree or
 9 certificate attainment at community colleges and universities.

12 **SECTION 9A.1.(a)** For each year of the 2021-2023 fiscal biennium, the maximum
13 monthly rate for residents in adult care home facilities shall be one thousand one hundred
14 eighty-two dollars (\$1,182) per month per resident.

16 **SECTION 9A.1.(b)** For each year of the 2021-2023 fiscal biennium, the maximum
17 monthly rate for residents in Alzheimer's/Dementia special care units shall be one thousand five
18 hundred fifteen dollars (\$1,515) per month per resident.
19

20 **INCREASE IN STATE-COUNTY SPECIAL ASSISTANCE PERSONAL NEEDS** 21 **ALLOWANCE**

22 **SECTION 9A.2.(a)** Effective October 1, 2021, the Department of Health and Human
23 Services, Division of Aging and Adult Services shall increase the personal needs allowance under
24 the State-County Special Assistance program from forty-six dollars (\$46.00) per month per
25 recipient to seventy dollars (\$70.00) per month per recipient.

26 **SECTION 9A.2.(b)** Effective January 1, 2022, the personal needs allowance will be
27 indexed to the COLA issued by the Social Security Commission effective January 1st of the

46 percent (15%) cap on the number of Special Assistance in-home payments, as the Secretary

12 protection from health and safety hazards, protection from physical mistreatment, and protection
13 from exploitation.

14 **SECTION 9A.4.(c)** Based on items in subsection (b) of this section, the Department
15 of Health and Human Services, Division of Aging and Adult Services shall develop a detailed
16 list of acceptable uses of the fund.

17 **SECTION 9A.4.(d)** Funds will be allocated to local departments of social services
18 based on the following formula:

27 **SECTION 9B.1.(a)** Of the funds appropriated in this act to the Department of Health
28 and Human Services, Division of Central Management and Support, the sum of twenty nine
29 million fifty seven thousand three hundred and twenty nine dollars (\$29,057,329) in nonrecurring
30 funds for the 2021-2022 fiscal year and thirty two million four hundred seventy eight thousand
31 eight hundred and thirty four dollars (\$32,478,834) in nonrecurring funds for the 2022-2023
32 fiscal year shall be used to match federal funds to implement the augmentation and enhancement
33 strategy of Child Welfare Services as recommended by PED and Gartner studies and modernize
34 the Platform, Infrastructure, and Architecture components of the North Carolina Families
35 Accessing Services through Technology (NC FAST) application. The Department shall report
36 any changes in approved federal funding or federal match rates within 30 days after the change
37 to the Joint Legislative Oversight Committee on Health and Human Services, the Joint
38 Legislative Oversight Committee on Information Technology, and the Fiscal Research Division.
39 Departmental receipts appropriated in this act in the sum of sixteen million eight hundred
40 forty-two thousand five hundred and seventy-two dollars (\$16,842,572) for the 2021-2022 fiscal
41 year and twenty four million nine hundred forty seven thousand and seventy dollars
42 (\$24,947,070) for the 2022-2023 fiscal year shall be used to implement the components of the
43 NC FAST project described in this subsection.

44 **SECTION 9B.1.(b)** Of the funds appropriated in this act to the Department of Health
45 and Human Services, Division of Central Management and Support, the sum of twenty two
46 million three hundred twenty six thousand nine hundred and fifty two dollars (\$22,326,952) in
47 recurring funds for the 2021-2022 and 2022-2023 fiscal year and ten million six hundred five
48 thousand nine hundred and eighty eight dollars (\$10,605,988) in nonrecurring funds for the
49 2021-2022 fiscal year and five million eight hundred seventy six thousand eight hundred and six
50 dollars (\$5,876,806) in nonrecurring funds for the 2022-2023 fiscal year shall be used to provide
51 ongoing maintenance and operations for the NC FAST system, including the remaining Medicaid

1 Transformation initiative and the creation of 4 full-time equivalent positions for the 2021-2022

8 **COMMUNITY HEALTH GRANT PROGRAM CHANGES**

9 **SECTION 9B.2.(a)** Of the funds appropriated in this act to the Department of Health
10 and Human Services, Division of Central Management and Support, Office of Rural Health, for
11 Community Health Grants, the sum of seven million five hundred thousand dollars (\$7,500,000)
12 in recurring funds for the 2021-2022 fiscal year and the sum of seven million five hundred
13 thousand dollars (\$7,500,000) in recurring funds for the 2022-2023 fiscal year shall be used as
14 follows:

- 15 (1) Up to two hundred thousand dollars (\$200,000) in recurring funds for each
16 fiscal year of the 2021-2023 fiscal biennium shall be used to maintain four
17 permanent, full-time equivalent positions within the Office of Rural Health to
18 support administration of the Community Health Grant Program.
- 19 (2) Up to two hundred thousand dollars (\$200,000) in recurring funds for each
20 fiscal year of the 2021-2023 fiscal biennium may be used for administrative
21 purposes.
- 22 (3) At least six million nine hundred fifty thousand dollars (\$6,950,000) in
23 recurring funds for each fiscal year of the 2021-2023 fiscal biennium shall be
24 used to award grants on a competitive basis to free and charitable clinics,
25 federally qualified health centers, State-designated rural health centers, local
26 health departments, school-based health centers, and other nonprofit
27 organizations that (i) provide primary and preventative medical services to
28 uninsured or medically indigent patients and (ii) serve as a medical home to
29 these vulnerable populations, in order to accomplish any of the following
30 purposes:
 - 31 a. Increase access to primary care and preventative health services for
32 these vulnerable populations in existing primary care locations.
 - 33 b. Establish primary care and preventative health services in counties
34 where no such services exist to serve these vulnerable populations.
 - 35 c. Create new services, sustain existing service levels, or augment
36 existing services provided to these vulnerable populations, including
37 primary care and preventative health services and including dental,
38 pharmacy, and behavioral health services when integrated into the
39 medical home.
 - 40 d. Increase primary care capacity to serve these vulnerable populations,
41 including enhancing or replacing facilities, equipment, or technologies
42 necessary to participate in the exchange of data and tools to monitor
43 and improve the quality of care provided.

44 **SECTION 9B.2.(b)** The Office of Rural Health shall work with the North Carolina
45 Community Health Center Association, the North Carolina Association of Local Health
46 Directors, the North Carolina Association of Free and Charitable Clinics, the North Carolina
47 School-Based Health Alliance, and other organizations representing eligible grant recipients to
48 establish a Primary Care Advisory Committee to develop an objective and equitable process for
49 grading applications for grants funded by this section and making recommendations to the Office
50 of Rural Health for the award of grants funded by this section.

1 The Office of Rural Health shall make the final decision about awarding grants funded
2 by this section. In awarding grants, the Office of Rural Health shall consider the availability of
3 other funds for the applicant; the incidence of poverty in the area served by the applicant or the
4 number of indigent clients served by the applicant; the availability of, or arrangements for,
5 after-hours care; and collaboration between the applicant and a community hospital or other
6 safety-net organizations.

7 **SECTION 9B.2.(c)** Grant recipients shall not use these funds to do any of the
8 following:

- 9 (1) Enhance or increase compensation or other benefits of personnel,
10 administrators, directors, consultants, or any other persons receiving funds for
11 program administration; provided, however, funds may be used to hire or
12 retain health care providers. The use of grant funds for this purpose does not
13 obligate the Department of Health and Human Services to continue to fund
14 compensation beyond the grant period.
- 15 (2) Supplant existing funds, including federal funds traditionally received by
16 federally qualified community health centers. However, grant funds may be
17 used to supplement existing programs that serve the purposes described in
18 subsection (a) of this section.
- 19 (3) Finance or satisfy any existing debt.

20 **SECTION 9B.2.(d)** The Office of Rural Health shall develop a standardized method
21 for grant recipients to report objective, measurable quality health outcomes and shall require
22 grant recipients to report these quality health outcomes to the Department. Beginning recipients
23 of grant funds shall annually provide to the Office of Rural Health a written report detailing the
24 number of patients that are cared for, the types of services that were provided, quality measures
25 and outcomes, and any other information requested by the Office of Rural Health as necessary
26 for evaluating the success of the Community Health Grant Program.

27 **SECTION 9B.2.(e)** Of the funds appropriated in this act to the Department of Health
28 and Human Services, Division of Central Management and Support, Office of Rural Health, for
29 the Community Health Grant Program, the sum of up to one hundred fifty thousand dollars
30 (\$150,000) in recurring funds for each fiscal year of the 2021-2023 fiscal biennium shall be used
31 to match federal funds to provide to safety net providers eligible to participate in the Community
32 Health Grant Program, through the Rural Health Technology Team, ongoing training and
33 technical assistance with respect to health information technology, the adoption of electronic
34 health records, and the establishment of connectivity to the State's health information exchange
35 network known as NC HealthConnex.

36 37 **COMPETITIVE GRANTS/NONPROFIT ORGANIZATIONS**

38 **SECTION 9B.3.(a)** Of the funds appropriated in this act to the Department of Health
39 and Human Services, Division of Central Management and Support, the sum of ten million six
40 hundred fifty-three thousand nine hundred eleven dollars (\$10,653,911) for each year of the
41 2021-2023 fiscal biennium, the sum of four million seven hundred seventy-four thousand five
42 hundred twenty-five dollars (\$4,774,525) for each year of the 2021-2023 fiscal biennium
43 appropriated in Section 9K.1 of this act in Social Services Block Grant funds, and the sum of one
44 million six hundred thousand dollars (\$1,600,000) for each year of 2021-2023 fiscal biennium in
45 Section 9K.1 of this act in Substance Abuse Prevention and Treatment Block Grant funds shall
46 be used to allocate funds for nonprofit organizations.

47 **SECTION 9B.3.(b)** The Department shall continue administering a competitive
48 grants process for nonprofit funding. The Department shall administer a plan that, at a minimum,
49 includes each of the following:

- 50 (1) A request for application (RFA) process to allow nonprofits to apply for and
51 receive State funds on a competitive basis. The Department shall require

- 1 nonprofits to include in the application a plan to evaluate the effectiveness,
2 including measurable impact or outcomes, of the activities, services, and
3 programs for which the funds are being requested.
- 4 (2) A requirement that nonprofits match a minimum of fifteen percent (15%) of
5 the total amount of the grant award.
- 6 (3) A requirement that the Secretary prioritize grant awards to those nonprofits
7 that are able to leverage non-State funds in addition to the grant award.

17 substance abusers, or the elderly.
- 18 d. Supports and services to children and adults with developmental
19 disabilities or mental health diagnoses.
- 20 e. A food distribution system for needy individuals.
- 21 f. The provision and coordination of services for the homeless.
- 22 g. The provision of services for individuals aging out of foster care.
- 23 h. Programs promoting wellness, physical activity, and health education
24 programming for North Carolinians.
- 25 i. The provision of services and screening for blindness.
- 26 j. A provision for the delivery of after-school services for
27 apprenticeships or mentoring at-risk youth.
- 28 k. The provision of direct services for amyotrophic lateral sclerosis
29 (ALS) and those diagnosed with the disease.
- 30 l. A comprehensive smoking prevention and cessation program that
31 screens and treats tobacco use in pregnant women and postpartum
32 mothers.
- 33 m. A program providing short-term or long-term residential substance
34 abuse services. For purposes of this sub-subdivision, "long-term"
35 means a minimum of 12 months.
- 36 n. A program that provides year-round sports training and athletic
37 competition for children and adults with disabilities.
- 38 (5) A process that ensures that funds received by the Department to implement
39 the plan supplement and do not supplant existing funds for health and wellness
40 programs and initiatives.
- 41 (6) A process that allows grants to be awarded to nonprofits for up to two years.
- 42 (7) A requirement that initial disbursement of the grants be awarded no later than
43 30 days after certification of the State budget for the respective fiscal year.

44 **SECTION 9B.3.(c)** No later than July 1 of each year, as applicable, the Secretary
45 shall announce the recipients of the competitive grant awards and allocate funds to the grant
46 recipients for the respective grant period pursuant to the amounts designated under subsection
47 (a) of this section. After awards have been granted, by September 1 of each year, the Secretary
48 shall submit a report to the Joint Legislative Oversight Committee on Health and Human Services
49 on the grant awards that includes at least all of the following:

- 50 (1) The identity and a brief description of each grantee and each program or
51 initiative offered by the grantee.

1 (2) The amount of funding awarded to each grantee.

2 (3) The number of persons served by each grantee, broken down by program or
3 initiative.

4 **SECTION 9B.3.(d)** No later than December 1 of each fiscal year, each nonprofit
5 organization receiving funding pursuant to this section in the respective fiscal year shall submit
6 to the Division of Central Management and Support a written report of all activities funded by
7 State appropriations. The report shall include the following information about the fiscal year
8 preceding the year in which the report is due:

9 (1) The entity's mission, purpose, and governance structure.

10 (2) A description of the types of programs, services, and activities funded by State
11 appropriations.

12 (3) Statistical and demographical information on the number of persons served by
13 these programs, services, and activities, including the counties in which
14 services are provided.

15 (4) Outcome measures that demonstrate the impact and effectiveness of the
16 programs, services, and activities.

17 (5) A detailed program budget and list of expenditures, including all positions
18 funded, matching expenditures, and funding sources.

19 **SECTION 9B.3.(e)** Funds appropriated pursuant to this section that have been
20 awarded but not yet disbursed or encumbered at the end of each fiscal year shall not revert but
21 shall remain available for expenditure.

22 **SECTION 9B.3.(f)** For the 2021-2023 fiscal biennium only, from the funds
23 identified in subsection (a) of this section, the Department shall make the following allocations,
24 provided that each nonprofit organization receiving funds pursuant to this subsection shall be
25 required to seek future funding through the competitive grants process in accordance with
26 subsection (b) of this section:

27 (1) The sum of three hundred fifty thousand dollars (\$350,000) in each year of
28 the 2021-2023 fiscal biennium to provide grants to Big Brothers Big Sisters.

29 (2) The sum of one million six hundred twenty-five thousand dollars (\$1,625,000)
30 for each year of the 2021-2023 fiscal biennium and the sum of one million six
31 hundred thousand dollars (\$1,600,000) appropriated in Section 9K.1 of this
32 act in Substance Abuse Prevention and Treatment Block Grant funds in each
33 year of the 2021-2023 fiscal biennium to Triangle Residential Options for
34 Substance Abusers, Inc., (TROSAs) for the purpose of assisting individuals
35 with substance abuse addiction.

36 (3) The sum of two million seven hundred fifty thousand dollars (\$2,750,000) in
37 each year of the 2021-2023 fiscal biennium to provide grants to Boys and Girls
38 Clubs across the State to implement (i) programs that improve the motivation,
39 performance, and self-esteem of youth and (ii) other initiatives that would be
40 expected to reduce gang participation, school dropout, and teen pregnancy
41 rates.

42 43 **PART IX-C. CHILD DEVELOPMENT AND EARLY EDUCATION**

44 45 **NC PRE-K PROGRAMS/STANDARDS FOR FOUR- AND FIVE-STAR RATED** 46 **FACILITIES**

47 **SECTION 9C.1.(a)** Eligibility. – The Department of Health and Human Services,
48 Division of Child Development and Early Education, shall continue implementing the
49 prekindergarten program (NC Pre-K). The NC Pre-K program shall serve children who are four
50 years of age on or before August 31 of the program year. In determining eligibility, the Division
51 shall establish income eligibility requirements for the program not to exceed seventy-five percent

(75%) of the State median income. Up to twenty percent (20%) of children enrolled may have family incomes in excess of seventy-five percent (75%) of median income if those children have other designated risk factors. Furthermore, any age-eligible child who is a child of either of the following shall be eligible for the program: (i) an active duty member of the Armed Forces of the United States, including the North Carolina National Guard, State military forces, or a reserve component of the Armed Forces who was ordered to active duty by the proper authority within the last 18 months or is expected to be ordered within the next 18 months, or (ii) a member of the Armed Forces of the United States, including the North Carolina National Guard, State military forces, or a reserve component of the Armed Forces who was injured or killed while serving on active duty. Eligibility determinations for NC Pre-K participants may continue through local education agencies and local North Carolina Partnership for Children, Inc., partnerships.

Other than developmental disabilities or other chronic health issues, the Division shall not consider the health of a child as a factor in determining eligibility for participation in the NC Pre-K program.

SECTION 9C.1.(b) Multiyear Contracts. – The Division of Child Development and Early Education shall require the NC Pre-K contractor to issue multiyear contracts for licensed private child care centers providing NC Pre-K classrooms.

SECTION 9C.1.(c) Building Standards. – Notwithstanding G.S. 110-91(4), private child care facilities and public schools operating NC Pre-K classrooms shall meet the building standards for preschool students as provided in G.S. 115C-521.1.

SECTION 9C.1.(d) Programmatic Standards. – Except as provided in subsection (b1) of this section, entities operating NC Pre-K classrooms shall adhere to all of the policies prescribed by the Division of Child Development and Early Education regarding programmatic standards and classroom requirements.

SECTION 9C.1.(e) NC Pre-K Committees. – Local NC Pre-K committees shall use the standard decision-making process developed by the Division of Child Development and Early Education in awarding NC Pre-K classroom slots and student selection.

SECTION 9C.1.(f) Reporting. – The Division of Child Development and Early Education shall submit an annual report no later than March 15 of each year to the Joint Legislative Oversight Committee on Health and Human Services, the Office of State Budget and Management, and the Fiscal Research Division. The report shall include the following:

- (1) The number of children participating in the NC Pre-K program by county.
- (2) The number of children participating in the NC Pre-K program who have never been served in other early education programs such as child care, public or private preschool, Head Start, Early Head Start, or early intervention programs.
- (3) The expected NC Pre-K expenditures for the programs and the source of the local contributions.
- (4) The results of an annual evaluation of the NC Pre-K program.

SECTION 9C.1.(g) Audits. – The administration of the NC Pre-K program by local partnerships shall be subject to the financial and compliance audits authorized under G.S. 143B-168.14(b).

RAISE BASE SLOT REIMBURSEMENT RATES FOR NC PRE-K

SECTION 9C.2. Of the funds appropriated in this act to the Department of Health and Human Services, Division of Child Development and Early Education, funds shall be allocated to raise the base slot reimbursement rates for the North Carolina Prekindergarten (NC Pre-K) program by thirteen percent (13%) over the 2020-2021 fiscal year rates for the 2021-2022 fiscal year and by an additional two and a half percent (2.5%) over the 2021-2022 rates for the 2022-2023 fiscal year. It is the intent of the General Assembly that the funds allocated pursuant to this section be used to increase the salaries of licensed B-K teachers working in private or

1 Head Start NC Pre-K classrooms. These funds shall be used as a means to address disparities in
2 teacher salaries among teachers working in child care centers versus those working in public
3 schools.

4
5 **SLOT EXPANSION FOR NC PRE-K**

6 **SECTION 9C.3.** Of the funds appropriated in this act to the Department of Health
7 and Human Services, Division of Child Development and Early Education, funds shall be
8 allocated to add one thousand five hundred (1,500) student slots in North Carolina
9 Prekindergarten (NC Pre-K) programs over the 2021-2022 number for the 2022-2023 fiscal year.

10
11 **CHILD CARE SUBSIDY RATES**

12 **SECTION 9C.4.(a)** The maximum gross annual income for initial eligibility,
13 adjusted annually, for subsidized child care services shall be determined based on a percentage
14 of the federal poverty level as follows:

15	AGE	INCOME PERCENTAGE LEVEL
16	0 – 5	200%
17	6 – 12	133%

18 The eligibility for any child with special needs, including a child who is 13 years of
19 age or older, shall be two hundred percent (200%) of the federal poverty level.

20 **SECTION 9C.4.(b)** Fees for families who are required to share in the cost of care
21 are established based on nine percent (9%) of gross family income. When care is received at the
22 blended rate, the co-payment shall be eighty-three percent (83%) of the full-time co-payment.
23 Co-payments for part-time care shall be seventy-five percent (75%) of the full-time co-payment.

24 **SECTION 9C.4.(c)** Payments for the purchase of child care services for low-income
25 children shall be in accordance with the following requirements:

- 26 (1) Religious sponsored child care facilities operating pursuant to G.S. 110-106
27 and licensed child care centers that meet the minimum licensing standards that
28 are participating in the subsidized child care program shall be paid the one-star
29 county market rate or the rate they charge privately paying parents, whichever
30 is lower, unless prohibited by subsection (f) of this section.
- 31 (2) Licensed child care centers and homes with three or more stars shall receive
32 the market rate for that rated license level for that age group or the rate they
33 charge privately paying parents, whichever is lower, unless prohibited by
34 subsection (g) of this section.
- 35 (3) No payments shall be made for transportation services charged by child care
36 facilities.
- 37 (4) Payments for subsidized child care services for postsecondary education shall
38 be limited to a maximum of 20 months of enrollment. This shall not be
39 determined before a family's annual recertification period.

40 **SECTION 9C.4.(d)** Provisions of payment rates for child care providers in counties
41 that do not have at least 50 children in each age group for center-based and home-based care are
42 as follows:

- 43 (1) Except as applicable in subdivision (2) of this subsection, payment rates shall
44 be set at the statewide or regional market rate for licensed child care centers
45 and homes.
- 46 (2) If it can be demonstrated that the application of the statewide or regional
47 market rate to a county with fewer than 50 children in each age group is lower
48 than the county market rate and would inhibit the ability of the county to
49 purchase child care for low-income children, then the county market rate may
50 be applied.

1 **SECTION 9C.4.(e)** A market rate shall be calculated for child care centers and
2 homes at each rated license level for each county and for each age group or age category of
3 enrollees and shall be representative of fees charged to parents for each age group of enrollees
4 within the county. The Division of Child Development and Early Education shall also calculate
5 a statewide rate and regional market rate for each rated license level for each age category.

6 **SECTION 9C.4.(f)** The Division of Child Development and Early Education shall
7 continue implementing policies that improve the quality of child care for subsidized children,
8 including a policy in which child care subsidies are paid, to the extent possible, for child care in
9 the higher quality centers and homes only. The Division shall define higher quality, and subsidy
10 funds shall not be paid for one- or two-star rated facilities. For those counties with an inadequate
11 number of four- and five-star rated facilities, the Division shall continue a transition period that
12 allows the facilities to continue to receive subsidy funds while the facilities work on the increased
13 star ratings. The Division may allow exemptions in counties where there is an inadequate number
14 of four- and five-star rated facilities for non-star rated programs, such as religious programs.

15 **SECTION 9C.4.(g)** Facilities licensed pursuant to Article 7 of Chapter 110 of the
16 General Statutes and facilities operated pursuant to G.S. 110-106 may participate in the program
17 that provides for the purchase of care in child care facilities for minor children of needy families.
18 Except as authorized by subsection (f) of this section, no separate licensing requirements shall
19 be used to select facilities to participate. In addition, child care facilities shall be required to meet
20 any additional applicable requirements of federal law or regulations. Child care arrangements
21 exempt from State regulation pursuant to Article 7 of Chapter 110 of the General Statutes shall
22 meet the requirements established by other State law and by the Social Services Commission.

23 County departments of social services or other local contracting agencies shall not
24 use a provider's failure to comply with requirements in addition to those specified in this
25 subsection as a condition for reducing the provider's subsidized child care rate.

26 **SECTION 9C.4.(h)** Payment for subsidized child care services provided with
27 Temporary Assistance for Needy Families Block Grant funds shall comply with all regulations
28 and policies issued by the Division of Child Development and Early Education for the subsidized
29 child care program.

30 **SECTION 9C.4.(i)** Noncitizen families who reside in this State legally shall be
31 eligible for child care subsidies if all other conditions of eligibility are met. If all other conditions
32 of eligibility are met, noncitizen families who reside in this State illegally shall be eligible for
33 child care subsidies only if at least one of the following conditions is met:

- 34 (1) The child for whom a child care subsidy is sought is receiving child protective
35 services or foster care services.
- 36 (2) The child for whom a child care subsidy is sought is developmentally delayed
37 or at risk of being developmentally delayed.
- 38 (3) The child for whom a child care subsidy is sought is a citizen of the United
39 States.

40 **SECTION 9C.4.(j)** The Department of Health and Human Services, Division of
41 Child Development and Early Education, shall require all county departments of social services
42 to include on any forms used to determine eligibility for child care subsidy whether the family
43 waiting for subsidy is receiving assistance through the NC Pre-K Program or Head Start.

44 **SECTION 9C.4.(k)** Department of Defense-certified child care facilities licensed
45 pursuant to G.S. 110-106.2 may participate in the State-subsidized child care program that
46 provides for the purchase of care in child care facilities for minor children in needy families,
47 provided that funds allocated from the State-subsidized child care program to Department of
48 Defense-certified child care facilities shall supplement and not supplant funds allocated in
49 accordance with G.S. 143B-168.15(g). Payment rates and fees for military families who choose
50 Department of Defense-certified child care facilities and who are eligible to receive subsidized
51 child care shall be as set forth in this section.

CHILD CARE ALLOCATION FORMULA

SECTION 9C.5.(a) The Department of Health and Human Services, Division of Child Development and Early Education (Division), shall allocate child care subsidy voucher funds to pay the costs of necessary child care for minor children of needy families. The mandatory thirty percent (30%) North Carolina Partnership for Children, Inc., subsidy allocation under G.S. 143B-168.15(g) shall constitute the base amount for each county's child care subsidy allocation. The Department of Health and Human Services shall use the following method when allocating federal and State child care funds, not including the aggregate mandatory thirty percent (30%) North Carolina Partnership for Children, Inc., subsidy allocation:

- (1) Funds shall be allocated to a county based upon the projected cost of serving children under age 11 in families with all parents working who earn less than the applicable federal poverty level percentage set forth in Section 9C.4(a) of this act.
- (2) The Division may withhold up to two percent (2%) of available funds from the allocation formula for (i) preventing termination of services throughout the fiscal year and (ii) repayment of any federal funds identified by counties as overpayments, including overpayments due to fraud. The Division shall allocate to counties any funds withheld before the end of the fiscal year when the Division determines the funds are not needed for the purposes described in this subdivision. The Division shall submit a report to the Joint Legislative Oversight Committee on Health and Human Services and the Fiscal Research Division, which report shall include each of the following:
 - a. The amount of funds used for preventing termination of services and the repayment of any federal funds.
 - b. The date the remaining funds were distributed to counties.
 - c. As a result of funds withheld under this subdivision and after funds have been distributed, any counties that did not receive at least the amount the counties received the previous year and the amount by which funds were decreased.

The Division shall submit a report in each year of the 2021-2023 fiscal biennium 30 days after the funds withheld pursuant to this subdivision are distributed but no later than April 1 of each respective year.

- (3) The Division shall set aside four percent (4%) of child care subsidy allocations for vulnerable populations, which include a child identified as having special needs and a child whose application for assistance indicates that the child and the child's family is experiencing homelessness or is in a temporary living situation. A child identified by this subdivision shall be given priority for receiving services until such time as set-aside allocations for vulnerable populations are exhausted.

SECTION 9C.5.(b) The Division may reallocate unused child care subsidy voucher funds in order to meet the child care needs of low-income families. Any reallocation of funds shall be based upon the expenditures of all child care subsidy voucher funding, including North Carolina Partnership for Children, Inc., funds within a county. Counties shall manage service levels within the funds allocated to the counties. A county with a spending coefficient over one hundred percent (100%) shall submit a plan to the Division for managing the county's allocation before receiving any reallocated funds.

SECTION 9C.5.(c) When implementing the formula under subsection (a) of this section, the Division shall include the market rate increase in the formula process rather than calculating the increases outside of the formula process. Additionally, the Department shall do the following:

- 1 (1) Implement the final one-third change in a county's allocation beginning fiscal
2 year 2020-2021. A county's initial allocation shall be the county's expenditure
3 in the previous fiscal year or a prorated share of the county's previous fiscal
4 year expenditures if sufficient funds are not available.
- 5 (2) Effective immediately following the next new decennial census data release,
6 implement (i) one-third of the change in a county's allocation in the year
7 following the data release, (ii) an additional one-third of the change in a
8 county's allocation beginning two years after the initial change under this
9 subdivision, and (iii) the final one-third change in a county's allocation
10 beginning the following two years thereafter.

11 SMART START INITIATIVES

12 **SECTION 9C.6.(a)** Policies. – The North Carolina Partnership for Children, Inc.,
13 and its Board shall ensure policies focus on the North Carolina Partnership for Children, Inc.'s
14 mission of improving child care quality in North Carolina for children from birth to five years of
15 age. North Carolina Partnership for Children, Inc.-funded activities shall include assisting child
16 care facilities with (i) improving quality, including helping one-, two-, and three-star-rated
17 facilities increase their star ratings, and (ii) implementing prekindergarten programs. State
18 funding for local partnerships shall also be used for evidence-based or evidence-informed
19 programs for children from birth to 5 years of age that do the following:

- 20 (1) Increase children's literacy.
- 21 (2) Increase the parents' ability to raise healthy, successful children.
- 22 (3) Improve children's health.
- 23 (4) Assist four- and five-star-rated facilities in improving and maintaining quality.

24 **SECTION 9C.6.(b)** Administration. – Administrative costs shall be equivalent to,
25 on an average statewide basis for all local partnerships, not more than eight percent (8%) of the
26 total statewide allocation to all local partnerships. For purposes of this subsection, administrative
27 costs shall include costs associated with partnership oversight, business and financial
28 management, general accounting, human resources, budgeting, purchasing, contracting, and
29 information systems management. The North Carolina Partnership for Children, Inc., shall
30 continue using a single statewide contract management system that incorporates features of the
31 required standard fiscal accountability plan described in G.S. 143B-168.12(a)(4). All local
32 partnerships are required to participate in the contract management system and, directed by the
33 North Carolina Partnership for Children, Inc., to collaborate, to the fullest extent possible, with
34 other local partnerships to increase efficiency and effectiveness.

35 **SECTION 9C.6.(c)** Salaries. – The salary schedule developed and implemented by
36 the North Carolina Partnership for Children, Inc., shall set the maximum amount of State funds
37 that may be used for the salary of the Executive Director of the North Carolina Partnership for
38 Children, Inc., and the directors of the local partnerships. The North Carolina Partnership for
39 Children, Inc., shall base the schedule on the following criteria:

- 40 (1) The population of the area serviced by a local partnership.
- 41 (2) The amount of State funds administered.
- 42 (3) The amount of total funds administered.
- 43 (4) The professional experience of the individual to be compensated.
- 44 (5) Any other relevant factors pertaining to salary, as determined by the North
45 Carolina Partnership for Children, Inc.

46 The salary schedule shall be used only to determine the maximum amount of State
47 funds that may be used for compensation. Nothing in this subsection shall be construed to prohibit
48 a local partnership from using non-State funds to supplement an individual's salary in excess of
49 the amount set by the salary schedule established under this subsection.
50

1 **SECTION 9C.6.(d)** Match Requirements. – The North Carolina Partnership for
2 Children, Inc., and all local partnerships shall, in the aggregate, be required to match one hundred
3 percent (100%) of the amount budgeted for the program in each fiscal year of the base budget
4 for the 2021-2023 biennium. Of the funds the North Carolina Partnership for Children, Inc., and
5 the local partnerships are required to match, contributions of cash shall be equal to at least thirteen
6 percent (13%) and in-kind donated resources shall be equal to no more than six percent (6%) for
7 a total match requirement of nineteen percent (19%) for each year of the 2021-2023 fiscal
8 biennium. The North Carolina Partnership for Children, Inc., may carry forward any amount in
9 excess of the required match for a fiscal year in order to meet the match requirement of the
10 succeeding fiscal year. Only in-kind contributions that are quantifiable shall be applied to the
11 in-kind match requirement. Volunteer services may be treated as an in-kind contribution for the
12 purpose of the match requirement of this subsection. Volunteer services that qualify as
13 professional services shall be valued at the fair market value of those services. All other volunteer
14 service hours shall be valued at the statewide average wage rate as calculated from data compiled
15 by the Division of Employment Security of the Department of Commerce in the Employment
16 and Wages in North Carolina Annual Report for the most recent period for which data are
17 available. Expenses, including both those paid by cash and in-kind contributions, incurred by
18 other participating non-State entities contracting with the North Carolina Partnership for
19 Children, Inc., or the local partnerships also may be considered resources available to meet the
20 required private match. In order to qualify to meet the required private match, the expenses shall:

- 21 (1) Be verifiable from the contractor's records.
- 22 (2) If in-kind, other than volunteer services, be quantifiable in accordance with
23 generally accepted accounting principles for nonprofit organizations.
- 24 (3) Not include expenses funded by State funds.
- 25 (4) Be supplemental to and not supplant preexisting resources for related program
26 activities.
- 27 (5) Be incurred as a direct result of the Early Childhood Initiatives Program and
28 be necessary and reasonable for the proper and efficient accomplishment of
29 the Program's objectives.
- 30 (6) Be otherwise allowable under federal or State law.
- 31 (7) Be required and described in the contractual agreements approved by the
32 North Carolina Partnership for Children, Inc., or the local partnership.
- 33 (8) Be reported to the North Carolina Partnership for Children, Inc., or the local
34 partnership by the contractor in the same manner as reimbursable expenses.

35 Failure to obtain a nineteen-percent (19%) match by June 30 of each year of the
36 2021-2023 fiscal biennium shall result in a dollar-for-dollar reduction in the appropriation for the
37 Program for a subsequent fiscal year. The North Carolina Partnership for Children, Inc., shall be
38 responsible for compiling information on the private cash and in-kind contributions into a report
39 that is submitted to the Joint Legislative Oversight Committee on Health and Human Services in
40 a format that allows verification by the Department of Revenue. The same match requirements
41 shall apply to any expansion funds appropriated by the General Assembly.

42 **SECTION 9C.6.(e)** Bidding. – The North Carolina Partnership for Children, Inc.,
43 and all local partnerships shall use competitive bidding practices in contracting for goods and
44 services on contract amounts as follows:

- 45 (1) For amounts of five thousand dollars (\$5,000) or less, the procedures specified
46 by a written policy as developed by the Board of Directors of the North
47 Carolina Partnership for Children, Inc.
- 48 (2) For amounts greater than five thousand dollars (\$5,000), but less than fifteen
49 thousand dollars (\$15,000), three written quotes.
- 50 (3) For amounts of fifteen thousand dollars (\$15,000) or more, but less than forty
51 thousand dollars (\$40,000), a request for proposal process.

- 1 (4) For amounts of forty thousand dollars (\$40,000) or more, a request for
2 proposal process and advertising in a major newspaper.

3 **SECTION 9C.6.(f)** Allocations. – The North Carolina Partnership for Children, Inc.,
4 shall not reduce the allocation for counties with less than 35,000 in population below the
5 2012-2013 funding level.

6 **SECTION 9C.6.(g)** Performance-Based Evaluation. – The Department of Health
7 and Human Services shall continue to implement the performance-based evaluation system.

8 **SECTION 9C.6.(h)** Expenditure Restrictions. – Except as provided in subsection (i)
9 of this section, the Department of Health and Human Services and the North Carolina Partnership
10 for Children, Inc., shall ensure that the allocation of funds for Early Childhood Education and
11 Development Initiatives for the 2021-2023 fiscal biennium shall be administered and distributed
12 in the following manner:

- 13 (1) Capital expenditures are prohibited for the 2021-2023 fiscal biennium. For the
14 purposes of this section, "capital expenditures" means expenditures for capital
15 improvements as defined in G.S. 143C-1-1(d)(5).
16 (2) Expenditures of State funds for advertising and promotional activities are
17 prohibited for the 2021-2023 fiscal biennium.

18 For the 2021-2023 fiscal biennium, local partnerships shall not spend any State funds
19 on marketing campaigns, advertising, or any associated materials. Local partnerships may spend
20 any private funds the local partnerships receive on those activities.

21 **SECTION 9C.6.(i)** Notwithstanding subsection (h) of this section, the North
22 Carolina Partnership for Children, Inc., and local partnerships may use up to one percent (1%) of
23 State funds for fund-raising activities. The North Carolina Partnership for Children, Inc., shall
24 include in its annual report required under G.S. 143B-168.12(d) a report on the use of State funds
25 for fund-raising. The report shall include the following:

- 26 (1) The amount of funds expended on fund-raising.
27 (2) Any return on fund-raising investments.
28 (3) Any other information deemed relevant.
29

30 SMART START VISITING PROGRAMS

31 **SECTION 9C.7.** Funds allocated to the North Carolina Partnership for Children,
32 Inc., from the Department of Health and Human Services, shall be used for evidence based,
33 family strengthening and home visiting programs and other evidence-based or
34 evidence-informed early childhood initiatives. Funds appropriated under this section shall not be
35 subject to the child care services funding requirements under G.S. 143B-168.15(b), child care
36 subsidy expansion requirements under G.S. 143B-168.15(g), or the match requirements under
37 Section 9C.6(d) of this act.
38

39 EDUCATOR PIPELINE PROGRAM

40 **SECTION 9C.8.** Of the funds appropriated in this act to the Department of Health
41 and Human Services, Division of Child Development and Early Education, funds shall be
42 allocated to facilitate the alignment of existing educator workforce programs, and, where
43 necessary, work with partners to build and advance pathways for certification, higher education,
44 and employment for early education educators.
45

46 EARLY CHILDHOOD WORKFORCE RACIAL EQUITY INITIATIVE

47 **SECTION 9C.9.(a)** The Department of Health and Human Services, Division of
48 Child Development and Early Education shall facilitate the alignment of existing policies and
49 efforts around educator and program bias and reducing or eliminating preschool expulsion and
50 exclusionary practices. The Division shall then create and appoint a Design Team to (i) study
51 issues related to implicit bias in early education settings and (ii) make recommendations and

1 implementation plans to reduce educator and program bias and reduce or eliminate preschool
2 expulsion and exclusionary practices.

3 **SECTION 9C.9.(b)** Beginning in the 2022-2023 fiscal year, the Department of
4 Health and Human Services, Division of Child Development and Early Education shall begin
5 executing plans resulting from the study conducted under subsection (a) of this section.
6

7 **PRE-K TEACHER BIRTH-K LICENCE PAY EQUITY**

8 **SECTION 9C.10.** Of the funds appropriated in this act to the Department of Health
9 and Human Services, Division of Child Development and Early Education, funds shall be
10 allocated to develop and implement a model to gradually increase compensation of licensed
11 birth-kindergarten educators working in private child care settings.
12

13 **PART IX-D. HEALTH BENEFITS**

14 **MEDICAID ANNUAL REPORT**

15 **SECTION 9D.1.** The Department of Health and Human Services, Division of Health
16 Benefits (Division), shall continue the publication of the Medicaid Annual Report and
17 accompanying tables. The Division shall publish the report and tables on its Web site no later
18 than December 31 following each State fiscal year.
19

20 **ANNUAL ISSUANCE OF MEDICAID IDENTIFICATION CARDS**

21 **SECTION 9D.2.** The Department of Health and Human Services (Department) shall
22 issue Medicaid identification cards to recipients on an annual basis with updates as needed.
23
24

25 **ADMINISTRATIVE HEARINGS FUNDING**

26 **SECTION 9D.3.** Of the funds appropriated to the Department of Health and Human
27 Services, Division of Health Benefits, for administrative contracts and interagency transfers, the
28 Department of Health and Human Services (Department) shall transfer the sum of one million
29 dollars (\$1,000,000) for the 2021-2022 fiscal year and the sum of one million dollars
30 (\$1,000,000) for the 2022-2023 fiscal year to the Office of Administrative Hearings (OAH).
31 These funds shall be allocated by the OAH for mediation services provided for Medicaid
32 applicant and recipient appeals and to contract for other services necessary to conduct the appeals
33 process. The OAH shall continue the Memorandum of Agreement (MOA) with the Department
34 for mediation services provided for Medicaid recipient appeals and contracted services necessary
35 to conduct the appeals process. The MOA will facilitate the Department's ability to draw down
36 federal Medicaid funds to support this administrative function. Upon receipt of invoices from the
37 OAH for covered services rendered in accordance with the MOA, the Department shall transfer
38 the federal share of Medicaid funds drawn down for this purpose.
39

40 **ACCOUNTING FOR MEDICAID RECEIVABLES AS NONTAX REVENUE**

41 **SECTION 9D.4.(a)** Receivables reserved at the end of the 2021-2022 and
42 2022-2023 fiscal years shall, when received, be accounted for as nontax revenue for each of those
43 fiscal years.
44

45 **SECTION 9D.4.(b)** For the 2021-2022 fiscal year, the Department of Health and
46 Human Services shall deposit from its revenues one hundred forty-eight million eight hundred
47 thousand dollars (\$148,800,000) with the Department of State Treasurer to be accounted for as
48 nontax revenue. For the 2022-2023 fiscal year, the Department of Health and Human Services
49 shall deposit from its revenues one hundred fifty-five million nine hundred thousand dollars
50 (\$155,900,000) with the Department of State Treasurer to be accounted for as nontax revenue.
51 These deposits shall represent the return of General Fund appropriations, nonfederal revenue,
fund balances, or other resources from State-owned and State-operated hospitals that are used to

1 provide indigent and nonindigent care services. The return from State-owned and State-operated
2 hospitals to the Department of Health and Human Services shall be made from nonfederal
3 resources as follows:

- 4 (1) The University of North Carolina Hospitals at Chapel Hill shall deposit:
5 a. For the 2021-22 fiscal year: thirty three million, four hundred thousand
6 (\$33,400,000).
7 b. For the 2022-2023 fiscal year and annually thereafter, an amount equal to
8 the 2021-2022 amount adjusted based on the percentage change in
9 payments to the University of North Carolina Hospitals at Chapel Hill for
10 Medicaid and NC Health Choice enrollees, as demonstrated in data from
11 prepaid health plans and the State, as determined by the Department.
12 (2) All other State-owned and State-operated hospitals specializing in psychiatric
13 care shall deposit annually an amount equal to the amount of the payments
14 from the Division of Health Benefits for uncompensated care.

15 **SECTION 9D.4.(c)** The treatment of any revenue derived from federal programs
16 shall be in accordance with the requirements specified in the Code of Federal Regulations, Title
17 2, Part 225.

18 **VOLUME PURCHASE PLANS AND SINGLE SOURCE PROCUREMENT**

19 **SECTION 9D.5.** The Department of Health and Human Services, Division of Health
20 Benefits, may, subject to the approval of a change in the State Medicaid Plan, contract for
21 services, medical equipment, supplies, and appliances by implementation of volume purchase
22 plans, single source procurement, or other contracting processes in order to improve cost
23 containment.
24

25 **LME/MCO INTERGOVERNMENTAL TRANSFERS**

26 **SECTION 9D.6.** The local management entities/managed care organizations
27 (LME/MCOs) shall make intergovernmental transfers to the Department of Health and Human
28 Services, Division of Health Benefits (DHB), an aggregate amount of eighteen million
29 twenty-eight thousand two hundred seventeen dollars (\$18,028,217) in the 2021-2022 fiscal year.
30 The due date and frequency of the intergovernmental transfer required by this section shall be
31 determined by DHB. The amount of the intergovernmental transfer that each individual
32 LME/MCO is required to make in each fiscal year shall be determined by DHB.

33 In the event that any county disengages from an LME/MCO and realigns with another
34 LME/MCO during the 2021-2022 fiscal year, DHB shall have the authority to reallocate the
35 amount of the intergovernmental transfer that each affected LME/MCO is required to make,
36 taking into consideration the change in catchment area and covered population, provided that the
37 aggregate amount of the transfers received from all LME/MCOs is achieved.
38

39 **EXPAND NORTH CAROLINA INNOVATIONS WAIVER SLOTS**

40 **SECTION 9D.7.** The Department of Health and Human Services, Division of Health
41 Benefits, shall amend the North Carolina Innovations waiver to increase the number of slots
42 available under the waiver. These additional slots shall be made available on October 1, 2021.
43

44 **USE OF MEDICAID TRANSFORMATION FUND FOR MEDICAID 45 TRANSFORMATION NEEDS**

46 **SECTION 9D.8.(a)** Claims Run Out. – Funds from the Medicaid Transformation
47 Fund may be transferred to the Department of Health and Human Services, Division of Health
48 Benefits (DHB), as needed for the purpose of paying claims related to services billed under the
49 fee-for-service payment model for recipients who are being, or have been, transitioned to
50 managed care, otherwise known as "claims run out." Funds may be transferred to DHB as the
51

1 need to pay claims run out arises and need not be transferred in one lump sum. To the extent that
2 any funds are transferred under this subsection, the funds are appropriated for the purpose set
3 forth in this subsection.

4 **SECTION 9D.8.(b)** Non-Claims Run Out Medicaid Transformation Needs. –
5 Subject to the fulfillment of conditions specified in subsection (c) of this section, the sum of one
6 hundred sixteen million one hundred nine thousand seven hundred fourteen dollars
7 (\$116,109,714) in nonrecurring funds for the 2021-2022 fiscal year and the sum of ninety-seven
8 million nine hundred four thousand eight hundred dollars (\$97,904,800) in nonrecurring funds
9 for the 2022-2023 fiscal year from the Medicaid Transformation Fund may be transferred to the
10 Department of Health and Human Services, Division of Health Benefits (DHB), for the sole
11 purpose of providing the State share for nonrecurring qualifying needs directly related to
12 Medicaid transformation, as required by S.L. 2015-241, as amended. Funds may be transferred
13 to DHB as nonrecurring qualifying needs arise during the 2021-2023 fiscal biennium and need
14 not be transferred in one lump sum.

15 For the purposes of this section, the term "qualifying need" shall be limited to
16 information technology, time-limited staffing, and contracts related to the following Medicaid
17 transformation needs:

- 18 (1) Program design.
- 19 (2) Beneficiary experience.
- 20 (3) NC FAST upgrades related to Medicaid transformation.
- 21 (4) Data management tools.
- 22 (5) Program integrity.
- 23 (6) Technical and operational integration.
- 24 (7) Tailored Plan Care Management.
- 25 (8) Healthy Opportunities Pilots.
- 26 (9) Other nonrecurring needs identified by DHB, as determined in consultation
27 with the Office of State Budget and Management.

28 **SECTION 9D.8.(c)** Requests for Transfer of Funds for Qualifying Need. – A request
29 by the Department of Health and Human Services, Division of Health Benefits (DHB), for the
30 transfer of funds pursuant to subsection (b) of this section shall be made to the Office of State
31 Budget and Management (OSBM) and shall include the amount requested and the specific
32 nonrecurring qualifying need for which the funds are to be used. None of the funds identified in
33 subsection (b) of this section shall be transferred to DHB until OSBM verifies the following
34 information:

- 35 (1) The amount requested is to be used for a nonrecurring qualifying need in the
36 2021-2023 fiscal biennium.
- 37 (2) The amount requested provides a State share that will not result in total
38 requirements that exceed six hundred ninety-nine million nine hundred
39 fifty-two thousand three hundred sixty-four dollars (\$699,952,364) in
40 nonrecurring funds for the 2021-2023 fiscal biennium.

41 **SECTION 9D.8.(d)** Federal Fund Receipts. – Any federal funds received in any
42 fiscal year by the Department of Health and Human Services, Division of Health Benefits (DHB),
43 that represent a return of State share already expended on a qualifying need related to the funds
44 received by the DHB under this section shall be deposited into the Medicaid Transformation
45 Fund.

46 **MEDICAID EXPANSION/CLOSING THE COVERAGE GAP**

47 **SECTION 9D.9.** The Department of Health and Human Services, Division of Health
48 Benefits, shall provide Medicaid coverage to adults ages 19 to 64 at or below 133% of the federal
49 poverty level in accordance with 1902(a)(10)(A)(i)(VIII) of Section 1905 of the Social Security
50 Act.
51

HOSPITAL UNCOMPENSATED CARE FUND TRANSFER

SECTION 9D.10. Of the funds transferred to the Department of Health and Human Services for Medicaid programs pursuant to G.S. 143C-9-9, there is appropriated from the Hospital Uncompensated Care Fund to the Department of Health and Human Services the sum of forty-three million dollars (\$43,000,000) for the 2021-2022 fiscal year and the sum of forty-three million dollars (\$43,000,000) for the 2022-2023 fiscal year. These funds shall be allocated as prescribed by G.S. 143C-9-1(b) for Medicaid programs. Notwithstanding the prescription in G.S. 143C-9-1(b) that these funds not reduce State general revenue funding, these funds shall replace the reduction in general revenue funding effected in this act.

MISCELLANEOUS MEDICAID PROVISIONS

SECTION 9D.11. Cost Containment Programs. – The Department of Health and Human Services, Division of Health Benefits, may undertake cost containment programs, including contracting for services, preadmissions to hospitals, and prior approval for certain outpatient surgeries before they may be performed in an inpatient setting.

MOBILE DENTAL PROVIDER ENROLLMENT

SECTION 9D.12. For mobile dental providers seeking enrollment as a Medicaid provider, and upon reenrollment of current Medicaid mobile dental providers, the Department of Health and Human Services, Division of Health Benefits, shall require as a condition of enrollment or reenrollment that the mobile dental provider show proof of a contractual affiliation with a dental practice that is not mobile, and the Department shall require the mobile dental provider to use the National Provider Identifier (NPI) of the nonmobile dental practice for purposes of filing claims.

REDUCTION OF MEDICAID FRAUD, WASTE AND ABUSE THROUGH COST CONTAINMENT

SECTION 9D.13.(a) The Department of Health and Human Services may use up to five million dollars (\$2,500,000) in the 2021-22 fiscal year and up to five million dollars (\$5,000,000) in the 2022-23 fiscal year in Medicaid funds budgeted for program services to support the cost of program integrity activities when cost effectiveness and documentable savings are demonstrated. The funds shall be used to support program integrity activities that contain the costs of the Medicaid Program through post payment recoveries and activities that prevent payments of fraudulent, wasteful or abusive claiming. Program Integrity will reinvest funding to implement technology solutions and increase investigative and compliance monitoring staffing and throughput. Investments will also include funding to support enhanced case management and reporting capabilities to assist in reporting and targeting the most cost effective approaches in addressing fraud, waste, and abuse. Funds may also be used to add up to 24.00 time-limited FTE to expand prepayment and post-payment solutions within existing Medicaid payment systems and through other prepayment reviews completed by contractors. Expenditures for these activities will be targeted to exceed a minimum return on investment of no less than 2:1 when considering the increased recoupments and reductions in improper payments versus overall costs for the activities as defined in the section.

SECTION 9D.13.(b) The Department shall report annually on the expenditures under this section. The report shall include the methods used to achieve savings and the amount saved by these methods. No later than October 1 of each year, the Department of Health and Human Services, Division of Health Benefits, shall report to the Joint House Appropriations Subcommittee on Health and Human Services, the Senate Appropriations Committee on Health and Human Services, and the Fiscal Research Division on the activities of the previous State fiscal year.

6 **SECTION 9D.14.(b)** Chapter 108A of the General Statutes is amended by adding a
7 new Article to read:

8 "Article 7B.

9 "Hospital Assessment Act.

10 "Part 1. General.

11 **"§ 108A-145.1. Short title and purpose.**

12 This Article shall be known as the "Hospital Assessment Act." This Article does not authorize
13 a political subdivision of the State to license a hospital for revenue or impose a tax or assessment
14 on a hospital.

15 **"§ 108A-145.3. Definitions.**

16 The following definitions apply in this Article:

- 17 (1) Acute care hospital. – A hospital licensed in North Carolina that is not a
18 freestanding psychiatric hospital, a freestanding rehabilitation hospital, a
19 long-term care hospital, or a State-owned and State-operated hospital.
- 20 (2) Base capitation rate. – A periodic per-enrollee or per-event amount paid by
21 the Department to prepaid health plans for the delivery of Medicaid and NC
22 Health Choice services in accordance with Article 4 of Chapter 108D of the
23 General Statutes applicable to a particular rating group and appearing in a
24 Medicaid managed care capitation rate certification, as adjusted by the
25 Department and allowed by CMS in accordance with Part 438 of Subchapter
26 C of Chapter IV of Title 42 of the Code of Federal Regulations.
- 27 (3) Capitated contract plan type. – Any type of capitated prepaid health plan
28 contract defined in G.S. 108D-1.
- 29 (4) CMS. – Centers for Medicare and Medicaid Services.
- 30 (5) Critical access hospital. – As defined in 42 C.F.R. § 400.202.
- 31 (6) Federal medical assistance percentage (FMAP). – The federal share of North
32 Carolina Medicaid service costs as calculated by the federal Department of
33 Health and Human Services in accordance with Section 1905(b) of the Social
34 Security Act, in effect at the start of the applicable assessment quarter,
35 expressed as a decimal.
- 36 (7) Hospital costs. – A hospital's costs as calculated using the most recent
37 available Hospital Cost Report Information System's cost report data available
38 through CMS, including both inpatient and outpatient components.
- 39 (8) Inpatient hospital financing percentage. – For the 2021-2022 State fiscal year,
40 the inpatient hospital financing percentage is sixty-six and one-tenth percent
41 (66.1%), expressed as a decimal. For each subsequent State fiscal year, the
42 inpatient hospital financing percentage is the sum of the inpatient hospital
43 financing percentage for the previous State fiscal year plus the market basket
44 percentage, divided by the sum of one plus the market basket percentage.
- 45 (9) Inpatient hospital services. – As defined in the Medicaid State Plan, excluding
46 payments made under the graduate medical education methodology and the
47 disproportionate share hospital methodology.
- 48 (10) Inpatient portion of the statewide capitation rate. – The amount of the
49 statewide capitation rate applicable to a particular rating group that is
50 attributed to inpatient hospital facility health services in the applicable

- 1 Medicaid managed care rate certification, expressed as a statewide weighted
2 average of all PHP regions.
- 3 (11) Market basket percentage. – The hospital inpatient prospective payment
4 system market basket minus the multifactor productivity adjustment
5 established in rule by CMS and in effect on March 1 of the previous State
6 fiscal year, expressed as a decimal.
- 7 (12) Medicaid managed care capitation rate certification. – A rate certification for
8 any capitated contract plan type that contains the rates paid to prepaid health
9 plans and that has been submitted to CMS under 42 C.F.R. 438.7 and, except
10 as otherwise provided in this subdivision, (i) has been approved by CMS, and
11 (ii) is in effect during the applicable time period. If, on the first day of any
12 assessment quarter, CMS has not approved a rate certification for a particular
13 capitated contract plan type for that quarter, then the Medicaid managed care
14 capitation rate certification for that capitated contract plan type is the rate
15 certification submitted to CMS under 42 C.F.R. 438.7 applicable to that
16 quarter.
- 17 (13) Outpatient hospital financing percentage. – Twenty-eight percent (28%),
18 expressed as a decimal.
- 19 (14) Outpatient hospital services. – As defined in the Medicaid State Plan.
- 20 (15) Outpatient portion of the statewide capitation rate. – The amount of the
21 statewide capitation rate applicable to a particular rating group that is
22 attributed to outpatient hospital facility services and emergency room facility
23 services in the applicable Medicaid managed care capitation rate
24 certifications, expressed as a statewide weighted average of all PHP regions.
- 25 (16) Paid capitation. – The total amount of the capitation payments made by the
26 Department to all prepaid health plans for a particular rating group (i)
27 attributable to the base capitation rate in the applicable Medicaid managed
28 care capitation rate certification and (ii) adjusted by the Department as a result
29 of retroactively implementing any base capitation rate adjustment that is
30 approved by CMS or allowed under Part 438 of Subchapter C of Title 42 of
31 the Code of Federal Regulations.
- 32 (17) Previous data collection period. – The period beginning on the eleventh day
33 of the month that is four months prior to the start of the applicable assessment
34 quarter and ending on the tenth day of the month prior to the start of applicable
35 assessment quarter.
- 36 (18) Private acute care hospital. – An acute care hospital that (i) is not qualified to
37 certify public expenditures as described in 42 C.F.R. § 433.51(b), (ii) is not a
38 critical access hospital, and (iii) is not part of UNC Health Care System.
- 39 (19) Private hospital historical assessment share. – Seventy-nine percent (79%),
40 expressed as a decimal.
- 41 (20) Public acute care hospital. – An acute care hospital that (i) is qualified to
42 certify public expenditures as described in 42 C.F.R. § 433.51(b), (ii) is not a
43 critical access hospital, (iii) is not part of the UNC Health Care System, and
44 (iv) is not the primary affiliated teaching hospital for the East Carolina Brody
45 School of Medicine.
- 46 (21) Public hospital historical assessment share. – Twenty-one percent (21%),
47 expressed as a decimal.
- 48 (22) Rating group. – A category of beneficiaries or maternity services for which a
49 periodic per-enrollee or per-event amount appears in a Medicaid managed
50 care capitation rate certification.

- 1 (23) State's annual Medicaid payment. – An annual amount equal to one hundred
2 ten million dollars (\$110,000,000) for the period July 1, 2021, through June
3 30, 2022, increased each year over the prior year's payment by the market
4 basket percentage.
- 5 (24) Statewide capitation rate. – A periodic per-enrollee or per-event amount paid
6 by the Department to prepaid health plans for the delivery of Medicaid and
7 NC Health Choice services in accordance with Article 4 of Chapter 108D of
8 the General Statutes applicable to a particular rating group, expressed as a
9 statewide weighted average for the applicable capitated contract plan type for
10 all PHP regions and appearing in a Medicaid managed care capitation rate
11 certification, as adjusted by the Department and allowed by CMS in
12 accordance with Part 438 of Subchapter C of Chapter IV of Title 42 of the
13 Code of Federal Regulations.
- 14 (25) Third-party coverage. – Liability by any individual, entity, or program for the
15 payment of all or part of the expenditures for medical assistance under the
16 Medicaid State Plan that has been identified by the Department before making
17 the medical assistance expenditure.
- 18 (26) University of North Carolina Health Care System (UNC Health Care System).
19 – As established in G.S. 116-37 and including the following hospitals:
20 a. The University of North Carolina Hospitals at Chapel Hill.
21 b. Rex Hospital, Inc.
22 c. Chatham Hospital, Inc.
23 d. UNC Rockingham Health Care, Inc.
24 e. Caldwell Memorial Hospital, Inc.

25 **"§ 108A-145.5. Due dates and collections.**

26 (a) Assessments under this Article are calculated, imposed, and due quarterly in the time
27 and manner prescribed by the Secretary and shall be considered delinquent if not paid within
28 seven calendar days of this due date.

29 (b) With respect to any hospital owing a past-due assessment amount under this Article,
30 the Department may withhold the unpaid amount from Medicaid or NC Health Choice payments
31 otherwise due or impose a late payment penalty. The Secretary may waive a penalty for good
32 cause shown.

33 (c) In the event the data necessary to calculate an assessment under this Article is not
34 available to the Secretary in time to impose the quarterly assessment, the Secretary may defer the
35 due date for the assessment to a subsequent quarter.

36 **"§ 108A-145.7. Assessment appeals.**

37 A hospital may appeal a determination of the assessment amount owed through a
38 reconsideration review. The pendency of an appeal does not relieve a hospital from its obligation
39 to pay an assessment amount when due.

40 **"§ 108A-145.9. Allowable costs; patient billing.**

41 (a) Assessments paid under this Article may be included as allowable costs of a hospital
42 for purposes of any applicable Medicaid reimbursement formula, except that assessments paid
43 under this Article shall be excluded from cost settlement.

44 (b) Assessments imposed under this Article may not be added as a surtax or assessment
45 on a patient's bill.

46 **"§ 108A-145.11. Rule-making authority.**

47 The Secretary may adopt rules to implement this Article.

48 **"§ 108A-145.13. Repeal.**

49 If CMS determines that an assessment under this Article is impermissible or revokes approval
50 of an assessment under this Article, then that assessment shall not be imposed and the
51 Department's authority to collect the assessment is repealed.

2 "Part 2. Modernized Hospital Assessments.

3 **"§ 108A-146.1. Public Hospital Assessment.**

4 (a) The public hospital assessment imposed under this Part shall apply to all public acute
5 care hospitals.

9 quarter shall equal the aggregate assessment collection amount under G.S. 108A-146.5
10 multiplied by the public hospital historical assessment share and divided by the total hospital
11 costs for all public acute care hospitals holding a license on the first day of the assessment quarter.

12 **"§ 108A-146.3. Private Hospital Assessment.**

13 (a) The private hospital assessment imposed under this Part shall apply to all private acute
14 care hospitals.

15 (b) The private hospital assessment shall be assessed as a percentage of each private acute
16 care hospital's hospital costs. The assessment percentage shall be calculated quarterly by the
17 Department of Health and Human Services in accordance with this Part. The percentage for each
18 quarter shall equal the aggregate assessment collection amount under G.S. 108A-146.5
19 multiplied by the private hospital historical assessment share and divided by the total hospital
20 costs for all private acute care hospitals holding a license on the first day of the assessment
21 quarter.

22 **"§ 108A-146.5. Aggregate Assessment Collection Amount.**

23 The aggregate assessment collection amount is an amount of money that is calculated by
24 adding (i) the managed care component under G.S. 108A-146.7, (ii) the fee-for-service
25 component under G.S. 108A-146.9, (iii) the GME component under G.S. 108A-146.11, and (iv)
26 one-fourth of the State's annual Medicaid payment, and then subtracting the intergovernmental
27 transfer adjustment component under G.S. 108A-146.13.

28 **"§ 108A-146.7. Managed Care Component.**

29 (a) The managed care component is an amount of money that is a portion of the total paid
30 capitation for all rating groups in all capitated contracted plan types for the previous data
31 collection period and is calculated in accordance with this section. The managed care component
32 consists of an inpatient subcomponent and an outpatient subcomponent.

33 (b) The inpatient subcomponent is an amount calculated for each rating group by
34 multiplying the paid capitation for the applicable rating group in the previous data collection
35 period by the percentage that is calculated by (i) multiplying the inpatient portion of the statewide
36 capitation rate for the applicable rating group by the inpatient hospital financing percentage, (ii)
37 multiplying that product by the difference of one minus the FMAP, and (iii) dividing that product
38 by the statewide capitation rate for the applicable rating group.

39 (c) The outpatient subcomponent is an amount calculated for each rating group by
40 multiplying the paid capitation for the applicable rating group in the previous data collection
41 period by the percentage that is calculated by (i) multiplying the outpatient portion of the
42 statewide capitation rate for the applicable rating group by the outpatient hospital financing
43 percentage, (ii) multiplying that product by the difference of one minus the FMAP, and (iii)
44 dividing that product by the statewide capitation rate for the applicable rating group.

45 (d) The managed care component is calculated by adding together the aggregate inpatient
46 subcomponents for all rating groups, and the aggregate outpatient subcomponents for all rating
47 groups.

48 **"§ 108A-146.9 Fee-For-Service Component.**

49 (a) The fee-for-service component is an amount of money that is a portion of all the
50 Medicaid fee-for-service payments made to acute care hospitals during the previous data
51 collection period for claims with a date of service on or after July 1, 2021. The fee-for-service

1 component consists of a subcomponent pertaining to claims for which there is no third-party
2 coverage and a subcomponent pertaining to claims for which there is third-party coverage.

3 (b) The subcomponent pertaining to claims for which there is no third-party coverage is
4 the sum of the inpatient amount and the outpatient amount described in this subsection:

5 (1) The inpatient amount is the product of the total fee-for-service payments for
6 claims for which there is no third-party coverage made to all acute care
7 hospitals for inpatient hospital services multiplied by the inpatient hospital
8 financing percentage and multiplied by the difference of one minus the
9 FMAP.

10 (2) The outpatient amount is the product of the total fee-for-service payments for
11 claims for which there is no third-party coverage made to all acute care
12 hospitals for outpatient hospital services multiplied by the outpatient hospital
13 financing percentage and multiplied by the difference of one minus the
14 FMAP.

15 (c) The subcomponent pertaining to claims for which there is third-party coverage is the
16 product of the total fee-for-service payments for claims for which there is third-party coverage
17 made for inpatient hospital services and outpatient hospital services to (i) public acute care
18 hospitals, (ii) private acute care hospitals, and (iii) critical access hospitals multiplied by the
19 difference of one minus the FMAP.

20 (d) The fee-for-service component is calculated by adding together the subcomponent
21 pertaining to claims for which there is no third-party coverage and the subcomponent pertaining
22 to claims for which there is third-party coverage.

23 **"§ 108A-146.11. Graduate Medical Education Component.**

24 The graduate medical education component is an amount of money that is one-fourth (1/4)
25 of the total amount of payments that will be made by the Department during the current State
26 fiscal year to all public acute care hospitals and private acute care hospitals in accordance with
27 the Medicaid graduate medical education methodology in the Medicaid State Plan multiplied by
28 the difference of one minus the FMAP.

29 **"§ 108A-146.13. Intergovernmental Transfer Adjustment Component.**

30 (a) The intergovernmental transfer adjustment component is forty-four million nine
31 hundred twelve thousand five hundred seven dollars (\$44,912,507) for each quarter of the
32 2021-2022 State fiscal year. For each subsequent State fiscal year, the intergovernmental transfer
33 adjustment component shall be increased over the prior year's quarterly payment by the market
34 basket percentage.

16 adjustment component in G.S. 108A-146.13, as well as the mathematical
17 calculations supporting the proposed changes.

18 (c) The Department of Health and Human Services shall report to the House of
19 Representatives Appropriations Committee on Health and Human Services, the Senate
20 Appropriations Committee on Health and Human Services, and the Fiscal Research Division
21 whenever the Department is notified that a change in hospital status has occurred. The report
22 shall be due 60 days after the Department is notified of the change. The report shall include all
23 of the following:

25 (2) Any proposed revisions to Article 7B of Chapter 108A of the General Statutes
26 that are needed as a result of the change in hospital status, including proposed

37 be thirty-eight hundredths percent (0.38%) of total hospital costs for all public acute care
38 hospitals.

8 hospital assessment collected for the assessment quarter beginning July 1, 2021, from the
9 aggregate assessment collection amount calculated under G.S. 108A-146.5 for the assessment
10 quarter beginning October 1, 2021, with the adjustment required in accordance with subsection
11 (d) of this section. If the reconciliation component is a positive number, then the aggregate
12 assessment collection amount shall be increased by the reconciliation component in accordance
13 with this section. If the reconciliation component is a negative number, then the aggregate
14 assessment collection amount shall be reduced by the reconciliation component in accordance
15 with this section.

16 **SECTION 9D.14.(h)** Notwithstanding the definition of federal medical assistance

17 Department's final determination of the total amount of reimbursement, if any,
18 due to either the provider or the Department following receipt of a provider's
19 annual Medicaid or Health Choice cost report, or amended Medicaid or Health
20 Choice cost report where permitted or required.

9 or federal agency's behalf. The payment suspension shall not exceed the amount owed to the
10 Department, including any applicable penalty and interest charges.

12 shall be recovered immediately against subsequent claims by the Department or by the process
13 specified in section (b)(i) of this section by a managed care entity, whichever results in the earliest
14 recovery by the Department of the amount owed by the provider.

16 (h) All payments suspended in accordance with this Chapter shall be applied toward any
17 final overpayment, assessment, or fine owed to the Department. Amounts described in subsection
18 (b)(i) of this section.

19 (h1) The Department may collect payments for delinquent provider health care
20 assessments as defined in 42 C.F.R. § 433.55(a). In addition to all other methods of collection
21 allowed by law, the Department may collect such assessments in the same manner as set forth in
22 G.S. 105-242 and G.S. 105- 242.1. The collection of delinquent assessments from a managed
23 care entity for money owed by a provider and on behalf of the provider to the State shall not
24 constitute a donation as defined in 42 C.F.R. § 433.52.

42 (n) The results of audits that result in the extrapolation of results may be challenged by a

If the provider elects to appeal the Department's decision to the Office of Administrative Hearings, the provider shall have 45 days from the date that the appeal is filed to submit any additional documentation or records which address or challenge the findings of the audit. The Department shall not review, and the Office of Administrative Hearings shall not admit into evidence, any materials submitted after 45 days from the date the appeal was filed.

(q) Except as required by federal agency, law, or regulation, or instances of credible allegation of fraud, the provider shall be subject to audits which result in the extrapolation of results for a time period of up to 36 months from date of payment of a provider's claim results. An audit that results in extrapolation must be initiated via notice of the audit to the provider within 36 months of the date of payment of the provider's claim. No extrapolated audit shall include claims that were paid more than 36 months prior to the date of the notice of audit.

48 benefit plans and to last four years, BH IDD tailored plans shall be operated
49 only by LME/MCOs that meet certain criteria established by the Department.
50 Any LME/MCO desiring to operate a BH IDD tailored plan will make an
51 application to the Department in response to this set of criteria. Approval to

The previous sentence shall not be construed to apply to any requests to disengage from an LME/MCO made by a county or a board of county commissioners, in accordance with Chapter 122C, prior to June 30, 2021.

(11) The Department may contract with entities operating BH IDD tailored plans under a capitated or other arrangement for the management of behavioral health, intellectual/developmental disabilities, or traumatic brain injury services for the recipients described in any of the categories excluded from PHP coverage under G.S. 108D-40(a)."

SECTION 9D.17.(c) G.S. 122C-115 reads as rewritten:

"§ 122C-115. Duties of counties; appropriation and allocation of funds by counties and cities.

(a) A county shall provide mental health, developmental disabilities, and substance abuse services in accordance with rules, policies, and guidelines adopted pursuant to statewide restructuring of the management responsibilities for the delivery of services for individuals with mental illness, intellectual or other developmental disabilities, and substance abuse disorders under a 1915(b)/(c) Medicaid Waiver through an area authority. ~~Beginning July 1, 2012, the catchment area of an area authority shall contain a minimum population of at least 300,000. Beginning July 1, 2013, the catchment area of an area authority shall contain a minimum population of at least 500,000.~~ To the extent this section conflicts with G.S. 153A-77 or G.S. 122C-115.1, the provisions of this section control.

(a1) ~~Effective July 1, 2012, the Department shall reduce the administrative funding for LMEs that do not comply with the minimum population requirement of 300,000 to a rate consistent with the funding rate provided to LMEs with a population of 300,000.~~

(a2) ~~Effective July 1, 2013, the Department shall reassign management responsibilities for Medicaid funds and State funds away from LMEs that are not in compliance with the minimum population requirement of 500,000 to LMEs that are fully compliant with all catchment area requirements, including the minimum population requirements specified in this section.~~

(a3) A county that wishes to disengage from a local management entity/managed care organization and realign with another multicounty area authority operating under the 1915(b)/(c) Medicaid Waiver may do so with the approval of the ~~Secretary.~~ Secretary except during the time frame set forth in G.S. 108D-60(3). The Secretary shall adopt rules to establish a process for county disengagement that shall ensure, at a minimum, the following:

1 (e) Beginning on the date that capitated contracts under Article 4 of Chapter 108D of the
2 General Statutes begin, LME/MCOs shall cease managing Medicaid services for all Medicaid
3 recipients other than recipients described in G.S. 108D-40~~(a)(1)~~, (4), (5), ~~(5a)~~, ~~(6)~~, (7), (10), (11),
4 (12), and (13). Until BH IDD tailored plans become operational, all of the following shall occur:

- 5 (1) LME/MCOs shall continue to manage the Medicaid services that are covered
6 by the LME/MCOs under the combined 1915(b) and (c) waivers for Medicaid
7 recipients described in G.S. 108D-40~~(a)(1)~~, (4), (5), ~~(5a)~~, ~~(6)~~, (7), (10), (11),
8 (12), and (13).

10 When BH IDD tailored plans become operational, entities operating the BH IDD tailored
11 plans may continue to manage the behavioral health, intellectual/developmental disability, or
12 traumatic brain injury services for Medicaid recipients described in G.S. 108D-40(a)(4), (5), (7),
13 (10), (11), (12), and (13), as determined by the Department in accordance with
14 G.S. 108D-60(11)."

15 **SECTION 9D.17.(d)** Subsections (a), (a1) and (a2) of this section become effective
16 on the date BH IDD Tailored Plans contracts begin. The Department shall notify the Revisor of
17 Statutes of the date the contracts begin. Subsection (a3) and (e) are effective when this act
18 becomes law.

19 LME/MCO MEDICAID RISK RESERVES AND SOLVENCY RANGES

20 **SECTION 9D.18.(a)** G.S. 122C-115.3 reads as rewritten:

21 "**§ 122C-115.3. Dissolution or merger of area authority.**

22 ...

23 (e) Any fund balance including the Medicaid Risk Reserve available to an area authority
24 at the time of its dissolution that is not utilized to pay liabilities shall be transferred to ~~the area~~
25 ~~authority~~ one or more area authorities contracted to operate the 1915(b)/(c) Medicaid Waiver in
26 the catchment area of the dissolved area authority. If the fund balance including the Medicaid
27 Risk Reserve transferred from the dissolved area authority is insufficient to constitute fifteen
28 percent (15%) of the anticipated operational expenses arising from assumption of responsibilities
29 from the dissolved area authority, the Secretary shall guarantee the operational reserves for the
30 area authority assuming the responsibilities under the 1915(b)/(c) Medicaid Waiver until the
31 assuming area authority has reestablished fifteen percent (15%) operational reserves.

33 (h) Any authority under contract with the Department to operate the 1915(b)/(c) Medicaid
34 Waiver that does not receive an initial contract to operate a BH IDD tailored plan in accordance
35 with G.S. 108D-60(3) shall transfer any fund balance, including the Medicaid Risk Reserve,
36 available to the area authority that is not utilized to pay liabilities to one or more area authorities
37 contracted with the Department to operate the BH IDD tailored plan in the catchment area of the
38 area authority that did not receive a BH IDD tailored plan contract, as directed by the Department.

39 (i) During the contract term for the initial contracts for BH IDD tailored plans, any fund
40 balance available to the area authority at the time of its dissolution or the termination of its
41 contract with the Department to operate a BH IDD tailored plan that is not utilized to pay
42 liabilities shall be transferred, as directed by the Department, to one or more area authorities
43 under contract with the Department to operate a BH IDD tailored plan in the catchment area of
44 the area authority that was dissolved or whose contract was terminated."

45 **SECTION 9D.18.(b)** G.S. 122C-125.2 is repealed in its entirety.

46 MEDICAID ELIGIBILITY REDETERMINATIONS

47 **SECTION 9D.19.** Section 6(b) of S.L. 2020-88 reads as rewritten:

48 "**SECTION 6.(b)** In complying with the requirements of this section, county departments of
49 social services shall not terminate benefits for a Medicaid beneficiary if doing so would result in

1 the State being ineligible for the increased Medicaid funding under Section 6008 of P.L. 116-127.
2 When a county department of social services identifies a case that would be subject to termination
3 of Medicaid eligibility in the absence of the preceding requirement, the case shall be identified
4 in the NC FAST system utilizing a uniform identifier to be established by the Department of
5 Health and Human Services no later than July 31, 2020. Notices of termination for cases with the
6 identifier shall be sent in accordance with G.S. 108A-79 within ~~90~~180 days after the expiration
7 of the declared nationwide public health emergency as a result of the 2019 novel coronavirus."

9 **MEDICAID TEMPORARILY INCREASED REIMBURSEMENT RATES**

10 **SECTION 9D.20.** Section 4.6 of S.L. 2020-4, as amended by S.L. 2021-3, reads as
11 rewritten:

12 **"SECTION 4.6.** In addition to the five percent (5%) rate increases already requested by the
13 Department of Health and Human Services (DHHS) in the 1135 Medicaid disaster State Plan
14 amendment (SPA) submitted to the Centers for Medicare and Medicaid Services (CMS) on April
15 8, 2020, for certain provider types, DHHS shall increase the fee-for-service Medicaid rates paid
16 directly by the Division of Health Benefits for all remaining provider types by five percent (5%).
17 The rate increases authorized under this section shall be effective March 1, 2020. Any rate
18 increases authorized under this section shall expire on the earlier of the following dates:

- 19 (1) The date the declared nationwide public health emergency as a result of the
20 2019 novel coronavirus expires.
- 21 (2) The date Executive Order No. 116, Declaration of a State of Emergency to
22 Coordinate Response and Protective Actions to Prevent the Spread of
23 COVID-19 expires or is rescinded.
- 24 (3) June 30, ~~2021~~2022.

25 DHHS is authorized to adjust and/or end any of the rate increases directed in this section that
26 will otherwise cause the State to be in violation of federal Medicaid upper payment limit
27 restrictions, as set by CMS."
28

29 **PART IX-E. HEALTH SERVICE REGULATION [RESERVED]**

30 **PART IX-F. MENTAL HEALTH/DEVELOPMENTAL DISABILITIES/ SUBSTANCE** 31 **ABUSE SERVICES**

32 **SINGLE-STREAM FUNDING FOR MH/DD/SAS COMMUNITY SERVICES**

33 **SECTION 9F.1.(a)** For the purpose of mitigating cash flow problems that many
34 local management entities/managed care organizations (LME/MCOs) experience at the
35 beginning of each fiscal year relative to single-stream funding, the Department of Health and
36 Human Services, Division of Mental Health, Developmental Disabilities, and Substance Abuse
37 Services (DMH/DD/SAS), shall distribute not less than one-twelfth of each LME/MCO's base
38 budget allocation at the beginning of the fiscal year and subtract the amount of that distribution
39 from the LME/MCO's total reimbursements for the fiscal year. For each month of the fiscal year
40 after July, the DMH/DD/SAS shall distribute, on the third working day of the month,
41 one-eleventh of the amount of each LME/MCO's single-stream allocation that remains after
42 subtracting the amount of the distribution that was made to the LME/MCO in July of the fiscal
43 year.
44

45 During each year of the 2021-2023 fiscal biennium, each LME/MCO shall offer at
46 least the same level of service utilization as during the 2014-2015 fiscal year across the
47 LME/MCO's catchment area. This requirement shall not be construed to require LME/MCOs to
48 authorize or maintain the same level of services for any specific individual whose services were
49 paid for with single-stream funding. Further, this requirement shall not be construed to create a
50 private right of action for any person or entity against the State of North Carolina or the
51

1 Department of Health and Human Services or any of its divisions, agents, or contractors and shall
2 not be used as authority in any contested case brought pursuant to Chapter 108C or 108D of the
3 General Statutes.

4 **SECTION 9F.1.(b)** The Department of Health and Human Services shall continue
5 to use the monthly reporting package submitted by the LME/MCOs to the Department, as
6 modified pursuant to Section 12F.2(c) of S.L. 2015-241, to include revenues and expenditures
7 for the State funding sources for single-stream, intellectual and developmental disability, and
8 substance abuse services on Schedule D2. Additionally, the Department shall continue to use
9 appropriate schedules in the LME/MCO monthly reporting package, as modified pursuant to
10 Section 12F.2(c) of S.L. 2015-241, to include unduplicated recipients and encounters in the same
11 level of detail included in each D schedule for each source of funding for the reporting for the
12 current and previous year's month and year-to-date periods. The Department shall continue to
13 submit these reports to the Joint Legislative Oversight Committee on Health and Human Services
14 and the Fiscal Research Division on a quarterly basis.

15 **SECTION 9F.1.(c)** The Secretary of Health and Human Services may adjust the
16 Single Stream Base allocations and any recurring or non-recurring reductions among the
17 LME/MCOs for the 2021-23 fiscal biennium; provided, however, that the Secretary shall submit
18 a detailed explanation for any such adjustment along with supporting documentation to the Office
19 of State Budget and Management, the Joint Legislative Oversight Committee on Health and
20 Human Services and the Fiscal Research Division within 10 business days after making the
21 adjustment.

22 **SECTION 9F.1.(d)** If, on or after June 1, 2021, the Office of State Budget and
23 Management (OSBM) certifies a Medicaid budget surplus in funds 1310, 1311, and 1312 and
24 sufficient cash in Budget Code 14445 to meet total obligations for the 2021-2022 fiscal year,
25 then the Department of Health and Human Services, Division of Medical Assistance (DMA),
26 may transfer to the DMH/DD/SAS funds not to exceed the amount of the certified surplus or
27 thirty million dollars (\$30,000,000), whichever is less.

28 If, on or after June 1, 2022, the OSBM certifies a Medicaid budget surplus in funds
29 1310, 1311, and 1312 and sufficient cash in Budget Code 14445 to meet total obligations for
30 fiscal year 2022-2023, then the DMA may transfer to the DMH/DD/SAS funds not to exceed the
31 amount of the certified surplus or thirty million dollars (\$30,000,000), whichever is less.

32 The DMH/DD/SAS shall allocate funds transferred pursuant to this subsection among
33 the LME/MCOs based on a formula to identify unmet need determined by the Department of
34 Health and Human Services, Division of Mental Health, Developmental Disabilities, and
35 Substance Abuse Services (DMH/DD/SAS).

36 **SECTION 9F.1.(e)** The Department of Health and Human Services shall develop a
37 maintenance of effort (MOE) spending requirement for all mental health and substance abuse
38 services which must be maintained using nonfederal, State appropriations on an annual basis in
39 order to meet MOE requirements for federal block grant awards. LME/MCOs shall ensure the
40 MOE spending requirement is met using State appropriations.

41 **FUNDS FOR LOCAL INPATIENT PSYCHIATRIC BEDS OR BED DAYS**

42 **SECTION 9F.2.(a)** Use of Funds. – Of the funds appropriated to the Department of
43 Health and Human Services, Division of Mental Health, Developmental Disabilities, and
44 Substance Abuse Services, for crisis services, the sum of forty-one million three hundred
45 fifty-one thousand six hundred forty-four dollars (\$41,351,644) in recurring funds for the
46 2021-2022 fiscal year and the sum of forty-one million three hundred fifty-one thousand six
47 hundred forty-four dollars (\$41,351,644) in recurring funds for the 2022-2023 fiscal year shall
48 be used to purchase additional new or existing local inpatient psychiatric beds or bed days not
49 currently funded by or through LME/MCOs. The Department shall continue to implement a
50 two-tiered system of payment for purchasing these local inpatient psychiatric beds or bed days
51

1 based on acuity level with an enhanced rate of payment for inpatient psychiatric beds or bed days
2 for individuals with higher acuity levels, as defined by the Department. The enhanced rate of
3 payment for inpatient psychiatric beds or bed days for individuals with higher acuity levels shall
4 not exceed the lowest average cost per patient bed day among the State psychiatric hospitals. In
5 addition, at the discretion of the Secretary of Health and Human Services, existing funds allocated
6 to LME/MCOs for community-based mental health, developmental disabilities, and substance
7 abuse services may be used to purchase additional local inpatient psychiatric beds or bed days.
8 Funds designated in this subsection for the purchase of local inpatient psychiatric beds or bed
9 days shall not be used to supplant other funds appropriated or otherwise available to the
10 Department for the purchase of inpatient psychiatric services through contracts with local
11 hospitals.

12 **SECTION 9F.2.(b)** Distribution and Management of Beds or Bed Days. – Except as
13 provided in this subsection, the Department shall work to ensure that any local inpatient
14 psychiatric beds or bed days purchased in accordance with this section are utilized solely for
15 individuals who are medically indigent, as defined in this subsection. In addition, the Department
16 shall work to ensure that any local inpatient psychiatric beds or bed days purchased in accordance
17 with this section are distributed across the State in LME/MCO catchment areas and according to
18 need as determined by the Department. The Department shall ensure that beds or bed days for
19 individuals with higher acuity levels are distributed across the State in LME catchment areas,
20 including any catchment areas served by managed care organizations, and according to greatest
21 need based on hospital bed utilization data. The Department shall enter into contracts with
22 LME/MCOs and local hospitals for the management of these beds or bed days. The Department
23 shall work to ensure that these contracts are awarded equitably around all regions of the State.
24 LME/MCOs shall manage and control these local inpatient psychiatric beds or bed days,
25 including the determination of the specific local hospital or State psychiatric hospital to which
26 an individual should be admitted pursuant to an involuntary commitment order.

27 The Department may use up to ten percent (10%) of the funds allocated in this section
28 for each year of the 2021-2023 fiscal biennium to pay for facility-based crisis services and
29 nonhospital detoxification services for individuals in need of these services, regardless if the
30 individuals are medically indigent, defined as uninsured persons who (i) are financially unable
31 to obtain private insurance coverage as determined by the Department and (ii) are not eligible for
32 government-funded health coverage such as Medicare or Medicaid.

33 **SECTION 9F.2.(c)** Funds to Be Held in Statewide Reserve. – Funds appropriated to
34 the Department for the purchase of local inpatient psychiatric beds or bed days shall not be
35 allocated to LME/MCOs but shall be held in a statewide reserve at the Division of Mental Health,
36 Developmental Disabilities, and Substance Abuse Services to pay for services authorized by the
37 LME/MCOs and billed by the hospitals through the LME/MCOs. LME/MCOs shall remit claims
38 for payment to the Department within 15 working days after receipt of a clean claim from the
39 hospital and shall pay the hospital within 30 working days after receipt of payment from the
40 Department.

41 **SECTION 9F.2.(d)** Ineffective LME/MCO Management of Beds or Bed Days. – If
42 the Department determines that (i) an LME/MCO is not effectively managing the beds or bed
43 days for which it has responsibility, as evidenced by beds or bed days in the local hospital not
44 being utilized while demand for services at the State psychiatric hospitals has not decreased, or
45 (ii) the LME/MCO has failed to comply with the prompt payment provisions of subsection (c) of
46 this section, the Department may contract with another LME/MCO to manage the beds or bed
47 days or, notwithstanding any other provision of law to the contrary, may pay the hospital directly.

48 **SECTION 9F.2.(e)** Reporting by LME/MCOs. – The Department shall establish
49 reporting requirements for LME/MCOs regarding the utilization of these beds or bed days.

50 **SECTION 9F.2.(f)** Reporting by Department. – By no later than December 1, 2022,
51 and by no later than December 1, 2023, the Department shall report to the Joint Legislative

1 Oversight Committee on Health and Human Services and the Fiscal Research Division on all of
2 the following:

- 3 (1) A uniform system for beds or bed days purchased during the preceding fiscal
4 year from (i) funds appropriated in this act that are designated for this purpose
5 in subsection (a) of this section, (ii) existing State appropriations, and (iii)
6 local funds.
- 7 (2) An explanation of the process used by the Department to ensure that, except
8 as otherwise provided in subsection (a) of this section, local inpatient
9 psychiatric beds or bed days purchased in accordance with this section are
10 utilized solely for individuals who are medically indigent, along with the
11 number of medically indigent individuals served by the purchase of these beds
12 or bed days.
- 13 (3) The amount of funds used to pay for facility-based crisis services, along with
14 the number of individuals who received these services and the outcomes for
15 each individual.
- 16 (4) The amount of funds used to pay for nonhospital detoxification services, along
17 with the number of individuals who received these services and the outcomes
18 for each individual.
- 19 (5) Other Department initiatives funded by State appropriations to reduce State
20 psychiatric hospital use.

21 **CHANGE TO STATUTORY DEFINITION OF TRAUMATIC BRAIN INJURY**

22 **SECTION 9F.3.** G.S. 122C-3 reads as rewritten:

23 **"§ 122C-3. Definitions.**

24 The following definitions apply in this Chapter:

- 25 ...
- 26 (38a) "Traumatic Brain Injury" (TBI) means an insult to the brain from an outside
27 physical force that may or may not have produced a diminished or altered state
28 of consciousness. The term applies to open or closed head injuries resulting in
29 an impairment of cognitive ability and/or physical functions but not
30 necessarily both. Impairments in one or more areas including but not limited
31 to: cognition; language; memory; attention; reasoning; abstract thinking;
32 judgment; problem-solving; sensory; perceptual, and motor abilities;
33 psychosocial behavior, physical function, information process and speech.
34 Impairments may be either temporary or permanent and may cause partial or
35 total functional disability and/or psychosocial disorientation.

36"

37 **TRAUMATIC BRAIN INJURY FUNDING**

38 **SECTION 9F.4.** Of the funds appropriated in this act to the Department of Health
39 and Human Services, Division of Mental Health, Developmental Disabilities, and Substance
40 Abuse Services, for traumatic brain injury (TBI) services, the sum of two million three hundred
41 seventy-three thousand eighty-six dollars (\$2,373,086) in recurring funds for the 2021-2022
42 fiscal year and the sum of two million three hundred seventy-three thousand eighty-six dollars
43 (\$2,373,086) in recurring funds for the 2022-2023 fiscal year shall be used exclusively to support
44 TBI services as follows:

- 45 (1) The sum of three hundred fifty-nine thousand two hundred eighteen dollars
46 (\$359,218) shall be used to fund contracts with the Brain Injury Association
47 of North Carolina, Carolinas Rehabilitation, or appropriate service providers
48 to assist families in accessing the continuum of care and to provide
49 educational programs on brain injury prevention, intervention, and care.
50
51

- 1 (2) The sum of two million thirteen thousand eight hundred sixty-eight dollars
2 (\$2,013,868) shall be used to provide services and supports such as, but not
3 limited to, residential day program, transportation, respite and home
4 modification to individuals with TBI statewide. The program will be
5 administered in accordance with the program operating policies established
6 by the Division of Mental Health, Developmental Disabilities and Substance
7 Abuse.
8

9 **DOROTHEA DIX HOSPITAL PROPERTY FUNDS**

10 **SECTION 9F.5.** Any funds allocated to the Department of Health and Human
11 Services, Division of Mental Health, Developmental Disabilities, and Substance Abuse Services,
12 from the Dorothea Dix Hospital Property Fund established under G.S. 143C-9-2(b1), pursuant to
13 Section 12F.4 of S.L. 2016-94 and Section 11F.5 of S.L. 2017-57, as amended, that are not
14 expended or encumbered as of June 30, 2021, shall remain in the Dorothea Dix Hospital Property
15 Fund.
16

17 **USE OF CERTAIN VENDING RECEIPTS**

18 **SECTION 9F.6.** G.S. 122C-185 reads as rewritten:

19 "**§ 122C-185. Application of funds belonging to State facilities.**

20 ...

21 (d1) Notwithstanding G.S. 111-43, the net proceeds from coin-operated vending machines
22 located within a facility as defined in 122C-3(14) are authorized for use by the facility as follows:

- 23 (1) At least fifty percent (50%) of revenues generated from coin-operated vending
24 machines at each facility shall be utilized for patient/resident activities,
25 recreational equipment and/or upkeep of the machines.
26 (2) Up to fifty percent (50%) of revenues generated from coin-operated vending
27 machines at each facility may be used for employee reward and recognition
28 activities. All requests for expenditures for employee reward and recognition
29 shall be pre-approved by the facility director, Division director, and the
30 Division's chief financial officer."
31

32 **PART IX-G. PUBLIC HEALTH**

33 **LOCAL HEALTH DEPARTMENTS/COMPETITIVE GRANT PROCESS TO** 34 **IMPROVE MATERNAL AND CHILD HEALTH**

35 **SECTION 9G.1.(a)** Funds appropriated in this act to the Department of Health and
36 Human Services, Division of Public Health, for each year of the 2021-2023 fiscal biennium to
37 award competitive grants to local health departments for the improvement of maternal and child
38 health shall be used to continue administering a competitive grant process for local health
39 departments based on maternal and infant health indicators and the county's detailed proposal to
40 invest in evidence-based programs to achieve the following goals:
41

- 42 (1) Improve North Carolina's birth outcomes.
43 (2) Improve the overall health status of children in this State from birth to age 5.
44 (3) Lower the State's infant mortality rate.

45 **SECTION 9G.1.(b)** The plan for administering the competitive grant process shall
46 include at least all of the following components:

- 47 (1) A request for application (RFA) process to allow local health departments to
48 apply for and receive State funds on a competitive basis. The Department shall
49 require local health departments to include in the application a plan to evaluate
50 the effectiveness, including measurable impact or outcomes, of the activities,
51 services, and programs for which the funds are being requested.

1 (2) A requirement that the Secretary prioritize grant awards to those local health
2 departments that are able to leverage non-State funds in addition to the grant
3 award.

4 (3) Ensures that funds received by the Department to implement the plan
5 supplement and do not supplant existing funds for maternal and child health
6 initiatives.

7 (4) Allows grants to be awarded to local health departments for up to three years.

8 **SECTION 9G.1.(c)** No later than July 1 of each year, as applicable, the Secretary
9 shall announce the recipients of the competitive grant awards and allocate funds to the grant
10 recipients for the respective grant period pursuant to the amounts designated under subsection
11 (a) of this section. After awards have been granted, the Secretary shall submit a report to the Joint
12 Legislative Oversight Committee on Health and Human Services on the grant awards that
13 includes at least all of the following:

14 (1) The identity and a brief description of each grantee and each program or
15 initiative offered by the grantee.

16 (2) The amount of funding awarded to each grantee.

17 (3) The number of persons served by each grantee, broken down by program or
18 initiative.

19 **SECTION 9G.1.(d)** No later than December 1 of each fiscal year, each local health
20 department receiving funding pursuant to this section in the respective fiscal year shall submit to
21 the Division of Public Health a written report of all activities funded by State appropriations. The
22 report shall include the following information about the fiscal year preceding the year in which
23 the report is due:

24 (1) A description of the types of programs, services, and activities funded by State
25 appropriations.

26 (2) Statistical and demographical information on the number of persons served by
27 these programs, services, and activities, including the counties in which
28 services are provided.

29 (3) Outcome measures that demonstrate the impact and effectiveness of the
30 programs, services, and activities based on the evaluation protocols developed
31 by the Division, in collaboration with the University of North Carolina
32 Gillings School of Global Public Health, pursuant to Section 12E.11(e) of S.L.
33 2015-241, and reported to the Joint Legislative Oversight Committee on
34 Health and Human Services on April 1, 2016.

35 (4) A detailed program budget and list of expenditures, including all positions
36 funded, matching expenditures, and funding sources.

37 38 **MATERNAL MORTALITY REVIEW COMMITTEE**

39 **SECTION 9G.2.** Part 5 of Article 1B of Chapter 130A of the General Statutes reads
40 as rewritten:

41 **"§ 130A-33.60. Maternal Mortality Review Committee; membership, compensation.**

42 ...

43 (b) The Secretary shall appoint a multidisciplinary committee comprised of ~~nine~~ twenty
44 members who represent the community, several academic disciplines, and professional
45 specializations essential to reviewing cases of mortality due to complications from pregnancy or
46 childbirth. Committee members shall serve without compensation but may receive travel
47 reimbursement from funds available to the Department.

49 50 **PART IX-H. SERVICES FOR THE BLIND/DEAF/HARD OF HEARING [RESERVED]**

PART IX-I. SOCIAL SERVICES**TANF BENEFIT IMPLEMENTATION**

SECTION 9I.1.(a) The General Assembly approves the plan titled "North Carolina Temporary Assistance for Needy Families State Plan FY 2019-2022," prepared by the Department of Health and Human Services and presented to the General Assembly. The North Carolina Temporary Assistance for Needy Families State Plan covers the period October 1, 2019, through September 30, 2022. The Department shall submit the State Plan, as revised in accordance with subsection (b) of this section, to the United States Department of Health and Human Services.

SECTION 9I.1.(b) The counties approved as Electing Counties in the North Carolina Temporary Assistance for Needy Families State Plan FY 2019-2022, as approved by this section, are Beaufort, Caldwell, Catawba, Lenoir, Lincoln, Macon, and Wilson.

SECTION 9I.1.(c) Counties that submitted the letter of intent to remain as an Electing County or to be redesignated as an Electing County and the accompanying county plan for years 2019 through 2022, pursuant to G.S. 108A-27(e), shall operate under the Electing County budget requirements effective July 1, 2021. For programmatic purposes, all counties referred to in this subsection shall remain under their current county designation through September 30, 2022.

SECTION 9I.1.(d) For each year of the 2021-2023 fiscal biennium, Electing Counties shall be held harmless to their Work First Family Assistance allocations for the 2020-2021 fiscal year, provided that remaining funds allocated for Work First Family Assistance and Work First Diversion Assistance are sufficient for payments made by the Department on behalf of Standard Counties pursuant to G.S. 108A-27.11(b).

SECTION 9I.1.(e) In the event that departmental projections of Work First Family Assistance and Work First Diversion Assistance for the 2021-2022 fiscal year or the 2022-2023 fiscal year indicate that remaining funds are insufficient for Work First Family Assistance and Work First Diversion Assistance payments to be made on behalf of Standard Counties, the Department is authorized to deallocate funds, of those allocated to Electing Counties for Work First Family Assistance in excess of the sums set forth in G.S. 108A-27.11, up to the requisite amount for payments in Standard Counties. Prior to deallocation, the Department shall obtain approval by the Office of State Budget and Management. If the Department adjusts the allocation set forth in subsection (d) of this section, then a report shall be made to the Joint Legislative Oversight Committee on Health and Human Services and the Fiscal Research Division.

INTENSIVE FAMILY PRESERVATION SERVICES FUNDING AND PERFORMANCE ENHANCEMENTS

SECTION 9I.2.(a) Notwithstanding the provisions of G.S. 143B-150.6, the Intensive Family Preservation Services (IFPS) Program shall provide intensive services to children and families in cases of abuse, neglect, and dependency where a child is at imminent risk of removal from the home and to children and families in cases of abuse where a child is not at imminent risk of removal. The Program shall be implemented statewide on a regional basis. The IFPS shall ensure the application of standardized assessment criteria for determining imminent risk and clear criteria for determining out-of-home placement.

SECTION 9I.2.(b) The Department of Health and Human Services shall require that any program or entity that receives State, federal, or other funding for the purpose of IFPS shall provide information and data that allows for the following:

- (1) An established follow-up system with a minimum of six months of follow-up services.
- (2) Detailed information on the specific interventions applied, including utilization indicators and performance measurement.

- 1 (3) Cost-benefit data.
2 (4) Data on long-term benefits associated with IFPS. This data shall be obtained
3 by tracking families through the intervention process.
4 (5) The number of families remaining intact and the associated interventions
5 while in IFPS and 12 months thereafter.
6 (6) The number and percentage, by race, of children who received IFPS compared
7 to the ratio of their distribution in the general population involved with Child
8 Protective Services.

9 **SECTION 9I.2.(c)** The Department shall continue implementing a
10 performance-based funding protocol and shall only provide funding to those programs and
11 entities providing the required information specified in subsection (b) of this section. The amount
12 of funding shall be based on the individual performance of each program.
13

14 **CHILD CARING INSTITUTIONS**

15 **SECTION 9I.3.** The maximum reimbursement for each fiscal year of the 2021-2023
16 biennium for child caring institutions shall not exceed the rate established for the specific child
17 caring institution by the Department of Health and Human Services, Office of the Controller. In
18 determining the maximum reimbursement, the State shall include county and IV-E
19 reimbursements.
20

21 **USE OF FOSTER CARE BUDGET FOR GUARDIANSHIP ASSISTANCE PROGRAM**

22 **SECTION 9I.4.** Of the funds available for the provision of foster care services, the
23 Department of Health and Human Services, Division of Social Services, may continue to provide
24 for the financial support of children who are deemed to be (i) in a permanent family placement
25 setting, (ii) eligible for legal guardianship, and (iii) otherwise unlikely to receive permanency.
26 No additional expenses shall be incurred beyond the funds budgeted for foster care for the
27 Guardianship Assistance Program (GAP). The Guardianship Assistance Program shall include
28 provisions for extending guardianship services for individuals and youth who exited foster care
29 through the Guardianship Assistance Program after 16 years of age or who have attained the age
30 of 18 years and opt to continue to receive guardianship services until reaching 21 years of age if
31 the individual is (i) completing secondary education or a program leading to an equivalent
32 credential, (ii) enrolled in an institution that provides postsecondary or vocational education, (iii)
33 participating in a program or activity designed to promote, or remove barriers to, employment,
34 (iv) employed for at least 80 hours per month, or (v) incapable of completing the educational or
35 employment requirements of this section due to a medical condition or disability. The
36 Guardianship Assistance Program rates shall reimburse the legal guardian for room and board
37 and be set at the same rate as the foster care room and board rates in accordance with rates
38 established under G.S. 108A-49.1.
39

40 **CHILD WELFARE POSTSECONDARY SUPPORT PROGRAM (NC REACH)**

41 **SECTION 9I.5.(a)** Funds appropriated from the General Fund to the Department of
42 Health and Human Services for the child welfare postsecondary support program shall be used
43 to continue providing assistance with the "cost of attendance" as that term is defined in 20 U.S.C.
44 § 1087*ll* for the educational needs of foster youth aging out of the foster care system, youth who
45 exit foster care to a permanent home through the Guardianship Assistance Program (GAP), or
46 special needs children adopted from foster care after age 12. These funds shall be allocated by
47 the State Education Assistance Authority.

48 **SECTION 9I.5.(b)** Of the funds appropriated from the General Fund to the
49 Department of Health and Human Services, the sum of fifty thousand dollars (\$50,000) for each
50 year of the 2021-2023 fiscal biennium shall be allocated to the North Carolina State Education
51 Assistance Authority (SEAA). The SEAA shall use these funds only to perform administrative

1 functions necessary to manage and distribute scholarship funds under the child welfare
2 postsecondary support program.

3 **SECTION 91.5.(c)** Of the funds appropriated from the General Fund to the
4 Department of Health and Human Services, the sum of three hundred thirty-nine thousand four
5 hundred ninety-three dollars (\$339,493) for each year of the 2021-2023 fiscal biennium shall be
6 used to contract with an entity to administer the child welfare postsecondary support program
7 described under subsection (a) of this section, which administration shall include the performance
8 of case management services.

9 **SECTION 91.5.(d)** Funds appropriated to the Department of Health and Human
10 Services for the child welfare postsecondary support program shall be used only for students
11 attending public institutions of higher education in this State.
12

13 **FEDERAL CHILD SUPPORT INCENTIVE PAYMENTS**

14 **SECTION 91.6.(a)** Centralized Services. – The North Carolina Child Support
15 Services Section (NCCSS) of the Department of Health and Human Services, Division of Social
16 Services, shall retain up to fifteen percent (15%) of the annual federal incentive payments it
17 receives from the federal government to enhance centralized child support services. To
18 accomplish this requirement, NCCSS shall do the following:

- 19 (1) In consultation with representatives from county child support services
20 programs, identify how federal incentive funding could improve centralized
21 services.
- 22 (2) Use federal incentive funds to improve the effectiveness of the State's
23 centralized child support services by supplementing and not supplanting State
24 expenditures for those services.
- 25 (3) Continue to develop and implement rules that explain the State process for
26 calculating and distributing federal incentive funding to county child support
27 services programs.

28 **SECTION 91.6.(b)** County Child Support Services Programs. – NCCSS shall
29 allocate no less than eighty-five percent (85%) of the annual federal incentive payments it
30 receives from the federal government to county child support services programs to improve
31 effectiveness and efficiency using the federal performance measures. To that end, NCCSS shall
32 do the following:

- 33 (1) In consultation with representatives from county child support services
34 programs, examine the current methodology for distributing federal incentive
35 funding to the county programs and determine whether an alternative formula
36 would be appropriate. NCCSS shall use its current formula for distributing
37 federal incentive funding until an alternative formula is adopted.
- 38 (2) Upon adopting an alternative formula, develop a process to phase in the
39 alternative formula for distributing federal incentive funding over a four-year
40 period.

41 **SECTION 91.6.(c)** Reporting by County Child Support Services Programs. –
42 NCCSS shall continue implementing guidelines that identify appropriate uses for federal
43 incentive funding. To ensure those guidelines are properly followed, NCCSS shall require county
44 child support services programs to comply with each of the following:

- 45 (1) Submit an annual plan describing how federal incentive funding would
46 improve program effectiveness and efficiency as a condition of receiving
47 federal incentive funding.
- 48 (2) Report annually on the following: (i) how federal incentive funding has
49 improved program effectiveness and efficiency and been reinvested into their
50 programs, (ii) provide documentation that the funds were spent according to
51 their annual plans, and (iii) explain any deviations from their plans.

1 **SECTION 9I.6.(d)** Reporting by NCCSS. – NCCSS shall submit a report on federal
2 child support incentive funding to the Joint Legislative Oversight Committee on Health and
3 Human Services and the Fiscal Research Division by November 1 of each year. The report shall
4 describe how federal incentive funds enhanced centralized child support services to benefit
5 county child support services programs and improved the effectiveness and efficiency of county
6 child support services programs. The report shall further include any changes to the State process
7 the NCCSS used in calculating and distributing federal incentive funding to county child support
8 services programs and any recommendations for further changes.

9
10 **INCREASE ACCESS TO PUBLIC BENEFITS FOR OLDER DUAL ELIGIBLE**
11 **SENIORS**

12 **SECTION 9I.7.(a)** The Department of Health and Human Services, Division of
13 Social Services (Division), shall continue implementing an evidence-based pilot program to
14 increase access to public benefits for seniors aged 65 and older who are dually enrolled in
15 Medicare and Medicaid to (i) improve the health and independence of seniors and (ii) reduce
16 health care costs. The Division shall continue to partner with a not-for-profit firm for the purposes
17 of engaging in a data-driven campaign to help seniors aged 65 and older who are dually enrolled
18 in Medicare and Medicaid meet their basic social needs. The not-for-profit firm shall have
19 demonstrated experience in assisting with these types of services and the partnership shall
20 accomplish each of the following:

- 21 (1) Identify, through data sharing, dual eligible seniors aged 65 and older who
22 qualify for the Supplemental Nutrition and Assistance Program (SNAP) but
23 are not currently enrolled.
- 24 (2) Conduct an outreach program toward those seniors for the purpose of
25 enrolling them into SNAP.
- 26 (3) Provide comprehensive application assistance through outreach specialists to
27 complete public benefits application processes.
- 28 (4) Evaluate project effectiveness and explore how data can be utilized to achieve
29 optimal outcomes.
- 30 (5) Make recommendations regarding policy options available to the State to
31 streamline access to benefits.

32 **SECTION 9I.7.(b)** The Division shall report to the Office of the Governor and the
33 Joint Legislative Oversight Committee on Health and Human Services on its progress in the pilot
34 program by February 1 following each year the pilot program is in place. The report shall, at a
35 minimum, include the following:

- 36 (1) The number of seniors age 65 and older who are dual eligibles but are not
37 enrolled in SNAP.
- 38 (2) The number of those identified that would be included in the sample
39 population.
- 40 (3) Methods of outreach toward those seniors in the sample population.
- 41 (4) Number of to date enrollments in SNAP as a direct result of outreach during
42 the pilot program.
- 43 (5) Participation rate to date in SNAP of those seniors in the sample population.
- 44 (6) Any other findings the Division deems relevant.

45 **SECTION 9I.7.(c)** If funding and capacity exist, the Division of Social Services may
46 expand the pilot program to include other public benefits programs.

47
48 **SUCCESSFUL TRANSITION/FOSTER CARE YOUTH**

49 **SECTION 9I.8.** The Foster Care Transitional Living Initiative Fund shall continue
50 to fund and support transitional living services that demonstrate positive outcomes for youth,
51 attract significant private sector funding, and lead to the development of evidence-based

1 programs to serve the at-risk population described in this section. The Fund shall continue to
2 support a demonstration project with services provided by Youth Villages to (i) improve
3 outcomes for youth ages 17-21 years who transition from foster care through implementation of
4 outcome-based Transitional Living Services, (ii) identify cost-savings in social services and
5 juvenile and adult correction services associated with the provision of Transitional Living
6 Services to youth aging out of foster care, and (iii) take necessary steps to establish an
7 evidence-based transitional living program available to all youth aging out of foster care. In
8 continuing to implement these goals, the Foster Care Transitional Living Initiative Fund shall
9 support the following strategies:

- 10 (1) Transitional Living Services, which is an outcome-based program that follows
11 the Youth Villages Transitional Living Model. Outcomes on more than 7,000
12 participants have been tracked since the program's inception. The program has
13 been evaluated through an independent Randomized Controlled Trial. Results
14 indicate that the Youth Villages Transitional Living Model had positive
15 impacts in a variety of areas, including housing stability, earnings, economic
16 hardship, mental health, and intimate partner violence in comparison to the
17 control population.
- 18 (2) Public-Private Partnership, which is a commitment by private-sector funding
19 partners to match at least twenty-five percent (25%) of the funds appropriated
20 to the Foster Care Transitional Living Initiative Fund for the 2021-2023 fiscal
21 biennium for the purposes of providing Transitional Living Services through
22 the Youth Villages Transitional Living Model to youth aging out of foster
23 care.
- 24 (3) Impact Measurement and Evaluation, which are services funded through
25 private partners to provide independent measurement and evaluation of the
26 impact the Youth Villages Transitional Living Model has on the youth served,
27 the foster care system, and on other programs and services provided by the
28 State which are utilized by former foster care youth.
- 29 (4) Advancement of Evidence-Based Process, which is the implementation and
30 ongoing evaluation of the Youth Villages Transitional Living Model for the
31 purposes of establishing the first evidence-based transitional living program
32 in the nation. To establish the evidence-based program, additional randomized
33 controlled trials may be conducted to advance the model.

34 **CHILD ADVOCACY CENTER FUNDING**

35 **SECTION 9I.9.** Of the funds appropriated in this act to the Department of Health
36 and Human Services, Division of Social Services, for each year of the 2021-2023 fiscal biennium
37 for child advocacy centers, allocations shall be made as follows:

- 38 (1) Up to one hundred thousand dollars (\$100,000) for each child advocacy center
39 in good standing with Children's Advocacy Centers of North Carolina, Inc.
- 40 (2) One hundred thousand dollars (\$100,000) to Children's Advocacy Centers of
41 North Carolina, Inc., for its operations.

42 **ENHANCE PERMANENCY INNOVATION INITIATIVE**

43 **SECTION 9I.10.(a)** G.S. 131D-10.9B(a) reads as rewritten:

44 "(a) There is created the Permanency Innovation Initiative Fund that will support a
45 ~~demonstration~~ project with services provided by Children's Home Society of North Carolina to
46 (i) improve permanency outcomes for children living in foster care through reunification with
47 parents, providing placement or guardianship with other relatives, or adoption, (ii) improve
48 engagement with biological relatives of children in or at risk of entering foster care, and (iii)
49
50

1 reduce costs associated with maintaining children in foster care. In implementing these goals, the
 2 Permanency Innovation Initiative Fund shall support the following strategies:

3"

4 **SECTION 9L10.(b)** Funds appropriated to the Department of Health and Human
 5 Services, Division of Social Services, for each year of the 2021-2023 fiscal biennium for the
 6 Permanency Innovation Initiative Fund shall be supplemented, not supplanted, by all available
 7 federal matching funds.

8
 9 **FOOD AND NUTRITION SERVICES – ABLE BODIED ADULTS WITHOUT**
 10 **DEPENDENTS WAIVER**

11 **SECTION 9L11.** Notwithstanding G.S. 108A-51.1, for the 2021-2023 fiscal
 12 biennium, the Department of Health and Human Services may seek a temporary waiver from the
 13 U.S. Department of Agriculture (USDA) for time limits established by federal law for
 14 able-bodied adults without dependents (ABAWD) participating in the Food and Nutrition
 15 Services Program in this State.

16
 17 **FAMILY FIRST PREVENTION SERVICES ACT FUNDS**

18 **SECTION 9L12.** Funds appropriated to the Department of Health and Human
 19 Services, Division of Social Services for the Family First Prevention Services Act shall not revert
 20 at the end of the 2021-2022 fiscal year but shall remain available for the 2022-2023 fiscal year.

21
 22 **PART IX-J. VOCATIONAL REHABILITATION SERVICES [RESERVED]**

GENERAL PROVISIONS

29 **SECTION 9K.1.(b)** Information to Be Included in Block Grant Plans. – The
30 Department of Health and Human Services shall submit a separate plan for each Block Grant
31 received and administered by the Department, and each plan shall include the following:

- 32 (1) A delineation of the proposed allocations by program or activity, including
33 State and federal match requirements.
- 34 (2) A delineation of the proposed State and local administrative expenditures.
- 35 (3) An identification of all new positions to be established through the Block
36 Grant, including permanent, temporary, and time-limited positions.
- 37 (4) A comparison of the proposed allocations by program or activity with two
38 prior years' program and activity budgets and two prior years' actual program
39 or activity expenditures.
- 40 (5) A projection of current year expenditures by program or activity.
- 41 (6) A projection of federal Block Grant funds available, including unspent federal
42 funds from the current and prior fiscal years.
- 43 (7) The required amount of maintenance of effort and the amount of funds
44 qualifying for maintenance of effort in the previous year delineated by
45 program or activity.

46 **SECTION 9K.1.(c)** Changes in Federal Fund Availability. – If the Congress of the
47 United States increases the federal fund availability for any of the Block Grants or contingency
48 funds and other grants related to existing Block Grants administered by the Department of Health
49 and Human Services from the amounts appropriated in this act, the Department shall allocate the
50 increase proportionally across the program and activity appropriations identified for that Block
51 Grant in this section. In allocating an increase in federal fund availability, the Office of State

1 Budget and Management shall not approve funding for new programs or activities not
2 appropriated in this act.

3 If the Congress of the United States decreases the federal fund availability for any of
4 the Block Grants or contingency funds and other grants related to existing Block Grants
5 administered by the Department of Health and Human Services from the amounts appropriated
6 in this act, the Department shall develop a plan to adjust the Block Grants based on reduced
7 federal funding.

8 Notwithstanding the provisions of this subsection, for fiscal years 2021-2022 and
9 2022-2023, increases in the federal fund availability for the Temporary Assistance to Needy
10 Families (TANF) Block Grant shall be used only for the North Carolina Child Care Subsidy
11 program to pay for child care in four- or five-star rated facilities for 4-year-old children and shall
12 not be used to supplant State funds.

13 Prior to allocating the change in federal fund availability, the proposed allocation
14 must be approved by the Office of State Budget and Management. If the Department adjusts the
15 allocation of any Block Grant due to changes in federal fund availability, then a report shall be
16 made to the Joint Legislative Oversight Committee on Health and Human Services and the Fiscal
17 Research Division.

18 **SECTION 9K.1.(d)** Except as otherwise provided, appropriations from federal
19 Block Grant funds are made for each year of the fiscal biennium ending June 30, 2023, according
20 to the schedule enacted for State fiscal years 2021-2022 and 2022-2023 or until a new schedule
21 is enacted by the General Assembly.

22 **SECTION 9K.1.(e)** All changes to the budgeted allocations to the Block Grants or
23 contingency funds and other grants related to existing Block Grants administered by the
24 Department of Health and Human Services that are not specifically addressed in this section shall
25 be approved by the Office of State Budget and Management. The Office of State Budget and
26 Management shall not approve funding for new programs or activities not appropriated in this
27 section. Additionally, if budgeted allocations are decreased, the Office of State Budget and
28 Management shall not approve any reduction of funds designated for subrecipients in subsection
29 (a) of this section under (i) Item 03 of the Substance Abuse Prevention and Treatment Block
30 Grant or (ii) Item 01 of the Maternal and Child Health Block Grant. The Office of State Budget
31 and Management shall consult with the Joint Legislative Oversight Committee on Health and
32 Human Services for review prior to implementing any changes. In consulting, the report shall
33 include an itemized listing of affected programs, including associated changes in budgeted
34 allocations. All changes to the budgeted allocations to the Block Grants shall be reported
35 immediately to the Joint Legislative Oversight Committee on Health and Human Services and
36 the Fiscal Research Division. This subsection does not apply to Block Grant changes caused by
37 legislative salary increases and benefit adjustments.

38 **SECTION 9K.1.(f)** Except as otherwise provided, the Department of Health and
39 Human Services shall have flexibility to transfer funding between the Temporary Assistance for
40 Needy Families (TANF) Block Grant and the TANF Emergency Contingency Funds Block Grant
41 so long as the total allocation for the line items within those block grants remains the same.

42 43 **TEMPORARY ASSISTANCE FOR NEEDY FAMILIES (TANF) FUNDS**

44 **SECTION 9K.1.(g)** The sum of eighty million ninety-three thousand five hundred
45 sixty-six dollars (\$80,093,566) for each year of the 2021-2023 fiscal biennium appropriated in
46 this act in TANF funds to the Department of Health and Human Services, Division of Social
47 Services, shall be used for Work First County Block Grants. The Division shall certify these
48 funds in the appropriate State-level services based on prior year actual expenditures. The Division
49 has the authority to realign the authorized budget for these funds among the State-level services
50 based on current year actual expenditures. The Division shall also have the authority to realign
51 appropriated funds from Work First Family Assistance for electing counties to the Work First

1 County Block Grant for electing counties based on current year expenditures so long as the
2 electing counties meet Maintenance of Effort requirements.

3 **SECTION 9K.1.(h)** The sum of nine million four hundred twelve thousand three
4 hundred ninety-one dollars (\$9,412,391) appropriated in this act to the Department of Health and
5 Human Services, Division of Social Services, in TANF funds for each fiscal year of the
6 2021-2023 fiscal biennium for child welfare improvements shall be allocated to the county
7 departments of social services for hiring or contracting staff to investigate and provide services
8 in Child Protective Services cases; to provide foster care and support services; to recruit, train,
9 license, and support prospective foster and adoptive families; and to provide interstate and
10 post-adoption services for eligible families.

11 Counties shall maintain their level of expenditures in local funds for Child Protective
12 Services workers. Of the Block Grant funds appropriated for Child Protective Services workers,
13 the total expenditures from State and local funds for fiscal years 2021-2022 and 2022-2023 shall
14 not be less than the total expended from State and local funds for the 2012-2013 fiscal year.

15 **SECTION 9K.1.(i)** The sum of two million twenty-six thousand eight hundred
16 seventy-seven dollars (\$2,026,877) appropriated in this act in TANF funds to the Department of
17 Health and Human Services, Special Children Adoption Fund, for each fiscal year of the
18 2021-2023 fiscal biennium shall be used in accordance with G.S. 108A-50.2. The Division of
19 Social Services, in consultation with the North Carolina Association of County Directors of
20 Social Services and representatives of licensed private adoption agencies, shall develop
21 guidelines for the awarding of funds to licensed public and private adoption agencies upon the
22 adoption of children described in G.S. 108A-50 and in foster care. Payments received from the
23 Special Children Adoption Fund by participating agencies shall be used exclusively to enhance
24 the adoption services program. No local match shall be required as a condition for receipt of these
25 funds.

26 **SECTION 9K.1.(j)** The sum of one million four hundred thousand dollars
27 (\$1,400,000) appropriated in this act in TANF funds to the Department of Health and Human
28 Services, Division of Social Services, for each fiscal year of the 2021-2023 fiscal biennium shall
29 be used for child welfare initiatives to (i) enhance the skills of social workers to improve the
30 outcomes for families and children involved in child welfare and (ii) enhance the provision of
31 services to families in their homes in the least restrictive setting.

32 **SECTION 9K.1.(k)** Of the three million four hundred fifty thousand dollars
33 (\$3,450,000) allocated in this act in TANF funds to the Department of Health and Human
34 Services, Division of Public Health, for each year of the 2021-2023 fiscal biennium for teen
35 pregnancy prevention initiatives, the sum of five hundred thousand dollars (\$500,000) in each
36 year of the 2021-2023 fiscal biennium shall be used to provide services for youth in foster care
37 or the juvenile justice system.

38 **SECTION 9K.1.(l)** The sum of twelve million six hundred thousand dollars
39 (\$12,600,000) in non-recurring funds appropriated in this act in TANF funds to the Department
40 of Health and Human Services, Division of Child Development, for each fiscal year of the
41 2021-2023 fiscal biennium shall be used for the Child Care Subsidy program.

42 43 **SOCIAL SERVICES BLOCK GRANT**

44 **SECTION 9K.1.(m)** The sum of nineteen million nine hundred five thousand eight
45 hundred forty-nine dollars (\$21,205,849) for each year of the 2021-2023 fiscal biennium
46 appropriated in this act in the Social Services Block Grant to the Department of Health and
47 Human Services, Division of Social Services, and the sum of thirteen million ninety-seven
48 thousand seven hundred eighty-three dollars (\$13,097,783) for each year of the 2021-2023 fiscal
49 biennium transferred from funds appropriated in the TANF Block Grant shall be used for county
50 block grants. The Division shall certify these funds in the appropriate State-level services based
51 on prior year actual expenditures. The Division has the authority to realign the authorized budget

1 for these funds, as well as State Social Services Block Grant funds, among the State-level services
2 based on current year actual expenditures.

3 **SECTION 9K.1.(n)** The sum of two hundred eighty-five thousand six hundred
4 twelve dollars (\$285,612) appropriated in this act in the Social Services Block Grant to the
5 Department of Health and Human Services, Division of Social Services, for each fiscal year of
6 the 2021-2023 fiscal biennium shall be used to support various child welfare training projects as
7 follows:

8 (1) Provide a regional training center in southeastern North Carolina.

9 (2) Provide training for residential child caring facilities.

10 (3) Provide for various other child welfare training initiatives.

11 **SECTION 9K.1.(o)** The Department of Health and Human Services is authorized,
12 subject to the approval of the Office of State Budget and Management, to transfer Social Services
13 Block Grant funding allocated for departmental administration between divisions that have
14 received administrative allocations from the Social Services Block Grant.

15 **SECTION 9K.1.(p)** Social Services Block Grant funds appropriated for the Special
16 Children Adoption Incentive Fund shall require a fifty percent (50%) local match.

17 **SECTION 9K.1.(q)** The sum of five million forty thousand dollars (\$5,040,000)
18 appropriated in this act in the Social Services Block Grant for each fiscal year of the 2021-2023
19 fiscal biennium shall be allocated to the Department of Health and Human Services, Division of
20 Social Services. The Division shall allocate these funds to local departments of social services to
21 replace the loss of Child Protective Services State funds that are currently used by county
22 governments to pay for Child Protective Services staff at the local level. These funds shall be
23 used to maintain the number of Child Protective Services workers throughout the State. These
24 Social Services Block Grant funds shall be used to pay for salaries and related expenses only and
25 are exempt from 10A NCAC 71R .0201(3) requiring a local match of twenty-five percent (25%).

26 **SECTION 9K.1.(r)** The sum of four million seven hundred seventy-four thousand
27 five hundred twenty-five dollars (\$4,774,525) for each year of the 2021-2023 fiscal biennium
28 appropriated in this act in the Social Services Block Grant to the Department of Health and
29 Human Services (DHHS), Division of Central Management and Support, shall be used for DHHS
30 competitive block grants pursuant to Section 9B.3 of this act. These funds are exempt from the
31 provisions of 10A NCAC 71R .0201(3).

32 **SECTION 9K.1.(s)** The sum of one million five hundred eighty-two thousand
33 dollars (\$1,582,000) appropriated in this act in the Social Services Block Grant for each fiscal
34 year of the 2021-2023 fiscal biennium to the Department of Health and Human Services, Division
35 of Social Services, shall be used to continue support for the Child Advocacy Centers, and the
36 funds are exempt from the provisions of 10A NCAC 71R .0201(3).

37 **SECTION 9K.1.(t)** The sum of three million eight hundred twenty-five thousand
38 four hundred forty-three dollars (\$3,825,443) for each fiscal year of the 2021-2023 fiscal
39 biennium appropriated in this act in the Social Services Block Grant to the Department of Health
40 and Human Services, Divisions of Social Services and Aging and Adult Services, shall be used
41 for guardianship services pursuant to Chapter 35A of the General Statutes. The Department may
42 expend funds allocated in this section to support existing corporate guardianship contracts during
43 the 2021-2022 and 2022-2023 fiscal years.

44 **SECTION 9K.1.(u)** Of the funds appropriated in the Social Services Block Grant to
45 the Division of Aging and Adult Services for Adult Protective Services, the sum of eight hundred
46 ninety-three thousand forty-one dollars (\$893,041) shall be used to increase the number of Adult
47 Protective Services workers where these funds can be the most effective. These funds shall be
48 used to pay for salaries and related expenses and shall not be used to supplant any other source
49 of funding for staff. These funds are also exempt from 10A NCAC 71R .0201(3) requiring a local
50 match of twenty-five percent (25%).
51

LOW-INCOME ENERGY ASSISTANCE BLOCK GRANT

SECTION 9K.1.(v) The Division of Social Services shall have the authority to realign appropriated funds between the State-level services Low Income Energy Assistance Payments and Crisis Assistance Payments without prior consultation with the Joint Legislative Oversight Committee on Health and Human Services to ensure needs are effectively met without exceeding the total amount appropriated for these State-level service items. Additional emergency contingency funds received may be allocated for Energy Assistance Payments or Crisis Intervention Payments without prior consultation with the Joint Legislative Oversight Committee on Health and Human Services. Additional funds received shall be reported to the Joint Legislative Oversight Committee on Health and Human Services and the Fiscal Research Division upon notification of the award. The Department of Health and Human Services shall not allocate funds for any activities, including increasing administration, other than assistance payments, without prior consultation with the Joint Legislative Oversight Committee on Health and Human Services.

SECTION 9K.1.(w) The sum of thirty-two million nine hundred eighty thousand nine hundred eighty-one dollars (\$32,980,981) for the 2021-2022 fiscal year and the sum of thirty-two million seven hundred sixty-four thousand seven hundred fifty-one dollars (\$32,764,751) for 2022-2023 fiscal year appropriated in this act in the Low-Income Energy Assistance Block Grant to the Department of Health and Human Services, Division of Social Services, shall be used for Energy Assistance Payments for the households of (i) elderly persons age 60 and above with income up to one hundred thirty percent (130%) of the federal poverty level and (ii) disabled persons eligible for services funded through the Division of Aging and Adult Services.

County departments of social services shall submit to the Division of Social Services an outreach plan for targeting households with 60-year-old household members no later than August 1 of each year. The outreach plan shall comply with the following:

- (1) Ensure that eligible households are made aware of the available assistance, with particular attention paid to the elderly population age 60 and above and disabled persons receiving services through the Division of Aging and Adult Services.
- (2) Include efforts by the county department of social services to contact other State and local governmental entities and community-based organizations to (i) offer the opportunity to provide outreach and (ii) receive applications for energy assistance.
- (3) Be approved by the local board of social services or human services board prior to submission.

SECTION 9K.1.(x) The Department of Health and Human Services shall develop and implement a centralized system to collect, track, analyze, monitor, and disseminate performance, outputs, and outcome data for the Community Services Block Grant Program and the Department of Environmental Quality (DEQ) Weatherization Assistance Program to replace the current software solution, Accountable Results for Community Action (AR4CA). The project shall not proceed until the business case has been approved by the Office of State Budget and Management and the State Chief Information Officer in the Enterprise Project Management Office's Touchdown System. Upon approval, amounts not to exceed fifty thousand dollars (\$50,000) in Low Income Energy Assistance funds may be budgeted for transfer to Budget Code 24410 for information technology projects for the 2021-2022 fiscal year.

COMMUNITY SERVICES BLOCK GRANT

SECTION 9K.1.(y) Upon development, implementation, and approval of the centralized system described in subsection (w1) of this section, amounts not to exceed three hundred twenty-seven thousand nine hundred forty-four dollars (\$327,944) in Community

1 Service Block Grant funds may be budgeted for transfer to Budget Code 24410 for information
2 technology projects for the 2021-2022 fiscal year.

4 **CHILD CARE AND DEVELOPMENT FUND BLOCK GRANT**

5 **SECTION 9K.1.(z)** Payment for subsidized child care services provided with federal
6 TANF funds shall comply with all regulations and policies issued by the Division of Child
7 Development and Early Education for the subsidized child care program.

8 **SECTION 9K.1.(aa)** If funds appropriated through the Child Care and Development
9 Fund Block Grant for any program cannot be obligated or spent in that program within the
10 obligation or liquidation periods allowed by the federal grants, the Department may move funds
11 to child care subsidies, unless otherwise prohibited by federal requirements of the grant, in order
12 to use the federal funds fully.

14 **MENTAL HEALTH SERVICES BLOCK GRANT**

15 **SECTION 9K.1.(bb)** The sum of four million two hundred five thousand three
16 hundred sixty-nine dollars (\$4,205, 369) for state fiscal year 2021-2022 and two million six
17 hundred fifteen thousand four hundred ninety-seven dollars (\$2,615,497) for state fiscal year
18 2022-2023 appropriated in this act in the Mental Health Services Block Grant to the Department
19 of Health and Human Services, Division of Mental Health, Developmental Disabilities, and
20 Substance Abuse Services, is allocated for Mental Health Services – First Psychotic Symptom
21 Treatment.

22 Of the funds allocated in the Mental Health Services Block Grant to the Department
23 of Health and Humans Services, Division of Mental Health, Developmental Disabilities, and
24 Substance Abuse Services, for the 2021-2023 biennium, the sum of three hundred fifty thousand
25 one hundred fifty dollars (\$350,150) shall be used to established three (3) positions and operating
26 costs: two (2) recovering peer advocates to focus on recovery oriented care, and one (1) focused
27 on developing pilot programs and implementing policy to improve services to transition aged
28 youth with significant behavioral health needs.

30 **SUBSTANCE ABUSE PREVENTION AND TREATMENT BLOCK GRANT**

31 **SECTION 9K.1.(cc)** The sum of two hundred fifty thousand dollars (\$250,000)
32 appropriated in this act in the Substance Abuse Prevention and Treatment Block Grant to the
33 Department of Health and Human Services, Division of Mental Health, Developmental
34 Disabilities, and Substance Abuse Services, for each fiscal year of the 2021-2023 fiscal biennium
35 shall be used to support Veterans initiatives.

36 **SECTION 9K.1.(dd)** Of the funds allocated in the Substance Abuse Prevention and
37 Treatment Block Grant for the 2021-2023 fiscal biennium to the Department of Health and
38 Human Services, Division of Mental Health, Developmental Disabilities, and Substance Abuse
39 Services, one million forty-eight thousand three hundred fifty dollars (\$1,048,350) shall be used
40 to establish nine (9) positions and operating costs to provide oversight, technical support,
41 training, coordination, monitoring and other functions necessary to support substance use
42 services, in the efforts of ensuring strategic planning and development of recovery supports and
43 treatment leading towards a comprehensive recovery system of care.

45 **MATERNAL AND CHILD HEALTH BLOCK GRANT**

46 **SECTION 9K.1.(ee)** If federal funds are received under the Maternal and Child
47 Health Block Grant for abstinence education, pursuant to section 912 of Public Law 104-193 (42
48 U.S.C. § 710), for the 2021-2022 fiscal year or the 2022-2023 fiscal year, then those funds shall
49 be transferred to the State Board of Education to be administered by the Department of Public
50 Instruction. The Department of Public Instruction shall use the funds to establish an abstinence
51 until marriage education program and shall delegate to one or more persons the responsibility of

1 implementing the program and G.S. 115C-81(e1)(4) and (4a). The Department of Public
2 Instruction shall carefully and strictly follow federal guidelines in implementing and
3 administering the abstinence education grant funds.

4 **SECTION 9K.1.(ff)** The sum of one million five hundred seventy-five thousand
5 dollars (\$1,575,000) appropriated in this act in the Maternal and Child Health Block Grant to the
6 Department of Health and Human Services, Division of Public Health, for each year of the
7 2021-2023 fiscal biennium shall be used for evidence-based programs in counties with the
8 highest infant mortality rates. The Division shall report on (i) the counties selected to receive the
9 allocation, (ii) the specific evidence-based services provided, (iii) the number of women served,
10 and (iv) any impact on the counties' infant mortality rate. The Division shall report its findings
11 to the House of Representatives Appropriations Committee on Health and Human Services, the
12 Senate Appropriations Committee on Health and Human Services, and the Fiscal Research
13 Division no later than December 31 of each year.

14 **SECTION 9K.1.(gg)** The sum of seventy-three thousand nine hundred twenty
15 dollars (\$73,920) allocated in this section in the Maternal and Child Health Block Grant to the
16 Department of Health and Human Services, Division of Public Health, Women and Children's
17 Health Section, for each fiscal year of the 2021-2023 fiscal biennium shall not be used to supplant
18 existing State or federal funds. This allocation shall be used for a Public Health Program
19 Consultant position assigned full-time to manage the North Carolina Perinatal Health Strategic
20 Plan and provide staff support for the stakeholder work group.

21 **PART X. AGRICULTURE AND CONSUMER SERVICES**

22 **TOBACCO TRUST FUND ADMINISTRATIVE EXPENSES**

23
24 **SECTION 10.1.** G.S. 143-717(i) reads as rewritten:

26 "(i) Limit on Operating and Administrative Expenses. – All administrative expenses of
27 the Commission shall be paid from the Fund. No more than ~~three hundred fifty thousand dollars~~
28 ~~(\$350,000)~~ three hundred seventy-five thousand dollars may be used each fiscal year for
29 administrative and operating expenses of the Commission and its staff, provided that the
30 Commission may annually adjust the administrative expense cap imposed by this subsection, so
31 long as that any cap increase does not exceed the amount necessary to provide for statewide
32 salary and benefit adjustments enacted by the General Assembly."

34 **PLANT CONSERVATION PROGRAM TRANSFER**

35 **SECTION 10.2.** From funds deposited with the State Treasurer in a capital
36 improvement account to the credit of the Department of Agriculture and Consumer Services
37 pursuant to G.S. 146-30, the sum of seventy-five thousand dollars (\$75,000) for the 2021-2022
38 fiscal year and the sum of seventy-five thousand dollars (\$75,000) for the 2022-2023 fiscal year
39 shall be transferred to the Department of Agriculture and Consumer Services to be used,
40 notwithstanding G.S. 146-30, by the Department for its plant conservation program under Article
41 19B of Chapter 106 of the General Statutes for costs incidental to the acquisition of land, such as
42 land appraisals, land surveys, title searches, and environmental studies, and for the management
43 of the plant conservation program preserves owned by the Department.

49 **SECTION 11.1.(a)** Appropriations from federal block grant funds are made for the

SECTION 11.1.(b) If federal funds are reduced below the amounts specified in this section after the effective date of this act, then every program in each of these federal block grants shall be reduced by the same percentage as the reduction in federal funds.

SECTION 11.1.(c) Any block grant funds appropriated by the Congress of the United States in addition to the funds specified in this section shall be expended as follows: each program category under the Community Development Block Grant shall be increased by the same percentage as the increase in federal funds.

SECTION 11.1.(d) Of the funds appropriated in this section for the Community Development Block Grant, the following shall be allocated in each category for each program year: up to one million five hundred sixty thousand two hundred eighty six dollars (\$1,560,286) may be used for State Administration, up to fifteen million four hundred nineteen thousand seven hundred ninety six dollars (\$15,419,796) may be used for Neighborhood Revitalization, up to eleven million three hundred thirty-two thousand five hundred eighty five dollars (\$11,332,585) may be used for Economic Development, and up to twenty million three hundred sixty three thousand one hundred ninety one dollars (\$20,363,191) may be used for community development. If federal block grant funds are reduced or increased by the Congress of the United States after the effective date of this act, then these reductions or increases shall be allocated in accordance with subsection (b) or (c) of this section, as applicable.

SECTION 11.1.(e) The Department of Commerce shall consult with the Joint Legislative Commission on Governmental Operations prior to reallocating Community Development Block Grant Funds. Notwithstanding the provisions of this subsection, whenever the Director of the Budget finds that:

- (1) A reallocation is required because of an emergency that poses an imminent threat to public health or public safety, the Director of the Budget may authorize the reallocation without consulting the Commission. The Department of Commerce shall report to the Commission on the reallocation no later than 30 days after it was authorized and shall identify in the report the emergency, the type of action taken, and how it was related to the emergency.
- (2) The State will lose federal block grant funds or receive less federal block grant funds in the next fiscal year unless a reallocation is made. The Department of Commerce shall provide a written report to the Commission on the proposed reallocation and shall identify the reason that failure to take action will result in the loss of federal funds. If the Commission does not hear the issue within 30 days of receipt of the report, the Department may take the action without consulting the Commission.

SECTION 11.1.(f) By September 1, 2021, and September 1, 2022, the Department of Commerce shall report to the chairs of the House of Representatives Appropriations

1 Committee on Agriculture and Natural and Economic Resources, the chairs of the Senate
2 Appropriations Committee on Agriculture, Natural, and Economic Resources, the Joint
3 Legislative Economic Development and Global Engagement Oversight Committee, and the
4 Fiscal Research Division on the use of Community Development Block Grant Funds
5 appropriated in the prior fiscal year. The report shall include the following:

- 6 (1) A discussion of each of the categories of funding and how the categories were
7 selected, including information on how a determination was made that there
8 was a statewide need in each of the categories.
- 9 (2) Information on the number of applications that were received in each category
10 and the total dollar amount requested in each category.
- 11 (3) A list of grantees, including the grantee's name, county, category under which
12 the grant was funded, the amount awarded, and a narrative description of the
13 project.

14 **SECTION 11.1.(g)** For purposes of this section, eligible activities are expanded to
15 include rural community development. Of the funds appropriated in subsection (a) for the
16 Community Development Block Grant, \$20,363,191 will be directed for Rural Community
17 Development to provide grants that support community development, comprehensive growth,
18 and housing related projects to be awarded by the North Carolina Department of Commerce. The
19 Rural Community Development Category will provide grants to units of local government in
20 Tier 1 and Tier 2 counties and rural census tracts of Tier 3 counties in support of projects that
21 promote broad-based community development activities, increased local investment and
22 economic growth, expanded access to equitable and affordable housing opportunities, and
23 stronger and more viable rural neighborhoods. The funds available for grants under this category
24 may be used in support of, but not limited to the following:

- 25 (1) Projects that enhance community viability.
- 26 (2) Projects that increase community competitiveness.
- 27 (3) Projects that broaden opportunities for economic investment and growth.
- 28 (4) Projects that support the construction and development of new single family
29 or multi-family housing units.
- 30 (5) Acquisition of real property.
- 31 (6) Relocation and demolition projects.
- 32 (7) Rehabilitation of residential and non-residential structures.
- 33 (8) Construction of public facilities and improvements, such as water and sewer
34 facilities, streets, neighborhood centers, and the conversion of school
35 buildings for eligible purposes.
- 36 (9) Public services, within certain limits.
- 37 (10) Activities relating to energy conservation and renewable energy resources.
- 38 (11) Provision of assistance to profit-motivated small businesses and
39 micro-enterprises to carry out economic development and job
40 creation/retention activities.
- 41 (12) In awarding grants under this Part, preference shall be given to projects in the
42 40 most distressed counties under G.S. 143B-437.08.

43 **SECTION 11.1.(h)** Throughout each year, deobligated funds arise in the various
44 funding categories and program years of the Community Development Block Grant (CDBG)
45 program as a result of (i) projects coming in under budget, (ii) projects being cancelled, or (iii)
46 projects being required to repay funds. Surplus federal administrative funds in the CDBG
47 program may vary from year to year based upon the amount of State-appropriated funds allocated
48 and the amount of eligible in-kind funds identified.

49 **SECTION 11.1.(i)** To allow the Department of Commerce to quickly deploy
50 deobligated and surplus federal administrative funds as they are identified throughout the

1 program year, the following shall apply to the use of deobligated CDBG funds and surplus federal
2 administrative funds:

- 3 (1) All deobligated funds allocated to the Department of Commerce and any
4 surplus federal administrative funds, as provided for in subdivision (1) of this
5 subsection, may be used by the Department for all of the following:
6 a. To issue grants in the CDBG economic development, neighborhood
7 revitalization, or rural community development program category.
8 b. For providing training and guidance to local governments relative to
9 the CDBG program, its management, and administrative requirements.
10 c. For additional assistance for pilot broadband projects.
11 d. For any other purpose consistent with the Department's administration
12 of the CDBG program if an equal amount of State matching funds is
13 available.

15 **INNOVATION ASSISTANCE FOR INDUSTRY DIVERSIFICATION & EXTENSION** 16 **(INNOVATION AIDE) PROGRAM**

17 **SECTION 11.2.(a)** Program. – The Innovation AIDE Program (Program) is
18 established as a special revenue fund in the Department of Commerce (Department). The Board
19 of Science, Technology, and Innovation (Board) within the Department shall be responsible for
20 administering the Program.

21 **SECTION 11.2.(b)** Purposes. – The Board shall be authorized to make grants from
22 the Program for the benefit of communities in the 80 most economically distressed counties,
23 micropolitan communities, and communities in other areas of the state that demonstrate a need
24 to reorient their economic competitive advantages and enhance their innovation ecosystems or
25 help them transition to a knowledge-based economy by fostering vibrant local innovation
26 ecosystems rooted in globally competitive industries or industry clusters that stimulate business
27 creation, economic resilience, growth, or diversification of entrepreneurs.

28 **SECTION 11.2.(c)** Definitions. – The following definitions apply in this section:

- 29 (1) Innovation. – The creation and adoption of new products, services, and
30 business models to yield value.
31 (2) Economically Distressed Counties. – As determined by the methodology
32 prescribed by §143B-437.08 Development tier designation and updated
33 annually by the North Carolina Department of Commerce.
34 (3) Micropolitan Community. – One or more adjacent counties that have at least
35 one urban core area that has a population of at least 10,000 but less than
36 50,000, plus outlying counties having a high degree of social and economic
37 integration with the central county or counties as measured through
38 commuting, as defined by 75 FR 37245 – 2010 Standards for Delineating
39 Metropolitan and Micropolitan Statistical Areas.
40 (4) Innovation Ecosystem. – A collection of people, organizations, cultures,
41 policies, and programs that creates innovative ideas and discoveries and
42 translates them into innovative products, services, and business models to
43 create new companies and industries, makes existing ones globally
44 competitive, and drives future economic growth, resilience, and well-being.
45 (5) Globally competitive industries or industry clusters. – Industries meeting the
46 following criteria in a community, as supported with data and analysis: (a)
47 Assets in place that could be leveraged for growth, (b) Potential for, or
48 emerging signals of, growth and innovation, such as research & development,
49 patents and other intellectual property, or investment or job or wage growth,
50 (c) Potential to have extended reach across larger tech-focused cities,
51 medium-sized cities, and rural areas, and (d) Global market potential.

1 (6) Eligible Grantees. – Private businesses, nonprofit organizations, councils of
2 government, and local governments.

3 **SECTION 11.2.(d)** Use of Funds. – Moneys in the Program shall promote the
4 extension and diversification of globally competitive industries or industry clusters throughout
5 North Carolina by supporting projects that:

- 6 (1) Provide outreach and technical or other assistance to the targeted communities
7 to aid them in identifying, developing, and growing globally competitive
8 industries or industry clusters;
- 9 (2) Strengthen internal and external networks among local entrepreneurs and
10 innovators and the broader business community, as well as the connection
11 between the local innovation ecosystem and other innovation ecosystems;
- 12 (3) Attract more capital investment into the local innovation ecosystem;
- 13 (4) Start and grow the number of locally owned businesses in the communities;
- 14 (5) Increase employment opportunities within the communities;
- 15 (6) Foster more enterprises led and owned by rural entrepreneurs, women, and
16 entrepreneurs of color;
- 17 (7) Contribute to increased business activity, density, and local ownership in
18 under-developed commercial corridors;
- 19 (8) Increase media visibility for these efforts locally, statewide and, ultimately,
20 nationally; and
- 21 (9) Create statewide or regionwide innovation network that strengthen
22 opportunities for shared learning and collaboration.

23 **SECTION 11.2.(e)** Cap and Matching Funds. – The Department may require a
24 grantee to provide matching funds.

25 **SECTION 11.2.(f)** Administrative Expenses. – Of the funds appropriated to the
26 Program, the Department may use up to one-hundred thousand dollars (\$100,000) or five percent
27 (5%) annually, whichever is greater, to administer the Program.

28 **SECTION 11.2.(g)** Agreements Required. – Funds may be disbursed from the
29 Program only in accordance with agreements entered into between the Department and an
30 eligible grantee.

31 **SECTION 11.2.(h)** Program Guidelines. – The Board shall develop guidelines
32 related to the administration of this Program. At least 20 days before the effective date of any
33 guidelines or nontechnical amendments to the guidelines, the Department shall publish the
34 proposed guidelines on the Department's website and provide notice to persons who have
35 requested notice of proposed guidelines. In addition, the Department must accept oral and written
36 comments on the proposed guidelines, and shall in its discretion consider such comments before
37 finalizing the guidelines, during the 15 business days beginning on the first day that the
38 Department has completed these notifications. Guidelines adopted under this section shall not be

44 (a) Program. – There is established the North Carolina SBIR/STTR Incentive Program
45 to be administered by the North Carolina Board of Science, Technology, and Innovation. In order
46 to foster job creation and economic development ~~in~~ throughout the State, the Board may provide
47 grants to eligible businesses to offset costs associated with applying ~~to the United States Small~~
48 ~~Business Administration for federal~~ Small Business Innovative Research (SBIR) grants or Small
49 Business Technology Transfer Research (STTR) grants. The grants shall be paid from the One
50 North Carolina Small Business Account established in G.S. 143B-437.71.

51 ...

1 (c) Grant. – The North Carolina Board of Science, Technology, and Innovation may
 2 award grants to reimburse ~~a business~~ an eligible business in the state's more distressed counties
 3 for up to one hundred percent (100%) of the costs of preparing and submitting a SBIR/STTR
 4 Phase I proposal, and an eligible business in the state's less distressed counties for up to fifty
 5 percent (50%) of the costs of preparing and submitting a SBIR/STTR Phase I proposal, up to a
 6 maximum of ~~three thousand dollars (\$3,000)~~ twelve thousand dollars (\$12,000). A business may
 7 receive only one grant under this section per year. A business may receive only ~~one~~ two grant
 8 grants under this section with respect to each federal proposal submission. Costs that may be
 9 reimbursed include costs incurred directly related to preparation and submission of the grant such
 10 as word processing services, proposal consulting fees, project-related supplies, literature
 11 searches, rental of space or equipment related to the proposal ~~preparation~~ preparation, educational
 12 programs, and salaries of individuals involved with the preparation of the proposals. Costs that
 13 shall not be reimbursed include travel expenses, large equipment purchases, facility or leasehold
 14 improvements, and legal fees.

15 ...

16 (e) Education & Outreach. – The North Carolina Board of Science, Technology, and
 17 Innovation can use up to ten percent of appropriated funding for the North Carolina SBIR/STTR
 18 Incentive Program to provide education and outreach to aid in the awareness and successful
 19 completion of Phase I SBIR/STTR proposals. Appropriate expenses associated with these efforts
 20 include training, materials, location costs, and other-associated expenses."

21 **SECTION 11.3(b)** G.S. 143B-437.81 reads as rewritten:

22 "**§ 143B-437.81. North Carolina SBIR/STTR Matching Funds Program.**

23 ...

24 (c) Grant. – The North Carolina Board of Science, Technology, and Innovation may
 25 award grants to match the funds received by a business through a SBIR/STTR Phase I proposal
 26 up to a maximum of ~~one two hundred thousand dollars (\$100,000)~~ (\$200,000). Seventy-five
 27 percent (75%) of the total grant shall be remitted to the business upon receipt of the SBIR/STTR
 28 Phase I award and application for funds under this section. Twenty-five percent (25%) of the
 29 total grant shall be remitted to the business upon submission by the business of the Phase II
 30 application to the funding agency and acceptance of the Phase I report by the funding agency. ~~A~~
 31 ~~business may receive only one grant under this section per year.~~ A business may receive only
 32 one grant under this section with respect to each federal ~~proposal submission~~ proposal award.
 33 Over its lifetime, a business may receive a maximum of ~~five~~ ten awards under this section."

34 **CLEAN ENERGY INNOVATION AND RESEARCH GRANTS**

35 **SECTION 11.4** G.S. 143B-437.9 is amended by adding a new Part to read:

36 "Part 2BA. Clean Energy Innovation and Research Fund.

37 "**§ 143B-437.9. NC Clean Energy Innovation and Research (CLEIR) Fund and grant program.**

38 (a) Fund. – The NC Clean Energy Innovation and Research Fund is established as a
 39 special revenue fund in the Department of Commerce, and the Office of Science, Technology
 40 and Innovation in the Department shall be responsible for administering the Fund.

41 (b) Purposes. – Moneys in the NC Clean Energy Innovation and Research Fund shall be
 42 allocated pursuant to this subsection. The Department of Commerce shall make grants from the
 43 Fund to private businesses with less than 100 employees, nonprofit organizations, local
 44 governments, and State agencies to encourage the expansion of small to medium size businesses
 45 with less than 100 employees to help grow a green economy in the State. Moneys in the NC
 46 Clean Energy Innovation and Research Fund shall be used for clean energy and energy efficiency
 47 innovations and research for to encourage innovation, entrepreneurship, and the development
 48 of small business in this area.

49 The priority areas are:

1 (1) To encourage the development and deployment of renewable energy, energy
2 efficient, and environmentally conscious clean technologies and products in
3 the State. The Department of Commerce may make grants available to
4 maximize development, production, distribution, retail infrastructure,
5 deployment, and consumer purchase of such technologies and products in
6 North Carolina, including grants to enhance related workforce development.

7 (2) To encourage the development of the clean energy industry in the State. The
8 Department of Commerce may make grants available to assist in the
9 development and growth of a market for environmentally conscious and
10 energy efficient green building processes.

11 (3) To attract and leverage private-sector investments and entrepreneurial growth
12 in renewable energy, energy efficient, and environmentally conscious clean
13 technologies, products and businesses, including grants to enhance workforce
14 development in such businesses.

15 (c) Cap and Matching Funds. – The Department of Commerce, Office of Science,
16 Technology and Innovation may set a cap on a grant from the NC Clean Energy Innovation and
17 Research Fund and may require a private business to provide matching funds for a grant from

 10 be used during any given fiscal year, or if the projects are accomplished at a lower cost, the
 11 Department may use the resulting fund availability to fund any of the following:

- 12 (1) U.S. Army Corps of Engineers project feasibility studies.
- 13 (2) U.S. Army Corps of Engineers projects whose schedules have advanced and
 14 require State matching funds in the current fiscal year.
- 15 (3) State-local water resources development projects.
- 16 (4) NRCS-EQIP stream restoration projects.

17 (c) Reports – The Department shall submit semiannual reports on the use of these funds
 18 to the Joint Legislative Oversight Committee on Agriculture and Natural and Economic
 19 Resources, the Fiscal Research Division, and the Office of State Budget and Management on or
 20 before March 1 and September 1. Each report shall include all of the following:

- 21 (1) The project name.
- 22 (2) The estimated cost of each project.
- 23 (3) The date that work on each project began or is expected to begin.
- 24 (4) The date that work on each project was completed or is expected to be
 25 completed.
- 26 (5) The actual cost of the project.

CLEAN ENERGY COMMUNITIES

SECTION 12.13.(a) Fund Creation and Purpose – The Clean Energy Communities Fund is established as a special revenue fund within the Department of Environmental Quality's State Energy Office. The Fund provides grants to local governments statewide to help them achieve their sustainability goals through planning and implementation of clean energy and clean transportation projects that equitably advance energy efficiency, renewable energy, vehicle electrification, and related priorities.

SECTION 12.13.(b) Uses of Funds – Funds may be used to help communities with projects, including but not limited to, energy efficiency assessments and improvements; planning and installation of renewable energy projects (e.g., solar PV, rooftop solar, battery storage, and microgrids); purchase of zero-emission vehicles; purchase, planning and installation of electric vehicle infrastructure short- and long-term sustainability analysis and planning; improved procurement practices; stakeholder engagement with underrepresented communities; and clean energy financing strategies.

SECTION 12.13.(c) Basis of Distribution – Funds will be distributed through an application process which may include the following eligibility criteria:

- (1) The economic, social, and environmental benefits to be provided by the projects;
- (2) The viability and expected useful life of the proposed project;
- (3) Project Efficiency/ long term management plan;
- (4) Regional benefits of the project to an underserved area;
- (5) The financial resources of the local government; and
- (6) The cost savings, healthy community living, and energy burden relief provided.
- (7) Ability to leverage funds from federal, private, and other sources.

SECTION 12.13.(d) Planning and Administration – At least fifteen percent (15%) will be allocated to planning and capacity building grants for communities to create and implement sustainability plans and up to two and one half percent (2.5%) of funds or two-hundred fifty thousand dollars (\$250,000), whichever is greater in each fiscal year of the revenues credited to the Fund, to support temporary staff, time limited positions, planning, technical assistance, and program administrative functions.

CLEAN ENERGY SCHOOLS

SECTION 12.14.(a) Fund Creation and Purpose – The Clean Energy Schools Fund is established as a special revenue fund within the Department of Environmental Quality's State Energy Office. The fund provides for a grant program for school districts to implement energy efficiency and clean energy projects that provide a healthier, safer, and more cost-effective learning environment. A portion of funds may be used to support a statewide transition to clean, zero-emission school buses. The Department of Environmental Quality shall consult with the Department of Public Instruction on the use of a portion of funds for clean, zero-emissions school buses.

SECTION 12.14.(b) Uses of Funds – Funds may be used to support projects at schools, including but not limited to, energy efficiency assessments and improvements, planning and installation of renewable energy projects (e.g., solar PV, rooftop solar, battery storage, and microgrids); purchase and maintenance of zero-emission school buses; purchase, planning and installation of infrastructure for zero-emission buses; improved procurement practices; and clean energy financing strategies.

SECTION 12.14.(c) Basis of Distribution – Funds will be distributed through an application process which may include the following eligibility criteria:

- 1 (1) The economic, health, social, and environmental benefits to be provided by
- 2 the projects;
- 3 (2) The viability of the proposed project;
- 4 (3) Regional benefits of the project to an underserved area;
- 5 (4) The financial resources of the school district;
- 6 (5) The cost savings/energy burden relief provided; and
- 7 (6) Ability to leverage funds from federal, private, and other sources.

8 **SECTION 12.14.(d)** Planning and Administration – The Department of
9 Environmental Quality may utilize up to two and one-half percent (2.5%) or two-hundred fifty
10 thousand dollars (\$250,000), whichever is greater in each fiscal year of the revenues credited to
11 the Fund, for support temporary staff, time limited positions planning, technical assistance, and

17 (a) Fund Creation and Purpose – The Low-Income Clean Energy Program is established

OFFICE OF INDIGENT DEFENSE SERVICES POSITIONS

SECTION 16.2. The Office of Indigent Defense Services, may use appropriated funds in each fiscal year of the 2021-2023 fiscal biennium for the expansion of existing offices currently providing legal services to the indigent population under the oversight of the Office of Indigent Defense Services, considering changing caseloads, cost effectiveness, implementation of new initiatives, response to statutory changes, and reduced availability of experienced private counsel in specific case types. Funds may be used for the creation of new positions or offices within existing public defender programs, including satellite offices of the Office of Capital Defender, for the establishment of regional public defender programs, or for positions providing support to private assigned counsel. Notwithstanding the defender districts established by G.S. 7A498.7, the Office of Indigent Defense Services may use a portion of these funds to create positions within existing public defender programs to handle cases in adjacent counties or districts. These funds may be used for the salaries, benefits, equipment, and related expenses for up to 10 attorney positions and six non-attorney positions during the fiscal year with the total annualized cost of these positions no more than one million seven hundred thousand dollars (\$1,700,000). Prior to using funds for this purpose, the Office of Indigent Defense Services shall report to the Chairs of the House of Representatives and the Senate Appropriations Subcommittees on Justice and Public Safety on the proposed expansion.

OFFICE OF INDIGENT DEFENSE SERVICES TITLE IV-E REIMBURSEMENT FUNDS

SECTION 16.3. Funds received by the Office of Indigent Defense Services, as reimbursement for eligible expenses necessary to support an attorney providing legal representation of parents with children in the custody of the Department of Social Services are authorized to be used for these purposes and shall not revert. Unencumbered funds at the end of the fiscal year may be carried over for purposes allowed under the memorandum of agreement between the NC Department of Health and Human Services and the Office of Indigent Defense Services.

As used in this Article, the following definitions apply:

...

- (5) Eligible County. – ~~A county with a population of less than 125,000 according to the latest federal decennial census or a county designated as a development tier one area pursuant to G.S. 143B-437.08, or both.~~ Any county located in the State of North Carolina.

...."

NO HIRING OF SWORN STAFF POSITIONS FOR NC STATE CRIME LAB

SECTION 17.2. The Department of Justice shall not hire sworn personnel to fill vacant positions in the North Carolina State Crime Laboratory. Nothing in this section shall be construed to require the termination of sworn personnel or to affect North Carolina State Crime Laboratory personnel who are sworn and employed by the Laboratory as of the effective date of this section and who continue to meet the sworn status retention standards mandated by the North Carolina Criminal Justice Education and Standards Commission.

PART XVIII. PUBLIC SAFETY**GRANT REPORTING AND MATCHING FUNDS**

SECTION 18.1. Notwithstanding the provisions of G.S. 143C-6-9, the Department of Public Safety may use up to the sum of two million dollars (\$2,000,000) during the 2021-2022 fiscal year and up to the sum of two million dollars (\$2,000,000) during the 2022-2023 fiscal year from funds available to the Department to provide the State match needed in order to receive grant funds. Prior to using funds for this purpose, the Department shall report to the chairs of the House of Representatives Appropriations Committee on Justice and Public Safety and the Senate Appropriations Committee on Justice and Public Safety on the grants to be matched using these funds.

CODIFY USE OF SEIZED AND FORFEITED PROPERTY

SECTION 18.2. G.S. 14-2.3 reads as rewritten:

"§ 14-2.3. Forfeiture of gain acquired through criminal activity.

...

(d) Seized and forfeited assets transferred to the Department of Justice or to the Department of Public Safety pursuant to applicable federal law shall be credited to the budget of the recipient department and shall result in an increase of law enforcement resources for that department. The Department of Public Safety and the Department of Justice shall each make the following reports to the chairs of House of Representatives Appropriations Committee on Justice and Public Safety and the Senate Appropriations Committee on Justice and Public Safety:

(1) A report upon receipt of any assets.

(2) A report that shall be made prior to use of the assets on their intended use and the departmental priorities on which the assets may be expended.

(3) A report on receipts, expenditures, encumbrances, and availability of these assets for the previous fiscal year, which shall be made no later than September 1 of each year.

(e) The General Assembly finds that the use of seized and forfeited assets transferred pursuant to federal law for new personnel positions, new projects, acquisition of real property, repair of buildings where the repair includes structural change, and construction of or additions to buildings may result in additional expenses for the State in future fiscal periods. Therefore, the Department of Justice and the Department of Public Safety are prohibited from using these assets for such purposes without the prior approval of the General Assembly.

(f) Nothing in this section prohibits State law enforcement agencies from receiving funds from the United States Department of Justice, the United States Department of the Treasury, and the United States Department of Health and Human Services."

REPEAL STATE CAPITOL POLICE/CREATION OF RECEIPT-SUPPORTED POSITIONS

SECTION 18.3. Section 16B.1 of S.L. 2017-57 is repealed.

USE OF CLOSED FACILITIES

SECTION 18.4.(a) In conjunction with the closing of prison facilities, youth detention centers, and youth development centers, the Department of Public Safety shall consult with the county or municipality in which the facility is located, with elected State and local officials, and with State and federal agencies about the possibility of converting that facility to other use. The Department may also consult with any private for-profit or nonprofit firm about the possibility of converting the facility to other use. In developing a proposal for future use of each facility, the Department shall give priority to converting the facility to other criminal justice use. Consistent with existing law and the future needs of the Department of Public Safety, the

1 State may provide for the transfer or the lease of any of these facilities to counties, municipalities,
2 State agencies, federal agencies, or private firms wishing to convert them to other use.
3 G.S. 146-29.1(f) through (g) shall not apply to a transfer made pursuant to this section. The
4 Department of Public Safety may also consider converting some of the facilities recommended
5 for closing from one security custody level to another, where that conversion would be
6 cost-effective. A prison unit under lease to a county pursuant to the provisions of this section for
7 use as a jail is exempt for the period of the lease from any of the minimum standards adopted by
8 the Secretary of Health and Human Services pursuant to G.S. 153A-221 for the housing of adult
9 prisoners that would subject the unit to greater standards than those required of a unit of the State
10 prison system.

11 **SECTION 18.4.(b)** The Department may convert closed facilities for the following
12 purposes:

- 13 (1) Training needs.
- 14 (2) Population Management.
- 15 (3) Transitional housing.

16 Sixty days prior to converting facilities to these purposes, the Department shall report
17 to the Joint Legislative Oversight Committee on Justice and Public Safety. The report shall
18 include the justification for the conversion, operational requirements for the facility, and
19 available resources for staffing and operating the facility. If the proposed facility will require
20 additional funding in the future, the report shall provide a five-year projection of those funding
21 needs.

22 23 **REIMBURSE COUNTIES FOR HOUSING AND EXTRAORDINARY MEDICAL** 24 **EXPENSES**

25 **SECTION 18.5.** Notwithstanding G.S. 143C-6-9, the Department of Public Safety

30 report annually by February 1 of each year to the chairs of the Joint Legislative Oversight

33 Committee on Justice and Public Safety on the expenditure of funds to reimburse counties for

41 provide training programs and equipment purchases for the Section of Community Corrections,
42 but only to the extent sufficient funds remain available in the Fund to support the mission of the
43 Interstate Compact Program.

46 **SECTION 18.7.** G.S. 15B-2 reads as rewritten:

13 medically-related property, and other remedial treatment and care of a victim
14 shall be limited to sixty-six and two-thirds percent (66 2/3%) of the amount
15 usually charged by the provider for the treatment or care. By accepting the
16 compensation paid as allowable expense pursuant to this subdivision, the
17 provider agrees that the compensation is payment in full for the treatment or
18 care and shall not charge or otherwise hold a claimant financially responsible
19 for the cost of services in addition to the amount of allowable expense.

29 (7) This Act, for law enforcement officers of the State Capital Police and certified

33 **USE OF FUNDS APPROPRIATED FOR COST-OF-LIVING**
34 **ADJUSTMENT/LEGISLATIVE INCREASES, COMPENSATION BONUSES, AND**
35 **EMPLOYEE BENEFITS**

36 **SECTION 38.18.(a)** The appropriations set forth in Section 2.1 of this act include
37 appropriations for cost-of-living adjustments, compensation bonuses, and legislatively mandated
38 employee benefit increases. The Office of State Budget and Management shall ensure that those
39 funds are used only for the purposes of salary increases and employee benefits.

40 **SECTION 38.18.(b)** If the Director of the Budget determines that funds appropriated
41 to a State agency for legislatively mandated salary increases and employee benefits exceed the
42 amount required by that agency for those purposes, the Director may reallocate those funds to
43 other State agencies that received insufficient funds for required cost-of-living and benefit
44 increases.

45 **SECTION 38.18.(c)** Funds appropriated for legislatively mandated salary and
46 employee benefit increases and compensation bonuses may not be used to adjust the budgeted
47 salaries of vacant positions, to provide salary increases in excess of those required by the General
48 Assembly, or to increase the budgeted salary of filled positions to the minimum of the position's
49 respective salary range

1 **SECTION 38.18.(d)** Any funds appropriated for legislatively mandated salary and
2 benefits increases and compensation bonuses in excess of the amounts required to implement the
3 increases shall be credited to the Pay Plan Reserve

4 **SECTION 38.18.(e)** No later than March 1 of each year of the biennium, the Office
5 of State Budget and Management shall report to the Joint Legislative Commission on
6 Governmental Operations on the expenditure of funds for legislatively mandated salary
7 increases, compensation bonuses, and employee benefits. This report shall include at least the
8 following information for each State agency:

- 9 (1) The total amount of funds that the agency received for legislatively mandated
10 salary increases and employee benefits.
- 11 (2) The total amount of funds transferred from the agency to other State agencies
12 pursuant to subsection (b) of this section. This section of the report shall
13 identify the amounts transferred to each recipient State agency.
- 14 (3) The total amount of funds used by the agency for legislatively mandated salary
15 increases and employee benefits.
- 16 (4) The amount of funds used pursuant so subsection (c) of this section.

17 18 **SALARY ADJUSTMENT FUNDS AND RESERVES FOR TURNOVER,** 19 **COMPRESSION AND EQUITY**

20 **SECTION 38.19.(a)** The funds appropriated for salary adjustments and to address
21 turnover, compression, and equity in this Act shall be used to provide salary adjustments using
22 allowable human resource practices, including in-range adjustments, salary range revisions,
23 allowances/geographic site differentials, and reclassifications, as follows:

- 24 (1) To address recruitment and retention of hard-to-staff, high-turnover positions.
- 25 (2) To address salaries relative to market rates.
- 26 (3) To promote pay equity, including but not limited to gender and racial equity.
- 27 (4) To address salary compression.
- 28 (5) To provide adjustments for employees with qualifications, including
29 specialized skills, certifications, education, or experience that significantly
30 exceed minimum qualifications.

31 Adjustments must be documented through data collection and analysis according to
32 accepted human resource professional practices and standards. Further, funds may only be used
33 for salary adjustments for the stated purposes that comply with the laws and adopted policies of
34 the appropriate governing entity.

35 **SECTION 38.19.(b)** Funds appropriated for salary adjustments by this act shall not
36 be used for other purposes, including in-range adjustments, career progression adjustments, or
37 other adjustments as these terms may be defined by State human resources policy.

38 39 **MITIGATE BONUS LEAVE**

40 **SECTION 38.20.** During the 2021-2023 fiscal biennium, State agencies,
41 departments, institutions, the North Carolina Community College System, and The University of
42 North Carolina may offer State employees the opportunity to use or to cash in special bonus leave
43 benefits that have accrued pursuant to Section 28.3A of S.L. 2002-126, Section 30.12B(a) of S.L.
44 2003-284, Section 29.14A of S.L. 2005-276, Section 35.10A of S.L. 2014-100, Section 35.25 of
45 S.L. 2018-5, Section 5.1 of S.L. 2019-208, Section 3.14 of S.L. 20219-209, Section 5.1 of S.L.
46 2019-210, Section 6.1 of S.L. 2019-211, but only if all of the following requirements are met:

- 47 (1) Employee participation in the program must be voluntary.
- 48 (2) Special leave that is liquidated for cash payment to an employee must be
49 valued at the amount based on the employee's current annual salary rate.

(3) By September 1, 2022 and September 1, 2023, a report on the demographic information shall be submitted to the respective agency head or employing agency and to the Fiscal Research Division.

SPECIAL ANNUAL LEAVE BONUS

SECTION 38.21.(a) Any person who is (i) a full-time permanent employee of the State, a community college institution, or a local board of education on July 1, 2021, and (ii) eligible to earn annual leave shall have a one-time additional five days of annual leave credited on July 1, 2021.

SECTION 38.21.(b) Except as provided by subsection (c) of this section, the additional leave shall be accounted for together with the leave provided by Section 35.25 of S.L. 2018-5 and shall remain available during the length of the employee's employment, notwithstanding any other limitation on the total number of days of annual leave that may be carried forward. Part-time permanent employees shall receive a pro rata amount of the five days awarded by this section.

SECTION 38.21.(c) The additional leave awarded under this section has no cash value and is not eligible for cash in. If not used prior to the time of separation or retirement, the bonus leave cannot be paid out and is lost.

SECTION 38.21.(d) Notwithstanding any provision of G.S. 126-8 to the contrary, any vacation leave remaining on December 31 of each year in excess of 30 days shall be reduced by the number of days awarded in this section that were actually used by the employee during the year such that the calculation of vacation leave days that would convert to sick leave shall reflect a deduction of those days of special annual leave awarded in this section that were used by the employee during the year.

SECTION 38.21.(e) The number of days awarded by this section that carry forward to each following year shall equal the number of days awarded in this section remaining on December 31 of each year plus the number of days awarded in this section that were deducted from vacation leave in excess of 30 days for the calculation of sick leave.

SECTION 38.21.(f) No employee may be required to take the additional leave awarded by this section.

EXPERIENCE IN CERTIFIED POSITION/ INTEGRATED PAYROLL/HR SYSTEM

SECTION 38.22. The Office of the State Controller, Department of Public Safety, and the Criminal Justice Education and Training Standards Commission within the Department of Justice shall work together to update the Integrated HR/Payroll system to track length of service in a certified position. This update shall be completed prior to June 30, 2022.

SECTION 38.23.(a) Effective July 1, 2021, the State's employer contribution rates budgeted for retirement and related benefits as a percentage of covered salaries for the 2021-2022 fiscal year for teachers and State employees, State law enforcement officers (LEOs), the University and Community Colleges Optional Retirement Programs (ORPs), the Consolidated Judicial Retirement System (CJRS), and the Legislative Retirement System (LRS) are as set forth below:

SECTION 38.24.(j) Notwithstanding any other provision of law to the contrary, in order to administer the cost of living adjustments and supplements for retirees provided for in this section, the Retirement Systems Division of the Department of State Treasurer may increase receipts from the retirement assets of the corresponding retirement system or pay costs associated with the administration of the payment directly from the retirement assets.

The appropriations made by the 2021 General Assembly for capital improvements are for constructing, repairing, or renovating State buildings, utilities, and other capital facilities, for acquiring sites for them where necessary, and for acquiring buildings and land for State government purposes.

25 **SECTION 39.3.(b)** From funds deposited with the State Treasurer in a capital
 26 improvement account to the credit of the Department of Agriculture and Consumer Services
 27 pursuant to G.S. 146-30, the sum of seventy–five thousand dollars (\$75,000) for the 2021–2022
 28 fiscal year and the sum of seventy–five thousand dollars (\$75,000) for the 2022–2023 fiscal year
 29 shall be transferred to the Department of Agriculture and Consumer Services to be used,
 30 notwithstanding G.S. 146-30, by the Department for its plant conservation program under Article
 31 19B of Chapter 106 of the General Statutes for costs incidental to the acquisition of land, such as
 32 land appraisals, land surveys, title searches, and environmental studies, and for the management
 33 of the plant conservation program preserves owned by the Department.

 35 **NATIONAL GUARD PROJECTS**

36 **SECTION 39.4.(a)** The Department of Public Safety shall allocate the funds

46 **SECTION 39.4.(b)** Subject to the limitations imposed by Section 39.2(a) of this act,
 47 the Adjutant General of the National Guard may determine which projects listed in subsection
 48 (a) of this section shall receive an allocation of State funds in each fiscal year of the biennium.

49 **SECTION 39.4.(c)** Where the actual costs are different from the estimated costs
 50 under subsection (a) of this section, the Adjutant General of the National Guard may adjust the
 51 allocations among projects as needed. However, State funds shall not be allocated to a project in

1 excess of the maximum amount of State funds authorized to be allocated to the project under
2 subsection (a) of this section. If any projects funded under subsection (a) of this section are
3 delayed and the budgeted State funds cannot be used during the 2021-2022 fiscal year, or if the
4 projects funded under subsection (a) of this section are accomplished at a lower cost, the
5 Department may use the resulting fund availability to fund any of the following:

- 6 (1) Future project feasibility studies.
- 7 (2) Survey, testing, and permitting.
- 8 (3) Planning and execution for reversion of facilities no longer in use.
- 9 (4) Previously funded projects that have experienced a cost overrun.

10 11 **EXPENDITURE OF FUNDS ONLY AFTER ALLOTMENTS APPROVED**

12 **SECTION 39.5.** The appropriations made by the 2021 General Assembly for capital
13 improvements shall be disbursed for the purposes provided by this act. Expenditure of funds shall
14 not be made by any State department, institution, or agency until an allotment has been approved
15 by the Governor as Director of the Budget. The allotment shall be approved only after full
16 compliance with the State Budget Act, Chapter 143C of the General Statutes. Prior to the award
17 of construction contracts for projects to be financed in whole or in part with self-liquidating
18 appropriations, the Director of the Budget shall approve the elements of the method of financing
19 of those projects, including the source of funds, interest rate, and liquidation period. Provided,
20 however, that if the Director of the Budget approves the method of financing a project, the
21 Director shall report that action to the Joint Legislative Commission on Governmental Operations
22 at its next meeting.

23 Where direct capital improvement appropriations include the purpose of furnishing
24 fixed and movable equipment for any project, those funds for equipment shall not be subject to
25 transfer into construction accounts except as authorized by the Director of the Budget. The
26 expenditure of funds for fixed and movable equipment and furnishings shall be reviewed and
27 approved by the Director of the Budget prior to commitment of funds.

28 Capital improvement projects authorized by the 2021 General Assembly shall be
29 completed, including fixed and movable equipment and furnishings, within the limits of the
30 amounts of the direct or self-liquidating appropriations provided, except as otherwise provided
31 in this act. Capital improvement projects authorized by the 2021 General Assembly for the design
32 phase only shall be designed within the scope of the project as defined by the approved cost
33 estimate filed with the Director of the Budget, including costs associated with site preparation,
34 demolition, and movable and fixed equipment.

35 36 **ALLOCATION OF NET PROCEEDS FROM WAKE COUNTY PROPERTY** 37 **DISPOSITIONS**

38 **SECTION 39.6.** G.S. 146-30 is amended by adding a new section to read:

39 "**§ 146-30.2. Application of Net Proceeds From Disposition of Property Allocated to the**
40 **Department of Administration in Wake County.**

41 (a) Limitation. – Notwithstanding G.S. 146-30 or any other provision of law, and subject
42 to the limitations contained in any applicable deed, the net proceeds of any disposition of, use of,
43 or activity on real property located in Wake County and allocated to the Department of
44 Administration shall be used solely to repair and renovate real property located in Wake County
45 and allocated to the Department of Administration. These funds shall only be used to fund
46 projects listed in G.S. 143C-4-3(b), subject to the approval of the Director of the Budget.

47 (b) Definition of Net Proceeds. – For purposes of this section, the term "net proceeds"
48 shall have the same meaning as in G.S. 146-30.

49 (c) Appropriation. – Net proceeds received on or after July 1, 2017, are hereby
50 appropriated for the uses contained in G.S. 146-30.2(a).

1 (d) Report. – The Director of the Budget shall report annually on July 1 on projects
2 funded under this subsection to the Joint Legislative Oversight Committee on Capital
3 Improvements."

4
5 **AUTHORIZE STATE AGENCIES TO UNDERTAKE SMALL REPAIRS AND**
6 **RENOVATIONS PROJECTS WITH FUNDS AVAILABLE**

7 **SECTION 39.7.** Article 1 of Chapter 143C of the General Statutes is amended by
8 adding a new section to read:

9 **"§143C-8-14. Small Repairs And Renovation Projects With Funds Available.**

10 (a) A State agency may undertake repairs and renovations projects so long as each project
11 satisfies the following requirements:

12 (1) Total project costs do not exceed the informal project limit set by the State
13 Building Commission.

14 (2) The project is one of the types set forth in G.S. 143C-4-3(b)(1) through (13).

15 a. General Funds shall be used only for the repair and renovation of
16 General Fund supported facilities.

17 (3) The project is paid for with funds available to the agency.

18 (b) Projects undertaken pursuant to this section shall be reported to the Fiscal Research
19 Division on a quarterly basis. A report under this subsection shall include information about all
20 the following for each project:

21 (1) The facility at which the project is being undertaken.

22 (2) The nature and scope of the project.

23 (3) The source of funds for the project.

24 (4) The category of projects set forth in G.S. 143C-4-3(b) that the project falls
25 within."

26
27 **INVEST NC BOND ACT**

28 **SECTION 39.8.(a)** Short Title. – This section may be cited as the "Invest NC Bond
29 Act of 2021."

30 **SECTION 39.8.(b)** Purpose. – It is the intent of the General Assembly by this act to
31 provide, subject to a vote of the qualified voters of the State, for the issuance of four billion seven
32 hundred million dollars (\$4,700,000,000) providing funds, with any other available funds, to
33 invest in the State's public facilities, without limitation, construction, repair, renovation, and
34 furnishing of new facilities in order to ensure that the citizens of North Carolina have access to
35 high quality educational facilities, cultural facilities and attractions, and health care facilities.

36 **SECTION 39.8.(c)** Findings – The General Assembly also finds:

37 (1) There is a documented need of \$8.1 billion in need in the construction and
38 renovation of Public School Facilities.

39 (2) There is a documented need of \$4.4 billion in deficiencies at the University of
40 North Carolina System.

41 (3) Community College facilities are necessary to educate and train the workforce
42 of tomorrow.

43 (4) Community College facilities are necessary to retrain those workers who have
44 been adversely impacted by changing economic conditions.

45 (5) Cultural facilities at the North Carolina Zoological Park and the North
46 Carolina History Museum are key cultural and educational attractions for the
47 citizens of the State.

48 (6) State Parks are vital to the well-being of all North Carolinians.

49 (7) The facilities constructed in this Act will benefit all future North Carolinians
50 for decades to come.

51 (8) All facilities are necessary to support the economic vitality of North Carolina.

- 1 (9) The State has prudently managed its finances.
2 (10) The State has achieved the highest credit rating available by independent
3 credit rating agencies.
4 (11) The debt proposed by this Act is affordable and preferable to address the needs
5 of the citizens of the State.

6 **SECTION 39.8.(d)** Definitions. – The following definitions apply in this section
7 unless the context otherwise requires:

- 8 (1) Bonds. – Bonds issued under this section.
9 (2) Cost. – The term includes all of the following:
10 a. The cost of constructing, reconstructing, renovating, repairing,
11 enlarging, acquiring, and improving State capital facilities, including
12 the acquisition of land, rights-of-way, easements, franchises,
13 equipment, machinery, furnishings, and other interests in real or
14 personal property acquired or used in connection with a State capital
15 facility.
16 b. The cost of engineering, architectural, and other consulting services as
17 may be required.
18 c. Administrative expenses and charges.
19 d. The cost of providing personnel to ensure effective project
20 management.
21 e. The cost of bond insurance, investment contracts, credit enhancement
22 and liquidity facilities, interest-rate swap agreements or other
23 derivative products, financial and legal consultants, and related costs
24 of bond and note issuance, to the extent and as determined by the State
25 Treasurer.
26 f. Finance charges, reserves for debt service, and other types of reserves
27 required pursuant to the terms of any bond or note or related
28 documents, interest before and during construction or acquisition of a
29 State capital facility and, if considered advisable by the State
30 Treasurer, for a period not exceeding two years after the estimated date
31 of completion of construction or acquisition.
32 g. The cost of bond insurance, investment contracts, credit enhancement
33 facilities and liquidity facilities, interest-rate swap agreements or other
34 derivative products, financial and legal consultants, and related costs
35 of the incurrence or issuance of any bond or note.
36 h. The cost of reimbursing the State for any payments made for any cost
37 described in this subdivision.
38 i. Any other costs and expenses necessary or incidental to the purposes
39 of this section.
40 (3) Credit facility. – An agreement entered into by the State Treasurer on behalf
41 of the State with a bank, savings and loan association, or other banking
42 institution, an insurance company, reinsurance company, surety company or
43 other insurance institution, a corporation, investment banking firm, or other
44 investment institution, or any financial institution or other similar provider of
45 a credit facility, which provider may be located within or without the United
46 States, such agreement providing for prompt payment of all or any part of the
47 principal or purchase price (whether at maturity, presentment or tender for
48 purchase, redemption, or acceleration), redemption premium, if any, and
49 interest on any bonds or notes payable on demand or tender by the owner, in
50 consideration of the State agreeing to repay the provider of the credit facility
51 in accordance with the terms and provisions of such agreement.

- 1 (4) Notes. – Notes issued under this section.
- 2 (5) Par formula. – A provision or formula adopted by the State to provide for the
- 3 adjustment, from time to time, of the interest rate or rates borne by any bonds
- 4 or notes, including the following:
- 5 a. A provision providing for such adjustment so that the purchase price
- 6 of such bonds or notes in the open market would be as close to par as
- 7 possible.
- 8 b. A provision providing for such adjustment based upon a percentage or
- 9 percentages of a prime rate or base rate, which percentage or
- 10 percentages may vary or be applied for different periods of time.
- 11 c. Such other provision as the State Treasurer may determine to be
- 12 consistent with this act and will not materially and adversely affect the
- 13 financial position of the State and the marketing of bonds or notes at a
- 14 reasonable interest cost to the State.
- 15 (6) State. – The State of North Carolina, including any State agency.
- 16 (7) State agency. – Any agency, institution, board, commission, bureau, council,
- 17 department, division, officer, or employee of the State. The term does not
- 18 include counties, municipal corporations, political subdivisions, local boards
- 19 of education, or other local public bodies.

20 **SECTION 39.8.(e)** Authorization of Bonds and Notes. – Subject to a favorable vote
 21 of a majority of the qualified voters of the State who vote on the question of issuing public
 22 improvement bonds in the election called and held as provided in this section, the State Treasurer
 23 is hereby authorized, by and with the consent of the Council of State, to issue and sell, at one
 24 time or from time to time, general obligation bonds of the State to be designated "State of North
 25 Carolina Public Improvement Bonds," with any additional designations as may be determined to
 26 indicate the issuance of bonds from time to time, or notes of the State as provided in this section,
 27 in an aggregate principal amount not exceeding four billion seven hundred million dollars
 28 (\$4,700,000,000) for the purpose of providing funds, with any other available funds, for the
 29 purposes authorized in this section.

30 **SECTION 39.8.(f)** Use of Public Improvement Bond and Note Proceeds. – (1)
 31 Subject to the provisions of subdivision (2) of this subsection, the proceeds of public
 32 improvement bonds and notes, including premium thereon, if any, shall be used for the projects
 33 in the following general amounts set forth below:

(1b) Process for Allocating Funds from the Unforeseen Costs Reserve. – The Office of State Budget and Management (OSBM) shall set out the process for applying for funds from the Unforeseen Costs Reserve, together with the criteria for assessing such applications, in a Budget Memo. OSBM may allocate funds from the Unforeseen Costs Reserve only when it is satisfied that the conditions set out under these criteria have been met. Once agreed, funds may only be drawn down as needed, in line with project cashflow requirements.

1 (2) Special Allocation Provisions. – In determining the use of the proceeds of public
2 improvement bonds and notes, including premium thereon, if any, set forth in
3 subdivision (1) of this subsection, the following special allocation provisions apply:

4 a. The proceeds of public improvement bonds and notes, including
5 premium thereon, if any, for public instruction for public schools
6 capital assistance, as provided in subdivision (1) of this subsection,
7 shall be allocated as follows:

- 8 1. One billion dollars (\$1,000,000,000) of such proceeds shall be
9 allocated equally to each county. Each county's allocation shall
10 be distributed to the local school administrative units located
11 in whole or in part in the county based on the average daily
12 membership of the county's students in the school units.
- 13 2. Three hundred seventy-five million dollars (\$375,000,000) of
14 such proceeds shall be allocated among local school
15 administrative units located in counties whose wealth is less
16 than the State average wealth. The allocation shall have a
17 numerator of the 2020-2021 low wealth allotment specific to
18 that local school administrative unit with a denominator of the
19 total 2020-2021 low wealth allotment, and then multiplied by
20 the total allocation in this sub-division.
- 21 3. One billion one hundred twenty-five million dollars
22 (\$1,125,000,000) of such proceeds shall be allocated among
23 local school administrative by on the basis of average daily
24 membership for Fiscal Year 2020-2021 where the numerator is
25 average daily membership for the local administrative unit and
26 the denominator is the total average daily membership for the
27 state for FY 2020-2021.
- 28 4. Bond proceeds for a county for any designation require no
29 local match if any portion of the proceeds results from
30 low-wealth county receiving funds in sub subdivision 2. Any
31 other county receiving bond proceeds allocated shall provide
32 local matching funds from county funds, other non-State funds,
33 or a combination of these sources for such proceeds. The
34 amount of matching funds shall be (i) one dollar (\$1.00) of
35 local matching funds for every three dollars (\$3.00) of such
36 proceeds for a local school administrative unit located in a
37 county that is a development tier one area, as defined in
38 G.S. 143B-437.08, (ii) one dollar (\$1.00) of local matching
39 funds for every two dollars (\$2.00) of such proceeds for a local
40 school administrative unit located in a county that is a
41 development tier two area, as defined in G.S. 143B-437.08,
42 and (iii) one dollar (\$1.00) of local matching funds for every
43 one dollar (\$1.00) of such proceeds for a local school
44 administrative unit located in a county that is a development
45 tier three area, as defined in G.S. 143B-437.08. The match
46 requirement may be satisfied by non-State expenditures for
47 public school facilities made on or after January 1, 2017. If a
48 debt has been incurred since January 1, 2017, for the general
49 purpose of public school facilities, then the face amount of the
50 debt shall be considered as a non-State expenditure for public
51 school facilities for the purpose of the match. No other

1 expenditures made or debts incurred before January 1, 2017,
2 may be used to satisfy the match requirement. As counties
3 satisfy the match requirements of this subsection, they shall
4 document the extent to which they have done so in periodic
5 reports to the State Board of Education. These reports shall
6 include any information and documentation required by the
7 State Board of Education. The State Board of Education shall
8 certify to the State Treasurer from time to time the extent to
9 which the match requirements of this subsection have been met
10 with respect to each county. Bond proceeds shall be distributed
11 for expenditure only as, and to the extent, the matching
12 requirement of this section are satisfied, as certified by the
13 State Board of Education. The State Board of Education shall
14 also require counties to report annually on the impact of funds
15 provided under this act on the property tax rate for that year.
16 These reports shall be public documents and shall be furnished
17 to any citizen upon request. If the State Board of Education
18 determines that a county has not met the matching requirement
19 set forth in this sub-subdivision by January 1, 2028, the State
20 Board of Education shall certify that fact to the State Treasurer
21 by March 1, 2028. The State Board of Education shall
22 reallocate unmatched funds in the following manner:

- 23 I. Proceeds allocated under sub subdivision (1) shall be
24 reallocated to local administrative units receiving funds
25 under sub subdivision (1) for which the State Board of
26 Educated has certified matching funds.
- 27 II. Proceeds allocated under sub subdivision (2) shall be
28 reallocated to local administrative units receiving funds
29 under sub subdivision (2) for which the State Board of
30 Educated has certified matching funds.
- 31 III. Proceeds allocated under sub subdivision (2) shall be
32 reallocated to local administrative units receiving funds
33 under sub subdivision (2) for which the State Board of
34 Educated has certified matching funds.

35 5. A local school administrative unit that receives proceeds under
36 this section shall ensure that such proceeds are used:

- 37 I. For acquisition of real property and construction,
38 acquisition, reconstruction, enlargement, renovation,
39 or replacement of buildings and other structures, and
- 40 II. To supplement local funds for public school capital
41 outlay projects and shall not decrease local funds for
42 those projects from one fiscal year to the next fiscal
43 year, as measured by the most recent five-year annual
44 average capital outlay expenditure.

45 b. The proceeds of public improvement bonds and notes, including
46 premium thereon, if any, for NC Community Colleges, as provided in
47 subdivision (1) of this subsection for new construction, repairs, and
48 renovations, shall be used for new construction or rehabilitation of
49 existing facilities and repairs and renovations. Any items purchased
50 with such proceeds and installed or replaced as part of a renovation or
51 rehabilitation must have a useful life of at least 10 years or must extend

1 the life of the facility by at least 10 years once renovated or
2 rehabilitated. In order to receive the proceeds under this
3 sub-subdivision for projects for new construction, the community
4 college receiving the proceeds shall provide local matching funds from
5 county funds, other non-State funds, or a combination of these sources
6 for such proceeds. The amount of matching funds shall be (i) one
7 dollar (\$1.00) of local matching funds for every three dollars (\$3.00)
8 of such proceeds for a community college project located in a
9 development tier one area, as defined in G.S. 143B-437.08, (ii) one
10 dollar (\$1.00) of local matching funds for every two dollars (\$2.00) of
11 such proceeds for a community college project located in a
12 development tier two area, as defined in G.S. 143B-437.08, and (iii)
13 one dollar (\$1.00) of local matching funds for every one dollar (\$1.00)
14 of such proceeds for a community college project located in a
15 development tier three area, as defined in G.S. 143B-437.08.
16 Community colleges are not required to match bond proceeds
17 allocated in this section for rehabilitation of existing facilities and
18 repairs and renovations.

19 **SECTION 39.8.(g)** Allocation and Tracking of Proceeds. –

20 (1) Public improvement bonds. – The proceeds of public improvement bonds and
21 notes, including premium thereon, if any, except the proceeds of bonds the
22 issuance of which has been anticipated by bond anticipation notes or the
23 proceeds of refunding bonds or notes, shall be placed by the State Treasurer
24 in a special fund to be designated "Public Improvement Bonds Fund," which
25 may include such appropriate special accounts therein as may be determined
26 by the State Treasurer and shall be disbursed as provided in this section.
27 Monies in the Public Improvement Bonds Fund shall be allocated and
28 expended as provided in this section.

29 Any additional monies that may be received by means of a grant or grants
30 from the United States of America or any agency or department thereof or
31 from any other source for deposit to the Public Improvement Bonds Fund may
32 be placed in the Public Improvement Bonds Fund or in a separate account or
33 fund and shall be disbursed, to the extent permitted by the terms of the grant
34 or grants, without regard to any limitations imposed by this section.

35 Monies in the Public Improvement Bonds Fund or any separate account
36 established under this section may be invested from time to time by the State
37 Treasurer in the same manner permitted for investment of monies belonging
38 to the State or held in the State treasury, except with respect to grant money
39 to the extent otherwise directed by the terms of the grant. Investment earnings,
40 except investment earnings with respect to grant monies to the extent
41 otherwise directed or restricted by the terms of the grant, may be (i) credited
42 to the Public Improvement Bonds Fund, (ii) used to pay debt service on the
43 bonds authorized by this section, (iii) used to satisfy compliance with
44 applicable requirements of the federal tax law, or (iv) transferred to the
45 General Fund of the State.

46 The proceeds of public improvement bonds and notes, including premium
47 thereon, if any, may be used with any other monies made available by the
48 General Assembly for funding the projects authorized by this section,
49 including the proceeds of any other State bond issues, whether heretofore
50 made available or that may be made available at the session of the General
51 Assembly at which this section is ratified or any subsequent sessions. The

1 proceeds of public improvement bonds and notes, including premium thereon,
2 if any, shall be expended and disbursed under the direction and supervision of
3 the Director of the Budget. The funds provided by this section shall be
4 disbursed for the purposes provided in this section upon warrants drawn on
5 the State Treasurer by the State Controller, which warrants shall not be drawn
6 until requisition has been approved by the Director of the Budget and which
7 requisition shall be approved only after full compliance with the State Budget
8 Act, Chapter 143C of the General Statutes.

9 (2) Tracking of bond proceeds. – The State Treasurer or the State Treasurer's
10 designee is hereby authorized and directed to set up a comprehensive system
11 of tracking the proceeds of the public improvement bonds and notes, including
12 premium thereon, if any, to the extent necessary to enable the State Treasurer
13 or the State Treasurer's designee to properly account for the use of such
14 proceeds for compliance with applicable requirements of the federal tax law
15 or otherwise. All recipients of such proceeds shall comply with any tracking
16 system implemented by the State Treasurer or the State Treasurer's designee
17 for this purpose. The State Treasurer may withhold such proceeds from any
18 State agency or department not complying with this subdivision.

19 (3) Costs. – Allocations to the costs of a capital improvement or undertaking in
20 each case may include allocations to pay the costs set forth in sub-subdivisions
21 c. through g. of subdivision (2) of subsection (d) of this section in connection
22 with the issuance of bonds for that capital improvement or undertaking.

23 **SECTION 39.8.(h)** Election. – The question of the issuance of the bonds authorized
24 by this section shall be submitted to the qualified voters of the State at a Statewide election to be
25 held November 2, 2021. Any other primary, election, or referendum validly called or scheduled
26 by law at the time the election on the bond question provided for in this subsection is held may
27 be held as called or scheduled. Notice of the election shall be given in the manner and at the times
28 required by G.S. 163-33(8). The election and the registration of voters therefor shall be held
29 under and in accordance with the general laws of the State. Absentee ballots shall be authorized
30 in the election and shall be available 50 days prior to the date on which the election is to be held.

31 Ballots, voting systems authorized by Article 14A of Chapter 163 of the General
32 Statutes, or both may be used in accordance with rules prescribed by the State Board of Elections.
33 The bond question to be used in the ballots or voting systems shall be in substantially the
34 following form:

35 "[] FOR [] AGAINST

36 The issuance of four billion seven hundred million dollars (\$4,700,000,000) State of
37 North Carolina Public Improvement Bonds constituting general obligation bonds of the State
38 secured by a pledge of the faith and credit and taxing power of the State for the purpose of
39 providing funds, with any other available funds, to fund capital improvements and new facilities
40 for the State, including, without limitation, the construction and furnishing of new facilities and
41 the renovation and rehabilitation of existing facilities for, without limitation, the public schools
42 of the state, the Department of Health and Human Services, the Department of Natural and
43 Cultural Resources, North Carolina Community College System, and the University of North
44 Carolina System." If a majority of those voting on the bond question in the election vote in favor
45 of the issuance of the bonds described in the question, those bonds may be issued as provided in
46 this section. If a majority of those voting on a bond question in the election do not vote in favor
47 of the issuance of the bonds described in the question, those bonds shall not be issued. The results
48 of the election shall be canvassed and declared as provided by law for elections for State officers;
49 the results of the election shall be certified by the State Board of Elections to the Secretary of
50 State in the manner and at the time provided by the general election laws of the State.

51 **SECTION 39.8.(i)** Issuance of Bonds and Notes. –

- 1 (1) Terms and conditions. – Bonds or notes may bear a date or dates, may be serial
2 or term bonds or notes, or any combination thereof, may mature in such
3 amounts and at such time or times, not exceeding 40 years from their date or
4 dates, may be payable at such place or places, either within or without the
5 United States of America, in such coin or currency of the United States of
6 America as at the time of payment is legal tender for payment of public and
7 private debts, may bear interest at such rate or rates, which may vary from
8 time to time, and may be made redeemable before maturity, at the option of
9 the State or otherwise as may be provided by the State, at such price or prices,
10 including a price less than or greater than the face amount of the bonds or
11 notes, and under such terms and conditions, all as may be determined by the
12 State Treasurer, by and with the consent of the Council of State.
- 13 (2) Signatures; form and denomination; registration. – Bonds or notes may be
14 issued in certificated or uncertificated form. If issued in certificated form,
15 bonds or notes shall be signed on behalf of the State by the Governor or shall
16 bear the Governor's facsimile signature, shall be signed by the State Treasurer
17 or shall bear the State Treasurer's facsimile signature, and shall bear the Great
18 Seal of the State, or a facsimile of the Seal shall be impressed or imprinted
19 thereon. If bonds or notes bear the facsimile signatures of the Governor and
20 the State Treasurer, the bonds or notes shall also bear a manual signature
21 which may be that of a bond registrar, trustee, paying agent, or designated
22 assistant of the State Treasurer. Should any officer whose signature or
23 facsimile signature appears on bonds or notes cease to be such officer before
24 the delivery of the bonds or notes, the signature or facsimile signature shall
25 nevertheless have the same validity for all purposes as if the officer had
26 remained in office until delivery. Bonds or notes may bear the facsimile
27 signatures of persons, who at the actual time of the execution of the bonds or
28 notes shall be the proper officers to sign any bond or note, although at the date
29 of the bond or note such persons may not have been such officers. The form
30 and denomination of bonds or notes, including the provisions with respect to
31 registration of the bonds or notes and any system for their registration, shall
32 be as the State Treasurer may determine in conformity with this section.
- 33 (3) Manner of sale; expenses. – Subject to the approval by the Council of State as
34 to the manner in which bonds or notes shall be offered for sale, whether at
35 public or private sale, whether within or without the United States, and
36 whether by publishing notices in certain newspapers and financial journals,
37 mailing notices, inviting bids by correspondence, negotiating contracts of
38 purchase, or otherwise, the State Treasurer is authorized to sell bonds or notes
39 at one time or from time to time at any rates of interest, which may vary from
40 time to time, and at any prices, including a price less than or greater than the
41 face amount of the bonds or notes, as the State Treasurer may determine. All
42 expenses incurred in the preparation, sale, and issuance of bonds or notes shall
43 be paid by the State Treasurer from the proceeds of bonds or notes or other
44 available moneys.
- 45 (4) Notes; repayment. –
46 a. By and with the consent of the Council of State, the State Treasurer is
47 hereby authorized to borrow money and to execute and issue notes of
48 the State for the same, but only in the following circumstances and
49 under the following conditions:

- 1 1. For anticipating the sale of bonds, the issuance of which the
2 Council of State has approved, if the State Treasurer considers
3 it advisable to postpone the issuance of the bonds;
- 4 2. For the payment of interest on or any installment of principal
5 of any bonds then outstanding, if there are not sufficient funds
6 in the State treasury with which to pay the interest or
7 installment of principal as they respectively become due;
- 8 3. For the renewal of any loan evidenced by notes authorized in
9 this section;
- 10 4. For the purposes authorized in this section; and
- 11 5. For refunding bonds or notes as authorized in this section.
- 12 b. Funds derived from the sale of bonds or notes may be used in the
13 payment of any bond anticipation notes issued under this section.
14 Funds provided by the General Assembly for the payment of interest
15 on or principal of bonds shall be used in paying the interest on or
16 principal of any notes and any renewals thereof, the proceeds of which
17 shall have been used in paying interest on or principal of the bonds.
- 18 (5) Refunding bonds and notes. – By and with the consent of the Council of State,
19 the State Treasurer is authorized to issue and sell refunding bonds and notes
20 pursuant to the provisions of the State Refunding Bond Act for the purpose of
21 refunding bonds or notes issued pursuant to this section. The refunding bonds
22 and notes may be combined with any other issues of State bonds and notes
23 similarly secured. Refunding bonds or notes may be issued at any time prior
24 to the final maturity of the debt obligation to be refunded. The proceeds from
25 the sale of any refunding bonds or notes shall be applied to the immediate
26 payment and retirement of the bonds or notes being refunded or, if not required
27 for the immediate payment of the bonds or notes being refunded, the proceeds
28 shall be deposited in trust to provide for the payment and retirement of the
29 bonds or notes being refunded and to pay any expenses incurred in connection
30 with the refunding. Money in a trust fund may be invested in (i) direct
31 obligations of the United States government, (ii) obligations the principal of
32 and interest on which are guaranteed by the United States government, (iii)
33 obligations of any agency or instrumentality of the United States government
34 if the timely payment of principal and interest on the obligations is
35 unconditionally guaranteed by the United States government, or (iv)
36 certificates of deposit issued by a bank or trust company located in the State
37 if the certificates are secured by a pledge of any of the obligations described
38 in (i), (ii), or (iii) above having an aggregate market value, exclusive of
39 accrued interest, equal at least to the principal amount of the certificates so
40 secured. This section does not limit the duration of any deposit in trust for the
41 retirement of bonds or notes being refunded but that have not matured and are
42 not presently redeemable, or if presently redeemable, have not been called for
43 redemption.
- 44 (6) Tax exemption. – Bonds and notes shall at all times be free from taxation by
45 the State or any political subdivision or any of their agencies, excepting estate,
46 inheritance, or gift taxes, income taxes on the gain from the transfer of bonds
47 or notes, and franchise taxes. The interest on bonds or notes is not subject to
48 taxation as income.
- 49 (7) Investment eligibility. – Bonds and notes are securities in which all of the
50 following may invest, including capital in their control or belonging to them:
51 public officers, agencies, and public bodies of the State and its political

1 subdivisions, all insurance companies, trust companies, investment
2 companies, banks, savings banks, savings and loan associations, credit unions,
3 pension or retirement funds, other financial institutions engaged in business
4 in the State, executors, administrators, trustees, and other fiduciaries. Bonds
5 and notes are hereby made securities which may properly and legally be
6 deposited with and received by any officer or agency of the State or political
7 subdivision of the State for any purpose for which the deposit of bonds, notes,
8 or obligations of the State or any political subdivision is now or may hereafter
9 be authorized by law.

10 (8) Faith and credit. – The faith and credit and taxing power of the State are hereby
11 pledged for the payment of the principal of and the interest on bonds and notes.
12 The State expressly reserves the right to amend any provision of this section
13 to the extent it does not impair any contractual right of a bond owner.

14 (9) Other agreements. – The State Treasurer may authorize, execute, obtain, or
15 otherwise provide for bond insurance, investment contracts, credit and
16 liquidity facilities, interest-rate swap agreements and other derivative products,
17 and any other related instruments and matters the State Treasurer determines
18 are desirable in connection with issuance, incurrence, carrying, or securing of
19 bonds or notes. The State Treasurer is authorized to employ and designate any
20 financial consultants, underwriters, and bond attorneys to be associated with
21 any bond or note issue under this section as the State Treasurer considers
22 necessary.

23 **SECTION 39.8.(j)** Variable Rate Demand Bonds and Notes. – In fixing the details
24 of bonds and notes, the State Treasurer may provide that any of the bonds or notes may:

- 25 (1) Be made payable from time to time on demand or tender for purchase by the
26 owner, if a credit facility supports the bonds or notes, unless the State
27 Treasurer specifically determines that a credit facility is not required upon a
28 finding and determination by the State Treasurer that the absence of a credit
29 facility will not materially and adversely affect the financial position of the
30 State and the marketing of the bonds or notes at a reasonable interest cost to
31 the State;
- 32 (2) Be additionally supported by a credit facility;
- 33 (3) Be made subject to redemption or a mandatory tender for purchase prior to
34 maturity;
- 35 (4) Bear interest at a rate or rates that may vary for any period of time, as may be
36 provided in the proceedings providing for the issuance of the bonds or notes,
37 including, without limitation, such variations as may be permitted pursuant to
38 a par formula; and
- 39 (5) Be made the subject of a remarketing agreement whereby an attempt is made
40 to remarket bonds or notes to new purchasers prior to their presentment for
41 payment to the provider of the credit facility or to the State.

42 If the aggregate principal amount payable by the State under a credit facility is in
43 excess of the aggregate principal amount of bonds or notes secured by the credit facility, whether
44 as a result of the inclusion in the credit facility of a provision for the payment of interest for a
45 limited period of time or the payment of a redemption premium or for any other reason, then the
46 amount of authorized but unissued bonds or notes during the term of such credit facility shall not
47 be less than the amount of such excess, unless the payment of such excess is otherwise provided
48 for by agreement of the State executed by the State Treasurer.

49 **SECTION 39.8.(k)** Interpretation of Section. –

- 50 (1) Additional method. – The foregoing subsections of this section shall be
51 deemed to provide an additional and alternative method for the doing of the

things authorized under it and shall be regarded as supplemental and additional to powers conferred by other laws and shall not be regarded as in derogation of any powers now existing.

- (2) Statutory references. – References in this section to specific sections or Chapters of the General Statutes or to specific acts are intended to be references to such sections, Chapters, or acts as they may be amended from time to time by the General Assembly.
- (3) Broad construction. – This section, being necessary for the health and welfare of the people of the State, shall be broadly construed to effect the purposes thereof.
- (4) Inconsistent provisions. – Insofar as the provisions of this section are inconsistent with the provisions of any general, special, or local laws, or parts thereof, the provisions of this section shall be controlling.
- (5) Severability. – If any provision of this section or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the section which can be given effect without the invalid provision or application, and to this end the provisions of this section are declared to be severable.

SECTION 39.8.(I) This section is effective when it becomes law.

WAKE COUNTY STATE VETERANS HOME

SECTION 39.9. Section 36.7.(d) of S.L. 2018-5, as amended by S.L. 2018-97, reads as rewritten:

"**SECTION 36.7.(d)** The General Assembly authorizes the Department of Military and Veterans Affairs to fund the construction of ~~two~~ a new State veterans home located in the Triangle ~~and Triad Regions~~ Region with funds available to it from the North Carolina Veterans Home Trust Fund established under G.S. 143B-1293 in an amount not to exceed ~~twenty-seven million two hundred twenty-three thousand five hundred sixty dollars (\$27,223,560).~~ twenty-nine million nine hundred ninety-five thousand dollars (\$29,995,000). The funds shall be used to provide the required State match for federal funding of the veterans home construction projects, and the matching funds and any federal dollars received for that purpose are hereby appropriated."

SECTION 40.1.(a) Subsections (b) and (c) of Section 4.1 of S.L. 2020-91 are repealed.

SECTION 40.1.(b) The General Assembly authorizes and certifies anticipated revenues for the Highway Fund as follows:

- 2 For Fiscal Year 2024-2025 \$ 2,692 million
- 3 For Fiscal Year 2025-2026 \$ 2,769 million
- 4 For Fiscal Year 2026-2027 \$ 2,832 million

5 **SECTION 40.1.(c)** The General Assembly authorizes and certifies anticipated
 6 revenues for the Highway Trust Fund as follows:

- 7 For Fiscal Year 2023-2024 \$ 1,674 million
- 8 For Fiscal Year 2024-2025 \$ 1,744 million
- 9 For Fiscal Year 2025-2026 \$ 1,796 million

11 **SECTION 40.1.(d)** The Department of Transportation, in collaboration with the
 12 Office of State Budget and Management, shall develop a four-year revenue forecast. The first

 14 revenue forecast developed under this subsection shall be used (i) to develop the four-year cash

 42 **BUILD NC AMENDMENTS**

43 **SECTION 40.3.(a)** Notwithstanding G.S. 142-97(2)(a), for the 2021-2023 fiscal
 44 biennium, the State Treasurer may issue Build NC Bonds without regard to any limitations on
 45 the Department of Transportation's average month-end cash balance for the first three months
 46 in the calendar year prior to the date of determination.

47 **SECTION 40.3.(b)** Notwithstanding G.S. 142-97(4), for the 2021-2023 fiscal
 48 biennium, individual issuance of Build NC Bonds may exceed three hundred million dollars
 49 (\$300,000,000) in each fiscal year of the 2021-2023 fiscal biennium.

 51 **EMERGENCY RESERVE CHANGES**

1 **SECTION 40.4.(a)** G.S. 136-44.2E reads as rewritten:

2 "**§ 136-44.2E. Transportation Emergency Reserve.**

3 (a) Creation. – The Transportation Emergency Reserve (Emergency Reserve) is
4 established as a special fund in the Highway Fund of the Department of Transportation.

5 (b) Funding; Use of Funds. – Subject to subsection (d) of this section, no later than July
6 30 of each fiscal year, the Department of Transportation shall transfer from the Highway Fund
7 to the Emergency Reserve the sum of one hundred twenty-five million dollars (\$125,000,000),
8 and these funds are hereby appropriated for expenses related to an emergency. For purposes of
9 this section, the term "emergency" has the same meaning as in G.S. 166A-19.3.

10 (c) Access to Funds. – The Department may only use funds in the Emergency Reserve
11 after the President of the United States issues a declaration under the Stafford Act (42 U.S.C. §§
12 5121 – 5207) that a major disaster exists in the State or the Governor makes a declaration or a
13 disaster exists under Title 23, USC, Section 125. The Secretary of Transportation shall ensure all
14 funds in the Emergency Reserve are accessed and used pursuant to this section, and in a manner
15 that ensures to the extent practicable that the funds are eligible for federal reimbursement or cost
16 sharing with the federal funds."

17 **SECTION 40.4.(b)** Of the thirty million (\$30,000,000) appropriated in S.L 2019-251
18 for Hurricane Dorian expenses, any funds unexpended after expenses are paid shall be transferred
19 to the Transportation Emergency Reserve within the Highway Fund created by GS 136-44.2E.

20 **BIENNIAL TO QUARTERLY POWELL BILL PAYMENTS**

21 **SECTION 40.5** G.S. 136-41.1(a) reads as rewritten:

35 **ALLOW EARNED INCOME TAX CREDIT**

36 **SECTION 41.1.(a)** G.S. 105-151.31 is reenacted as it existed immediately before its
37 expiration and reads as rewritten:

38 "**§ 105-151.31. Earned income tax credit.**

39 (a) **Credit.** – An individual who claims for the taxable year an earned income tax credit
40 under section 32 of the Code is allowed a credit against the tax imposed by this Part equal to a
41 ~~percentage~~ five percent (5%) of the amount of credit the individual qualified for under section
42 32 of the Code. A nonresident or part-year resident who claims the credit allowed by this section
43 must reduce the amount of the credit by multiplying it by the fraction calculated under
44 G.S. 105-134.5(b) or (c), as appropriate. ~~The percentage is as follows:~~

45 (1) ~~For taxable year 2013, four and one-half percent (4.5%).~~

46 (2) ~~For all other taxable years, five percent (5%).~~

(b) Credit Refundable. – If the credit allowed by this section exceeds the amount of tax imposed by this Part for the taxable year reduced by the sum of all credits allowable, the Secretary must refund the excess to the taxpayer. The refundable excess is governed by the provisions governing a refund of an overpayment by the taxpayer of the tax imposed in this Part. Section 3507 of the Code, Advance Payment of Earned Income Credit, does not apply to the credit allowed by this section. In computing the amount of tax against which multiple credits are allowed, nonrefundable credits are subtracted before refundable credits.

(c) ~~Sunset.~~—~~This section is repealed effective for taxable years beginning on or after 23 January 1, 2014."~~

SECTION 41.1.(b) Effective Date. – This act is effective for taxable years beginning on or after January 1, 2021.

ALLOW CREDIT FOR CHILD AND DEPENDENT CARE EXPENSES

SECTION 41.2.(a) Article 4 of Chapter 105 of the General Statutes is amended by adding a new section to read:

"§ 105-151.34. Credit for qualified child and dependent care expenses.

(a) Credit. – A person who is allowed a credit against federal income tax for a percentage of employment-related expenses under section 21 of the Code shall be allowed as a credit against the tax imposed by this Part an amount equal to one hundred percent (100%) of the amount of the credit provided for in Section 21 of the Code which is claimed and allowed pursuant to the Internal Revenue Code. To claim the credit allowed by this section, the taxpayer must provide with the tax return the information required by the Secretary of Revenue.

(b) Phaseout. – The credit allowed by this section shall be reduced by a percentage listed below, rounded to the nearest percentage point, based on the taxpayer's adjusted gross income as calculated under the Code:

<u>Filing Status</u>	<u>For AGI Exceeding</u>	<u>Percentage Reduction</u>
<u>Married, filing jointly</u>	<u>\$75,000</u>	<u>The lesser of 100% or [(Taxpayer's AGI – \$75,000)/\$125,000]</u>
<u>Head of Household</u>	<u>\$56,250</u>	<u>The lesser of 100% or [(Taxpayer's AGI – \$56,250)/\$93,750]</u>
<u>Single</u>	<u>\$37,500</u>	<u>The lesser of 100% or [(Taxpayer's AGI – \$37,500)/\$62,500]</u>

(d) Limitations. – A nonresident or part-year resident who claims the credit allowed by this section shall reduce the amount of the credit by multiplying it by the fraction calculated under G.S. 105-153.4(b) or (c), as appropriate. The credit allowed by this section may not exceed the amount of tax imposed by this Part for the taxable year reduced by the sum of all credits allowable, except for payments of tax made by or on behalf of the taxpayer."

SECTION 41.2.(b) Subsection (a) of this section becomes effective for taxable years beginning on or after January 1, 2021.

PART XLII. MISCELLANEOUS

STATE BUDGET ACT APPLIES

SECTION 42.1. The provisions of the State Budget Act, Chapter 143C of the General Statutes, are reenacted and shall remain in full force and effect and are incorporated in this act by reference.

COMMITTEE REPORT

1 **SECTION 42.2.(a)** The Joint Conference Committee Report on the Current
2 Operations Appropriations Act of 2021, dated June 30, 2021, which was distributed in the House
3 of Representatives and the Senate and used to explain this act, shall indicate action by the General
4 Assembly on this act and shall, therefore, be used to construe this act, as provided in the State
5 Budget Act, Chapter 143C of the General Statutes, and for these purposes shall be considered a
6 part of this act and, as such, shall be printed as a part of the Session Laws.

7 **SECTION 42.2.(b)** The budget enacted by the General Assembly is for the
8 maintenance of the various departments, institutions, and other spending agencies of the State
9 for the 2021-2023 biennial budget as provided in G.S. 143C35. This budget includes the
10 appropriations of State funds as defined in G.S. 143C11(d)(25).

11 The Director of the Budget submitted a recommended base budget to the General
12 Assembly in the Governor's Recommended Budget for the 2021-2023 fiscal biennium, dated
13 March 2021, and in the Budget Support Document for the various departments, institutions, and
14 other spending agencies of the State. The adjustments to the recommended base budget made by
15 the General Assembly are set out in the Committee Report.

16 **SECTION 42.2.(c)** The budget enacted by the General Assembly shall also be
17 interpreted in accordance with G.S. 143C-5-5, the special provisions in this act, and other
18 appropriate legislation. In the event that there is a conflict between the line item budget certified
19 by the Director of the Budget and the budget enacted by the General Assembly, the budget
20 enacted by the General Assembly shall prevail.

21 **SECTION 42.2.(d)** Notwithstanding subsection (a) of this section, the following
22 portions of the Committee Report are for reference, and do not expand, limit, or define the text
23 of the Committee Report:

- 24 (1) Summary pages setting forth the enacted budget, the legislative changes, the
25 revised budget, and the related FTE information for a particular budget code
26 and containing no other substantive information.
- 27 (2) Summary pages setting forth the enacted budget, the legislative changes, the
28 revised budget, and the related FTE information for multiple fund codes
29 within a single budget code and containing no other substantive information.

30 31 **REPORT BY FISCAL RESEARCH DIVISION**

32 **SECTION 42.3.** The Fiscal Research Division shall issue a report on budget actions
33 taken by the 2021 Regular Session of the General Assembly. The report shall be in the form of a
34 revision of the Committee Report described in Section 42.2 of this act pursuant to G.S. 143C-5-5.
35 The Director of the Fiscal Research Division shall send a copy of the report issued pursuant to
36 this section to the Director of the Budget. The report shall be published on the General
37 Assembly's Internet Web site for public access.

38 39 **MOST TEXT APPLIES ONLY TO THE 2021-2023 FISCAL BIENNIUM**

40 **SECTION 42.4.** Except for statutory changes or other provisions that clearly indicate
41 an intention to have effects beyond the 2021-2023 fiscal biennium, the textual provisions of this
42 act apply only to funds appropriated for, and activities occurring during, the 2021-2023 fiscal
43 biennium.

44 45 **EFFECT OF HEADINGS**

46 **SECTION 42.5.** The headings to the Parts, subparts, and sections of this act are a
47 convenience to the reader and are for reference only. The headings do not expand, limit, or define
48 the text of this act, except for effective dates referring to a Part or subpart.

49 50 **SEVERABILITY CLAUSE**

1 **SECTION 42.6.** If any section or provision of this act is declared unconstitutional
2 or invalid by the courts, it does not affect the validity of this act as a whole or any part other than
3 the part so declared to be unconstitutional or invalid.

6 **SECTION 42.7.** Except as otherwise provided, this act becomes effective July 1,
