1 A BILL TO BE ENTITLED
2 AN ACT TO STUDY PUBLIC INVOLVEMENT AND OUTREACH IN TRANSPORTATION
3 PLANNING AND TRANSPARENCY, ORGANIZATION, AND OVERSIGHT OF
4 METROPOLITAN PLANNING ORGANIZATIONS.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.(a)** The Study Committee on Metropolitan Planning Organizations is
7 created. The Committee shall consist of 10 members as follows: (i) five members of the House
8 of Representatives appointed by the Speaker of the House of Representatives, at least two of
9 whom are members of the minority party, and (ii) five members of the Senate appointed by the
10 President Pro Tempore of the Senate, at least two of whom are members of the minority party.
11 The Speaker of the House of Representatives and the President Pro Tempore of the Senate shall
12 each designate one member as a cochair. Vacancies of the Committee shall be filled within 30
13 days by the same appointing authority that made the initial appointment, and resignation or
14 removal from service in the General Assembly constitutes resignation or removal from service
15 on the Committee. The Committee shall meet upon the joint call of the cochairs. A majority shall
16 constitute a quorum of the Committee, and no official action may be taken except by a majority
17 vote at a meeting at which a quorum is present.

18 **SECTION 1.(b)** The Committee shall study the following:

- 19 (1) Public involvement and outreach in transportation planning by metropolitan
20 planning organization.
21 (2) Transparency, organization, and oversight of metropolitan planning
22 organizations.
23 (3) The role public involvement and outreach and transparency, organization, and
24 oversight play in transportation planning by metropolitan planning
25 organizations.
26 (4) The way current methods of public involvement and outreach in transportation
27 planning and transparency, organization, and oversight might be revised to
28 better provide for public involvement, participation, and consultation in
29 transportation planning by metropolitan planning organizations while
30 maintaining compliance with federal transportation requirements.

31 **SECTION 1.(c)** The Committee, while in the discharge of its official duties, may
32 exercise all powers provided for under G.S. 120-19 and G.S. 120-19.1 through G.S. 120-19.4.
33 The Committee may meet in the Legislative Building or the Legislative Office Building.
34 Members of the Committee shall receive subsistence and travel expenses at the rates set forth in
35 G.S. 120-3.1.



1 The Legislative Services Commission, through the Legislative Services Officer, shall
2 assign professional staff to assist the Committee in its work. The House of Representatives' and
3 the Senate's Director of Legislative Assistants shall assign clerical staff to the Committee, and
4 the expenses relating to the clerical employees shall be borne by the Committee. The Committee
5 may contract for professional, clerical, or consultant services, as provided by G.S. 120-32.02.

6 **SECTION 1.(d)** The Committee shall report its findings and recommendations,
7 including any recommended legislation, to the Speaker of the House of Representatives and
8 President Pro Tempore of the Senate no later than two years after the effective date of this act.
9 The Committee shall terminate upon filing its report or two years after the effective date of this
10 act, whichever is earlier.

11 **SECTION 2.** This act is effective when it becomes law.
