**SECTION 1.** Article 21 of Chapter 115C of the General Statutes is amended by adding a new section to read:

## "§ 115C-316.5. Appropriation for social workers and school psychologists.

(a) Beginning with the 2021-2022 fiscal year, there is appropriated from the General Fund to the Department of Public Instruction for the following fiscal years the following amounts to the instructional support allotment:

- (b) When developing the base budget, as defined by G.S. 143C-1-1, for each fiscal year specified in subsection (a) of this section, the Director of the Budget shall include the appropriated amount for that fiscal year.
- (c) Funds appropriated pursuant to subsection (a) of this section shall be allocated to local school administrative units to increase positions for school social workers and school psychologists in the following fiscal years to the following statewide ratios of personnel to students:
