SENATE BILL DRS45353-ML-107

Short Title: The Fair Sentencing Act.

(Public)

Sponsors: Senators Smith and Murdock (Primary Sponsors).

Referred to:

A BILL TO BE ENTITLED
AN ACT TO REMOVE THE MANDATORY MINIMUM SENTENCES REQUIRED FOR
CERTAIN CRIMINAL OFFENSES.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 14-7.41(a) reads as rewritten:

"(a) A person who is convicted of a firearm-related felony and is also convicted of the status offense must, upon conviction or plea of guilty under indictment as provided in this Article, be sentenced as a Class C felon (except where the felon has been sentenced as a Class A, B1, or B2 felon). ~~However, in no case shall the person receive a minimum term of imprisonment of less than 120 months.~~ The court may not suspend the sentence and may not place the person sentenced on probation."

SECTION 2. G.S. 20-179 reads as rewritten:

"§ 20-179. Sentencing hearing after conviction for impaired driving; determination of grossly aggravating and aggravating and mitigating factors; punishments.

...

(f3) Aggravated Level One Punishment. – A defendant subject to Aggravated Level One punishment may be fined up to ten thousand dollars (\$10,000) and shall be sentenced to a term of imprisonment that includes ~~a minimum term of not less than 12 months~~ and a maximum term of not more than 36 months. Notwithstanding G.S. 15A-1371, a defendant sentenced to a term of imprisonment pursuant to this subsection shall not be eligible for parole. However, the defendant shall be released from the Statewide Misdemeanant Confinement Program on the date equivalent to the defendant's maximum imposed term of imprisonment less four months and shall be supervised by the Division of Community Supervision and Reentry under and subject to the provisions of Article 84A of Chapter 15A of the General Statutes and shall also be required to abstain from alcohol consumption for the four-month period of supervision as verified by a continuous alcohol monitoring system. For purposes of revocation, violation of the requirement to abstain from alcohol or comply with the use of a continuous alcohol monitoring system shall be deemed a controlling condition under G.S. 15A-1368.4.

The term of imprisonment may be suspended only if a condition of special probation is imposed to require the defendant to serve a term of imprisonment of at least 120 days. If the defendant is placed on probation, the judge shall impose as requirements that the defendant (i) abstain from alcohol consumption for a minimum of 120 days to a maximum of the term of probation, as verified by a continuous alcohol monitoring system pursuant to subsection (h1) of this section, and (ii) obtain a substance abuse assessment and the education or treatment required by G.S. 20-17.6 for the restoration of a drivers license and as a condition of probation. The judge may impose any other lawful condition of probation.



(g) Level One Punishment. – A defendant subject to Level One punishment may be fined up to four thousand dollars (\$4,000) and shall be sentenced to a term of imprisonment that includes ~~a minimum term of not less than 30 days and~~ a maximum term of not more than 24 months. The term of imprisonment may be suspended only if a condition of special probation is imposed to require the defendant to serve a term of imprisonment of at least 30 days. A judge may reduce ~~the minimum term of imprisonment required to a term of not less than 10 days if~~ a condition of special probation is imposed to require that a defendant abstain from alcohol consumption and be monitored by a continuous alcohol monitoring system, of a type approved by the Division of Community Supervision and Reentry of the Department of Adult Correction, for a period of not less than 120 days. If the defendant is monitored on an approved continuous alcohol monitoring system during the pretrial period, up to 60 days of pretrial monitoring may be credited against the 120-day monitoring requirement for probation. If the defendant is placed on probation, the judge shall impose a requirement that the defendant obtain a substance abuse assessment and the education or treatment required by G.S. 20-17.6 for the restoration of a drivers license and as a condition of probation. The judge may impose any other lawful condition of probation.

(h) Level Two Punishment. – A defendant subject to Level Two punishment may be fined up to two thousand dollars (\$2,000) and shall be sentenced to a term of imprisonment that includes ~~a minimum term of not less than seven days and~~ a maximum term of not more than 12 months. The term of imprisonment may be suspended only if a condition of special probation is imposed to require the defendant to serve a term of imprisonment of at least seven days or to abstain from consuming alcohol for at least 90 consecutive days, as verified by a continuous alcohol monitoring system, of a type approved by the Division of Community Supervision and Reentry of the Department of Adult Correction. If the defendant is subject to Level Two punishment based on a finding that the grossly aggravating factor in subdivision (1) or (2) of subsection (c) of this section applies, the conviction for a prior offense involving impaired driving occurred within five years before the date of the offense for which the defendant is being sentenced and the judge suspends all active terms of imprisonment and imposes abstention from alcohol as verified by a continuous alcohol monitoring system, then the judge must also impose as an additional condition of special probation that the defendant must complete 240 hours of community service. If the defendant is monitored on an approved continuous alcohol monitoring system during the pretrial period, up to 60 days of pretrial monitoring may be credited against the 90-day monitoring requirement for probation. If the defendant is placed on probation, the judge shall impose a requirement that the defendant obtain a substance abuse assessment and the education or treatment required by G.S. 20-17.6 for the restoration of a drivers license and as a condition of probation. The judge may impose any other lawful condition of probation.

...

(i) Level Three Punishment. – A defendant subject to Level Three punishment may be fined up to one thousand dollars (\$1,000) and shall be sentenced to a term of imprisonment that includes ~~a minimum term of not less than 72 hours and~~ a maximum term of not more than six months. The term of imprisonment may be suspended. However, the suspended sentence shall include the condition that the defendant:

- (1) Be imprisoned for a term of at least 72 hours as a condition of special probation; or
- (2) Perform community service for a term of at least 72 hours; or
- (3) Repealed by Session Laws 2006-253, s. 23, effective December 1, 2006, and applicable to offenses committed on or after that date.
- (4) Any combination of these conditions.

If the defendant is placed on probation, the judge shall impose a requirement that the defendant obtain a substance abuse assessment and the education or treatment required by

1 G.S. 20-17.6 for the restoration of a drivers license and as a condition of probation. The judge
2 may impose any other lawful condition of probation.

3 (j) Level Four Punishment. – A defendant subject to Level Four punishment may be
4 fined up to five hundred dollars (\$500.00) and shall be sentenced to a term of imprisonment that
5 includes ~~a minimum term of not less than 48 hours and~~ a maximum term of not more than 120
6 days. The term of imprisonment may be suspended. However, the suspended sentence shall
7 include the condition that the defendant:

8 (1) Be imprisoned for a term of 48 hours as a condition of special probation; or

9 (2) Perform community service for a term of 48 hours; or

10 (3) Repealed by Session Laws 2006-253, s. 23, effective December 1, 2006, and
11 applicable to offenses committed on or after that date.

12 (4) Any combination of these conditions.

13 If the defendant is placed on probation, the judge shall impose a requirement that the
14 defendant obtain a substance abuse assessment and the education or treatment required by
15 G.S. 20-17.6 for the restoration of a drivers license and as a condition of probation. The judge
16 may impose any other lawful condition of probation.

17 (k) Level Five Punishment. – A defendant subject to Level Five punishment may be fined
18 up to two hundred dollars (\$200.00) and shall be sentenced to a term of imprisonment that
19 includes ~~a minimum term of not less than 24 hours and~~ a maximum term of not more than 60
20 days. The term of imprisonment may be suspended. However, the suspended sentence shall
21 include the condition that the defendant:

22 (1) Be imprisoned for a term of 24 hours as a condition of special probation; or

23 (2) Perform community service for a term of 24 hours; or

24 (3) Repealed by Session Laws 2006-253, s. 23, effective December 1, 2006, and
25 applicable to offenses committed on or after that date.

26 (4) Any combination of these conditions.

27 If the defendant is placed on probation, the judge shall impose a requirement that the
28 defendant obtain a substance abuse assessment and the education or treatment required by
29 G.S. 20-17.6 for the restoration of a drivers license and as a condition of probation. The judge
30 may impose any other lawful condition of probation.

32 **SECTION 3.** G.S. 90-95(h) reads as rewritten:

33 "(h) Notwithstanding any other provision of law, the following provisions apply except as
34 otherwise provided in this Article:

35 (1) Any person who sells, manufactures, delivers, transports, or possesses in
36 excess of 10 pounds (avoirdupois) of marijuana shall be guilty of a felony
37 which felony shall be known as "trafficking in marijuana" and if the quantity
38 of such substance involved:

39 a. Is in excess of 10 pounds, but less than 50 pounds, such person shall
40 be punished as a Class H felon and shall be sentenced to a ~~minimum~~
41 ~~term of 25 months and~~ a maximum term of 39 months in the State's
42 prison and shall be fined not less than five thousand dollars (\$5,000);

43 b. Is 50 pounds or more, but less than 2,000 pounds, such person shall be
44 punished as a Class G felon and shall be sentenced to a ~~minimum term~~
45 ~~of 35 months and~~ a maximum term of 51 months in the State's prison
46 and shall be fined not less than twenty-five thousand dollars (\$25,000);

47 c. Is 2,000 pounds or more, but less than 10,000 pounds, such person
48 shall be punished as a Class F felon and shall be sentenced to a
49 ~~minimum term of 70 months and~~ a maximum term of 93 months in the
50 State's prison and shall be fined not less than fifty thousand dollars
51 (\$50,000);

- d. Is 10,000 pounds or more, such person shall be punished as a Class D felon and shall be sentenced to a ~~minimum term of 175 months and a~~ maximum term of 222 months in the State's prison and shall be fined not less than two hundred thousand dollars (\$200,000).
- (1a) For the purpose of this subsection, a "dosage unit" shall consist of 3 grams of synthetic cannabinoid or any mixture containing such substance. Any person who sells, manufactures, delivers, transports, or possesses in excess of 50 dosage units of a synthetic cannabinoid or any mixture containing such substance, shall be guilty of a felony, which felony shall be known as "trafficking in synthetic cannabinoids," and if the quantity of such substance involved:
- a. Is in excess of 50 dosage units, but less than 250 dosage units, such person shall be punished as a Class H felon and shall be sentenced to a ~~minimum term of 25 months and a~~ maximum term of 39 months in the State's prison and shall be fined not less than five thousand dollars (\$5,000);
- b. Is 250 dosage units or more, but less than 1250 dosage units, such person shall be punished as a Class G felon and shall be sentenced to a ~~minimum term of 35 months and a~~ maximum term of 51 months in the State's prison and shall be fined not less than twenty-five thousand dollars (\$25,000);
- c. Is 1250 dosage units or more, but less than 3750 dosage units, such person shall be punished as a Class F felon and shall be sentenced to a ~~minimum term of 70 months and a~~ maximum term of 93 months in the State's prison and shall be fined not less than fifty thousand dollars (\$50,000);
- d. Is 3750 dosage units or more, such person shall be punished as a Class D felon and shall be sentenced to a ~~minimum term of 175 months and a~~ maximum term of 222 months in the State's prison and shall be fined not less than two hundred thousand dollars (\$200,000).
- (2) Any person who sells, manufactures, delivers, transports, or possesses 1,000 tablets, capsules or other dosage units, or the equivalent quantity, or more of methaqualone, or any mixture containing such substance, shall be guilty of a felony which felony shall be known as "trafficking in methaqualone" and if the quantity of such substance or mixture involved:
- a. Is 1,000 or more dosage units, or equivalent quantity, but less than 5,000 dosage units, or equivalent quantity, such person shall be punished as a Class G felon and shall be sentenced to a ~~minimum term of 35 months and a~~ maximum term of 51 months in the State's prison and shall be fined not less than twenty-five thousand dollars (\$25,000);
- b. Is 5,000 or more dosage units, or equivalent quantity, but less than 10,000 dosage units, or equivalent quantity, such person shall be punished as a Class F felon and shall be sentenced to a ~~minimum term of 70 months and a~~ maximum term of 93 months in the State's prison and shall be fined not less than fifty thousand dollars (\$50,000);
- c. Is 10,000 or more dosage units, or equivalent quantity, such person shall be punished as a Class D felon and shall be sentenced to a ~~minimum term of 175 months and a~~ maximum term of 222 months in the State's prison and shall be fined not less than two hundred thousand dollars (\$200,000).

(3) Any person who sells, manufactures, delivers, transports, or possesses 28 grams or more of cocaine and any salt, isomer (whether optical or geometric), salts of isomers, compound, derivative, or preparation thereof, or any coca leaves and any salt, isomer, salts of isomers, compound, derivative, or preparation of coca leaves, and any salt, isomer, salts of isomers, compound, derivative or preparation thereof which is chemically equivalent or identical with any of these substances (except decocainized coca leaves or any extraction of coca leaves which does not contain cocaine) or any mixture containing such substances, shall be guilty of a felony, which felony shall be known as "trafficking in cocaine" and if the quantity of such substance or mixture involved:

- a. Is 28 grams or more, but less than 200 grams, such person shall be punished as a Class G felon and shall be sentenced to a ~~minimum term of 35 months and a~~ maximum term of 51 months in the State's prison and shall be fined not less than fifty thousand dollars (\$50,000);
- b. Is 200 grams or more, but less than 400 grams, such person shall be punished as a Class F felon and shall be sentenced to a ~~minimum term of 70 months and a~~ maximum term of 93 months in the State's prison and shall be fined not less than one hundred thousand dollars (\$100,000);
- c. Is 400 grams or more, such person shall be punished as a Class D felon and shall be sentenced to a ~~minimum term of 175 months and a~~ maximum term of 222 months in the State's prison and shall be fined at least two hundred fifty thousand dollars (\$250,000).

(3a) Repealed by Session Laws 1999-370, s. 1, effective December 1, 1999.

(3b) Any person who sells, manufactures, delivers, transports, or possesses 28 grams or more of methamphetamine or any mixture containing such substance shall be guilty of a felony which felony shall be known as "trafficking in methamphetamine" and if the quantity of such substance or mixture involved:

- a. Is 28 grams or more, but less than 200 grams, such person shall be punished as a Class F felon and shall be sentenced to a ~~minimum term of 70 months and a~~ maximum term of 93 months in the State's prison and shall be fined not less than fifty thousand dollars (\$50,000);
- b. Is 200 grams or more, but less than 400 grams, such person shall be punished as a Class E felon and shall be sentenced to a ~~minimum term of 90 months and a~~ maximum term of 120 months in the State's prison and shall be fined not less than one hundred thousand dollars (\$100,000);
- c. Is 400 grams or more, such person shall be punished as a Class C felon and shall be sentenced to a ~~minimum term of 225 months and a~~ maximum term of 282 months in the State's prison and shall be fined at least two hundred fifty thousand dollars (\$250,000).

(3c) Any person who sells, manufactures, delivers, transports, or possesses 28 grams or more of amphetamine or any mixture containing such substance shall be guilty of a felony, which felony shall be known as "trafficking in amphetamine", and if the quantity of such substance or mixture involved:

- a. Is 28 grams or more, but less than 200 grams, such person shall be punished as a Class H felon and shall be sentenced to a ~~minimum term of 25 months and a~~ maximum term of 39 months in the State's prison and shall be fined not less than five thousand dollars (\$5,000);

- b. Is 200 grams or more, but less than 400 grams, such person shall be punished as a Class G felon and shall be sentenced to a ~~minimum term of 35 months and a maximum term of 51 months~~ in the State's prison and shall be fined not less than twenty-five thousand dollars (\$25,000);
- c. Is 400 grams or more, such person shall be punished as a Class E felon and shall be sentenced to a ~~minimum term of 90 months and a maximum term of 120 months~~ in the State's prison and shall be fined at least one hundred thousand dollars (\$100,000).
- (3d) Any person who sells, manufactures, delivers, transports, or possesses 28 grams or more of any substituted cathinone, as defined in G.S. 90-89(5)(j), or any mixture containing such substance shall be guilty of a felony, which felony shall be known as "trafficking in substituted cathinones," and if the quantity of such substance or mixture involved:
- a. Is 28 grams or more, but less than 200 grams, such person shall be punished as a Class F felon and shall be sentenced to a ~~minimum term of 70 months and a maximum term of 93 months~~ in the State's prison and shall be fined not less than fifty thousand dollars (\$50,000);
- b. Is 200 grams or more, but less than 400 grams, such person shall be punished as a Class E felon and shall be sentenced to a ~~minimum term of 90 months and a maximum term of 120 months~~ in the State's prison and shall be fined not less than one hundred thousand dollars (\$100,000);
- c. Is 400 grams or more, such person shall be punished as a Class C felon and shall be sentenced to a ~~minimum term of 225 months and a maximum term of 282 months~~ in the State's prison and shall be fined at least two hundred fifty thousand dollars (\$250,000).

- (4) Any person who sells, manufactures, delivers, transports, or possesses four grams or more of opium, opiate, or opioid, or any salt, compound, derivative, or preparation of opium, opiate, or opioid (except apomorphine, nalbuphine, analoxone and naltrexone and their respective salts), including heroin, or any mixture containing such substance, shall be guilty of a felony which felony shall be known as "trafficking in opium, opiate, opioid, or heroin" and if the quantity of such controlled substance or mixture involved:
- a. Is four grams or more, but less than 14 grams, such person shall be punished as a Class F felon and shall be sentenced to a ~~minimum term of 70 months and a maximum term of 93 months~~ in the State's prison and shall be fined as follows:
1. A fine of five hundred thousand dollars (\$500,000) if the controlled substance is heroin, fentanyl, or carfentanil, or any salt, compound, derivative, or preparation thereof, or any mixture containing any of these substances.
 2. A fine of not less than fifty thousand dollars (\$50,000) for any controlled substance described in this subdivision and not otherwise subject to sub-sub-subdivision 1. of this sub-subdivision.
- b. Is 14 grams or more, but less than 28 grams, such person shall be punished as a Class E felon and shall be sentenced to a ~~minimum term of 90 months and a maximum term of 120 months~~ in the State's prison and shall be fined as follows:

1. A fine of seven hundred fifty thousand dollars (\$750,000) if the controlled substance is heroin, fentanyl, or carfentanil, or any salt, compound, derivative, or preparation thereof, or any mixture containing any of these substances.
 2. A fine of not less than one hundred thousand dollars (\$100,000) for any controlled substance described in this subdivision and not otherwise subject to sub-sub-subdivision 1. of this sub-subdivision.
- c. Is 28 grams or more, such person shall be punished as a Class C felon and shall be sentenced to a ~~minimum term of 225 months and a~~ maximum term of 282 months in the State's prison and shall be fined as follows:
1. A fine of one million dollars (\$1,000,000) if the controlled substance is heroin, fentanyl, or carfentanil, or any salt, compound, derivative, or preparation thereof, or any mixture containing any of these substances.
 2. A fine of not less than five hundred thousand dollars (\$500,000) for any controlled substance described in this subdivision and not otherwise subject to sub-sub-subdivision 1. of this sub-subdivision.
- (4a) Any person who sells, manufactures, delivers, transports, or possesses 100 tablets, capsules, or other dosage units, or the equivalent quantity, or more, of Lysergic Acid Diethylamide, or any mixture containing such substance, shall be guilty of a felony, which felony shall be known as "trafficking in Lysergic Acid Diethylamide". If the quantity of such substance or mixture involved:
- a. Is 100 or more dosage units, or equivalent quantity, but less than 500 dosage units, or equivalent quantity, such person shall be punished as a Class G felon and shall be sentenced to a ~~minimum term of 35 months and a~~ maximum term of 51 months in the State's prison and shall be fined not less than twenty-five thousand dollars (\$25,000);
 - b. Is 500 or more dosage units, or equivalent quantity, but less than 1,000 dosage units, or equivalent quantity, such person shall be punished as a Class F felon and shall be sentenced to a ~~minimum term of 70 months and a~~ maximum term of 93 months in the State's prison and shall be fined not less than fifty thousand dollars (\$50,000);
 - c. Is 1,000 or more dosage units, or equivalent quantity, such person shall be punished as a Class D felon and shall be sentenced to a ~~minimum term of 175 months and a~~ maximum term of 222 months in the State's prison and shall be fined not less than two hundred thousand dollars (\$200,000).
- (4b) Any person who sells, manufactures, delivers, transports, or possesses 100 or more tablets, capsules, or other dosage units, or 28 grams or more of 3,4-methylenedioxymphetamine (MDA), including its salts, isomers, and salts of isomers, or 3,4-methylenedioxymphetamine (MDMA), including its salts, isomers, and salts of isomers, or any mixture containing such substances, shall be guilty of a felony, which felony shall be known as "trafficking in MDA/MDMA." If the quantity of the substance or mixture involved:
- a. Is 100 or more tablets, capsules, or other dosage units, but less than 500 tablets, capsules, or other dosage units, or 28 grams or more, but less than 200 grams, the person shall be punished as a Class G felon

- 1 and shall be sentenced to a ~~minimum term of 35 months and a~~
2 maximum term of 51 months in the State's prison and shall be fined
3 not less than twenty-five thousand dollars (\$25,000);
- 4 b. Is 500 or more tablets, capsules, or other dosage units, but less than
5 1,000 tablets, capsules, or other dosage units, or 200 grams or more,
6 but less than 400 grams, the person shall be punished as a Class F felon
7 and shall be sentenced to a ~~minimum term of 70 months and a~~
8 maximum term of 93 months in the State's prison and shall be fined
9 not less than fifty thousand dollars (\$50,000);
- 10 c. Is 1,000 or more tablets, capsules, or other dosage units, or 400 grams
11 or more, the person shall be punished as a Class D felon and shall be
12 sentenced to a ~~minimum term of 175 months and a~~ maximum term of
13 222 months in the State's prison and shall be fined not less than two
14 hundred fifty thousand dollars (\$250,000).
- 15 (5) Except as provided in this subdivision or subdivision (5a) of this subsection,
16 a person being sentenced under this subsection may not receive a suspended
17 sentence or be placed on probation. The sentencing judge may reduce the fine,

10 j. The defendant, to the best of his or her knowledge, has provided all
11 reasonable assistance in the identification, arrest, or conviction of any
12 accomplices, accessories, co-conspirators, or principals.
13 k. The defendant is being sentenced for trafficking, or conspiracy to
14 commit trafficking, for possession of an amount of a controlled
15 substance that is not of a quantity greater than the lowest category for
16 which a defendant may be convicted for trafficking of that controlled
17 substance under G.S. 90-95(h).

- 18 (6) Sentences imposed pursuant to this subsection ~~shall~~may run consecutively
19 with and shall commence at the expiration of any sentence being served by
20 the person sentenced hereunder.
