7 The General Assembly of North Carolina enacts:

9 **PART I. CONFORMING CROSS-REFERENCES TO LAND-USE LAWS, AS**
10 **RECOMMENDED BY THE GENERAL STATUTES COMMISSION**

11 **SECTION 1.** G.S. 18B-904 reads as rewritten:

12 **"§ 18B-904. Miscellaneous provisions concerning permits.**

13 ...

14 (g) Nothing in this Chapter shall be deemed to preempt local governments from
15 regulating the location or operation of adult establishments or other sexually oriented businesses
16 to the extent consistent with the constitutional protection afforded free speech, or from requiring
17 any additional fee for licensing as permitted under ~~G.S. 160A-181.1(e)~~ G.S. 160D-902(c).

19 **SECTION 2.** G.S. 20-81.12 reads as rewritten:

20 **"§ 20-81.12. Collegiate insignia plates and certain other special plates.**

21 ...

22 (b51) Historical Attraction Plates. – The Division must receive 300 or more applications for
23 an historical attraction plate representing a publicly owned or nonprofit historical attraction
24 located in North Carolina and listed below before the plate may be developed. The Division must
25 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from
26 the sale of historical attraction plates to the organizations named below in proportion to the
27 number of historical attraction plates sold representing that organization:

28 (1) Historical Attraction Within Historic District. – The revenue derived from the
29 special plate shall be transferred quarterly to the appropriate Historic
30 Preservation Commission, or entity designated as the Historic Preservation
31 Commission, and used to maintain property in the historic district in which
32 the attraction is located. As used in this subdivision, the term "historic district"
33 means a district created under ~~G.S. 160A-400.4~~ G.S. 160D-944.

34 (2) Nonprofit Historical Attraction. – The revenue derived from the special plate
35 shall be transferred quarterly to the nonprofit corporation that is responsible



1 for maintaining the attraction for which the plate is issued and used to develop
2 and operate the attraction.

- 3 (3) State Historic Site. – The revenue derived from the special plate shall be
4 transferred quarterly to the Department of Natural and Cultural Resources and
5 used to develop and operate the site for which the plate is issued. As used in
6 this subdivision, the term "State historic site" has the same meaning as in
7 G.S. 121-2(11).

38 (a) ~~The provisions of this Chapter shall apply.~~ This Chapter applies to any person,
39 partnership, corporation, limited liability company, association, or other business entity who that
40 acts as a landlord or real estate broker engaged in the rental or management of residential property
41 for vacation rental as defined in this Chapter. The provisions of G.S. 160A 424 and
42 G.S. 153A 364 shall apply. G.S. 160D-1117 applies to properties covered under this Chapter.

43 (b) ~~The provisions of this Chapter shall not apply to:~~ This Chapter does not apply to any
44 of the following:

- 45 (1) Lodging provided by hotels, motels, tourist camps, and other places subject to
46 regulation under Chapter 72 of the General Statutes.
47 (2) Rentals to persons temporarily renting a dwelling unit when traveling away
48 from their primary residence for business or employment purposes.
49 (3) Rentals to persons having no other place of primary residence.
50 (4) Rentals for which no more than nominal consideration is given."

3 (d) For any improvement to real property subject to G.S. 44A-11.1, any building permit
4 issued pursuant to ~~G.S. 160A-417(d) or G.S. 153A-357(e)~~ G.S. 160D-1110(g) shall be
5 conspicuously and continuously posted on the property for which the permit is issued until the
6 completion of all construction.

8 **SECTION 6.** G.S. 44A-24.2 reads as rewritten:

9 **"§ 44A-24.2. Definitions.**

10 The following definitions apply in this Part:

12 (3) Commercial real estate. – Any real property or interest therein, whether
13 freehold or nonfreehold, which at the time the property or interest is made the
14 subject of an agreement for broker services:

15 a. Is lawfully used primarily for sales, office, research, institutional,
16 agricultural, forestry, warehouse, manufacturing, industrial, or mining
17 purposes or for multifamily residential purposes involving five or
18 more dwelling units;

19 b. May lawfully be used for any of the purposes listed in sub-subdivision
20 (3)a. of this section by a zoning ordinance adopted pursuant to the
21 provisions of ~~Article 18 of Chapter 153A or Article 19 of Chapter~~
22 ~~160A~~ Chapter 160D of the General Statutes or which is the subject of
23 an official application or petition to amend the applicable zoning
24 ordinance to permit any of the uses listed in sub-subdivision (3)a. of

39 General Statutes.

41 **SECTION 8.** G.S. 87-14 reads as rewritten:

42 **"§ 87-14. Regulations as to issue of building permits.**

43 (a) Any person, firm, or corporation, upon making application to the building inspector
44 or ~~such~~ other authority of any incorporated city, town, or county in North Carolina charged with
45 the duty of issuing building or other permits for the construction of any building, highway, sewer,
46 grading, or any improvement or structure where the cost ~~thereof~~ is to be thirty thousand dollars
47 (\$30,000) or more, shall, before being entitled to ~~the issuance of~~ a permit, satisfy the following:

48 (1) Furnish satisfactory proof to the inspector or authority that the ~~person~~
49 applicant seeking the permit or another person contracting to superintend or
50 manage the construction is ~~duly~~ licensed under ~~the terms of~~ this Article to
51 carry out or superintend the construction or is exempt from licensure under

1 G.S. 87-1(b). If an applicant claims an exemption from licensure pursuant to
 2 G.S. 87-1(b)(2), the applicant for the building permit shall execute a verified
 3 affidavit attesting to the following:

- 4 a. That the ~~person-applicant~~ is the owner of the property on which the
 5 building is being constructed ~~or, in the case of and, if the applicant is~~
 6 a firm or corporation, ~~is legally authorized to act on behalf that the~~
 7 person submitting the application is an owner, officer, or member of
 8 the firm or corporation that owns the property.
 9 b. That the ~~person-applicant~~ will personally superintend and manage all
 10 aspects of the construction of the building and that the duty will not be
 11 delegated to any other person not ~~duly~~ licensed under ~~the terms of this~~
 12 Article.
 13 c. That the ~~person-applicant~~ will be personally present for all inspections
 14 required by the North Carolina State Building Code, unless the plans
 15 for the building were drawn and sealed by an architect licensed
 16 pursuant to Chapter 83A of the General Statutes.

17 The building inspector or other authority shall transmit a copy of the affidavit
 18 to the Board, ~~who~~ which shall verify that the applicant was validly entitled to
 19 claim the exemption under G.S. 87-1(b)(2). If the Board determines that the
 20 applicant was not entitled to claim the exemption under G.S. 87-1(b)(2), the
 21 building permit shall be revoked pursuant to ~~G.S. 153A-362 or G.S.~~
 22 ~~160A-422.~~ G.S. 160D-1115.

- 23 (2) Furnish proof that the ~~person-applicant~~ has in effect Workers' Compensation
 24 insurance as required by Chapter 97 of the General Statutes.

25 ~~(3)(a1)~~ Any person, firm, or corporation, upon making application to the building inspector
 26 or ~~such~~ other authority of any incorporated city, town, or county in North Carolina charged with
 27 the duty of issuing building permits pursuant to ~~G.S. 160A-417(a)(1) or G.S. 153A-357(a)(1)~~
 28 G.S. 160D-1110 for any improvements for which the combined cost is to be thirty thousand
 29 dollars (\$30,000) or more, other than for improvements to an existing single-family residential
 30 dwelling unit as defined in G.S. 87-15.5(7) that the owner occupies as a residence, or for the
 31 addition of an accessory building or accessory structure as defined in the North Carolina Uniform
 32 Residential Building Code, the use of which is incidental to that residential dwelling unit, shall
 33 be required to provide to the building inspector or other authority the name, physical and mailing
 34 address, telephone number, facsimile number, and ~~electronic mail~~ email address of the lien agent
 35 designated by the owner pursuant to G.S. 44A-11.1(a).

36 (b) It ~~shall be~~ is unlawful for the building inspector or other authority to issue or allow
 37 the issuance of a building permit pursuant to this section unless and until the applicant has
 38 furnished evidence that the applicant ~~is either exempt from the provisions of this Article and, if~~
 39 ~~applicable, fully complied with the provisions of subdivision (a)(1) of this section, or is duly~~
 40 ~~licensed under this Article to carry out or superintend the work for which permit has been applied;~~
 41 ~~and further, that the applicant has in effect Workers' Compensation insurance as required by~~
 42 ~~Chapter 97 of the General Statutes.~~ has complied with subsection (a) of this section. Any building
 43 inspector or other authority ~~who~~ that is subject to and violates ~~the terms of this section shall be~~
 44 is guilty of a Class 3 misdemeanor and subject only to a fine of not more than fifty dollars
 45 (\$50.00)."

46 **SECTION 9.** G.S. 106-678 reads as rewritten:

47 "**§ 106-678. Authority to regulate fertilizers.**

48 No county, city, or other political subdivision of the State shall adopt or continue in effect
 49 any ordinance or resolution regulating the use, sale, distribution, storage, transportation, disposal,
 50 formulation, labeling, registration, manufacture, or application of fertilizer. Nothing in this
 51 section shall prohibit a county, city, or other political subdivision of the State from exercising its

1 planning and zoning authority under ~~Article 19 of Chapter 160A of the General Statutes or Article~~
2 ~~18 of Chapter 153A-Chapter 160D~~ of the General Statutes or from exercising its fire prevention
3 or inspection authority. Nothing in this section shall limit the authority of the Department of
4 Environmental Quality or the Environmental Management Commission to enforce water quality
5 standards. Nothing in this section shall prohibit a county, city, or other political subdivision of
6 the State from adopting ordinances regulating fertilizers to protect water quality, provided that
7 the ordinances have been approved by the Environmental Management Commission or the
8 Department of Environmental Quality as part of a local plan or National Pollutant Discharge
9 Elimination System permit application and do not exceed the State's minimum requirements to
10 protect water quality as established by the Environmental Management Commission under Part
11 1 of Article 21 of Chapter 143 of the General Statutes. Nothing in this section shall prohibit a
12 county or city from exercising its authority to regulate explosive, corrosive, inflammable, or
13 radioactive substances pursuant to G.S. 153A-128 or G.S. 160A-183."

14 **SECTION 10.** G.S. 106-738 reads as rewritten:

15 **"§ 106-738. Voluntary agricultural districts.**

16 ...

17 (c) A county ordinance adopted pursuant to this Part is effective within the
18 unincorporated areas of the county. A city ordinance adopted pursuant to this Part is effective
19 within the corporate limits of the city. A city may amend its ordinances in accordance with
20 ~~G.S. 160A-383.2~~ G.S. 160D-903(e) with regard to agricultural districts within its planning
21 jurisdiction."

22 **SECTION 11.** G.S. 106-743.1 reads as rewritten:

23 **"§ 106-743.1. Enhanced voluntary agricultural districts.**

24 ...

25 (c) A county ordinance adopted pursuant to this Part is effective within the
26 unincorporated areas of the county. A city ordinance adopted pursuant to this Part is effective
27 within the corporate limits of the city. A city may amend its ordinances in accordance with
28 ~~G.S. 160A-383.2~~ G.S. 160D-903(e) with regard to agricultural districts within its planning
29 jurisdiction.

30"

31 **SECTION 12.(a)** G.S. 106-743.4 reads as rewritten:

32 **"§ 106-743.4. Enhanced voluntary agricultural districts; additional benefits.**

33 (a) Property that is subject to a conservation agreement under G.S. 106-743.2 that
34 remains in effect may receive up to twenty-five percent (25%) of its gross sales from the sale of
35 nonfarm products and still qualify as a bona fide farm that is exempt from zoning regulations
36 under ~~G.S. 153A-340(b)~~. G.S. 160D-903(a). For purposes of ~~G.S. 153A-340(b)~~,
37 G.S. 160D-903(a), the production of any nonfarm product that the Department of Agriculture
38 and Consumer Services recognizes as a "Goodness Grows in North Carolina" product that is
39 produced on a farm that is subject to a conservation agreement under G.S. 106-743.2 is a bona
40 fide farm purpose. A farmer seeking to benefit from this subsection shall have the burden of
41 establishing that the property's sale of nonfarm products did not exceed twenty-five percent
42 (25%) of its gross sales. A county may adopt an ordinance pursuant to this section that sets forth
43 the standards necessary for proof of compliance.

45 **SECTION 12.(b)** If Senate Bill 762, 2021 Regular Session, becomes law, then this
46 section is repealed.

47 **SECTION 13.** G.S. 106-850 reads as rewritten:

48 **"§ 106-850. Agriculture cost share program.**

49 ...

50 (b) The program shall be subject to the following requirements and limitations:

51 ...

(10) To be eligible for cost share funds under this program, each applicant must establish that the applicant ~~meets the definition of~~ is a bona fide farm as described by ~~G.S. 153A-340(b)(2)~~ G.S. 160D-903(a).

...."

SECTION 14. G.S. 115C-525 reads as rewritten:

"§ 115C-525. Fire prevention.

...

(b) Inspection of Schools for Fire Hazards; Removal of Hazards. – Every public school building in the State shall be inspected a minimum of two times during the year in accordance with the following plan: Provided, that the periodic inspections herein required shall be at least 120 days apart:

...

(2) The board of county commissioners of each county shall designate the persons to make the inspections and reports required by subdivision (1) of this subsection. The board may designate any city or county building inspector, any city or county fire prevention bureau, any city or county electrical inspector, the county fire marshal, or any other qualified persons, but no person shall make any inspection unless ~~he shall be~~ qualified as required by ~~G.S. 153A-351.1~~ G.S. 160D-1103 and Section 7 of Chapter 531 of the 1977 Session Laws. Nothing in this section shall be construed as prohibiting two or more counties from designating the same persons to make the inspections and reports required by subdivision (1) of this subsection. The board of county commissioners shall compensate or provide for the compensation of the persons designated to make all such inspections and reports. The board of county commissioners may make appropriations in the general fund of the county to meet the costs of such inspections, or in the alternative the board may add appropriations to the school current expense fund to meet the costs thereof: Provided, that if appropriations are added to the school current expense fund, such appropriations shall be in addition to and not in substitution of existing school current expense appropriations.

...."

SECTION 15. G.S. 122C-403 reads as rewritten:

"§ 122C-403. Secretary's authority over Camp Butner reservation.

The Secretary shall administer the Camp Butner reservation except (i) those areas within the municipal boundaries of the Town of Butner and (ii) that portion of the Town of Butner's extraterritorial jurisdiction consisting of lands not owned by the State of North Carolina. In performing this duty, the Secretary has the powers listed below. In exercising these powers the Secretary has the same authority and is subject to the same restrictions that the governing body of a city would have and would be subject to if the reservation was a city, unless this section provides to the contrary. The Secretary ~~may~~ may do the following:

...

(3) Regulate the development of the reservation in accordance with the powers granted in ~~Article 19, Parts 2, 3, 3C, 5, 6, and 7, of Chapter 160A~~ Articles 7, 8, 11, and 12 and Parts 4 and 5 of Article 9 of Chapter 160D of the General Statutes. The Secretary ~~may~~ shall not, however, grant a special use ~~permit, a conditional use permit, or a special exception under Part 3 of that Article.~~ permit under Article 7 of that Chapter. In addition, the Secretary is not required to notify landowners of zoning classification actions under ~~G.S. 160A-384, G.S. 160D-601,~~ but the Secretary shall give the mayor of the Town of Butner at least 14 days' advance written notice of any proposed zoning change. The Secretary may ~~designate Advisory~~ establish a board to act

1 like a Board of Adjustment to make recommendations to the Secretary
 2 concerning implementation of plans for the development of the reservation.
 3 When acting as a Board of Adjustment, ~~Advisory that the board shall be is~~
 4 subject to subsections ~~(b), (c), (d), (e), (f), and (g)~~ of ~~G.S. 160A-388~~ (c) and (d) of
 5 G.S. 160D-705 and subsections (f) and (g) of G.S. 160D-406.

6 (4) Establish one or more planning agencies in accordance with the power granted
 7 in ~~G.S. 160A-361~~ G.S. 160D-301.

8 ...

9 (6) Control erosion and sedimentation on the reservation in accordance with the
 10 powers granted in ~~G.S. 160A-458~~ G.S. 160D-922 and Article 4 of Chapter
 11 113A of the General Statutes.

12 (7) Contract with and undertake agreements with units of local government in
 13 accordance with the powers granted in ~~G.S. 160A-413~~ G.S. 160D-402 and
 14 ~~Article 20, Part 1, Part 1~~ of Article 20 of Chapter 160A of the General Statutes.

15 (8) Regulate floodways on the reservation in accordance with the powers granted
 16 in ~~G.S. 160A-458.1~~ G.S. 160D-923 and ~~Article 21, Part 6, Part 6~~ of Article 21
 17 of Chapter 143 of the General Statutes.

18"

19 **SECTION 16.** G.S. 122C-410 reads as rewritten:

20 "**§ 122C-410. Authority of county or city over Camp Butner Reservation; zoning**
 21 **jurisdiction by Town of Butner over State lands.**

22 ...

23 (b) A county ordinance may apply in part or all of the Camp Butner reservation (other
 24 than areas within the Town of Butner) if the Secretary gives written approval of the ordinance,
 25 except that ordinances adopted by a county under ~~Article 18 of Chapter 153A~~ Chapter 160D
 26 of the General Statutes may not apply in the extraterritorial jurisdiction of the Town of Butner
 27 without approval of the Butner Town Council. The Secretary may withdraw approval of a county
 28 ordinance by giving written notification, by certified mail, return receipt requested, to the county.
 29 A county ordinance ceases to be effective in the Camp Butner reservation 30 days after the county
 30 receives the written notice of the withdrawal of approval. This section does not enhance or
 31 diminish the authority of a county to enact ordinances applicable to the Town of Butner and its
 32 extraterritorial jurisdiction.

33 (c) Notwithstanding any other provision of this Article, no portion of the lands owned by
 34 the State as of September 1, 2007, which are located in the extraterritorial jurisdiction or the
 35 incorporated limits of the Town of Butner shall be subject to any of the powers granted to the
 36 Town of Butner pursuant to ~~Article 19 of Chapter 160A~~ Chapter 160D of the General Statutes
 37 except as to property no longer owned by the State. If any portion of such property owned by the
 38 State of North Carolina as of September 1, 2007, is no longer owned by the State, the Town of
 39 Butner may exercise all legal authority granted to the Town pursuant to the terms of its charter
 40 or by ~~Article 19 of Chapter 160A~~ Chapter 160D of the General Statutes and may do so by
 41 ordinances adopted prior to the actual date of transfer. Before the State shall dispose of any
 42 property inside the incorporated limits of the Town of Butner or any of that property currently
 43 under the control of the North Carolina Department of Health and Human Services or the North
 44 Carolina Department of Agriculture and Consumer Services within the extraterritorial
 45 jurisdiction of the Town of Butner, southeast of Old Highway 75, northeast of Central Avenue,
 46 southwest of 33rd Street, and northwest of "G" Street, by sale or lease for any use not directly
 47 associated with a State function, the Town of Butner shall first be given the right of first refusal
 48 to purchase said property at fair market value as determined by the average of the value of said
 49 property as determined by a qualified appraiser selected by the Secretary and a qualified appraiser
 50 selected by the Town of Butner."

51 **SECTION 17.** G.S. 130A-64.1 reads as rewritten:

1 **"§ 130A-64.1. Notice of new or increased charges and rates; public comment period.**

2 (a) A sanitary district shall provide notice to interested parties of the imposition of or
3 increase in service charges or rates applicable solely to the construction of development subject
4 to ~~Part 2 of Article 19 of Chapter 160A or Part 2 of Article 18 of Chapter 153A~~ Article 8 of
5 Chapter 160D of the General Statutes for any service provided by the sanitary district at least
6 seven days prior to the first meeting where the imposition of or increase in the charges or rates is
7 on the agenda for consideration. The sanitary district shall employ at least two of the following
8 means of communication in order to provide the notice required by this section:

10 **SECTION 18.** G.S. 130A-247 reads as rewritten:

11 **"§ 130A-247. Definitions.**

12 The following definitions shall apply throughout this Part:

13 ...

14 (13) "Temporary food establishment" means an establishment not otherwise
15 exempted from this part pursuant to G.S. 130A-250 that (i) prepares or serves
16 food, (ii) operates for a period of time not to exceed 30 days in one location,
17 and (iii) is affiliated with and endorsed by a transitory fair, carnival, circus,
18 festival, public exhibition, or agritourism business. For purposes of this
19 subdivision, "agritourism" means the same as in ~~G.S. 153A-340(b)(2a)-~~
20 G.S. 160D-903(a). Notwithstanding the time limit set out in this subdivision,
21 a local health department may, upon the request of a temporary food
22 establishment, grant a one-time, 15-day extension of the establishment's
23 permit if the establishment continues to meet all of the requirements of its
24 permit and applicable rules.

1 (f) Stays. – An appeal of a notice of violation or other enforcement order to the board of
2 adjustment and any subsequent appeal in accordance with G.S. 160D-1402 stays enforcement of
3 the action appealed from and accrual of any fines assessed during the pendency of the appeal ~~to~~
4 ~~the board of adjustment and any subsequent appeal in accordance with G.S. 160D-1402~~ or during
5 the pendency of any civil proceeding authorized by law or ~~appeals therefrom, unless related~~
6 appeal. If, however, the official who made the decision certifies to the board after notice of appeal
7 has been filed that, because of the facts stated in an affidavit, a stay would cause imminent peril

28 **SECTION 62.** Except as otherwise provided, this act is effective when it becomes
