ENGROSSED HOUSE BILL NO. 1013

1 A BILL for an Act to provide an appropriation for defraying the expenses of the commissioner of
2 university and school lands; and to provide for distributions from permanent funds.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
5 as may be necessary, are appropriated out of any moneys from special funds derived from the
6 state lands maintenance fund in the state treasury, to the commissioner of university and school
7 lands for the purpose of defraying the expenses of the commissioner of university and school
8 lands, for the biennium beginning July 1, 2023, and ending June 30, 2025, as follows:

17 **SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO THE**
18 **SIXTY-NINTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time funding
19 items approved by the sixty-seventh legislative assembly for the 2021-23 biennium and the
20 2023-25 biennium one-time funding items included in the appropriation in section 1 of this Act:

3 The 2023-25 biennium one-time funding amounts are not a part of the entity's base budget
4 for the 2025-27 biennium. The commissioner of university and school lands shall report to the
5 appropriations committees of the sixty-ninth legislative assembly on the use of this one-time
6 funding for the biennium beginning July 1, 2023, and ending June 30, 2025.

7 **SECTION 3. DISTRIBUTIONS TO STATE INSTITUTIONS.** Pursuant to article IX of the
8 Constitution of North Dakota, the board of university and school lands shall distribute during the
9 biennium beginning July 1, 2023, and ending June 30, 2025, the following amounts, from the
10 permanent funds managed for the benefit of the following entities:
