

**FIRST ENGROSSMENT  
with Senate Amendments  
ENGROSSED HOUSE BILL NO. 1016**

Introduced by

Appropriations Committee

1 A BILL for an Act to provide an appropriation for defraying the expenses of job service North  
2 Dakota.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
5 as may be necessary, are appropriated out of any moneys in the general fund in the state  
6 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
7 other income, to job service North Dakota for the purpose of defraying the expenses of  
8 job service North Dakota, for the biennium beginning July 1, 2023, and ending June 30, 2025,  
9 as follows:

22 **SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO**

23 **SIXTY-NINTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time funding

1 items approved by the sixty-seventh legislative assembly for the 2021-23 biennium and the  
2 one-time funding items included in the appropriation in section 1 of this Act:

6 The 2023-25 biennium one-time funding amounts are not part of the entity's base budget for  
7 the 2025-27 biennium. Job service North Dakota shall report to the appropriations committees  
8 of the sixty-ninth legislative assembly on the use of this one-time funding for the biennium  
9 beginning July 1, 2023, and ending June 30, 2025.

10 **SECTION 3. ADDITIONAL INCOME - APPROPRIATION.** All federal funds received by  
11 job service North Dakota in excess of those funds appropriated in section 1 of this Act are  
12 appropriated to job service North Dakota for the biennium beginning July 1, 2023, and ending  
13 June 30, 2025.

14 **SECTION 4. ESTIMATED INCOME - REED ACT FUNDS - UNEMPLOYMENT**

15 **INSURANCE COMPUTER MODERNIZATION.** The estimated income line item in section 1 of  
16 this Act includes the sum of \$10,915,000 from federal Reed Act funds made available to the  
17 state by the federal Reed Act distributions made in federal fiscal years 1957, 1958, 1999, and  
18 2002, pursuant to section 903 of the federal Social Security Act. This sum, or so much of the  
19 sum as may be necessary, is for the purpose of developing a modernization unemployment  
20 insurance computer system.

21 **SECTION 5. ESTIMATED INCOME - UNEMPLOYMENT INSURANCE MODERNIZATION**

22 **PROJECT - FEDERAL STATE FISCAL RECOVERY FUND - ONE-TIME FUNDING.** The  
23 estimated income line item in section 1 of this Act includes the sum of \$45,000,000 from federal  
24 funds derived from the state fiscal recovery fund for the unemployment insurance modernization  
25 project. This funding is considered a one-time funding item.
