- 1 A BILL for an Act to create and enact a new section to chapter 12.1-31 of the North Dakota
- 2 Century Code, relating to prohibiting economic harm; to amend and reenact subsection 1 of

3 section 12.1-31-01 of the North Dakota Century Code, relating to disorderly conduct; and to

4 provide a penalty.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 SECTION 1. AMENDMENT. Subsection 1 of section 12.1-31-01 of the North Dakota
7 Century Code is amended and reenacted as follows:

- An individual is guilty of a class B misdemeanor if, with intent to harass, annoy, or
 alarm another person or in reckless disregard of the fact that another person is
 harassed, annoved, or alarmed by the individual's behavior, the individual:
- 1. Engages in fighting, or in violent, tumultuous, or threatening behavior;
- 12 b. Makes unreasonable noise;
- 13 c. In a public place, uses abusive or obscene language, knowingly exposes that
 14 individual's penis, vulva, or anus, or makes an obscene gesture;
- 15 d. Obstructs vehicular or pedestrian traffic or, the use of a public <u>or private</u> facility, or
 16 <u>commercial activity or equipment;</u>
- 17 e. Persistently follows a person in or about a public place or places;
- f. While loitering in a public place for the purpose of soliciting sexual contact, the
 individual solicits the contact;
- 20 g. Creates a hazardous, physically offensive, or seriously alarming condition by any
 21 act that serves no legitimate purpose;
- h. Engages in harassing conduct by means of intrusive or unwanted acts, words, or
 gestures that are intended to adversely affect the safety, security, or privacy of
 another person; or

1		i.	Uses a fixed optical device that enhances or records a visual occurrence to view
2			through any window of another person's property; or uses a surveillance camera
3			to capture an image from the dwelling or accessory structure of another person;
4			however, an individual using a surveillance camera has seven days from notice
5			by a law enforcement officer to direct or shield the camera so as to not capture
6			an image from another person's dwelling or accessory structure before there is
7			an offense.
8	SECTION 2. A new section to chapter 12.1-31 of the North Dakota Century Code is created		
9	and enacted as follows:		
10	Economic harm prohibited - Penalty.		
11	<u>1.</u>	<u>An</u> i	individual may not commit a physical act constituting the commission of a
12		<u>mis</u>	demeanor offense, when done intentionally to cause direct or indirect economic
13		hari	m in excess of one thousand dollars to the government or to an individual.
14	<u>2.</u>	<u>Eco</u>	nomic harm under this section does not include court, prosecution, incarceration,
15		<u>or la</u>	aw enforcement costs. The prosecution must plead and prove an underlying
16		<u>mis</u>	demeanor offense the individual committed, and a jury must be instructed and
17		mal	ke a special finding regarding the elements of this section before an individual may
18		<u>be f</u>	ound guilty. This section may not be used as a basis for a conspiracy, accomplice,
19		<u>or a</u>	ittempt charge.
20	<u>3.</u>	<u>This</u>	s section does not apply to constitutionally protected activity. If an individual claims
21		<u>to h</u>	ave been engaged in a constitutionally protected activity, the court shall determine
22		<u>the</u>	validity of the claim as a matter of law and, if found valid, shall exclude evidence of
23		<u>the</u>	activity.
24	<u>4.</u>	Viol	ation of this section is a class C felony.
