- 1 A BILL for an Act to create and enact six new sections to chapter 15-10 of the North Dakota
- 2 Century Code, relating to the provision of matching grants for the advancement of
- 3 postsecondary academics; to provide for a legislative management report; and to provide an
- 4 expiration date.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 SECTION 1. A new section to chapter 15-10 of the North Dakota Century Code is created
7 and enacted as follows:

14			advancement of academics.
15		<u>b.</u>	To be eligible for a matching grant, an institution must demonstrate that:
16			1) Its foundation has raised at least fifty thousand dollars in cash or monetary
17			pledges for a qualifying project; and
18			2) The project has been approved by the grant review committee established
19			in section 4 of this Act.
20		<u>C.</u>	The board may award up to ten million dollars in matching grants to each
21			institution.
22	<u>2.</u>	<u>a.</u>	If any available dollars have not been awarded by the board before January 1,
23			2015, in accordance with subsection 1, either the university of North Dakota or
24			North Dakota state university may apply for an additional matching grant.

9	If the state board of higher education provides grant funds under this Act to an institution on						
10	the basis of a monetary pledge and if the amount forthcoming is less than the amount pledged,						
11	the institutional foundation is liable to the institution for any shortfall.						
12	SECTION 4. A new section to chapter 15-10 of the North Dakota Century Code is created						
13	and enacted as follows:						
14	Grant review committee.						
15	<u>1.</u>	There is created a grant review committee consisting of:					
16		<u>a.</u>	The governor, or the governor's designee, who shall serve as the chairman;				
17		<u>b.</u>	Two members of the house of representatives appropriations committee,				
18			selected by the majority leader of the house of representatives;				
19		<u>C.</u>	Two members of the senate appropriations committee selected by the majority				
20			leader of the senate; and				
21		<u>d.</u>	Two members appointed by the governor, with the consent of the legislative				
22			management.				
23	<u>2.</u>	<u>The</u>	gubernatorial appointees must have an understanding of higher education's role				
24		<u>in a</u>	dvancing agriculture, the arts, commerce and finance, manufacturing, mineral				
25		<u>extr</u>	action, natural resources, and the professions.				
26	<u>3.</u>	<u>The</u>	grant review committee shall establish its rules of operation and procedure and				
27		<u>sha</u>	I develop and publish the criteria upon which all requests for matching grants will				
28		<u>be r</u>	eviewed.				
29	<u>4.</u>	A request for a matching grant must be presented to the committee by the president of					
30		<u>the</u>	institution. The president may be accompanied by other individuals having an				
31		<u>exp</u>	ertise with respect to the project.

1 **SECTION 5.** A new section to chapter 15-10 of the North Dakota Century Code is created

2 and enacted as follows:

- 3 **Grant review committee Compensation.**
- 4 <u>Each member of the grant review committee is entitled to receive compensation in the</u>
- 5 amount of one hundred thirty-five dollars per day plus reimbursement for expenses as provided
- 6 by law for state officers if the member is attending meetings or performing duties directed by the
- 7 <u>committee. The compensation provided for in this section may not be paid to any member of the</u>
- 8 <u>committee who receives a salary or other compensation as an employee or official of this state</u>
- 9 if the individual is serving on the committee by virtue of the individual's state office or state

10 <u>employment.</u>

- 11 SECTION 6. A new section to chapter 15-10 of the North Dakota Century Code is created
- 12 and enacted as follows:

13 Definition.

14 For purposes of this Act, projects dedicated to the advancement of enhanced academics

15 include investments in research, scholarship, technology, endowed chairs, and investments in

16 <u>educational infrastructure, not to include new capital construction projects.</u>

17 SECTION 7. REPORT. Before October 1, 2014, the state board of higher education shall

- 18 provide a report to the legislative management regarding the number of matching grants that
- 19 were sought, the number that were awarded, and the manner in which the grants were used.

SECTION 8. EXPIRATION DATE. This Act is effective through June 30, 2015, and after that
date is ineffective.
