- 1 A BILL for an Act to create and enact a new section to chapter 57-38 and a new subdivision to
- 2 subsection 7 of section 57-38-30.3 of the North Dakota Century Code, relating to an income tax
- 3 credit for taxpayers whose children receive nonpublic school or home education; and to provide
- 4 an effective date.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 SECTION 1. A new section to chapter 57-38 of the North Dakota Century Code is created
7 and enacted as follows:

8 Nonpublic school or home education tax credit.

- 9 <u>1. A taxpayer is entitled to a credit against tax liability determined under section</u>
- 10 <u>57-38-30.3 for each dependent of the taxpayer who received nonpublic school</u>
- 11 education, at a nonpublic school approved under section 15.1-06-06.1, or home
- 12 education, as defined in section 15.1-23-01, for the entire school year ending in the
- 13 <u>taxable year if the taxpayer is a North Dakota resident. To qualify for the credit under</u>
- 14 this section, home education must meet the requirements of chapter 15.1-23.
- 15 <u>2.</u> <u>The amount of the credit is equal to five hundred dollars per student.</u>
- 3. <u>The amount of the credit under this section is reduced by fifty percent for a dependent</u>
 who received nonpublic school eduction or home education for less than the entire
 school year, but at least one-half of the school year, ending during the taxable year.
- 18 <u>school year, but at least one-half of the school year, ending during the taxable year.</u>
- <u>A credit under this section is not allowed for a dependent who received nonpublic</u>
 <u>school education or home education for less than one-half of the school year ending in</u>
 <u>the taxable year.</u>
- 5. If the amount of the credit determined under this section exceeds the taxpayer's
 liability for tax under this chapter, the excess may be carried forward to the next
 succeeding taxable year.

- 2 Century Code is created and enacted as follows:
- 3 Nonpublic school or home education tax credit under section 1 of this Act.
- 4 **SECTION 3. EFFECTIVE DATE.** This Act is effective for taxable years beginning after
- 5 December 31, 2020.
