- 1 A BILL for an Act to create and enact two new sections to chapter 15-10 of the North Dakota
- 2 Century Code, relating to the appointment of institution presidents and the commissioner of
- 3 higher education.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 **SECTION 1.** A new section to chapter 15-10 of the North Dakota Century Code is created 6 and enacted as follows:

- 7 Appointment process President of an institution.
- 8 <u>1.</u> Upon being notified that the state board of higher education must select an individual
- 9 to serve as the president of an institution of higher education under its control, the
- 10 <u>board shall provide for the creation of a presidential search committee.</u>
- 11 <u>2.</u> <u>The board shall:</u>
- 12 <u>a.</u> Establish criteria for the membership of the search committee and the manner in
 13 <u>which the search committee members are to be appointed;</u>
- 14 b. Define the presidential leadership qualities and qualifications the board desires;
- 15 <u>c.</u> Indicate whether the presidential search is to be regional or national in scope;
- 16 <u>d.</u> Articulate its expectations regarding the selection and use of search consultants;
 17 <u>and</u>
- 18 <u>e.</u> Determine the date by which the search committee's recommendations are to be
 19 provided to the board.
- 20 <u>3.</u> <u>The board may not select an individual to serve as the president of an institution</u>
- 21 unless the search committee has presented the board with no fewer than two nor
- 22 more than four candidates, each of whom is qualified by training and experience to
