- 1 A BILL for an Act to create and enact a new section to chapter 57-39.2 of the North Dakota
- 2 Century Code, relating to a sales and use tax holiday for clothing; and to provide an effective
- 3 date.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 SECTION 1. A new section to chapter 57-39.2 of the North Dakota Century Code is created
6 and enacted as follows:

7 Sales tax holiday for clothing.

8 Gross receipts from sales of clothing are exempt from taxes imposed under this chapter on

9 the third Friday of August of each year and the immediately following Saturday and Sunday. For

10 purposes of this section, "clothing" means all human wearing apparel suitable for general use.

11 For purposes of this section:

23		<u>with</u>	hair, fleece, or fur fibers attached, either in its raw or processed state, but does		
24		<u>not</u>	include skins that have been converted into leather or suede or, which in		
25		pro	cessing, the hair, fleece, or fur fiber has been completely removed.		
26	<u>5.</u>	"Protective equipment" means items for human wear and designed as protection of			
27		the wearer against injury or disease or as protection against damage or injury of other			
28		persons or property which are not suitable for general use. The term includes:			
29		<u>a.</u>	Breathing masks;		
30		<u>b.</u>	Clean room apparel and equipment;		
31		<u>C.</u>	Ear and hearing protectors:
