- 1 A BILL for an Act to create and enact a new section to chapter 15.1-19 of the North Dakota
- 2 Century Code, relating to the adoption of a restraint and seclusion policy by school districts.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 **SECTION 1.** A new section to chapter 15.1-19 of the North Dakota Century Code is created and enacted as follows:

School districts - Restraint and seclusion policy.

- a. "Chemical restraint" means medication that is not a standard treatment for an individual's medical or psychological condition which is used to control the behavior or restrict the movement of an individual.
 - b. "Mechanical restraint" means the use of any device or equipment to restrict the movement of an individual. The term does not include devices that are designed or prescribed for therapeutic or safety purposes, and which are used by trained school district personnel on a student or by a student on the student's own body.
 - c. "Physical restraint" means the use of the body of an individual to restrict or immobilize another individual from moving the individual's torso, arms, legs, or head. The term does not include a temporary touching or holding of the hand, wrist, arm, shoulder, or back for the purpose of directing or escorting an individual to walk to a designated location.
 - d. "Restraint" means a chemical restraint, mechanical restraint, physical restraint, or any combination of chemical, mechanical, or physical restraints.
 - e. "Seclusion" means the involuntary confinement of an individual alone in a room or area from which the individual is physically prevented from leaving. The term does not include a time-out.

12			<u>intru</u>	usive, nonphysical interventions have been attempted unsuccessfully or

14		<u>C.</u>	<u>Pro</u>	hibits the use of physical restraint under subdivision b:		
15			<u>(1)</u>	In a face-down position;		
16			<u>(2)</u>	In a position likely to impair a student's ability to breathe or communicate		
17				distress;		
18			<u>(3)</u>	In a position that places pressure on the student's head, neck, or torso; or		
19			<u>(4)</u>	In a position that obstructs the student's face from the view of school district		
20				personnel; and		
21		<u>d.</u>	Rec	quires school district personnel to receive annual professional development		
22			<u>and</u>	training in positive behavior interventions and trauma-informed practices,		
23			<u>incl</u>	uding crisis de-escalation, restorative practices, and behavior management.		
24	<u>3.</u>	Beginning July 1, 2023, and annually by July first each year thereafter, each school				
25		district shall submit a written report to the superintendent of public instruction. The				
26		report must include:				
27		<u>a.</u>	<u>The</u>	number of incidents, not to exceed one incident per student per day for state		
28			pur	poses, of both restraint and seclusion in each school located within the district		
29			<u>duri</u>	ng the preceding calendar year, and whether the student who was the subject

3		<u>b.</u>	The number of students, not to exceed one incident per student per day for state
4			purposes, who were the subject of restraint and seclusion methods by school
5			district personnel during the preceding calendar year, and whether the students
6			were on an individualized education program, or a 504 plan in compliance with
7			the requirements of section 504 of the Rehabilitation Act [29 U.S.C. 794]; and
8		<u>C.</u>	The type of restraint or seclusion used during each incident.
9	<u>4.</u>	<u>The</u>	superintendent of public instruction shall publish the data received under
0		sub	section 3 to the department's website within ninety days of receipt of the data.
