- 1 A BILL for an Act to create and enact section 54-52.1-04.18 of the North Dakota Century Code,
- 2 relating to vitamin D screening and testing; to amend and reenact section 26.1-36.6-03 of the
- 3 North Dakota Century Code, relating to self-insurance health plans; to provide for a report; to
- 4 provide for application; to provide an expiration date; and to declare an emergency.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. AMENDMENT. Section 26.1-36.6-03 of the North Dakota Century Code is
 amended and reenacted as follows:
- 8 **26.1-36.6-03. Self-insurance health plans Requirements.**
- The following policy provisions apply to a self-insurance health plan or to the administrative services only or third-party administrator, and are subject to the jurisdiction of the commissioner: 26.1-36-03, 26.1-36-03.1, 26.1-36-05, 26.1-36-10, 26.1-36-12, 26.1-36-12.4, 26.1-36-12.6, 26.1-36-13, 26.1-36-14, 26.1-36-17,
- 13 26.1-36-18, 26.1-36-19, 26.1-36-23, 26.1-36-29, 26.1-36-37.1, 26.1-36-38, 26.1-36-39,
- 14 26.1-36-41, 26.1-36-44, and 26.1-36-46.
- 15 2. The following health benefit provisions applicable to a group accident and health insurance policy under chapter 26.1-36 apply to a self-insurance health plan and are
- 17 subject to the jurisdiction of the commissioner: 26.1-36-06, 26.1-36-06.1, 26.1-36-07,
- 18 26.1-36-08, 26.1-36-08.1, 26.1-36-09, 26.1-36-09.1, 26.1-36-09.2, 26.1-36-09.3,
- 19 26.1-36-09.5, 26.1-36-09.6, 26.1-36-09.7, 26.1-36-09.8, 26.1-36-09.9, 26.1-36-09.10,

- 22 26.1-36-43. Section 2 of this Act applies to a self-insurance health plan and is subject
- to the jurisdiction of the commissioner.

- 1 SECTION 2. Section 54-52.1-04.18 of the North Dakota Century Code is created and 2 enacted as follows: 3 54-52.1-04.18. Coverage of vitamin D screening and testing. 4 The board shall provide medical benefits coverage under a contract for insurance, health 5 maintenance organization, or self-insurance plan for vitamin D deficiency screening and testing, 6 as deemed necessary by the health care provider. 7 SECTION 3. APPLICATION. This Act applies to medical benefits coverage that begins after 8 June 30, 2021, and which does not extend past June 30, 2023. 9 SECTION 4. PUBLIC EMPLOYEES RETIREMENT SYSTEM - VITAMIN D SCREENING -10 **REPORT.** Pursuant to section 54-03-28, the public employees retirement system shall prepare 11 and submit for introduction a bill to the sixty-eighth legislative assembly to repeal the expiration 12 date for sections 1 and 3 of this Act and to extend the coverage of vitamin D testing and 13 screening to all group and individual health insurance policies. The public employees retirement 14 system shall append a report to the bill regarding the effect of the testing and screening 15 requirement on the system's health insurance programs, information on the utilization and costs 16 relating to the coverage, and a recommendation regarding whether the coverage should be 17 continued. 18 SECTION 5. EXPIRATION DATE. Sections 1 and 2 of this Act are effective through July 31, 19 2023, and after that date are ineffective.
- **SECTION 6. EMERGENCY.** This Act is declared to be an emergency measure.
