- 1 A BILL for an Act to amend and reenact section 49-02-01.1 of the North Dakota Century Code,
- 2 relating to the jurisdiction of the public service commission.

## 3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 **SECTION 1. AMENDMENT.** Section 49-02-01.1 of the North Dakota Century Code is amended and reenacted as follows:

## 6 49-02-01.1. Jurisdiction of commission limited as to certain utilities <u>- Exemption</u>.

- 7 Nothing in this chapter or in chapter 49-21 authorizes the commission to make any 8 order affecting rates, contracts, services rendered, adequacy, or sufficiency of 9 facilities, or the rules or regulations of any public utility owned and operated by the 10 state or by any city, county, township, or other political subdivision of the state or any 11 public utility, that is not operated for profit, that is operated as a nonprofit, cooperative, 12 or mutual telecommunications company or is a telecommunications company having 13 fewer than eighteen thousand local exchange subscribers. However, anya 14 telecommunications utility that is operated as a nonprofit, cooperative, or mutual 15 telecommunications company or has fewer than eighteen thousand local exchange 16 subscribers is subject to sections 49-21-01.4, 49-21-02.4, 49-21-23, 49-21-24, and 17 49-21-25, subsections 6 through 14 of section 49-21-01.7, and to sections 49-21-01.2, 18 49-21-01.3, 49-21-06, 49-21-07, 49-21-09, and 49-21-10, regarding rates, terms, and 19 conditions of access services or connection between facilities and transfer of 20 telecommunications between two or more telecommunications companies. Nothing in 21 this section limits the authority of the commission granted under chapters 49-03 and 22 49-03.1 or sections 49-04-05 and 49-04-06.
  - Upon receipt of a resolution from the governing body of a city not served on August 1,
    2017, with natural gas distribution service from a public utility requesting an

1 exemption, and stating its reasons for doing so, the commission shall grant the public 2 utility an exemption from sections 49-02-03, 49-02-11, and 49-02-15, and chapters 3 49-03.1 and 49-04 if the public utility: 4 Has a franchise to supply customers within the city and the area of the 5 extraterritorial zoning jurisdiction of the city with natural gas distribution service; 6 <u>b.</u> Consents to the exemption; and 7 Serves no more than two thousand five hundred customers within the city and C. 8 the area of the extraterritorial zoning jurisdiction of the city. 9 Upon approval of the exemption, the rates, contracts, or services rendered by the <u>3.</u> 10 public utility within the exempted area are subject to regulation by the city. 11 Notwithstanding an exemption granted under this section, the public utility remains <u>4.</u> 12 subject to any rules of the commission governing customer service disconnections, 13 and resale of natural gas service furnished or causing the resale of natural gas service 14 by any customer is prohibited. 15 <u>5.</u> If a city files with the commission a resolution of its governing body rescinding the 16 request for exemption, if the public utility serves more than two thousand five hundred 17 customers within the city and the area of the city's extraterritorial zoning jurisdiction, or 18 if the public utility requests rescinding the exemption for good cause, the commission 19 may rescind the exemption granted under this section. The commission may require a 20 public utility providing nonexempt natural gas distribution service to provide any 21 exempted natural gas distribution service as a separate business entity. 22 Equipment covered by this section must be installed and maintained in compliance 6. 23 with the instructions provided by the manufacturer of any previously-installed equipment to which it will be added. Appliances designed to use only a specific fuel 24 25 may not be converted to use a different fuel if the manufacturer has prohibited the 26 conversions.
