- 1 A BILL for an Act to amend and reenact sections 61-24.5-03, 61-24.5-04, 61-24.5-07, and
- 2 61-24.5-08 of the North Dakota Century Code, relating to the parts of the state included in the
- 3 southwest water authority and the membership of the board of directors of the southwest water
- 4 authority; and to provide an effective date.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 SECTION 1. AMENDMENT. Section 61-24.5-03 of the North Dakota Century Code is
7 amended and reenacted as follows:

8 **61-24.5-03.** Southwest water authority created.

- 9 <u>1.</u> The southwest water authority shall consists of that part of the state which is-
- 10 included within the boundaries of Dunn, Stark, Golden Valley, Billings, Slope,
- 11 Bowman, Adams, Grant, Hettinger, Morton, and Mercer Counties and all of Morton

12 <u>County outside the boundaries of Mandan</u>.

- <u>SuchThe</u> authority is a governmental agency, body politic and corporate with the
 authority to exercise the powers specified in this chapter, or which <u>reasonably</u> may be
 reasonably implied.
- Any county adjoining the authority as herein created, or as hereafter composed, may
 join suchthe authority upon application of its board of county commissioners and the
 approval of suchthe application by the board of directors of the authority. The board of
- 19 directors, as a condition of approval of such<u>an</u> application, may require <u>equitable</u>
- payments as may be equitable to equalize the burden of such<u>the</u> county with the
 obligations paid or assumed by the other counties in the authority.

22 SECTION 2. AMENDMENT. Section 61-24.5-04 of the North Dakota Century Code is

23 amended and reenacted as follows:

61-24.5-04. Board of directors - Officers - Meetings - Compensation.

2 The authority must be governed by a board of directors who must be chosen in accordance 3 with this chapter. One director must be elected from each county within the authority, and two 4 directors must be elected in the city of from Dickinson, and one director must be elected in the-5 city of Mandan. The director from Stark County may not be a resident of the city of Dickinson. 6 The director from Morton County may not be a resident of Mandan. The board shall elect from 7 the directors a chairman, vice chairman, and secretary. A majority of the directors constitutes a 8 guorum for the purpose of conducting the business of the board. The board shall meet at the 9 time and place designated by the secretary. Board members are entitled to receive as 10 compensation an amount determined by the board not to exceed the amount per day provided 11 members of the legislative management under section 54-35-10, and must be reimbursed for 12 their mileage and expenses in the amount provided for by sections 44-08-04 and 54-06-09. 13 **SECTION 3. AMENDMENT.** Section 61-24.5-07 of the North Dakota Century Code is 14 amended and reenacted as follows:

15 **61-24.5-07. Election of city directors of the southwest water authority.**

16 Any personindividual who is a resident and gualified elector of the city of Dickinson or-17 Mandan who aspires to the office of director of the southwest water authority shall, before four 18 p.m. on the sixty-fourth day before the election, file with the city auditor a petition signed by not 19 less than ten percent of the number of qualified electors who voted for that office in the last city 20 election, except that the petition for the first election must be signed by not less than two 21 hundred qualified electors. Signers of a petition must reside within the corporate limits of the 22 city, and each signer of the petition shall include with the signer's name the signer's mailing 23 address. The petition must include the candidate's name, post-office address, and the title of 24 the office of the southwest water authority for which the candidate is seeking election.

The petition must be accompanied by an affidavit substantially as follows:

7	Upon receipt of the petition, the city auditor shall without fee place the name of the aspirant
8	on the election ballot as a candidate for the office of director. The candidate or candidates,
9	depending on whether one or two directors are being elected, receiving the highest number of
10	votes are elected. The provisions of chapter 40-21 govern the election of directors from the city
11	of Dickinson or Mandan for the southwest water authority.
12	SECTION 4. AMENDMENT. Section 61-24.5-08 of the North Dakota Century Code is
13	amended and reenacted as follows:
14	61-24.5-08. Term of office of directors - Oath of office - Bonds.
15	Members of the board of directors of the authority hold office for a term of four years, until a
16	successor has been duly elected and qualified. If the office of any director becomes vacant by
17	reason of the failure of any director elected at any election to qualify or for any other reason, the
18	director's successor must be appointed to fill the vacancy by the board of county commissioners
19	of the county in which the vacancy occurs, or by the governing body of the city of Dickinson or -
20	Mandan, as appropriate. A director appointed to fill a vacancy shall hold office for the unexpired
21	term of the director whose office has become vacant, and until a successor has been elected
22	and qualified.
23	Members of the board of directors elected from a county must be elected at the primary
24	election and assume office on the first Monday in July following their election. Members of the
25	board of directors elected from the city of Dickinson or Mandan must be elected at the municipal
26	election and assume office on the first Monday in July following their election.
27	In 2002 all directors' terms are deemed to have expired, and each county shall elect one
28	director to serve on the board of directors and the city of Dickinson shall elect two directors to
29	serve on the board of directors. In 2002 one director from the city of Dickinson and directors-
30	from Adams, Billings, Dunn, Grant, Oliver, and Slope Counties must be elected for two-year-

31 terms and in 2004 and thereafter must be elected for four-year terms. In 2010 the director from-

- 1 the city of Mandan must be elected to a four-year term. All subsequent directors elected must
- 2 be elected for four-year terms.
- 3 Before assuming the duties of the office of director, each director shall take and subscribe
- 4 to the oath of office prescribed by law for civil officers. The authority treasurer must be bonded
- 5 in an amount as the board may prescribe.
- 6 **SECTION 5. EFFECTIVE DATE.** This Act is effective for taxable years beginning after
- 7 December 31, 2018.
