- 1 A BILL for an Act to amend and reenact section 15.1-18-10 of the North Dakota Century Code,
- 2 relating to allowing individuals who do not have a teaching license to teach noncore subjects
- 3 upon meeting certain criteria; to provide for a legislative management report; and to provide an
- 4 expiration date.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 6 **SECTION 1. AMENDMENT.** Section 15.1-18-10 of the North Dakota Century Code is amended and reenacted as follows:
- 8 15.1-18-10. Specialty areas Teacher qualification.
- 9 Notwithstanding the requirements of this chapter:
- An individual may teach art, business education, computer education, a foreign
 language, music, physical education, special education, and technology education at
 any grade level from kindergarten through grade eight, provided the individual:
 - a. Is licensed to teach by the education standards and practices board;
- b. Is approved to teach in that area by the education standards and practices board;
 and
 - c. Meets all requirements set forth in rule by the superintendent of public instruction.
- An individual may teach Native American languages provided the individual is an
 eminence-credentialed teacher.
- 3. An individual may teach in the areas of trade, industry, technical occupations, or health occupations, provided the individual has been issued a license to teach in such areas by the education standards and practices board.
- 4. An individual may teach part-time in any subject, except elementary education, special education, mathematics, science, language arts, and social studies, if the individual has a permit issued by the board, has a high school diploma, and:

I		<u>a.</u>	Possesses at least five years of relevant work experience in the subject area to
2			be taught;
3		<u>b.</u>	Possesses a certificate, license, or degree in the subject area to be taught; or
4		<u>C.</u>	Achieves a passing score on the Praxis content test.
5	<u>5.</u>	The	board of a school district may authorize an individual to teach part-time under
6		<u>sub</u>	section 4 for one year, up to a maximum of three years, if:
7		<u>a.</u>	The administrator of a school within the district submits a written request to the
8			education standards and practices board which indicates the administrator is
9			unable to locate a qualified applicant and requests the education standards and
10			practices board issue a permit;
11		<u>b.</u>	The individual successfully completes a background check conducted by the
12			education standards and practices board; and
13		<u>C.</u>	The education standards and practices board issues a permit to the individual.
14	SECTION 2. ALTERNATIVE TEACHER CERTIFICATION PROGRAM - REPORT TO		
15	5 LEGISLATIVE MANAGEMENT. The education standards and practices board shall provide the		
16	legislative management a status report during the 2019-20 interim and during the 2021-22		
17	interim regarding the number of teacher licenses issued under an alternative teacher		
18	certification program, the effectiveness of the program, the quality of instruction provided under		
19	the program, and whether the program is accomplishing desired objectives. The report must		
20	include a recommendation regarding continuation of the program.		
21	SECTION 3. EXPIRATION DATE. This Act is effective through July 31, 2023, and after that		
22	date is in	neffe	ctive.
